This document highlights the major changes and fixes for Release 1.10.0.11 of Oracle Retail Brand Compliance Management Cloud Service.

## Overview

Oracle Retail Brand Compliance Management Cloud Service is an integrated suite of applications designed to meet all aspects of sourcing, developing, and protecting retailer brands. The suite provides solutions for product development, compliance, quality, and traceability. It is designed specifically for retail, food service, and manufacturing businesses to develop and protect their brands, manage their suppliers, and ensure full end-to-end product lifecycle management.

The suite is composed of the following applications:

- myLibrary - enables the issue, receipt, and acceptance of policies, guidelines, and key working documents.
- myProduct - supports the development of products and production specifications.
- myProject - supports the development of project briefs, plans, and workflow management.
- mySupplier - enables the identification, selection, and approval of suppliers.

TRUNKONEEIGHT-499 Ref 23203712	An error no longer occurs when a user clicks the "Change Status" text shown within the actions menu of a site in EDIT mode.

TRUNKONEEIGHT-487 Tesseract Ref 109791 Ref 22610091	A performance improvement is applied for switching an open specification in READ mode into EDIT mode.
TRUNKONEEIGHT-490 Ref 22975026	A fix is applied which ensures that the Fragrance Allergens field is pulled through to the FNF Pack Copy.
TRUNKONEEIGHT-495 Tesseract Ref 105860 Ref 22996325	A fix is applied so that the system now marks the "Reason For Various Suppliers" field, on a CNF specification, as mandatory when Yes is checked for the "Commodity Component Purchased From Various Suppliers" field.
TRUNKONEEIGHT-500 Ref 23335918	An error no longer occurs when saving a specification if too much data is pasted into the Source of Data field within the Nutrition section.
