This document highlights the fixes made for Release 1.10.0.18 of Oracle Retail Brand Compliance Management Cloud Service.

Overview

Oracle Retail Brand Compliance Management Cloud Service is an integrated suite of applications designed to meet all aspects of sourcing, developing, and protecting retailer brands. The suite provides solutions for product development, compliance, quality, and traceability. It is designed specifically for retail, food service, and manufacturing businesses to develop and protect their brands, manage their suppliers, and ensure full end-to-end product lifecycle management.

The suite is composed of the following applications:

- myLibrary - enables the issue, receipt, and acceptance of policies, guidelines, and key working documents.
- myProduct - supports the development of products and production specifications.
- myProject - supports the development of project briefs, plans, and workflow management.
- mySupplier - enables the identification, selection, and approval of suppliers.

Fixed Issues

Table 1 General Fixed Issues

Defect Number	Description
25529946	<p>Page loading causes cursor reposition</p> <p>A fix is made to rectify an issue with the cursor repositioning. The issue occurred when the user was editing a large text field and the system reloaded the page as a result of refreshing the contents of the user's Tasks and Urgent Items lists.</p> <p>The automatic refresh of user tasks can now be disabled to prevent this behavior occurring. It does mean that if disabled, the list of tasks will only refresh at the time of login. A future release may include a button on the Home page to allow the user to refresh their task lists without the need to log off. If not disabled for the portal, the task lists will continue to refresh automatically.</p> <p>Note: By default, this auto refresh will not be disabled. If this is required, it needs to be arranged as part of your maintenance release schedule, to ensure the necessary configuration is applied.</p> <p>-Dcom.oracle.retail.orbc.disableAutoUIUpdates=true</p>
26939685, 27000751	<p>Button text color</p> <p>A fix is made to rectify an issue with the color of the text on buttons in various areas, including the myLibrary site selector, in Project Brief templates, and in Food specifications.</p>

Table 2 myProject Fixed Issue

Defect Number	Description
25042233	<p>Answer to a Brief Question not showing data in Project Activity list view</p> <p>A fix is made to rectify an issue with the answer of a Brief Question not being shown when added as a column to the Project Activities list view.</p>

Table 3 myProduct Fixed Issues

Defect Number	Description
25922702	<p>Unable to delete Ingredients and Assurance Standards glossary entries</p> <p>A fix is made to rectify an issue where entries in the Ingredients and Assurance Standards glossaries could not be deleted, even if they were not being used by any specifications.</p>
26543250	<p>Error when changing the status of a Product Specification</p> <p>A fix is made to rectify an error when progressing the status of a specification.</p> <p>The error occurred when changing the status having edited a table, and with warning messages present in other sections. The status change can now be accomplished without the error.</p>

Table 4 myLibrary Fixed Issues

Defect Number	Description
24761978	<p>Timeout error when assigning Sites to a Document</p> <p>A fix is made to rectify a timeout issue when using the Select All button to assign a library document to a list of sites. The problem occurred where there were thousands of sites in the list. There was also an issue with the deselection of sites.</p> <p>The fix introduces paging on the list of sites and ensures the button correctly selects/deselects all accordingly.</p>
25338228	<p>Problems when searching for Library Documents</p> <p>A fix is made to rectify an issue with the quick search facility in the document library. The fix ensures the full list of documents can be navigated using the paging toolbar, and if the quick search is used, the retuned results can be navigated correctly.</p>
27000195	<p>Error when searching for External Readers to assign to a Library Document</p> <p>A fix is made to rectify an error when using the search option in the Site selector dialog box for assigning a library document to specific sites.</p>
27000385	<p>Error when assigning External Readers to a Library Document</p> <p>A fix is made to rectify an error when assigning a library document to specific sites. The problem occurred when the uncategorized list of sites was selected.</p>
27165230	<p>Slow loading of Document Library</p> <p>A fix is made to rectify an issue with slow loading of the Document Library. The issue occurred where the library contained hundreds of documents, when clicking the myLibrary node to open the list of documents. The fix now typically opens the list within three seconds.</p>

Table 5 myReports Fixed Issues

Defect Number	Description
23591840	<p>Values transposed in Site Details report</p> <p>A fix is made to rectify an issue with the values of the Use Supplier Address and Requires Maintenance Audit fields being transposed when reporting on a Site record.</p> <p>A fix has been made to the Supplier and Site reporting domain.</p>
26746769	<p>Problem reporting on Country of Origin data in CNF Specifications</p> <p>A fix is made to rectify an issue with incorrect country of origin data being returned when reporting on the Other Back of Pack details of a Constructed Non Food specification's Other Labelling Copy section.</p> <p>A fix has been made to the Product reporting domain.</p>
26865851	<p>Reports not returning up-to-date data</p> <p>A fix is made to rectify an issue with reports returning data that is older than the usual 24 hour window, where the problem occurred due to the failure of the reports scheduler.</p> <p>A change has been made to the reporting refresh module so that it will automatically start if configured to do so, and to ensure the scheduler is run on a daily basis, avoiding the data being more than 24 hours old. Other measures have also been implemented to allow health monitoring of the reports scheduler.</p>

Table 6 mySupplier Fixed Issue

Defect Number	Description
26941605	<p>Error when creating a Supplier Contact</p> <p>A fix is made to rectify an error when creating a new supplier contact with mandatory roles, and assigning the User account.</p> <p>The problem occurred when Supplier Contact custom fields were set up, and the custom fields included a rich text type of field.</p>

Post Release Tasks

If the page "loading" item needs to be addressed on the portal (25529946), then the appropriate configuration update needs to be arranged with your CSM as part of your maintenance upgrade.

If a reporting release has also been arranged for your maintenance upgrade (see specifically 26865851), then you should ensure that all of your current scheduled reports and any future scheduled reports are updated so that they are no longer scheduled to run at the same time as the reporting is doing its full 24 hour refresh. Please discuss this with your CSM if required.
