This document highlights the major changes and fixes made for Release 1.10.0.28 of Oracle Retail Brand Compliance Management Cloud Service.

## Overview

Oracle Retail Brand Compliance Management Cloud Service is an integrated suite of applications designed to meet all aspects of sourcing, developing, and protecting retailer brands. The suite provides solutions for product development, compliance, quality, and traceability. It is designed specifically for retail, food service, and manufacturing businesses to develop and protect their brands, manage their suppliers, and ensure full end-to-end product lifecycle management.

The suite is composed of the following applications:

- myLibrary - enables the issue, receipt, and acceptance of policies, guidelines, and key working documents.
- myProduct - supports the development of products and production specifications.
- myProject - supports the development of project briefs, plans, and workflow management.
- mySupplier - enables the identification, selection, and approval of suppliers.

**Table 1 General Fixed Issue**

Defect Number	Description
24315728, 29464766	<b>Quick Search returning unexpected results</b> A fix is made to rectify an issue with searches not returning expected results when using the quick search in categorized list views. Categorized list views are those that are organized using the <i>tree</i> selector in the left hand pane, such as Specifications by Technologist or Users by Role. After searching the list view with the quick search facility, selecting a category now correctly filters the list view contents based on the selection.

**Table 2 myProduct Fixed Issue**

Defect Number	Description
28080800, 28295771, 28794880	<b>Mandatory fields not being validated</b> A fix is made to rectify an issue with mandatory fields in the Product Specification not being validated. The issue occurred when the specification was being validated for the second time. Examples include the contents of the Packaging section.

**Table 3 myReports Fixed Issue**

Defect Number	Description
24464281, 26914495, 28657625	<b>Unable to report on Specify field in Dietary &amp; Allergy specification section</b> A fix is made to rectify an issue with the Specify field for Contains and Suitable For questions in the specification's Dietary & Allergy section not being available for reporting. The field has been added to the Product Specification report domain.

## Post Release Tasks

### Reporting

If a reporting release has also been arranged for your maintenance upgrade (see Table 3) then you should ensure that all of your current scheduled reports and any future scheduled reports are updated so that they are no longer scheduled to run at the same time as the reporting is doing its full 24 hour refresh. Please discuss this with your CSM if required.

The Reporting Scheduler refresh task runs at midnight and will take a variable amount of time to complete based upon your database size. During this time no reports can be run, so start times of scheduled reports may need to be adjusted accordingly.
