This document highlights the major changes for Release 16.0.4.4 of Oracle Retail Brand Compliance Management Cloud Service.

Overview

Oracle Retail Brand Compliance Management Cloud Service is an integrated suite of applications designed to meet all aspects of sourcing, developing, and protecting retailer brands. The suite provides solutions for product development, compliance, quality, and traceability. It is designed specifically for retail, food service, and manufacturing businesses to develop and protect their brands, manage their suppliers, and ensure full end-to-end product lifecycle management.

Oracle Retail Brand Compliance Management Cloud Service is composed of the following applications:

- Library enables the issue, receipt, and acceptance of policies, guidelines, and key working documents.
- Product supports the development of products and production specifications.
- Project supports the development of project briefs, plans, and workflow management.
- Supplier enables the identification, selection, and approval of suppliers.

Oracle Retail Cloud Services and Business Agility

Oracle Retail Brand Compliance Management Cloud Service is hosted in the Oracle Retail Cloud with the security features inherent to Oracle technology and a robust data center classification, providing significant uptime. The Oracle Cloud team is responsible for installing, monitoring, patching, and upgrading retail software.

Included in the service is continuous technical support, access to software feature enhancements, hardware upgrades, and disaster recovery. The Cloud Service model helps to free customer IT resources from the need to perform these tasks, giving retailers greater business agility to respond to changing technologies and to perform more value-added tasks focused on business processes and innovation.

Functional Enhancements

The following functional enhancements are included in this release:

Product Nutrition Table Support for South African Legislation

Defect Number: 24391673

In order to meet South African legislation requirements, a new field is added to the nutrient glossary called "Space before unit." This can be used to add a space between the nutrients value and the units when it is displayed in the Back of Pack Declaration table, such as, Fat could be set up to show 10 g instead of 10g.

Product Number Searchable in Specification List Views

Defect Number: 22480355

It is now possible to search the Specifications list views for a Product Number (Article Number/SKU). The quick search will return results if the Product Number column is present in the list view. The advanced search will return results whether the column is present in the list view or not.

Change to ANZ Legislation Nutrition Rounding Rules

Defect Number: 25403815

The nutrition rounding rules for the Australia/New Zealand legislation are changed to remove the significant figure odd/even rounding rule, which applied rounding based on whether the previous figure was odd or even. Instead, standard mathematical

rounding is applied, where figures below 5 round down and figures 5 and above round up.

Impact on Existing Systems

The new rounding rule applies to all ANZ nutrition calculations that are performed following the release. All existing calculations remain unchanged, unless a user chooses to recalculate a specification's nutrition values.

Multi-Pack Specifications to Default to Pack Copy Required

Defect Number: 25420650

When creating a multi-pack specification, the option for whether a pack copy is required or not, for the sections in the Multi-pack Components section now defaults to Yes instead of No.

Impact on Existing Systems

The default becomes effective for multi-pack specifications that are created following the release.

Performance Improvements

Defect Numbers: 25437500, 25694299

General performance improvements are made to the opening of certain task lists and list views. This includes changing the Default list view for Product Records from being a grouped type of list view.

Fixed Issues

Defect Number	Description
24598507	Performance improvements are made to the way the system handles embedded List Views, such as the list of specifications within a site record. These List Views now only refresh once when the record is opened rather than constantly refreshing while the record is open.
24659476	The system no longer allows users to select the "Mark as Read" action for a news item if the news item has been archived.
24807106	A fix is applied so that the default set of roles are generated when a new environment is created.
25070696	Error opening a News Item attachment A fix is made to rectify an issue when opening an attachment to a News Item.
25589977	User unable to login A fix is made to rectify an error that occurred when certain users logged in to the system. The issue was related to user accounts that had been created as part of a migration from a legacy system, and was due to the user preferences not being set.

25732329	<p>List Views not being added to Favourites</p> <p>A fix is made to rectify an issue where clicking the link on a list view's title was not adding it to the user's list of favourites.</p> <p>Clicking the list view's title link now adds the list view to the user's Favourite List View app on the Home page.</p>
25833366	<p>Change History log incorrectly showing current date</p> <p>A fix is made to rectify a problem with the Change History log incorrectly showing a record as being created on the current date. This occurred for records that are dependents of another record, such as Audit Checklists, which are automatically created with their parent Audit rather than being created individually. In the absence of individual created and updated dates, the current date was incorrectly being shown. A hyphen (-) is now shown in place of the date.</p>

An error no longer occurs when a Produce specification is approved and there is no Contact Role set in the To / External recipients field of the PRI01 email template.

If the column appears in the list view, it will be included in the download file. If a product has multiple countries, they will all be included.</p>
23260455	<p>Incorrect section name in error message when validating a Recipe</p> <p>A fix is made to rectify an issue where an incorrect section name was appearing in the validation error message box when a specification that contained multiple Recipe sections had its ingredients declaration calculated.</p>
23320843	Where selections are made using the Editable Text Selector, these are now listed in the same order in the Pack Copy as they are seen on screen within the specification.
23540722, 25316428	<p>Null Pointer exception when accessing a Specification</p> <p>A fix is made to rectify an exception that occurred when opening a specification.</p>

23748247	<p>QUID declaration below 1% showing (0.1%) as (0, 1%) in the List 2 ingredients list</p> <p>When generating the List 2 type Ingredients List, which formats component lists with commas instead of full stops, the decimal points in the QUID declarations were also being erroneously replaced with commas.</p> <p>A fix is applied to exclude the QUID values when replacing decimal points with commas.</p> <p>Impact on existing systems:</p> <p>Existing declaration panels will remain unchanged, unless the declaration is regenerated.</p>
23857529	The Servings per Package shown on the Nutrition panel is now displayed according to the Food Standards Australia New Zealand (FSANZ) standards.
24295204	<p>Field labels missing from Change History log</p> <p>A fix is made to rectify an issue where the list of field-level changes in the Change History log was not correctly displaying the field label for some fields.</p>
24367856	Supplier users are now able to see a task in the Task App covering produce specifications which are awaiting supplier approval.
24375090	<p>The Specification Type field remains editable if a specification has not been linked to the Product Record (as per other fields). Therefore, if the user has the necessary access rights to edit the Product Record, it is at a status where it can be edited, and no specifications have yet been linked to it, then the Specification Type will be editable.</p> <p>If the Product Record does have any specifications linked to it and if the user attempts to change the type to something different to that of the specifications, validation prevents the change, with the message: <i>Specification Type must be consistent between Product Record and any linked Specifications.</i></p>
24497775	The nutrition section validation now reports an error to make the user aware that Total Sugar + Starch cannot be greater than Carbohydrate.

24660265	The system now correctly rounds the QUID output within the ingredients list according to EU and ANZ regulations.

24842653	An error is no longer produced when a new version of a specification is created.

25077219	An error no longer occurs when exporting the recipe table from a specification.
25245176	An error no longer occurs opening a specification which has a nutrition section requiring a large number of translations.
25386603	<p>Unable to open the Storage section of a Specification</p> <p>A fix is made to rectify an issue where an exception occurred when opening the Storage section of a specification.</p>
25407551	<p>CNF Specification's Pack Copy formatting correction</p> <p>The Flashes & Logos section of a CNF specification's pack copy report contains three columns: Logos, Supporting Text, and Position. The width of these columns was set incorrectly, which meant only the first column was visible when viewed in Microsoft Word.</p> <p>The column widths are changed so that all three columns are visible in Microsoft Word.</p> <p>Impact on existing systems:</p> <p>Existing Pack Copy files will remain unchanged, unless they are regenerated.</p>

25422565, 26244844	<p>Error when editing the product sources in a Produce Specification</p> <p>A fix is made to rectify an issue where a specification with many ingredients may freeze when editing the Source of the ingredients.</p>
25475328	<p>Spaces inserted into the Pack Copy file's Product Title</p> <p>When viewing the Pack Copy file using Microsoft Word, the Product Title would contain spaces every 35 characters, to avoid truncation of long names. Product Titles in the Pack Copy file now wrap where necessary rather than have blank spaces inserted every 35 characters.</p> <p>Impact on existing systems:</p> <p>Existing Pack Copy files will remain unchanged, unless they are regenerated.</p>
25711725	<p>Issues with Allergens and Suitable For pages in a copied Specification</p> <p>A fix is made to rectify issues with the Allergens and Suitable for pages within the Allergy & Dietary Advice section of a specification that has been copied, specifically where the original specification contained validation overrides. The issues that have been resolved relate to:</p> <ul style="list-style-type: none"> ■ In the Allergens page, statements were being copied to the Suitable For page. ■ In the Suitable For page, statements were not being copied. ■ In the Allergens page, statements were being removed.
25732076	<p>Forced Addition column text not translated in Recipe table</p> <p>A fix is made to rectify an issue where the Forced Addition field was not being translated in the Recipe table when changing the Pack Copy Language.</p>
25795546	<p>Non unique codes assigned to Design Agencies</p> <p>A fix is made to rectify an upgrade issue where the code was being assigned to Design Agencies based on the name of the Design Agency, which potentially resulted in duplicate codes. A unique code is now always assigned.</p>
25795652	<p>Incorrect status change options for Specifications</p> <p>A fix is made to rectify an issue where incorrect status change options were shown for Specifications, such as the option to set to Collaborative Draft while already at that status, or to set to Active before the supplier had authorized. The Actions menu no longer shows the incorrect options.</p>
25833394	<p>CNF Specification Components section showing Units as editable field in read mode</p> <p>A fix is made to rectify an issue where the Units column of the Formulation table in a CNF specification was editable when the specification was in read mode.</p>
25833406	<p>Exception when adding a FNF OLC section to a Food Specification</p> <p>A fix is made to rectify an issue where an exception occurred when adding an FNF Other Labelling Copy section to a Food specification.</p>

25833693	<p>Field change information missing from Change History log</p> <p>A fix is made to rectify an issue where the From and To change history information was not displaying for some fields. 25875689	<p>Error when archiving a Produce Product Record</p> <p>A fix is made to rectify an error when setting the status of a Produce Product Record to Archived.</p>
26007062	<p>Issue with Nutrient Targets numeric field size</p> <p>The Target Value field in the Nutrient Target Categories glossary has the number of integers increased from 3 to 4, making the maximum size 9999.999.</p>
26135523	<p>Incorrect Nutrition declaration</p> <p>A fix is made to rectify an upgrade issue where a missing Front of Pack Nutrition glossary records resulted in an incorrect Nutrition declaration with a Specification.</p>
26135658	<p>Incorrect spacing in Ingredients seclaration</p> <p>A fix is made to rectify an issue where a space was being omitted in the Ingredients declaration of a Specification. For example, the incorrect declaration Tortillacontains would now correctly show as Tortilla contains.</p>
26173398	<p>Error when validating Nutrition section</p> <p>A fix is made to rectify an error that occurred when validating the Nutrition section of a Specification.</p>
