This document highlights the major changes for Release 18.3.0.4 of Oracle Retail Brand Compliance Management Cloud Service.

Overview

Oracle Retail Brand Compliance Management Cloud Service is an application designed to meet all aspects of sourcing, developing, and protecting retailer brands. The application provides solutions for product development, compliance, quality, and traceability. It is designed specifically for retail, food service, and manufacturing businesses to develop and protect their brands, manage their suppliers, and ensure full end-to-end product lifecycle management.

Oracle Retail Brand Compliance Management Cloud Service is composed of the following modules:

- Library enables the issue, receipt, and acceptance of policies, guidelines, and key working documents.
- Product supports the development of products and production specifications.
- Project supports the development of project briefs, plans, and workflow management.
- Supplier enables the identification, selection, and approval of suppliers.
- Reports - reporting tool for reporting across the system, using standard templates and custom reports.

Oracle Retail Cloud Services and Business Agility

Oracle Retail Brand Compliance Management Cloud Service is hosted in the Oracle Retail Cloud with the security features inherent to Oracle technology and a robust data center classification, providing significant uptime. The Oracle Cloud team is responsible for installing, monitoring, patching, and upgrading retail software.

Included in the service is continuous technical support, access to software feature enhancements, hardware upgrades, and disaster recovery. The Cloud Service model helps to free customer IT resources from the need to perform these tasks, giving retailers greater business agility to respond to changing technologies and to perform more value-added tasks focused on business processes and innovation.

Oracle Retail Software Cloud Service is acquired exclusively through a subscription service (SaaS) model. This shifts funding from a capital investment in software to an operational expense. Subscription-based pricing for retail applications offers flexibility and cost effectiveness.

30896143, 32013020, 32051861	<p>Language translation issues</p> <p>A fix has been made to rectify an issue with the translation of text in various pages, for languages that use the extended character set, such as Japanese.</p> <p>The issue occurred in the Landing page, Logout page, Product Specification validation window, and Error pages. Translations for non-Latin languages now show correctly within these pages.</p>

32046778, 32062296	<p>Order of columns in Nutrition declaration panel</p> <p>A fix has been made to rectify an issue with the order of the columns in the Nutrition declaration panel, as generated within the product specification's Nutrition section.</p> <p>The columns in the declaration panel are now ordered based on the sequence configuration of the associated Nutrition Panel glossary, instead of incorrectly using the sequence of the <i>Columns to be Declared</i> selection in the Nutrition section.</p> <p>When copying a specification, or creating a new version, the order of the columns to be declared will now also be updated to reflect the order in the current active version of the Nutrition Panel configuration.</p> <p>Note that updating the Nutrition section directly, rather than creating a new version, may result in a difference in the column sequence, however the declaration panel will always contain the columns that have been selected to be declared. If a Nutrition Panel configuration is needed to be changed, then it is advised that this done by creating a new version of the Nutrition Panel and then making the new version "active."</p>

Post Release Tasks

32046778, 32062296 Order of columns in Nutrition declaration panel

Any specifications that have been reverted or copied should be verified to ensure that the Nutrition columns are in the correct order as defined by the Nutrition Panel. Any that are found to be different will need to be regenerated on the Nutrition section. This could involve changing a specification status back to a status where this can be edited, or creating a new version of a specification if already at active status.
