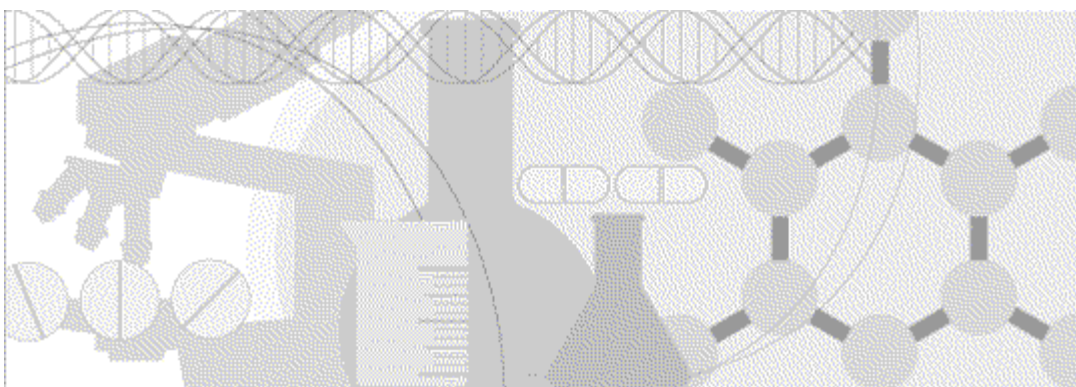

About report data

The Reporting and Analysis database

All data used for reporting resides in the Reporting and Analysis database, a database schema that is replicated from the InForm transactional database schema. Because data for reports is stored separately from InForm transactional data, you can write and run reports in the Reporting and Analysis module without affecting the performance of the InForm application.

Data in the Reporting and Analysis database is updated in real time, allowing you to access up-to-date information for your study.

The Reporting and Analysis database contains two types of data:

- **Study management data**

Study management data includes metrics and status data for a study. Use study management data to report on the completion status of your study. You can report on such things as the number of visits that are complete for a study or the number of forms that are frozen or locked.

The Reporting and Analysis database study management schema is installed with each InForm installation. It is not specific to your study.

- **Clinical reporting data**

Clinical data for reports includes data about each subject visit. Use clinical data to report on specific clinical questions and responses. You can report on such things as adverse events, vital signs information, and dosing records.

The Reporting and Analysis database clinical schema is built from the forms that are installed with your study. Therefore, the clinical data available for reports is unique for each study.

Basic relational database concepts

Term	Description	Example
Tables	Made up of rows and columns. Store collections of related data.	Subjects, Visits, and Forms tables.
Rows	Occurrences (records) of related data values in a database table. Each time you enter new data in a table, you create a row in that table.	Subjects, Visits, and Forms rows.
Columns	Occurrences (records) of individual data values in a database table.	The columns in the Subjects table might store a Subject ID, Subject Number, Subject Initials, Current Status, and First Screened Date for each subject (row) in the study.

Term	Description	Example
Primary keys	Columns in a database table whose values uniquely identify a row in a table.	The Subject ID column in the Subjects table is a primary key because each Subject ID value can only occur one time in that table and is unique to each subject.
Foreign keys	Columns in a database table that establish relationships with other tables in the database.	The Subject ID column in the Visits table is a foreign key that allows you to create a relationship between the Visits table and the Subjects table as well as a relationship between the Visits table and the Forms table.
Joins	Expressions of relationships between database tables. A join occurs when you match the data value of a key (primary or foreign) in one table to the data value of a key in another table to retrieve related data.	To retrieve a visit and form data for a subject: <ul style="list-style-type: none"> • Join the Subject ID value in the Subjects table to the Subject ID value in the Visits table. • Join the Subject ID value in the Visits table to the Subject ID value in the Forms table.

Reporting and Analysis terminology

Term	Description
Aggregate values	Quantitative (numeric) values that represent counts, averages, and totals.
Calculation	A report element that can perform many types of operations such as calculating the sum or average of the values in one column, or multiplying the values in two columns.
Chart	A report that shows patterns and trends in data using a graphical presentation: pie chart, bar chart, line chart, and so on.
Crosstab report	A report that shows summary data at the intersection points of rows and columns.
Data model	A logical representation of the data in the Reporting and Analysis database that describes data objects, structure, grouping, data relationships, and security.
Job	A group of ad hoc reports or other items that you can run and schedule as a batch.
List report	A report that shows detailed data in rows and columns.

Term	Description
Measure (or fact)	A report element that contains cumulative values that can be aggregated to produce meaningful results. Measures are quantitative performance indicators that produce the numbers that usually appear in the cells of a crosstab report or in a chart. Measures appear in the Ad Hoc Reporting tree for use in ad hoc reports.
Non-aggregate values	Non-numeric data that represents string (text) or date values.
Package	A graphical representation (container) for one or more data models and reports.
Personal folder	A folder in the Reporting and Analysis portal that only the folder owner can access.
Portal	A website or page that provides a single presentation and a single starting point for a set of information.
Prompts	Controls that allow you to select criteria and choose sort options for your report.
Public folder	A folder in the Reporting and Analysis portal that users with appropriate rights can access.
Report element	The equivalent of a column of data that contains the actual data from the Reporting and Analysis database. Report elements appear in the Ad Hoc Reporting tree for use in ad hoc reports.
Report palette	A workspace onto which the user drags and drops report elements to include in an ad hoc report.
Report topic	An object in a data model that is equivalent to a table of columns in the Reporting and Analysis database. Report topics appear in the Ad Hoc Reporting tree for use in ad hoc reports.
Report view	A report that contains data from the Reporting and Analysis database at any given point during a study. Use report views to compare and compile data over time.

Data models

A data model is a layer of the Reporting and Analysis database that describes the data objects, structure, grouping, data relationships, and security. The Reporting and Analysis module uses one or more data models to make the data in the Reporting and Analysis database available for reports.

Two data models exist for every InForm study.

Data model	Description
Trial Management data model	Describes only the study management portion of the Reporting and Analysis database. Note: This is also called the Operational model.

Data model	Description
Clinical data model	Describes the clinical and study management portions of the Reporting and Analysis database.

Data model security

Display override settings and site associations determine the clinical data that is available from the clinical model for use in reports. For example:

- If an item is not visible to you in the InForm application, when you create a report that contains the item, the cells in the column that corresponds to the item contain the text **N/A**.
- You can see and create reports using only information for the sites in the study to which you have access.

The clinical model also contains relationships to the operational report topics. These relationships allow you to create reports in the Ad Hoc Reporting workspace by dragging and dropping clinical and operational report elements onto the report palette. This operation is conceptually similar to creating an SQL join directly between a clinical view and an operational view.

Packages

A package is a grouping of data from one or more data models. Two packages are installed with every InForm study.

Package	Description
InForm Trial Management	Contains data from the Trial Management data model only. This package is installed with every InForm study.
Study-specific clinical	Contains data from both the Trial Management data model and the clinical data model (unique for each study).

In the Ad Hoc Reporting workspace, you can see each package structure in the Ad Hoc Reporting tree.

InForm Trial Management package

The InForm Trial Management package is installed with every instance of the Reporting and Analysis module, and is identical across studies. It contains report topics and report elements from the Trial Management data model only.

Note: Use the InForm Trial Management package to create reports that contain only study management data. Reports that you create with the InForm Trial Management package can be shared across studies.

Study-specific clinical package

The study-specific clinical package provides access to both clinical and study management data. It consists of report topics and report elements from both the clinical and Trial Management data

models.

Note: Use the study-specific package to create reports that include clinical data. Because clinical data is unique to each study, report definitions using the study-specific package might not be validated to work across different studies.

A clinical package groups data in each report topic into four sub-folders: Basic Data, Additional Data, Incomplete Data Reasons, and Internal IDs.

Locales in the Reporting and Analysis module

There are multiple locales that affect the languages that appear in the Reporting and Analysis environment.

- Default product locale
 - Set during the InForm installation.
 - Controls the language of the prefixes for clinical metadata, such as **Code~**, **Unit~**, and **Date~**, which appear in the Ad Hoc Reporting tree.
- Reporting product locale
 - Based on the default or user product locale settings in the InForm application.
 - Controls the language of Cognos commands and navigation controls.
 - Controls the language of the study metadata, such as the names of the report topics in the Ad Hoc Reporting tree, for the Trial Management data model.
- Review schema locale
 - Set automatically when you deploy your study to the InForm application.

Note: You can use the PFAdmin utility to change the review schema locale after the Reporting and Analysis installation. For more information, see the *Study and Reporting Setup Guide*.

- Defines the language in which language-dependent resources such as clinical data are displayed.

Note: Make sure that the review schema locale that you select for the Reporting and Analysis module contains all the forms and data elements from all the study locales for the study.

Reporting basics and options

Reporting and Analysis portal

The Reporting and Analysis portal is the first page that appears after you click **Reports** in the navigation toolbar.








Report folders

From the Reporting and Analysis portal, use the folder tabs to navigate to specific reports.

Tab	Description
Public Folders	Provides access to the InForm standard reports and custom reports that are shared with all users.
My Folders	Provides access to reports that only you can access.

Report output icons

The icons that appear next to the name of a saved report indicate the format in which you can view the report.

Icon	Description
	View the report in HTML format.
	View the report in PDF format.
	View the report in XML format.
	View the report in Excel 2007 Data format.
	View the report in Excel 2007 format.
	View the report in Excel 2002 format.
	View the report in CSV format.

Portal icons

Icons in the upper-right corner of the Reporting and Analysis portal let you perform actions on public or personal folders.

- Navigate between list and detailed folder views.
- Create new folders, packages, jobs, URLs, and pages.
- Cut, copy and paste folders.
- Delete folders.
- Set folder properties.
- Order folders.

Portal tools

The following options are available from the Reporting and Analysis portal, based on your InForm rights.

Report Studio	Launch the Cognos Report Studio application. Note: You must purchase the license for the Report Studio application separately from Oracle.
Drill-through Definitions	Create, edit, or delete drill-through definitions for packages in the Reporting and Analysis module.
Reporting Administration	Manage styles, Cognos portlets, and third-party portlets in the Reporting and Analysis module. <ul style="list-style-type: none"> • Status—View and manage schedules, run a report, and view report outputs. • Security—Create and manage users, groups, and roles; capabilities; and user interface profiles. • Configuration—Create and manage datasources, content administration, distribution lists and contacts, styles, portlets, and dispatchers and services.

Renewing your credentials

If you set up scheduled reports and then change your account password, you must renew your credentials. Otherwise, the report fails at the next scheduled time after the password change.

To renew your credentials:

- 1 Click the **My Area** icon () > **My Preferences**.
- 2 On the **Personal** tab, click **Renew the credentials**.
- 3 At the bottom-right corner of the window, click **Return**.

Personal pages


You can create up to 50 personal portal pages to organize the information that is most important to you. Using personal pages, you can access in one place the Reporting and Analysis features that you use the most, organized in the way that you want.

The personal page content consists of one or more frames that you display in a single-column, two-column, or three-column configuration. Each personal page frame can display:

- The contents of a public or a personal folder.
- Lists of public and private folders.
- Reports.

You can set up your personal pages to run your reports automatically during non-peak hours so that when you access your personal page at the beginning of the work day, the report output is ready for you to review.

- Bookmarks of URLs to websites.
- Web pages that you visit often.
- RSS feeds.

A toolbar provides personal page configuration and management functions. Each page has a Set Properties button () . Use the Set Properties button to modify personal pages.

New Page wizard

The New Page Wizard walks you through the pages that you use to create and configure personal portal pages.

Page	Description
Specify a name and description	Provides basic properties for a personal page. <ul style="list-style-type: none"> • Name. • Description. • Screen tip. • Location (folder).
Set columns and layout	Allows you to configure the columns on a personal page. <ul style="list-style-type: none"> • Number of columns. • Content. • Column width. • Layout options.
Set page style	Allows you to add titles and instructions to the page, configure their style settings, and set the style of all portlets on the page.

Page	Description
Select an action	Allows you to select what to do after closing the wizard. <ul style="list-style-type: none"> • Add the page to the portal tabs. • View the page.

Report options

You can configure the way the output appears for ad hoc and standard reports by using **Run with options** and **Run with advanced options** for the report. The options available allow you to specify settings such as output format, frequency of report generation, and so forth.

Report types

The Reporting and Analysis module includes ad hoc and standard reports, by default. You can also purchase the Report Studio application, which allows you to create more advanced custom reports, or you can contact Oracle for assistance in creating custom reports using the Report Studio application.

Ad hoc reports

You create ad hoc reports on both clinical and study management data using the Ad Hoc Reporting workspace, which is powered by the Query Studio application. Ad hoc reports allow limited use of Cognos features such as data output styles, report layout and formatting, summarizations and aggregations, mathematical functions, and prompts.

Note: References to *Query Studio* and *queries* have been removed from the Reporting and Analysis user interface and documentation to avoid confusion by clinical users to whom the term *query* means a clinical discrepancy, not a database operation. For example, in the Cognos documentation, report topics are referred to as query subjects and report elements are referred to as query topics.

InForm standard reports

The InForm application includes a set of management reports that provide information about the progress of a study. These reports contain several categories of information, and several views of each report are available. For example, you can display the query status reports by site and by user; month by month or study-to-date; and in text or graphical formats. Standard reports are created using the Report Studio application and are validated and optimized for the InForm application.

There are five categories of standard reports:

- Query reports provide information about query aging, status, and cycle time.
- Case Report Form (CRF) reports provide information about the progress of data entry and query activity on started case books.
- Item reports provide information about the progress of item source verification, as well as listings of items on forms.
- Subject reports provide information on the progress of case book completion for individual subjects. These reports also provide subject enrollment and dropout counts, as well as subject enrollment status.
- Audit trail reports provide auditing and operational information such as audit trail information and login history.

Custom reports

Custom reports are advanced reports that are created in the Report Studio application using all the Cognos features and functionality, such as different data output methods, increased report layout and formatting options, summarizations and aggregations, prompts, user-definable sorting, and drill-through reports.

Note: For more information on creating custom reports, contact Oracle or see the Cognos documentation.

Comparison of report types

Reporting and Analysis users can create ad hoc reports, standard reports, and custom reports. The reports contain data from different sources, and vary in complexity.

Report type	Ad hoc	Standard	Custom
Design complexity	Simple to medium	Medium	Simple to advanced
Data source	Model	Model and SQL	Model and SQL
Database schema	Reporting	Reporting	Transactional and Reporting and Analysis

* For ad hoc reports, you can see all revisions for operational data only.

** The audit trail standard report covers all revisions.


Scheduling reports

You can schedule ad hoc or standard reports to run automatically at times that are convenient for you. If you choose to schedule a report:

- Avoid scheduling reports during peak periods for the study.
- If a study is complete, remember to cancel any associated scheduled reports.

Note: For more information, see the Cognos documentation, which is available from the Help icon in the upper-right of the InForm window.

Scheduling a single report

- 1 Run the report.
- 2 Save the report.
- 3 Click the **Schedule** icon () for the report.
The Schedule - [Report Name] page appears.
- 4 Specify the following information for the report:
 - Priority.
 - Start and end date.
 - Frequency.
- 5 Specify whether you want to override the format, accessibility settings, report language, or delivery settings.
- 6 Specify whether you want to override the report prompt default values.
- 7 Click **OK**.

Scheduling multiple reports

To create a list of multiple reports, report views, or other items for which you want to share schedule settings and that you want to run simultaneously, you create a job.

Using the job development tools, you can:

- Create a new job using the New Job wizard.
- Manage a job using the Set Properties button for the job.
- Run a job manually using the Run with options page.
- Manage jobs using the My Activities and Schedules page.

Note: **Run with advanced options** settings for a report take precedence over job settings. For example, if you use the **Run with advanced options** page to schedule the Query Cycle Times by Site report to run at a specific date and time, and you create a job that includes the same report, and is scheduled to run daily, the Query Cycle Times by Site report will run at the time you specified on the **Run with advanced options** page.

New Job wizard

You create jobs using the New Job wizard ()

- The job identification provides the following options:
 - The language in which to display the job identification information.
 - The name of the job.
 - An optional screen tip for a job.
 - An optional description of a job.
- Jobs contain job steps:
 - Steps reference the individual reports, jobs, and report views.
 - Submission of steps specifies whether to run the steps all at one time or in sequence.

For more information, see the Cognos documentation.

Run with options page for an existing job


The Run with options page provides options for running a job manually. This page includes the same information as the Schedule page, which appears if you choose to schedule the job from the New Job wizard.

- **Time section**—Allows you to specify whether to run the job immediately or at a specified time.
- **Steps section**—Lists the components of the job.

Note: The settings that you implement on the **Run with options** page are in effect for this execution of the job only, and do not affect the original job definition.

Set Properties page for an existing job


- Click the **Set properties** button () associated with a job to open the Set properties page and edit the job definition.

Comments in saved reports

To allow users to add comments to a report:

- 1 Save the report output in the Reporting and Analysis portal in one of the following output formats:
 - HTML
 - PDF
 - XML
- 2 Enable comments for the report.

Enabling comments in a saved report

- 1 For a saved report in HTML, PDF or XML output, click **Set Properties** ().
- 2 Do one of the following:
 - For an ad hoc report, select the **Query** tab.
 - For a standard report, select the **Report** tab.
- 3 Click **Advanced options**.
- 4 Select **Enable comments in saved output versions**.

Adding a comment to a report

- 1 Open a saved report in HTML, PDF or XML output.
- 2 Click **Add comments > Add a comment**.

The Add a comment dialog box appears.
- 3 In the **Name** field, type your name.
- 4 In the **Comment** field, type the comment text.
- 5 Click **Finish**.

Study design considerations

Subject status requirements

The subject status that appears in reports depends on which InForm features you use to set the state. For instance, to display status data for a subject in the Randomized state, you must perform subject randomization through the InForm application.

This table outlines the requirements for subject status in the InForm application. If your organization does not take advantage of these InForm features, subject status reporting capabilities are limited in the Reporting and Analysis module.

Subject status	Required action in the InForm application
Screened	InForm Screening form (as designed per InForm requirements) must be successfully submitted for the subject.
Enrolled	InForm Enrollment form (as designed per InForm requirements) must be successfully submitted for the subject.
Screened Failed	InForm Screening form (as designed per InForm requirements) must be submitted for the subject. The subject subsequently fails the InForm screening process.
Enrolled Failed	InForm Enrollment form (as designed per InForm requirements) must be submitted for the subject. The subject subsequently fails the InForm enrollment process.
Enrolled Override	InForm Enrollment Override process must be successfully completed after the subject initially fails screening or enrollment.
Randomized	Subject must be randomized in the InForm application.
Dropped Out	InForm Study Completion form (as designed per InForm requirements) must be completed for the subject. The form must indicate that the subject has dropped out of the study.
Completed	InForm Study Completion form (as designed per InForm requirements) must be completed for the subject. The form must indicate that the subject has completed the study.

DOV controls

Form aging and cycle time reports show the amount of time it takes to capture data throughout various steps of the electronic data entry process. These calculations begin with the date of visit (DOV).

There are several options for designing DOV controls. In general, the DOV control should:

- Have a specific Universal Unique Identifier (UUID).
- Appear within a form section that is identified with a specific UUID.
- Not appear on a common form.

Note: For information on designing DOV controls, see the *Utilities Guide*.

The Reporting and Analysis module retrieves DOV data from the database, assuming that your study uses specific UUIDs.

If a study uses the special DOV UUIDs, an InForm user can leave the DOV item blank during data entry. When the DOV item does not contain data in the InForm application, reports that include the date of visit or calculations that rely on the date of visit do not contain data.

If an InForm user enters a DOV that is later than the data entry date, reports show negative values in cycle time columns.

Labels for clinical report elements

In the Central Designer application, study designers can specify a label in the Short Question property for an item. For items in an itemset, this label appears as the column heading in the row and column representation of the itemset in the Reporting and Analysis module.

Note: Do not use Subject Number as an Itemset Column Header name. It causes an error when you create the clinical model for the study.

In the Reporting and Analysis module, the Itemset Column Header property is also the default short name for the field in the clinical data model, whether or not the item is in an itemset.

Optional study elements

When you design a study in the Central Designer application, you can specify whether a study element is required or optional. Optional items that are included in the study design and deployed to the InForm application may be left blank by InForm users. If an optional element does not contain data, the row that corresponds to the element in an ad hoc report does not contain data.

For example, your study may include a Sponsor Name element, for which you can choose not to enter data. In this case, ad hoc reports that contain the SponsorName report element display a row for the item, but the cells in the row do not contain the sponsor name.

Reserved words for Reporting and Analysis

The reserved words below cannot be used for the following item properties:

- Short question.
- Default question or Question if a Short question is not provided, or is populated with a reserved word.

If you specify a reserved word for the item Default question or Question you must provide a Short question that is not a reserved word, or the clinical model in the Reporting and Analysis module fails to generate.

Note: You cannot use the English reserved words or Japanese reserved characters for any locale.

For example, to design an item for which a reserved word appears as the question on the form in the InForm application, specify the following:

- Question—Reserved word such as Subject Number.
- Default question or Short question—A word that is not on the reserved words list, such as Subj Number.

Subject Number appears as the question on the form, and Subj Number appears in the clinical model in the Reporting and Analysis module and as the itemset column header on the form in the InForm application. In addition, the clinical model is successfully generated.

A warning does not appear in the Central Designer application if a reserved word is used incorrectly.

About Ad Hoc Reporting






The Ad Hoc Reporting workspace provides the flexibility to quickly create different types of reports:

- **List**—Data details in columns and rows.
- **Crosstab**—Summary data in columns and rows.
- **Chart**—Summary data using graphical presentations, such as pie charts and bar charts.

You create ad hoc reports on both clinical and study management data using the Ad Hoc Reporting workspace, which is powered by the Query Studio application. Ad hoc reports allow limited use of Cognos features such as data output styles, report layout and formatting, summarizations and aggregations, mathematical functions, and prompts.

Note: References to *Query Studio* and *queries* have been removed from the Reporting and Analysis user interface and documentation to avoid confusion by clinical users to whom the term *query* means a clinical discrepancy, not a database operation. For example, in the Cognos documentation, report topics are referred to as query subjects and report elements are referred to as query topics.

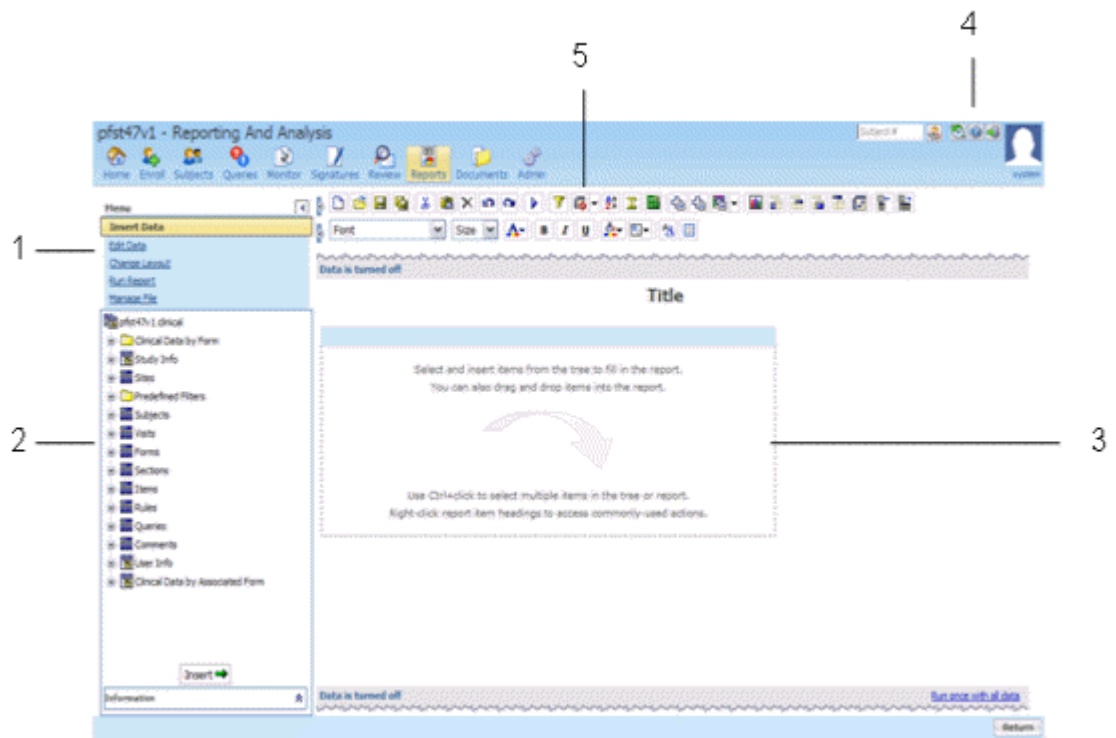

- 3—(Points to the report palette.) Drag report topics and elements to the **report palette** to create ad hoc reports.
- 4—(Points to the Help icon.) Use the **Ad Hoc Tools Help** to launch the online User Guide for Cognos Query Studio, which provides the Ad Hoc Reporting capability to the InForm application.
- 5—(Points to the Cognos 10 Business Intelligence toolbar.) Use the **Cognos 10 Business Intelligence tools** to save reports, cut and paste data, apply filters, and summarize data.

Running and saving ad hoc reports

Using the Ad Hoc Reporting tree to create reports

To create an ad hoc report, do one of the following:

- Drag a report element or report topic from the Ad Hoc Reporting tree to the Ad Hoc Reporting workspace.
- Double-click a report element or report topic.
- Select the report element or report topic, and click **Insert**.

When you double-click or drag a report topic, all report elements it contains appear as columns in the ad hoc report.

When you double-click or drag a report element, a single element appears as a report column in the ad hoc report.

Note: By default, data is turned off in the Ad Hoc Reporting workspace. When you add report topics or report elements to the report palette, the columns are populated with **abcd**. When you click **Run with all data** or **Preview with limited data**, the report is populated with the actual data.

Running an ad hoc report from the Ad Hoc Reporting workspace

- 1 From the **Ad Hoc Reporting** menu, click **Run Report**.
- 2 Choose an option:
 - Run with all data.
 - Preview with limited data.
 - Preview with no data. (This option is selected by default.)

Note: For reports that contain a large amount of data, Oracle recommends that you save the report and open it from your local machine.

Running an ad hoc report in a new window

- Right-click the link for any report to launch a new browser window in which to display the report.

Saving an ad hoc report

When you save an ad hoc report, you save the report definition. Each subsequent time you run the report, the data in the report reflects any changes in the Reporting and Analysis database.

- 1 Click **Save**.
- 2 If you are saving the report for the first time, specify:
 - **Name**—Name of the report.

- **Description**—Descriptive text about the report.
 - **Screen tip**—Hover text that appears for the report.
 - **Location**—Location in the Ad Hoc Reporting workspace in which to save the report.
- 3 Click **OK**.

Previewing report output with limited or no data

After you drag a report topic on to the Ad Hoc Reporting palette, you can view a sample report output.

- From the **Run Report** menu, click **Preview with Limited Data** or **Preview with No Data** to view a sample of the report.
 - **Preview with Limited Data**—Displays a subset of the data for the ad hoc report you created.
 - **Preview with No Data**—Displays the columns that you added to the Ad Hoc Reporting palette, populated with sample data.

For each option, the following appears in the Ad Hoc Reporting workspace:

- A jagged (torn-page look) top edge.
- A header with:
 - The report title that you created.
 - If you clicked **Preview with Limited Data**, a **Limited data** label.
 - If you clicked **Preview with No Data**, a **Data is turned off** label.
- A footer with:
 - The date when the preview was created.
 - The page number.
 - The time when the preview was created.
 - A **Run once with all data** link, which allows you to run the report with all the data you added.

Preview formats

The Ad Hoc Reporting workspace provides Run Report menu selections to preview the output format for a report during report development:

- View in PDF Format.
- View in Excel 2007 Format.
- View in Excel 2007 Data Format.
- View in Excel 2002 Format.
- View in CSV Format.
- View in XML Format.

Using the design-time report viewer

You can preview the report output in several different formats using the Run Report menu. When you select an output format, a separate window opens (either the report viewer or another window) in which to display the output.

Using predefined filters

Predefined filters let you limit a report to specific subjects, visits, and forms. These filters are shipped with the Reporting and Analysis module and can be used in all reports. The Predefined Filters folder is available in both the InForm Trial Management package and the clinical package.

You can also create filters. Each user-created filter is saved with the report in which it was created. The filter can be used only with that report and cannot be used globally across multiple reports.

Filter definitions

When you select a filter option for a column heading, the Filter pane appears. The following fields appear on the Filter pane:

- **Filter links**—Let you choose the way that you indicate your data selections.
 - Pick values from a list (default).
 - Search for values.
 - Type in values.
- **Filter on**—Identifies the column on which to apply the filter.
- **Prompt every time the report runs** checkbox—Select whether to prompt every time the report is run.
- **Condition** drop-down list—Includes the following options:
 - **Show only the following**—Select values to include in the report.
 - **Do not show the following (NOT)**—Select values to exclude from the report.
- **Data values** section—Indicates your selection values.
- **Missing values drop-down list**—Indicate whether to:
 - Include missing values.
 - Leave out missing values.
 - Show only missing values.
- **Apply the filter to individual values in the data source** checkbox—Allows you to apply the filter while retrieving the data from the database so that you retrieve only the data that you want. The alternative is to retrieve all the data from the database, then apply the filter to the retrieved data.

The following table shows which filters work with each type of reporting data.

Adding a filter

- 1 Create a report.
- 2 In the Ad Hoc Reporting report palette, select the column header for a report topic on which to filter the report.
- 3 Right-click the report column header and select **Filter**.

Or

Click the **Filter** button () in the toolbar.

The Filter (Pick values from a list) pane appears.

- 4 Do one of the following:
 - From the Filter (Pick values from a list) pane, select a filter from a list.
 - Click **Search for values** to search for a filter using keywords.
 - Click **Type in values** to search for a filter using text in the filter name.

Adding a filter without adding a column

You can filter a report based on a particular report element without adding a column for that item to the report.

- 1 In the Ad Hoc Reporting tree, right-click the report element name.
- 2 Select **Filter for report**.
The Filter pane appears.
- 3 Specify the parameters by which to filter the report.
- 4 Click **OK**.

Removing a filter

When you add a filter on a report column, the report output includes a link to the filter just below the report title. If you click this link, you can change the filter parameters to produce different output.

To hide filter links from the title area of an ad hoc report:

- 1 Double-click the report title.
- 2 Deselect **Show filters**.

This removes the links but not the filters.

Note: You cannot modify the parameters for a predefined filter.

Combining filters

Combine two or more filters to create a complex filter. For example, you can filter the columns Site Name, Visit Name, and Actual Date in a report.

- 1 From the Edit Data menu, select **Combine Filters**.
- 2 To add a filter, click **Add a filter line**.
- 3 To select a set of filters, click the name of the filter while holding down **Ctrl** or **Shift**.
- 4 Click **Group**.
- 5 Click the operator that appears between the filters and select **AND** or **OR** to combine them.
- 6 To convert a filter line or a combined filter into a NOT filter, click the filter line or combined filter and click **Apply NOT**.
- 7 Click **OK**.

Sorting the elements in a report

In the Sort Options section of the prompt page, you can choose the columns on which to sort a report.

Drop-down lists appear at the bottom of each report prompt page. Default sorting selections are automatically selected. You can change these to create your own report definition.

Each sort drop-down list includes **Ascending** and **Descending** radio buttons. Ascending sorts are automatically selected by default. Use the radio buttons to change the sort type.

Reports that include groupings, such as organization by user or by site, are sorted at the detail level within the grouping, according to the selections made in the drop-down lists. The grouping sort order can be modified (ascending or descending) but will always take precedence over other sorting settings.

Note: You can also sort data based on a report element without first adding the element to the report. For more information, see *Sorting data without adding a column* (on page 45).

Sorting data without adding a column

You can sort the data in a report based on a particular report element without adding a column for that item to the report.

- 1 In the Ad Hoc Reporting tree, right-click the report element name.
- 2 Select **Sort for report**.
The Sort pane appears.
- 3 Specify whether to sort the report in ascending order, descending order, or not to sort the report at all.
- 4 Click **OK**.

Summarization

When you create an ad hoc report, you can include summary data in the report output. Summary data provides high-level information such as totals, counts, calculations, minimum and maximum values, and so forth. The summary data that is available depends on the report element for which you are providing summary data.

In addition to providing the option to summarize specific data in ad hoc report outputs, the Ad Hoc Reporting workspace automatically suppresses duplicate data in the report output, and displays only unique combinations of data.

Adding summary data to a report

- 1 In the report palette, select the column heading for the report element for which to configure summary data.
- 2 Select **Edit Data > Summarize**.
or
Right-click a column header and select **Summarize**.
The Summarize pane for the type of data in the selected column appears.
- 3 Specify the type of summary to add to the report.
- 4 Click **OK**.

Configuring automatic summarization settings

- 1 Click **Run Report > Advanced Options**.
- 2 In the **Query Options** section, specify the following:
 - **Automatically generate footer summaries for measures** (selected by default)—Display a summary for each measure in the footer of the report output.
For example, if a report contains the Visit Mnemonic and Form Count report items, a row that contains the total number of forms for each visit exists in the report output.
 - **Automatically summarize detail values, suppressing duplicates** (selected by default)—Display only each unique combination of data, and display a summary of details.
For example, if you select this checkbox for a report that contains multiple combinations of Subject Number and Site data, the report displays only each unique combination of subject

and site. If the report also contains the Visit Mnemonic and Form Count report items, a row that contains the total number of forms for each visit exists in the report output.

- 3 Click **OK**.

Configuring drill up, drill down, and drill through settings

- 1 Click **Run Report > Advanced Options**.
- 2 In the **Drill Options** section, select the following:
 - **Enable drill up and drill down in the report output** (selected by default)—Allows you to navigate a report output according to a specific report item.

For example, if a report displays query data, organized by form, you can drill up and down through the report data by form name.
 - **Enable drill through from a package in the report output** (selected by default)—Allows you to navigate between reports that exist in a report package, if a drill-through definition exists for the package.

For example, you can navigate from an ad hoc report to a standard report in the same package.
- 3 Click **OK**.

Lineage information for data

Before you add a report element to an ad hoc report, you can view its origin. The lineage information displays metadata such as the report package, visit, form, and so forth, associated with the report element. Use the lineage information to ensure that you include the correct report element to a report.

- Right-click the report element, and click **Lineage**.

Lineage information for the report element appears in two views:

- **Business View**—Displays information about the report element and the package in which it exists.
- **Technical View** includes two panes:
 - **Diagram pane**—Graphical representation of the package, the database table, and the database (either the InForm database or the Reporting and Analysis database) in which the report element exists. This information appears in two columns:
 - **Package**—Displays metadata including the report topic and database table associated with the report element.
 - **Data Sources**—Indicates the database in which the report element exists (the InForm database or the Reporting and Analysis database).
 - **Properties for <Report Element> pane**—Displays additional information about the item that you select in the **Package** column in the Diagram pane.

Note: Lineage information is not available for reports that are created in Report Studio and include an if-then-else-if-then-else construct. This includes, but is not limited to, most InForm standard reports, and Oracle custom reports.

Changing the display format for report elements

- 1 On the report palette, click the column heading for a report column, and do one of the following:
 - From the **Edit Data** menu, select **Format Data**.
 - Right-click the column heading and select **Format Data**.
 The Format pane appears.
- 2 Specify the display characteristics for the selected column.
- 3 Click **OK**.

Renaming titles and headings

To customize a report title:





- Click the title in the report palette and enter data in the **Edit title area** pane.








To customize a report heading, do one of the following:

- Double-click the column heading in the report palette and enter data in the **Rename** pane.

Changing the page layout for a report

Use the following Change Layout menu selections to change the look and feel of an ad hoc report.

 Ungroup	Revert to showing all values in a column including duplicates.
 Create Sections	Organize a report into a distinct section for each unique value within a column.
 Swap Rows and Columns	Interchange rows and columns in a crosstab, a chart based on a crosstab, or both.
 Collapse Group	Temporarily reduce progressive levels of detail to high-level summaries.
 Expand Group	Restore temporary collapsed levels from a Collapse Group action to the full detail levels.

Suppressed and deleted data in reports

The Ad Hoc Reporting module automatically suppresses cells that correspond to items or controls without data and duplicate data from ad hoc reports. You can configure this functionality using the automatic summarization settings for a report.

The Ad Hoc Reporting module includes data from deleted records by default. To indicate that a form, visit, or subject and so forth is deleted, add the **Is Deleted** report item from the Properties folder for the report item to the report. You can also choose not to display deleted records to create reports for current data only.

Note: Calculations are performed before cells are suppressed.

In the Ad Hoc Reporting module, for clinical data, the text **N/A** appears for the following:

- Items or controls that are not started.
- Items or controls that are blank; that is, data for the item or control has been cleared.
- Items or controls that are blinded for the user running the report.
- Items or controls that are marked as Unknown.

Internal IDs

About internal IDs

Each clinical topic contains an Internal IDs folder. These folders contain unique database identifiers for various study components.

Use the following internal IDs to enhance reports:

- **Subject ID**—Unique ID that identifies a subject when the Subject Number is not unique. The Subject ID is unique for each subject.
- **Form Index, Itemset Index, and Visit Index**—Use with repeating forms, items, and visits to report on status information for individual instances of repeating objects.

Note: Indexes are also known as *sequence numbers*.

Use internal IDs when you need to identify unique instances of clinical data when there are no other elements containing unique data values.

For example, if the subject numbers in a study are not unique, to uniquely identify a subject in a report, you can use the SUBJECTID element from the Internal IDs folder.

Note: Because internal IDs access database indexes directly, they can improve the efficiency of reports that you create with the Report Studio application. Knowledge of database principles and the Reporting and Analysis database schema is recommended.

Internal IDs in the Clinical Data by Form folder

In the Clinical Data by Form folder, the content of the Internal IDs folder is the same for each report topic. Using the unique identifiers, you can focus a report on specific:

- Subjects
- Sites
- Study versions
- Visits
- Forms

Note: If your study does not enforce unique subject numbers, site mnemonics, or visit mnemonics, you can use the SUBJECTID, SITEID, or VISITID to uniquely identify a subject, site, or visit in a report.

Internal IDs in the Trial Management data model

In the Trial Management data model, the content of the Internal IDs folder depends on the level of nesting for a report element. The more nested an element is, the more internal IDs are available.

For example, the Internal IDs folder for the Subjects report topic focuses primarily on subject identifiers (primary keys), whereas the Visits Internal IDs folder contains unique identifiers for both

visits (primary keys) and subjects (secondary keys).

Calculations and conversion rules

About calculations and conversion rules

Some studies use calculations and conversions. Calculations and conversions set the value of data items by performing calculations that use the value in one or more related items. You can perform calculations such as:

- Aging on date time data.
- Concatenations and other string manipulation.
- Arithmetic and analytical operations on numeric data.

Note: You cannot edit a calculation. To modify a calculation, you must delete the calculated report element and recalculate it.


Calculations on date time elements

The Calculate page for date time elements allows you to perform the following operations.

Operation	Description
- (difference)	The difference between the date in the report and another specified date.
- (difference in days)	The number of days between the date in the report and another specified date.
- (difference in months)	The number of months between the date in the report and another specified date.
- (difference in years)	The number of years between the date in the report and another specified date.
Add days	Specify the number of days to add to a date.
Add months	Specify the number of months to add to a date.
Add years	Specify the number of years to add to a date.
Earliest	Determine the earliest date between the date in the report and another specified date.
Latest	Determine the latest date between the date in the report and another specified date.
Year	Extract the year value from a date.
Month (number)	Extract the month value from a date.
Week	Extract the week value from a date.
Day	Extract the day value from a date.
Hour	Extract the hour value from a date.

Operation	Description
Minute	Extract the minute value from a date.
Second	Extract the seconds value from a date.

Creating a calculation

- 1 On the report palette, click a column heading.
- 2 Optionally, select additional column headings by clicking them while holding down the Shift key.
- 3 Do one of the following:
 - From the Edit Data menu, click **Calculate**.
 - From the toolbar, click the **Calculate** () button.
 - Right-click a highlighted column heading, and select **Calculate**.
- 4 Complete the Calculate page:
 - a Select the operations.
 - b Select from other calculation parameters.
 - c Optionally, apply a new item name to the calculation.
- 5 To add the calculation to the ad hoc report, click **Insert**.

Note: When you select more than one column upon which to base a calculation, you can only select columns that contain the same type of data (numeric, string, date/time).

Dates with unknown date parts

If a date field allows unknown (UNK) values for a complete date, the InForm application stores the following date values:

- For a complete date:
 - A date/time column.
 - A date string column.
 - A month column.
 - A day column.
 - A year column.
- If there is at least one unknown value, the InForm application stores the date values in a date string column only.

Calculations on string elements

The Calculate page for string elements enables operations on text and alphanumeric values.

Operation	Description
First characters	Specify the number of left-most characters to display in the report column.
Last characters	Specify the number of right-most characters to display in the report column.
Concatenation	Specify how to join single or multiple report values together including: <ul style="list-style-type: none"> • Preceding text. • Following text. • Separator between report elements.
Remove trailing spaces	Delete the blank characters at the end (right) of a string value.

Calculations on numeric elements

The Calculate page for numeric elements allows arithmetic and other analysis operations.

Calculating business days versus number of days

The - (difference in days) operation determines the total number of days between the date value in the report element and another specified date.

To calculate the number of business days between two date values:

- 1 Create a - (difference in days) calculation.
- 2 From the original calculation, create a new calculation (product) that multiplies the difference calculation by .7142857142857 (this represents 5/7).
- 3 From the product calculation, create a new calculation that adds .5 to the product.
- 4 From the addition calculation, create a new calculation that rounds the result.
- 5 Delete the difference, product, and addition calculations from the report.

Crosstab reports

About crosstab reports

Crosstab reports show summary information in a two-dimensional grid. Using crosstab reports, you can display large amounts of tabular data.




A crosstab report must contain at least three reporting elements.

- A non-aggregate report element that provides distinct categories of values that become row labels.
- A non-aggregate report element that provides distinct categories of values that become column labels.
- A measure (aggregate) report element that provides numeric values upon which to produce summaries.

Crosstab development tools

Use Change Layout options to:

- Create a new crosstab report.
- Convert a list report to a crosstab report.
- Convert a crosstab report back to a list report.
- Switch the column and row headers in a crosstab report.

Option	Description
 Pivot	Converts a list report to a crosstab report.
 Ungroup	Reverts to a list report, showing all values in a column, including duplicates.
 Swap Rows and Columns	Interchanges rows and columns in a crosstab report, a chart based on a crosstab report, or both.

Charts

About charts

Charts show summary information graphically. Charts consist of at least two reporting elements:

- A non-aggregate report element that provides distinct categories of values.
- A measure (aggregate) report element that provides numeric values upon which to produce summaries.




Note: You can have up to two non-aggregate report elements and any number of measures in a chart.

For more information, see the Cognos documentation.

Chart development tools

Using Change Layout tools, you can:

- Create a new chart report.
- Convert a list report to a chart report.
- Convert a crosstab report to a chart report.
- Convert a chart report back to a list report.
- Switch the category values to change the focus of a chart.

Option	Description
Change layout menu or toolbar buttons	
 Chart	Converts a list or crosstab report to a chart report.
 Ungroup	Reverts to a list report, showing all values in a column including duplicates.

Note: You can use the Ungroup button only if you opted to display the table (crosstab report) along with the chart.

Custom groups

About custom groups

The Define Custom Groups selection in the Edit Data menu produces new report elements that contain groups of report values.

You can organize the data in a report using custom groups that create new report elements based on the values in a column. For example:

- Categorize a list of numeric results. For example, you can display the number of new, recent, and old queries.
- Divide the number of values into smaller sets. For example, you can organize a list of sites by region.

Study management report elements

Every InForm study includes the Trial Management data model. Because the Trial Management data model is standard in all InForm studies, you can create reports from this data model and reuse them in other studies. The data model contains:

- Report elements that provide study metrics.
- Predefined filters that allow you to limit the data in a report.

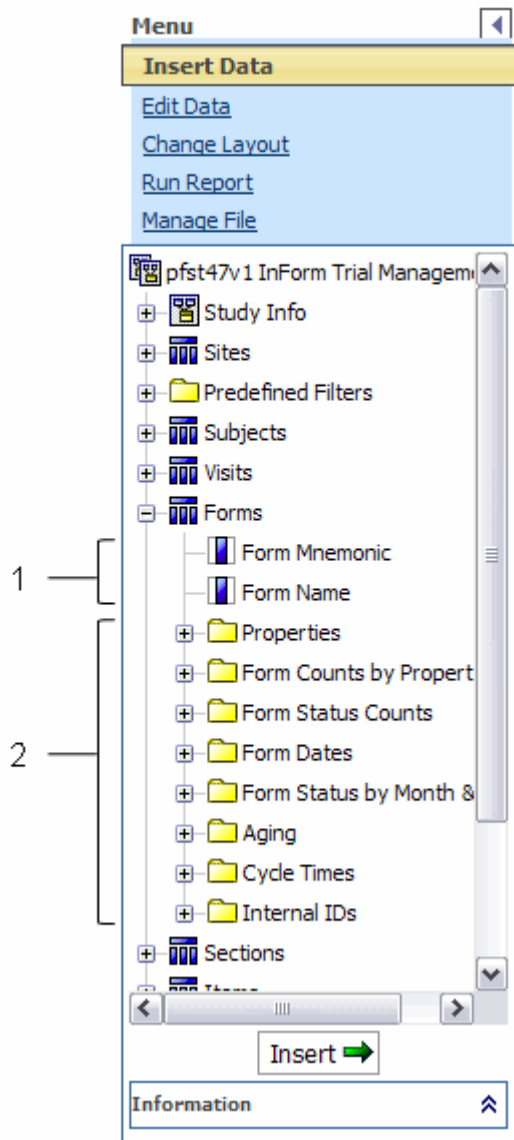
Study management data includes the following topics or report elements:

Report elements	Description
Study info	Provide information about the study, the study sponsor, and study version in your reports. Note: If an optional item is left blank in the InForm application, data does not appear in reports that contain the report element for that item.
Sites	Provide identifying and descriptive data for all sites in a given study.
Subjects	Provide metrics and status information about subjects during the course of the study. The elements and measures in this report topic return study management data. You can use these elements and measures to access such data as current status, status dates, and counts.
Visits	Allow you to create reports on visit properties, status, and dates. All visit types are included in general visit counts for ad hoc reports. To limit your reports to clinical visit counts only, use a predefined filter.
Forms	Provide metrics and status information about forms in your study. Use this report topic to include: <ul style="list-style-type: none"> • Counts of different form types. • Information about form properties and states. • Information on when forms were initially created and changed.
Sections	Allow you to report on form sections in a study design.
Items	Provide metrics and status information about items on forms in the study. Use this report topic to include counts of different item types, information about item properties, and information on when items were initially created and changed.
Rules	Provide information about rule types and the number of times rules have been triggered.
Queries	Display query text and type, to gather counts on manual and automatic queries, and to see query status.
Comments	Allow you to report on both item-level and form-level comments.

Report elements	Description
User Info	Allow you to gather information on your InForm users.
	Note: If an optional item is left blank in the InForm application, data does not appear in reports that contain the report element for that item.

InForm Trial Management reporting tree

The study management portion of the Ad Hoc Reporting tree contains report topics and elements related to non-clinical data such as subject numbers, visit and form mnemonics, query text, itemset indexes, comments, and so on.



- **1**—Study management report elements used to organize data, and indicate where in the study the data comes from. For example, use the Form Name property to develop a report that displays the number of queries that exist on each form in the study.
- **2**—Study management data that is used to track study progress. For example, use the report elements in the Form Status Counts folder to determine the number of forms in the Completed state for your study.

Element descriptions

The description of each element in this document might include the following:

- **Data displayed**—The type of data that is returned in the report. Possible values are:
 - Numeric
 - String (text)
 - Date/Time
 - Y/N
- **Description**—A brief description of the element.
- **How calculated**—Information about how data is calculated. (Included only for counts.)
- **Data source**—A description of where the data came from.

Subjects: Subject Status Counts

The Subjects: Subject Status Counts folder contains reporting elements that calculate subject counts that are based on subject state. The listed subject states are internal to the InForm application. Whether these states correlate to actual clinical states depends on your use of InForm features.

A subject can be in only one state at a time in the InForm application. Therefore, if a subject is randomized after being enrolled in the InForm application, the current state for the subject is Randomized, not Enrolled.

However, when you create reports on subjects who are still actively participating in the study, you will likely need to see totals that reflect the number of subjects who have ever been enrolled in the study. For example, a count of enrolled subjects should include all subjects who have ever been enrolled in the InForm application, even if their status changed to Randomized, because in clinical terms, a subject who has been randomized is still considered enrolled. Therefore, these subject status counts return totals of subjects who have ever had these states:

- Screened
- Enrolled
- Enrolled Override
- Randomized

To report on subjects who are no longer active in the study, use the Screened Failed, Enrolled Failed, Dropped Out, and Complete subject status counts. Unlike the other subject status counts, these report elements return totals of those subjects currently in any of these states. Subjects will have Dropped Out and Complete status only if your study uses the Study Completion form.

Note: The status assigned to a subject depends on the InForm features you use to set the status. For instance, for a subject to have a randomized state, you must perform subject randomization through the InForm application. For more information, see *Subject status requirements* (on page 20).

Unless otherwise noted, all of the calculations and dates that the elements in the Forms report topic return are based on expected form counts.

A form is counted as expected if it meets any of the following criteria:

- It appears within a scheduled visit (regardless of whether the form is started).
- It appears within a started unscheduled visit.
- It is a dynamic form that has been activated.

Note: Non-started common forms are not counted as expected.

Expected forms are counted for subjects in the following states:

- Enrolled
- Randomized
- Complete
- Dropped-out

Note: For subjects that have completed or dropped-out (as indicated by the Study Completion form), only forms in started visits or dynamic started forms are counted.

The expected forms calculation assumes the following:

Only CRFs are counted. Other special CRFs (such as screening and enrollment) are not included.

- **Alternate forms**—One form in each visit is counted.
- **Common forms**—A common form is counted only once for the study, regardless of the number of visits in which it occurs.
 - For enrolled or randomized subjects, common forms are considered expected.

You can use the Ad Hoc Reporting workspace to create reports that contain:

- **Study management data.**

The study management portion of the Ad Hoc Reporting tree allows you to create reports on the progress of your study.

- **Clinical data.**

The clinical portion of the Ad Hoc Reporting tree allows you to create reports that display entered values from the clinical forms in your study.

Reporting on clinical data

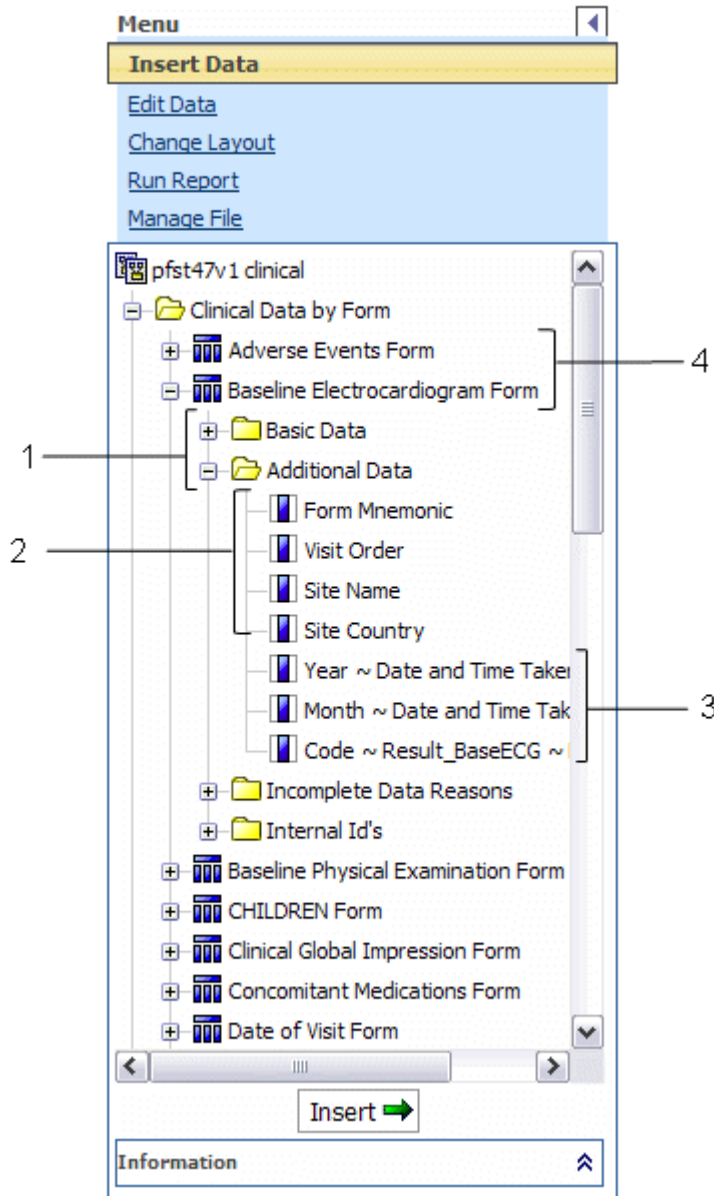
When you create reports using clinical data, keep in mind:

- Clinical data availability and organization are unique to each study; for this reason, reports that contain clinical data may not be validated to use across studies.
- Data that is entered on clinical forms can be changed several times during the course of a study. Although the InForm application captures audit trail data and stores it in the Reporting and Analysis database, the available clinical data elements in the Ad Hoc Reporting tree return only the most current values and revisions for any controls in clinical forms.
- A study is likely to go through many study versions. For example, forms and items might be added to or deleted from the original study design. The Clinical Data by Form folder contains data elements for every form and item that have ever been used in any version of the study.
- Your site associations and the display override settings on items determine the way reporting elements appear to you in the Ad Hoc Reporting workspace. For example, if an item is not visible to you in the InForm application, when you create a report that contains the item, the cells in the row that corresponds to the item contain the text **N/A**.
- When creating reports using clinical data, you must include a unique identifier for the study component on which to report. For example, to create a clinical report about a particular subject, you must use whatever identifiers uniquely identify the subject in your study. Depending on your study design, you may use:
 - Subject Number, if unique Subject Numbers are assigned for your study.
 - Subject Number and Subject Initials, if unique Subject Numbers are not assigned for your study.
 - SubjectID.
- When the same form is used in multiple visits, if a subject does not have any instances of the form, the resulting report may display extra rows that contain incomplete information. For more information, see *Reporting on multi-instance forms and visits* (on page 159).

Clinical reporting tree

The clinical portion of the Ad Hoc Reporting tree is built from the structure of the Reporting and Analysis database; report topics and elements are included for each form and control stored in the Reporting and Analysis database. The database structure is dependent on the study design.

The clinical portion of the Ad Hoc Reporting tree resides in the Clinical Data by Form and Clinical Data by Associated Form folders. The following image illustrates the structure of the Clinical Data by Form folder. The Clinical Data by Associated Form folder includes the same data that is in the Clinical Data by Form folder for each form that is part of an association.



- **1**—(Points to the Basic Data and Additional Data folders for a clinical form.) The **report element folders** consist of clinical reporting elements.
- **2**—(Points to the study management report elements in the Additional Data folder.) To create reports with clinical data, include **study management report elements** that identify the study component (subject, visit, and so forth) on which you want to report. The Clinical Data by Form folder contains some report elements from the Trial Management package; you can use these elements to identify visit, subject, and site in your clinical reports, and to identify unique instances of repeating visits, forms, or itemsets.
- **3**—(Points to report topics for clinical forms.) **Clinical report topics** reflect the item questions that appear on the forms within your study. Labels for reporting elements may or may not have been customized for display in the Ad Hoc Reporting tree.
- **4**—(Points to the clinical form report topics in the Clinical Data by Form folder.) Each **clinical form report topic** corresponds to a form or an itemset within your study.

Clinical reporting elements

Each report topic includes the following sub-folders.

Clinical reporting element	Description
Basic Data	<p>The Basic Data folder provides easy access to frequently run reports. You can select the entire folder to create a basic report for a given form that includes easy-to-read, meaningful data and appropriate key elements to ensure report accuracy.</p> <p>The Basic Data folder contains:</p> <ul style="list-style-type: none"> • Clinical report elements that return clinical values that are associated with the form. • Text values of items rather than database codes, as well as most of the available date formats. • Several reporting elements you can use to identify site, subject, and visit. These elements also appear in the InForm Trial Management portion of the Ad Hoc Reporting tree.
Additional Data	Contains report elements that you can use for more advanced reports. Some of the included elements return database codes rather than text values for fields, normalized values, and unit codes.
Incomplete Data Reason	Contains reporting elements that return text explanations for incomplete items.
Internal IDs	Contains reporting elements that return values that uniquely identify a record in the database.

Note: When the study-specific clinical package is originally generated, the labels of each reporting element match the labels in the study design. Report topics are placed within default folders (Basic Data, Additional Data, Incomplete Data Reason, and Internal IDs).

Labels and folder locations for elements can be customized. This guide describes label naming conventions and element folder locations. Your clinical data model labels and folders may vary.

Creating reports with both clinical and study management data

If you create reports that use elements from both the clinical portion and the study management portion of the Ad Hoc Reporting tree, keep the following restrictions in mind:

- You can include data from only one clinical form in any report that combines both clinical and study management data.
- Do not use elements from the following study management report topics in reports that also contain clinical elements:
 - Sections
 - Items
 - Rules
 - Queries
 - Comments

Report results will be difficult to interpret if you include these report elements.

- For best results, include only one element from the study-specific clinical data model with no more than two elements from the Trial Management data model for each report that includes both clinical and study management data.

Note: This suggestion does not apply to DOV elements.

Clinical data in the Ad Hoc Reporting tree

Default labeling

Default labels for clinical report elements come from properties that are established in the study design code. Study designers specify different pieces of information to identify each form, itemset, or control in your study. The InForm application retrieves the text in these properties and uses it for default labeling of the clinical report elements.

The InForm application creates default labels for elements that appear in the Clinical Data by Forms folder as follows:

Note: Study designers should make sure that Itemset Column Header definitions (values of the Central Designer Short Question property on items in a repeating section) are unique within a study. If there are duplicate Itemset Column Header values in a study, the Reporting and Analysis module appends each value with a suffix to uniquely identify it. For example, if two itemsets share the Itemset Column Header **VSItemset**, the Reporting and Analysis module identifies them as **VSItemset** and **VSItemset~1**.

Clinical report elements: forms and itemsets

When the clinical portion of the Reporting and Analysis database is generated, database views are created for each form and itemset in your study. When the InForm application generates the study-specific clinical reporting package, each of these database views is represented as a report element.

Each report element that appears in the Clinical Data by Form folder corresponds to either a form, or an itemset on a form.

Note: Alternate forms are also represented by a report element.

Report elements are labeled with an appropriate suffix (Form or Itemset). In addition, the labels for itemset report topics begin with a prefix that identifies the form on which they appear.

Code report elements

Some clinical data is represented both by a text value and a code in the Reporting and Analysis database. The InForm application saves a unique, audited data record for the data (code) and a more readable display (text value) that can be adjusted if necessary. For example, a *Yes* answer to a question on a form is stored both as Yes and as 1 in the database.

Clinical report elements that appear in the Ad Hoc Reporting tree allow you to include either (or both) the text answer to a question or the code values in your reports. Text values are more readable in a report and are therefore included in the Basic Data folder for easy access. By default, the labels for report elements that return code values begin with the prefix **Code~** and appear in the Additional Data folder for any form in the Ad Hoc Reporting tree.

Data that require units of measure

Some answers to form questions are qualified by a unit of measurement. For example, the weight of a subject may be measured in kilograms or pounds.

For each question that requires a unit of measure qualifier, the following report elements appear in the Ad Hoc Reporting tree:

- Entered value.
- Unit of measure.
- Normalized value.

Itemsets, repeating visits, and repeating forms

Itemsets and repeating forms may capture data multiple times for a given subject. Forms may also appear in repeating visits. You can report on data that was collected at different iterations of itemsets, repeating forms, and repeating visits using index elements from the Ad Hoc Reporting tree to

identify specific itemset, form, and visit instances.

Note: The Internal IDs folders also contain the following report elements: Form Index, Itemset Index, and Visit Index. While these elements also identify specific instances of repeating forms, visits, or items, they return the actual database value that is assigned to these instances.

- **Form index**—The report topic for any repeating form contains a Form Index report element. Use this element to separate data from each instance of the repeating form.
- **Itemset index**—The report topic for any form with an itemset contains an Itemset Index report element. Use this element to separate data from each instance of the itemset.
- **Visit index**—The report topic for any form or itemset that appears within a repeating (unscheduled) visit contains a Visit Index report element. Use this element to identify the visit instance in which data was gathered.

Deleted itemset and form instances

InForm users can mark both Add Entry itemset instances and instances of repeating forms for deletion. (By marking a form or itemset for deletion, the InForm application removes the form or itemset from the case report book, but keeps a record of the form or itemset in the database.) The Ad Hoc Reporting tree allows you to report on itemset and form instances that have been marked for deletion.

The report topic for any itemset or repeating form instance contains an element, **IsDeleted**, which returns data on whether the form or itemset was deleted in the InForm application. When you create reports on forms and itemsets, you may want to include these report elements to identify instances that have been marked for deletion, and add a filter to show information for forms or itemsets.

Note: You cannot delete or undelete a Repeating Data itemset.

Date controls

Date controls in your study are represented in different ways in the Ad Hoc Reporting tree. Some dates are stored as numeric values, and others are string values. For example, for a start date for an adverse event, the date control could appear as Date ~ Start Date, Month Yr ~ Start Date, and so forth, depending on your study design. This format determines the data that appears in ad hoc reports.

In addition, the format for dates in the Reporting and Analysis module is determined by Cognos settings, and locale settings for your InForm study.

Incomplete Data Reasons

Each clinical report topic contains an Incomplete Data Reasons folder. Report elements that appear in the folder return a textual value with the reason why an item question is marked Incomplete or, for a Repeating Data itemset, the reason why an item is Blank.

Reporting on multi-instance forms and visits

About multi-instance forms and visits

Your study may include any number of multi-instance forms or items, including:

- Repeating forms.
- Non-repeating forms that occur within repeating visits.
- Itemsets.

When you create ad hoc reports, you can include data from more than one of these multi-instance forms, items, or visits on the same report.

A report can accurately provide data on the adverse events and concomitant medications for a subject. For example, it can accurately illustrate the relationships between:

- The subject and each adverse event.
- The subject and each medication.
- The adverse event and its associated concomitant medication.

Note: When the same form is used in multiple visits, if a subject does not have any instances of the form, the resulting report may display extra rows that contain incomplete information.

Filtering reports with more than one multi-instance form or itemset

You can apply filters to reports that contain data from more than one multi-instance form. However, results will vary depending on where you apply the filter. The following table describes how reporting behavior differs, depending on the filtered element.

Reporting on forms with itemsets

For forms that contain a non-repeating section and an itemset, an association exists between the itemset and non-repeating section. You can create ad hoc reports to show the relationship between the data in a non-repeating section and its associated itemsets. The report output contains columns with data from the non-repeating section, and columns with data from each itemset.

For example, if an itemset exists on the Vital Signs form and the Demographics form, the itemset is associated with the non-repeating sections on each form.

- You can only create reports with data from a non-repeating section and itemsets that exist on the same form, and are therefore associated.
- You can create reports with data from a non-repeating section and itemsets that exist on non-repeating or repeating forms.
- For reports that contain a non-repeating section and multiple itemsets, there is no relationship between the itemsets.
- During study versioning:
 - If a non-repeating section with an associated itemset is deleted, the association between the non-repeating section and the itemset remains for subjects with data in the non-repeating section. You can still generate reports using the existing data from the deleted section for those subjects. For subjects that do not have data in the non-repeating section, the columns in the report do not contain data.
 - If an itemset with an associated non-repeating section is deleted, the association between the itemset and the non-repeating section remains for subjects with data in the itemset. You can still generate reports using the existing data from the deleted itemset for those subjects. For subjects that do not have data in the itemset, the columns in the report do not contain data.
 - An association is created between a non-repeating section and an itemset when:

- A non-repeating section is added to a form that contains an itemset.
- An itemset is added to a form that contains a non-repeating section.

Example 1: One non-repeating section and one itemset

This example shows the report output for subjects AAA and AAB. In this example, the non-repeating section appears on a repeating form. Therefore, more than one instance of the non-repeating section exists in the study.

For subjects AAA and AAB, the itemset data is associated with the data in the non-repeating section, and the data in the non-repeating section is associated with the data on the SI form. Therefore, in this instance, the itemset data is associated with the data on the SI form for subjects AAA and AAB. Because data is not entered in the non-repeating section for subject AAC, the data that exists for subject AAC on the SI form is not associated with the itemset data, and therefore does not appear in the report, even if data for subject AAC exists on the SI form.

Because data in the non-repeating section is complete for subject BBA, the data for all five itemset instances appears in three rows in the report output. The data for the two instances of Itemset 1 and the first two instances of Itemset 2 appears in the first two rows, and the data for the additional instance of Itemset 2 appears in the third row.

2—For subject AQW, at least one of the three items that appear in the non-repeating section for the report is incomplete.

3—For subject AQW, data for five itemset instances appears for two itemsets. Three instances of Itemset 1 exist, and two instances of Itemset 2 exist.

Because the data from the non-repeating section that appears in the report is incomplete for subject AQW, the data for all five itemset instances appears in five rows in the report output, with each row corresponding to an itemset instance. The data for the three instances of Itemset 1 appears in the first three rows, and the data for the two instances of Itemset 2 appears in the last two rows.

Note: If a non-repeating section contains incomplete data items, but the incomplete items are not included in the report, the report does not have a row for each instance of each itemset.

Reporting on associated forms

You can create an ad hoc report to show the relationship between data in two associated forms.

- The associated forms must be repeating.
- The forms must be marked as associated in the study design application (either the InForm Architect application or the Central Designer application).
- The report must only contain data from two associated forms.
- If the report topics in the report are not from associated forms, data does not display.
- If the report contains data from more than two associated forms, data does not display.

Use the report data in the Clinical Data by Associated Form package to create ad hoc reports with associated form data.

Note: You cannot create an ad hoc report that contains data from both the Clinical Data by Form report element and the Clinical Data by Associated Form package.

Example: Adverse Events and Concomitant Medications association

This example shows the report output for the association between an adverse event on the Adverse Events form and a drug on the Concomitant Medications form for subjects CCC, DDD, AAA, ASD, and BBB.

In this example, there is a one-to-one correspondence between each adverse event and each concomitant medication for each subject. If, for example, subject CCC reported two adverse events associated with Drug1, an additional row for subject CCC would exist with Event2 data in the Event column, and Drug1 data in the Drug name column.

Standard reports

The InForm application includes a set of management reports that provide information about the progress of a study. These reports contain several categories of information, and several views of each report are available. For example, you can display the query status reports by site and by user; month by month or study-to-date; and in text or graphical formats. Standard reports are created using the Report Studio application and are validated and optimized for the InForm application.

There are five categories of standard reports:

- Query reports provide information about query aging, status, and cycle time.
- Case Report Form (CRF) reports provide information about the progress of data entry and query activity on started case books.
- Item reports provide information about the progress of item source verification, as well as listings of items on forms.
- Subject reports provide information on the progress of case book completion for individual subjects. These reports also provide subject enrollment and dropout counts, as well as subject enrollment status.
- Audit trail reports provide auditing and operational information such as audit trail information and log in history.

Note: For reports that contain a large amount of data, Oracle recommends that you save the report and open it from your local machine.

Running a standard report in a new window

- Right-click the link for any report to launch a new browser window in which to display the report.

Saving a standard report definition

When you save a report, the Reporting and Analysis module saves the report definition. A report definition includes the report elements and report topics that exist in the report you created, but does not include the report data. Each time you run a saved report, the Reporting and Analysis module creates a report with the report elements and report topics that exist in the report, and displays the most current data that exists in the Reporting and Analysis database.

- 1 Run the report.
- 2 Select **Keep this version > Save Report**.

The Reporting and Analysis module saves the report definition to the location from which you ran the report.

Saving a standard report as a report view

To save a report definition and the report data at the time when you ran the report, save the report as a report view. A report view allows you to save report data at specific times during the course of a study so that you can track study progress.

Note: To avoid overwriting report data, and to prevent confusion, save reports and report views with different names.

- 1 Run the report.
- 2 Select **Keep this version > Save as Report View**.

The **Save as report view** dialog box appears.

- 3 In the **Name** field, specify a name for the report view.
- 4 In the Location field, specify a location. By default, the home folder is specified.
 - To save the report view to a specific location:
 - 1 Click **Select another location**.
The Select a location (Navigate) dialog box appears.
 - 2 Specify the folder in which to save the report view.
 - 3 Click **OK**.
 - To save the report view to the My Folders page, click **Select My Folders**.

Opening a standard report in the Report Studio application

If you have access to the Report Studio application, you can open a standard report in the Report Studio application from the main Reporting and Analysis portal page. You can then use the Report Studio application to add advanced functionality to the report.

- For the report, click the **Open with Report Studio** icon ()

Components of a standard report

Report prompt page

On the report prompt page, you select criteria and choose sort options for your report. Prompt pages have three sections:

- Selection Criteria.
- Sort Options.
- Buttons (Run Report, More options, Cancel).

Selection Criteria section

In the Selection Criteria section of the prompt page, you can narrow the criteria for your report. This section might contain:

- Cascading prompts
- Checkboxes
- Drop-down lists
- Text boxes
- Calendars
- List boxes

Depending on the report, you can select one or more items to limit the report to your selections.

You can choose not to make any selections, which means no criteria are applied for a particular prompt to limit the reported data. Not making a selection often causes a report to run faster than selecting all values in the prompt list.

Cascading prompts

Cascading prompts allow you to select criteria in one category to narrow the selections that are offered in another category.

In the following example, the **Countries** and **Sites** list boxes are cascading prompts. You can select one or more countries from the **Countries** list, and click **Update** to see only sites for selected countries in the **Sites** list.

Note: If you change a selection in one prompt, be sure to click **Update** to update all cascading prompts.

Checkboxes

Checkboxes allow you to select one or more options for narrowing report criteria.

Sort Options section

In the Sort Options section of the prompt page, you can choose the columns on which to sort a report.

Drop-down lists appear at the bottom of each report prompt page. Default sorting selections are automatically selected. You can change these to create your own report definition.

Each sort drop-down list includes **Ascending** and **Descending** radio buttons. Ascending sorts are automatically selected by default. Use the radio buttons to change the sort type.

Reports that include groupings, such as organization by user or by site, are sorted at the detail level within the grouping, according to the selections made in the drop-down lists. The grouping sort order can be modified (ascending or descending) but will always take precedence over other sorting settings.

Buttons

The bottom-left corner of each prompt page contains buttons you can use to:

- Run the report.
- See more options (if available).
- Cancel the report.

Note: Some reports require you to make a selection before you can run the report. In this case, the Run Report button is grayed out, and red dashes indicate the field in which you must make a selection.

Summary page

The summary page for a report displays the selections you made on the report prompt page. This information is in report printouts to tell readers what criteria were used.

Report/Graph page

The Report/Graph page contains:

- Show/hide report selections.
- Graphs and columns.
- Report header and footer.

Show/hide report selections

A **Show/Hide Selections** link appears for all reports. Click this link to show or hide a list of the chosen selections on the prompt page, or to change the sort selections for the report.

Graphs and columns

Metrics or performance standard reports include graphs that represent the report results. When a graph is included in a report, it appears on the first page. Use the **Page Down** link to move down to

the report columns.

Report columns display data that is returned when the report is run. Some columns include totals and subtotals.

Report header and footer

The report header displays the report title and study name. The header can also display a logo.

The report footer contains the following data.

Footer label	Description
Run at	Date and time the report was run.
Page	Page number, centered in the footer. <ul style="list-style-type: none">• In HTML reports, only the page number appears.• In PDF reports, the page number and total page count appear.
Data as of	Date and time that data was last replicated to the Reporting and Analysis database.

Data in standard reports

Standard reports show data only for clinical visits and clinical form types.

- **Subtotals and totals**—Standard reports display subtotals and totals for numeric columns, unless the column displays a median value. For reports that include median calculations, subtotals and totals are blank.
 - CRA-oriented reports that have grand totals calculate those totals based on unique sites and count only unique data when a site is associated with more than one CRA. In these cases, the total on the report is clearly labeled, and the Prompt Page for that report warns you that site information is duplicated across CRAs sharing the same sites.
 - Minimum (Min), maximum (Max), and average values for subtotals and totals are calculated by taking the Min, Max, and Average of the sites.
- **Percentages**—When percentages are shown in a report, either the column head or a special footnote identifies what the number is a percentage of.

When percentages are shown in the same column as counts, sorting on that column is based on the percentage value and not the count value.

- **by User reports**—The *by User* reports in the Reporting and Analysis module are designed to provide information on the performance of primary monitors for your study. The reports provide performance statistics about all roles within a study. For sites with more than one person in a given role, you will see the same data multiple times, one row for each person. You can limit this by selecting specific individual users, such as primary CRAs, or establishing special rights groups that prohibit duplication by site.

To get the most out of the *by User* reports, follow these guidelines. When you can easily identify key rights groups and users, the *by User* reports will be manageable and will yield reliable results.

- Understand the rights group organization for your study, and know how primary monitors fit into this organization. All primary monitors can be assigned to a single rights group, or they can be scattered among several rights groups. To target only primary monitors and avoid producing unwieldy reports, you must know which rights group to select.
- Know how to identify your primary monitors. This information is especially important if your organization has not designated a single rights group for all primary monitors.
- **UUIDs**—Studies created using the Central Designer application automatically specify the Universal Unique Identifiers (UUIDs) that are required to populate columns in certain reports.
 - In this guide, the UUIDs are listed in the report descriptions where applicable.
 - If a column in a standard report does not contain any values, it is most likely the result of the InForm special fields not being specified when the study was created in the Central Designer application.

Report folders

All of the InForm standard reports appear on the Public Folders tab of the Reporting and Analysis portal.

Standard reports are organized into five folders. Click each folder name to access a complete list of standard reports for the chosen category.

- CRF Reports
- Item Reports
- Query Reports
- Subject Reports
- Audit Trail Reports

Note: You can display either a list view or a detail view of the standard reports folders.

Report actions

Each standard report folder lists Action icons. In the list view, these icons appear under the label **Actions**. In the details view, these icons appear under the report name and last run time information. Click **More** in either view to see a complete list of report actions.
