Order of installations

The installation is to be done in the following stages -

1. Installation of Database
2. Bootstrap Installation
3. Installation of the Host
4. Installation of the Branch.
5. Setting up Multi Branch Registries

Installation of Database

The installation of the Database is elucidated in the document - Oracle FLEXCUBE-Core 5.2.0.0.0-RCU_Installation_Guide. By following this document, one will be able to successfully install the database with initial required data and proceed to the installation of the FLEXCUBE-CORE Host.

Bootstrap Installation

This enables to install system and product related data with Chinese localization so that one can perform banking operations after installation. Please refer the doc - Oracle FLEXCUBE Common Setup & Extract User Guide_v1.2.doc

Note : If we are using Bootstrap, please make sure you are setting the below values correctly in RCU installer , Host Installer and Branch Installer :

- **Branch Code – 9999**
- **Currency Code – 156**
- **Bank Code – 1**
- **Bank IC Code -- 1**

Installation of the Host

The installation of the Host on a Linux machine is explained in the document - Oracle FLEXCUBE-CORE 5.2.0.0.0-Installation_Guide_Host. By following this document, one will be able to install the FLEXCUBE-CORE Host and proceed to the installation of the FLEXCUBE-CORE Branch.

Installation of the Branch

The installation of FLEXCUBE-CORE branch is to be done on a windows machine and this is explained in the document - Oracle FLEXCUBE-CORE 5.2.0.0.0-Installation_Guide_branch(winServer). Using this document we can install the FLEXCUBE-CORE Branch on the to a windows machine.

Setting up Multi Branch Registry
