# **2** Features and Updates

## **Reporting and Analytics**

#### Organization-Specific ExactTarget Settings (8.4.4.12)

System administrators can now configure ExactTarget WSDL and FTP settings for their organization.

- 1. In Reporting and Analytics, click **iCare**, click **iCare GPL**, click **Organization Configuration**, and then click the **ExactTarget** tab.
- 2. Select **Enable ExactTarget Campaigning**, and then enter the **ExactTarget WSDL URL**, and the **ExactTarget FTP** information.

## **Inventory Management**

### Poland Fiscal Inventory Export (8.4.4.7)

You can now configure and run the **Fiscal Export – Poland** job to create fiscal inventory data outputs for legal compliance. The *Oracle Hospitality Inventory Management Poland Fiscal Inventory Export User Guide* contains configuration instructions and references for the exported data.

# 3 Installing the Patch

## **Reporting and Analytics**

- 1. Download the file install\_Patch\_8.4.x.x.exe to a local drive on the environment that is being upgraded.
- 2. Run install\_Patch\_8.4.x.x.exe.
- 3. The patch installer detects and adds all Oracle Hospitality Reporting and Analytics modules with a registered service to the install set.
- 4. Select **Yes** to run it and enter to appropriate database connection information to run the database update. You do not need to run the update more than once.
- 5. Select a backup folder to save the current builds.
- 6. The patch installer backs up each module in the install set, and then installs the new builds.
- 7. If any errors were reported, review the patchInstaller.log located in the C:\temp folder.
- 8. From the Windows Services Manager, start the associated services for each installed Oracle Hospitality Reporting and Analytics module.
- 9. Review the logs for each individual module to ensure there are no errors.
- 10. Review the versionInfo.txt file in the install directory to verify that the patch was properly installed.
