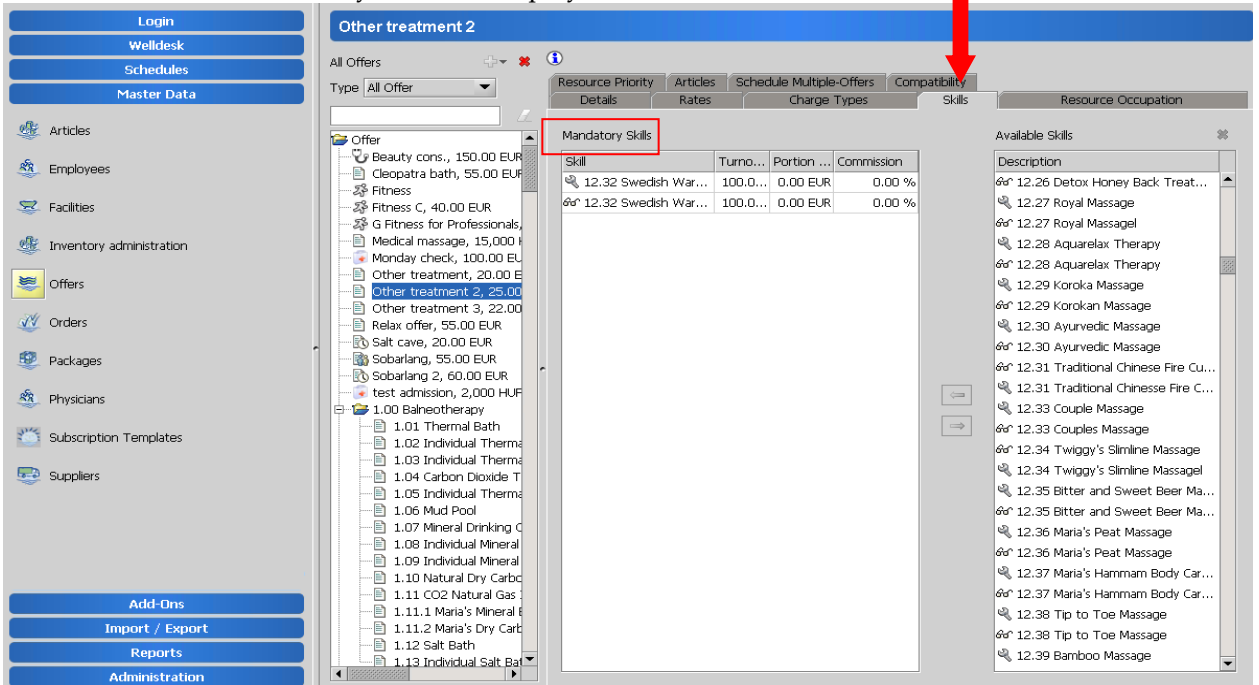

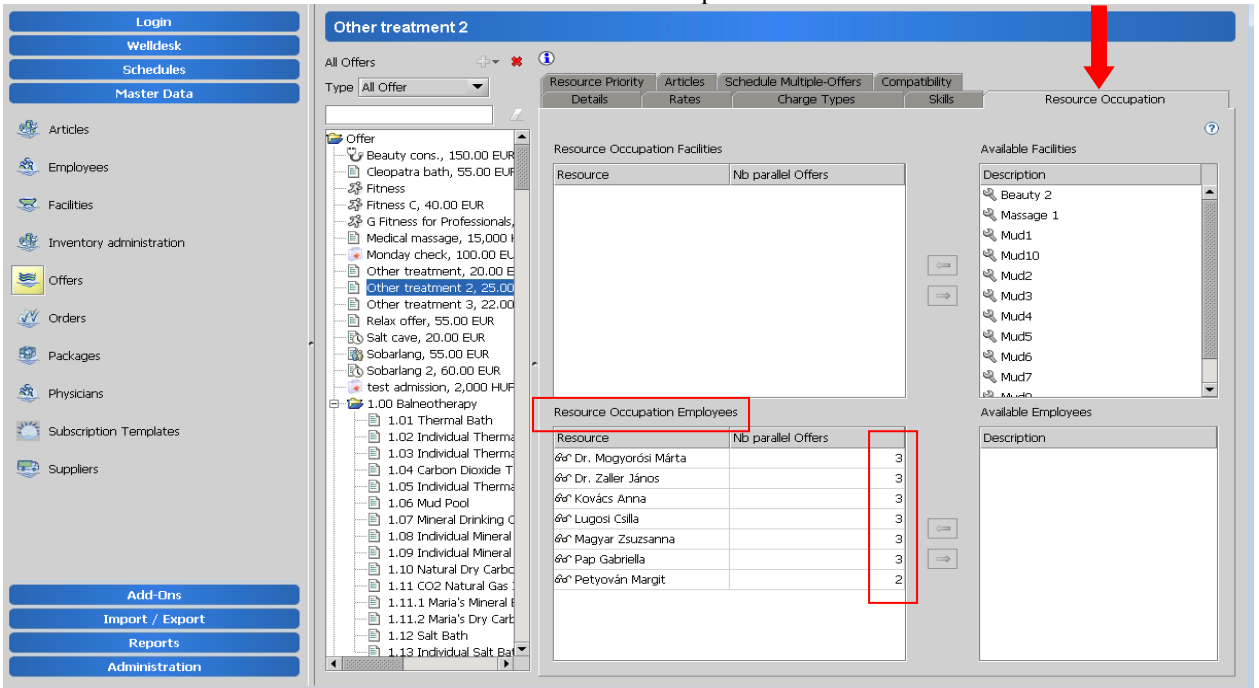

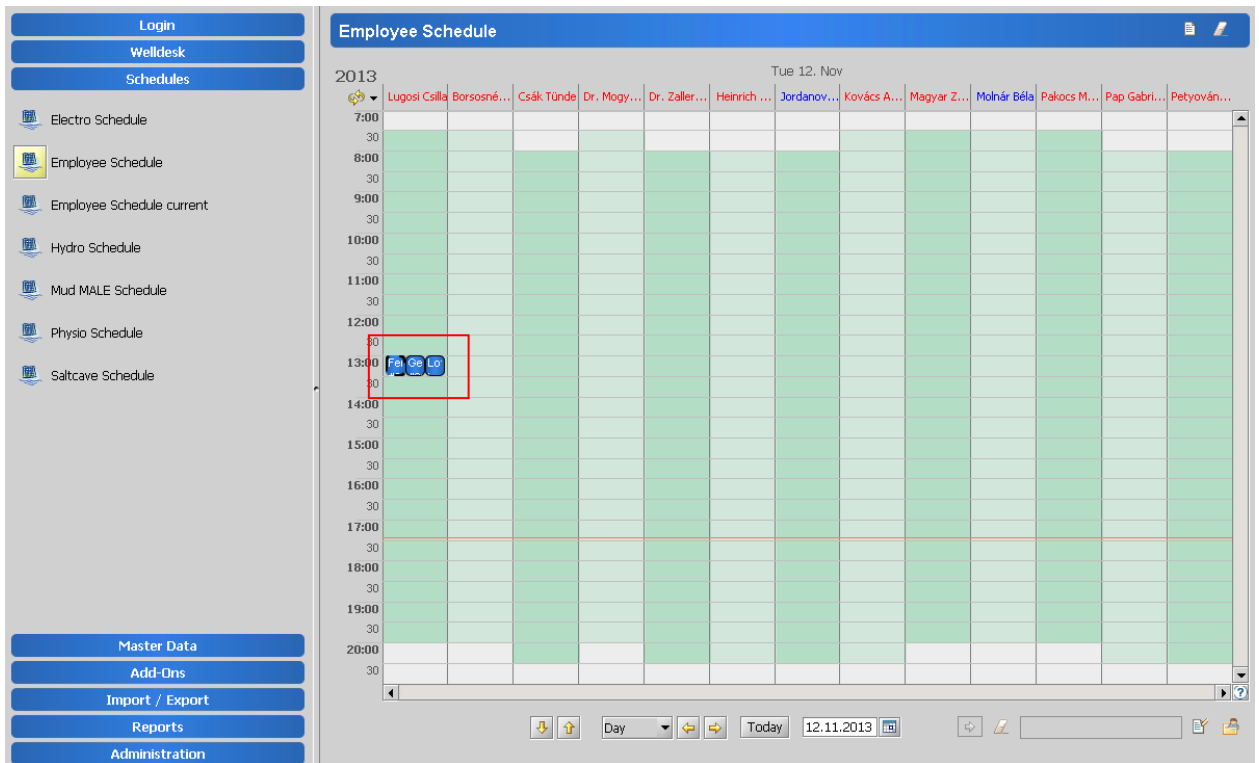
In Master Data/ Offers create a new Offer or use an existing one.
 On Skills tab add the necessary Skills for Employees and Facilities.



On resource occupation tab/ Resource occupation Employees/ add those employees who are able to do the treatment at the same time and set the number of parallel offers.



On Employee schedule you can start creating bookings with same offers for the same time for one Employee.



It is possible to enlarge the column or zoom on that period by pressing the cursor continuously and create a square around the booking.
