1 Features and Updates

New Features

- **HBV 4357: System Parameter for keep guest behavior**
The parameter `ch.corix.w4y.ui.guest.GuestPanelUI.SearchDialog.setSelectedGuestAfterSearch` can be used in order to control the behavior. This is to keep / not to keep the guest not automatically after guest search.
- **HBV 4365: No Advertisement flag in guest details should be enabled / disabled by default**
No Advertisement flag in guest details should be enabled / disabled by default. Use parameter: `ch.corix.w4y.bo.Guest.DontWishAds =[true | false]`
- **HBV 4371: Crontab Log Entries should be retrieved only for the last two days**
This is now limited to the latest number of rows. Thus the log is still maintained and visible. The log views are replaceable by the installer (replace view `CRT_CrontabRun_Limit2Rows`).
- **HBV 4403: Optional warning: Booking marked "Can't checkout because guest already checked out"**
Optional warning: Booking marked "Can't checkout because guest already checked out"

3 Installation and Upgrade

To install, download the patch from the My Oracle Support site as follows:

1. Login to My Oracle Support at the following URL: <https://support.oracle.com>
2. Click the **Patches & Updates** tab.
3. On the **Search** tab, select **Product or Family (Advanced)**.
4. In the **Product** field, enter MICROS BellaVita.
5. In the **Release** field, select **MICROS BellaVita 2.7.2.2**.
6. Click **Search**.
7. On the Search Results page, select patch number **23747818** with the description “Therapy can't be assigned to Employee”.

4 Resolved Issues

The following issues were resolved in this release:

- **HBV 4292 Bug: Batch batch.document.basetype.setter fails.**
Batch batch.document.basetype.setter fails. Invalid document number are skipped with this fix.
- **HBV 4359: Price calculation problem for offer in package**
The price for an offer in a reserved package is now posted as the price for a master data offer in.package and not as the master data offer price.
- **HBV 4362 Multiple Offer: Booking can't be added to the multioffer occurrence**
Multiple Offer: Booking can't be added to the periodic multioffer occurrence. If the multioffer is booked via the schedule in OccurrenceDialog, then no more bookings can be added.
- **HBV 4366: Removing offer in package now adapts price according to offer in package attribute "price reduction, if removed"**
Up to now, system parameter
ch.corix.w4y.bo.packages.PackageLink.adaptPriceWhenReplaced could prevent price adaptation.
- **HBV 4347: Guest gender is now transferred from Suite8 into BellaVita/Leisure.**
Guest gender is now transferred from Suite8 into BellaVita/Leisure.
- **HBV 4355: Calendar in Schedule is hidden partly when Screen resolution 1280 x 1024**
Calendar in Schedule is hidden partly when Screen resolution 1280 x 1024
- **HBV 4356: Closing button is always active**
Closing button is always active (if the user has the permission) because the day closure can be executed still after all cash sessions are closed. This is highlighted by a tooltip.
- **HBV 4360: PM / room number is not printed on invoice and cashier close report anymore**
This is due to different room number per document. If more than one exists, then the first in the list is returned; otherwise, the single room number is used.
- **HBV 4363: Offer creation under Polish Fiscalization again possible.**
This problem was caused by the introduction of ad-hoc packages.
- **HBV 3776: Polish Fiscalization cannot handle Oracle failover database connection**
Polish Fiscalization cannot handle Oracle failover database connection. Bellavita knows now to handle also: {{db.override.enable = true}} {{db.override.url = jdbc:oracle:thin:@(DESCR
- **HBV 4370: Transaction cleanup upon start may fail for Leisure**
Transaction cleanup upon start may fail for Leisure. This is due departmentcode is implemented as a view since 8.7.6.3.
- **HBV 3801: Importing database from an older product version may require additional manual actions.**

If the database dump originates from Oracle >= 11.2, then empty tables are not included. The user will be informed by the import procedure which actions to take.

- **HBV 4410: Client Card Attendance is not yet populated anymore**
Because of changes in the data model, the Client Card Attendance is not populated for non-premier contracts.
- **HBV 4337: HTNG posting fails with sales itemizer with different VAT rate**
If two positions with different vat rates were used, the posting failed. This is not the case anymore.
- **HBV 4342: Guest search could fail if guests with possible inconsistent sales were included.**
This was caused by ReplacedOfferSales without sale dates, thus in connection with customized packages attached to the guest.
- **HBV 4361: Detailed Cash Closure Report doesn't show correct room number.**
Detailed Cash Closure Report doesn't show correct room number. This is fixed. The document room number (manual) is prioritized before the guest room number.
- **HBV 4373: Leisure InstallShield: New installation against 2.4.3. database**
Leisure InstallShield: New installation against 2.4.3. database
- **HBV 4388: VAT rate is not printed in Percentage format in Inventory report**
Percentage format in Inventory report. VAT rate is printed in percentage format.
- **HBV 4395: Display issues in PMS package**
Display issues in PMS package
- **HBV 4402: Parallel overbooking is always possible and not disabled if the user chooses to disable it**
Parallel overbooking is always possible and not disabled if the user chooses to disable it

The following known issues exist in this release:

- **Mixed payment method when settling offers is not possible**
When a mixed payment method is used for settling an offer, then one of the payment methods is overridden with the other.
