DM Upgrades v4.x Database to v4.12

The RES 4.12 rules are basically the same as in RES 5.x.

- 1. In a RES 4.12 system the Database Manager GUI can only Restore a database that is already at 4.12 and backed up so that it ends in an extension of .mbz4g2.
- 2. To restore a 4.11.mbz to an existing 4.12 RES server, please refer to the instructions titled "RES 4.12 Database Manager Rules" located in the *RES412_Install_rmf.pdf*.

Database Manager Does Not Delete Micros.mbz Files (By Design)

RES v4.12 creates database backups with the .mbz4g2 extension so that Database Manager can distinguish it from .mbz and .mbz5 databases. It also keeps track of and saves the configured number of .mbz4g2 backups. RES v4.12 will NOT delete leftover database backups with the extension of .mbz. These legacy backed up databases can be deleted by the user after the desired number of .mbz4g2 backups have been created.

Common - Reports

New RES Patch Replaces Web.config Files CR ID #: N/A SCR #: 40030

The Web.config files for Manager Procedures, Report Viewer, etc. (located in C:\Program Files\MICROS\Common\) will always be replaced when a new RES patch is loaded. Therefore, if any custom modifications were made to these files, they must first be backed up (make a copy of each file and save them).

Before running a new RES patch (upgrade), save the Web.config files located within the following folders under the Common folder:

The Sybase ODBC service registry setting has been changed with the installation of RES v4.12. To enhance security, the RES server will now ignore all universal broadcast requests that do not specify the server's IP address.

POS Operations

Group Combination Pricing Incorrect with Non-Priced Trigger Items and Priced Condiments CR ID #: N/A

SCR #: 40067

Previously, under certain scenarios, if the print option **Group Combination on Guest Check** (*POS Configurator | Sales | Discounts | Rule Setup*) was enabled, and a non-priced item was used as one of the discount triggers, the printed check was incorrect. The non-priced trigger item was not printing under the Combination Discount Group name on the guest check and the priced condiment was printing the price. This has been corrected.

Non-Priced Menu Item as Discount Trigger not working with Combination Pricing CR ID #: N/A SCR #: 40067

Previously, when the option **Allow non-priced menu items as discount triggers** (*POS Configurator | Revenue Center | RVC Discount | Service*) was enabled, non-priced menu items would not trigger an Automatic Discount that had a **Rule Type** (*POS Configurator | Sales | Discounts | Rule Setup*) of **Combination Pricing**. This has been corrected.

Consolidated RVC and SYS Tax Totals Reports Show Incorrect Value for Net Sales

Previously, the Consolidated RVC Tax Totals and the Consolidated SYS Tax Totals reports would show an incorrect value for net sales when run for a range of days. This has been corrected.

Consolidated SYS Menu Item Sales Summary Reports Grouped by Family Group

Previously, the Consolidated SYS Menu Item Sales Summary report did not list the Family Group Name for each grouped category. This has been corrected.

Employee Sales and Tips Totals by RVC Returns all RVC's CR ID #: 32590 SCR #: 40055

Previously, the Employee Sales and Tip Totals by Revenue Center Report did not filter the revenue center(s) based on the user's selection. All revenue centers would always display or print. This has been corrected.

An error occurs when trying to launch PMProcedures.exe from POS Operations on an MC55 or MC70 Handheld device. This is a known limitation. For this reason, workaround procedures have been provided below to explain how to install PM Procedures on the handheld and how to execute the application from File Explorer. This will avoid known limitations attempting to run PM Procedures in POS Operations.

Workaround Procedures:

- 1. On the MC55 / MC70, open FILE EXPLORER and go to the MicrosBin folder.
- 2. Locate 'Symbol.all.arm' and click on this file to install manually on the handheld client.
- 3. When prompted with 'Choose a location to install "Symbol Managed Class Libraries", select DEVICES (default) and then press the INSTALL button in the bottom Task Bar.
- 4. Once installed, you will receive a confirmation message on the handheld device: "symbol.all.arm.cab, was successfully installed on your device", Press the OK button in the upper right-hand corner of the screen to return to the \Micros\Bin folder.
- 5. Click on 'PMProcedures' to launch the PM application.
- 6. Log in to PM Procedures and select the desired function.

Due to known issues found when trying to run PM Procedures in POS Operations, it is recommended that POS Operations NOT be used to run PM Procedures on the MC55/ MC70 handheld devices in RES v4.12.
