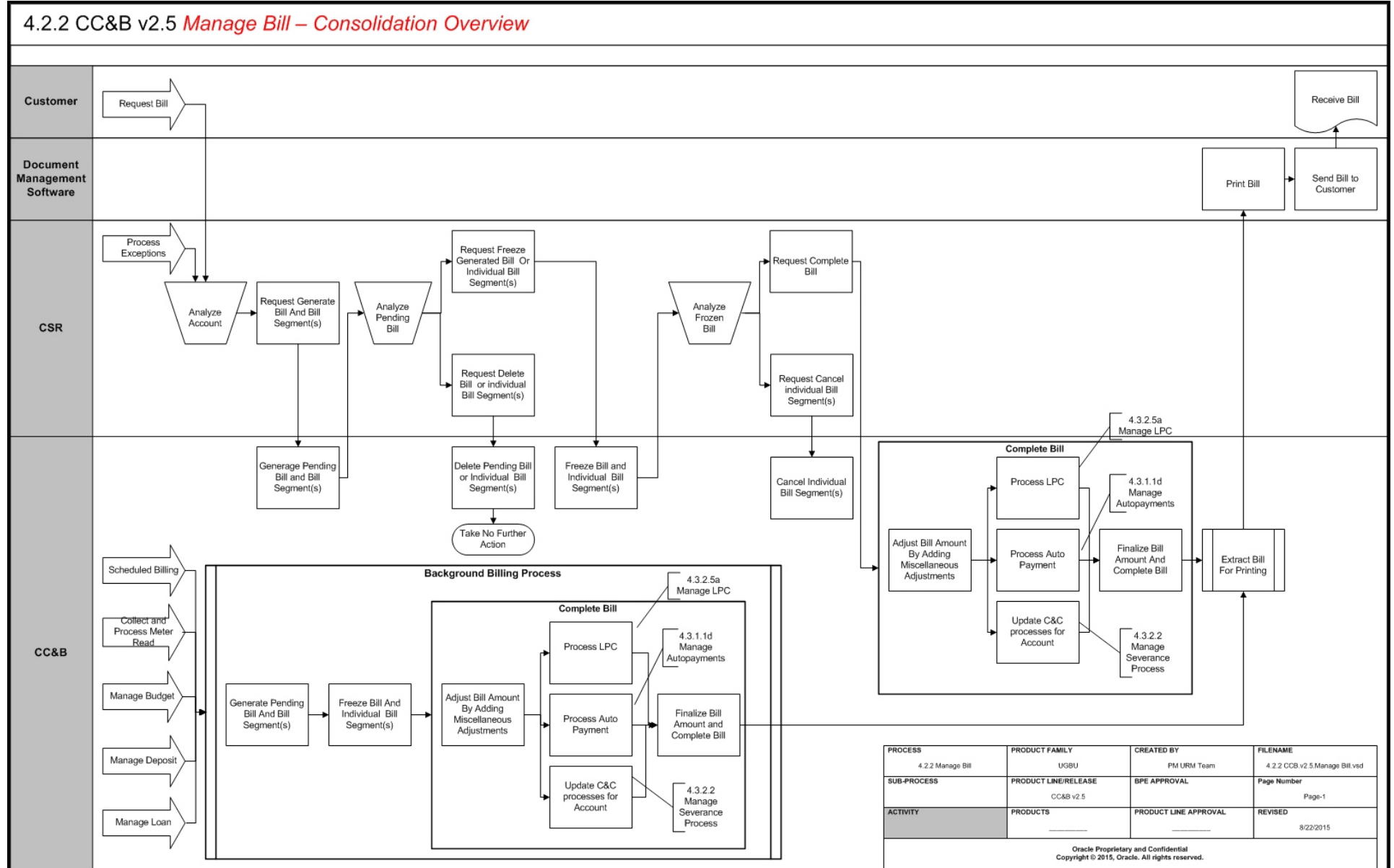

- High level overview with details to reflect specific services being billed.

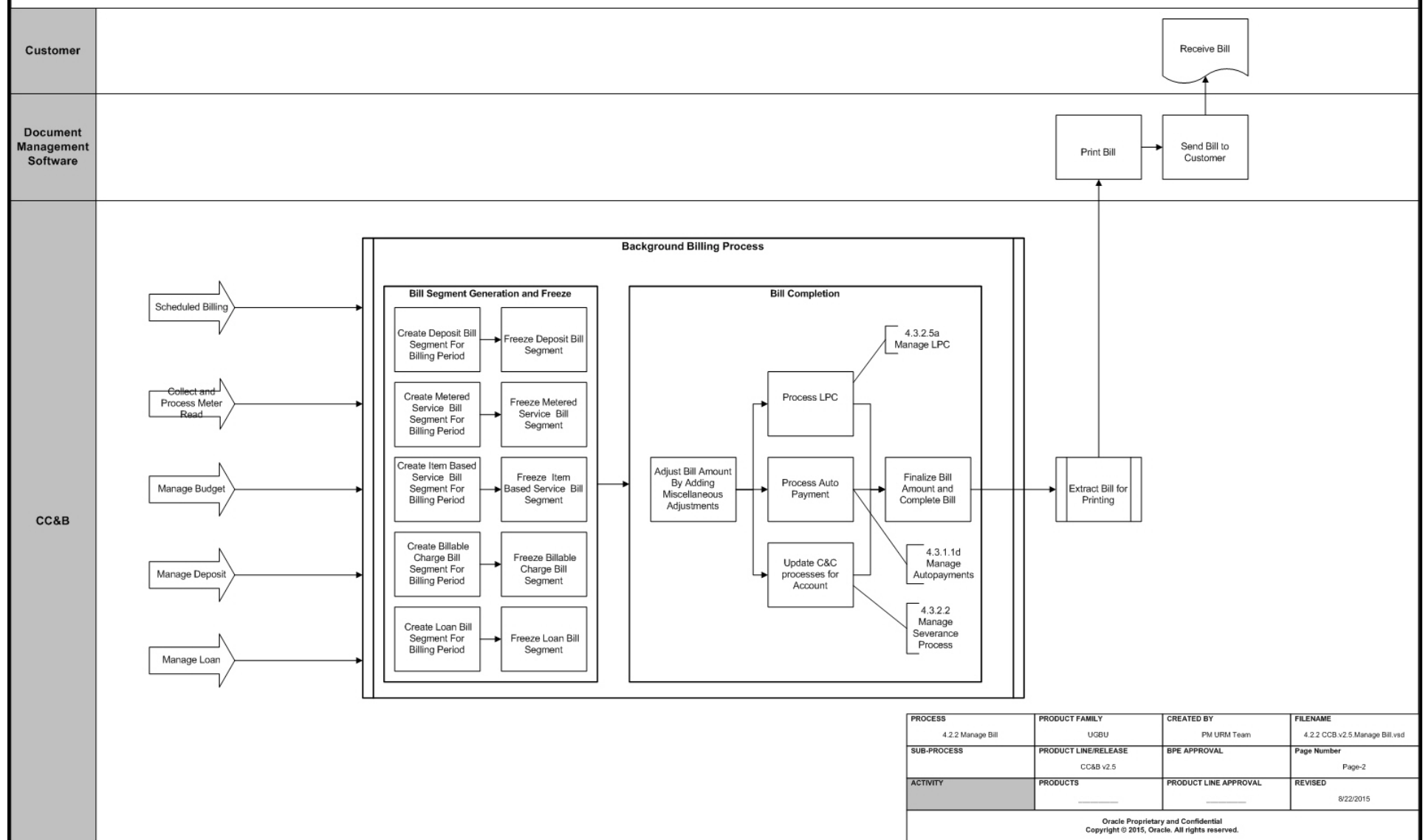
