### ***EM Corporate Version Error Caused by Storage Locations***

*CR ID #: 30685*

*SCR ID #: 38694*

Previously, EM corporate verified all stores were at RES version 3.1 or higher prior to allowing storage locations to be disabled in PM Parameters. Version checking has been removed since EM version 5.0 will no longer support RES versions below 4.3 HF2.

### ***Inventory Count Task Fail to Open on a Concept Database***

Previously, when opening the Inventory Count Tasks on a concept database, the application will error. This has been corrected.
