This document highlights the major changes for Patch Release 15.0.1 of Oracle Retail Open Commerce Platform Cloud Service.

## Overview

Oracle Retail Open Commerce Platform Cloud Service (OCP) is a mid-tier e-commerce solution that supports retailers' "order anywhere, fulfill anywhere" strategy. OCP provides retailers with a single view of the customer and enables retailers to provide a consistent experience across all channels and all touch points.

## Oracle Retail Cloud Services and Business Agility

The Oracle Retail Open Commerce Platform Cloud Service is hosted in the Oracle Cloud with the security features inherent to Oracle technology and a robust data center classification, providing significant uptime. The Oracle Cloud team is responsible for installing, monitoring, patching, and upgrading retail software. Included in the service is continuous technical support, access to software feature enhancements, hardware upgrades, and disaster recovery. The Cloud Service model helps to free customer IT resources from the need to perform these tasks, giving retailers greater business agility to respond to changing technologies and to perform more value-added tasks focused on business processes and innovation. Oracle Retail Software Cloud Service is acquired exclusively through a subscription service (SaaS) model. This shifts funding from a capital investment in software to an operational expense. Subscription-based pricing for retail applications offers flexibility and cost effectiveness.

## Functional Enhancement

### Oracle Key Manager

OROC 15.0.1 provides a new packaged integration with Oracle Key Manager (OKM). The previous key management integration with AKM is still available, but AKM has been replaced by OKM as the default key manager. OKM creates AES 256 keys and still uses a similar dual key setup with both a local encrypted DEK file and a KEK stored at OKM. There are new configurations across ROOT.xml, context.xml.default, and OKM specific configuration files.
