



3 Installing TopLink 12c

- Open command prompt as administrator
- Set path variable with JDK 7
- Run the following command to run the installer:
 - 'java -jar <downloaded path>\toplink_quick_121300.jar'



4 Configuring TopLink 12c

- Create a global shared library containing the following file:
 - a) eclipselink.jar
 - Find this file in the

'TOPLINK_INSTALLATION\oracle_common\modules\oracle.toplink_ver_no' directory created by the TopLink quick installer.
