Oracle Retail Invoice Matching (ReIM) Release 13.0.3.2 is a bundled hot fix release for ReIM 13.0. ReIM 13.0.3.2 includes selected defect fixes and enhancements for ReIM 13.0 code.

Oracle Customer Support investigates submitted issues assuming that all released updates have been applied. It is the customer's decision when to apply a new release; however, delays in applying updates can complicate the support process.

About Bundled Hot Fix Releases

Oracle Retail bundled hot fix releases are the most frequent releases to update Oracle Retail applications. These releases typically contain only defect fixes; they may also include enhancements that address application performance or other issues. Bundled hot fix releases are of smaller scope than less-frequent patch releases, and they are intended to be easier and faster for the customer to install than major patch updates.

Each bundled hot fix release contains a unique set of defect fixes or enhancements. Note that bundled hot fix releases are not cumulative; that is, defect fixes from a previous bundled hot fix release are not also included in a later bundled hot fix release.

Bundled hot fix releases must be applied in sequential order. Before you can apply a new bundled hot fix release, you must first apply all previous bundled hot fix releases since the last patch release. The Release Notes for each Oracle Retail release identify whether a release is a bundled hot fix release or a patch release.

Periodic patch releases include all defect fixes that have been released through bundled hot fix releases since the last patch release. Patch releases may also include new defect fixes and enhancements that have not previously been included in any bundled hot fix release.

Applying Source Code

Before applying the fixes included in the ReIM 13.0.3.2 bundled hot fix release, be sure that ReIM 13.0 has been installed and the ReIM 13.0.3 patch release has been applied.

Before applying the source files over your code:

- Note whether any modules have been customized. If so, the customizations must be reapplied to the new version of the module, or the fix may need to be applied to the custom version of the code.
- Copy the original files to a different directory before you copy over them, in case you need to refer to them at a later date.

Running Scripts

Back up data before running any script, because the scripts provided *do not* preserve data. See defect reports for details.

Check with your database administrator to determine whether your database should be analyzed after a script is run. In many cases, analysis of the database is necessary to take advantage of new or modified indexes intended to improve performance of the application.

Defect Fixes and Documentation

A defect fix is a modification to the base Oracle Retail code (for example, a bug fix, a performance enhancement, or a functional enhancement). Each defect fix that is included in this patch has a corresponding defect report titled *<defect-number>.PDF* (for example, 1234567.PDF).

In the same folder, the file named DEFECT MODULE XREF ReIM 13.0.3.2.XLS lists every defect number and the modules and scripts that are included in the patch. Review each defect report carefully before implementing the defect fixes. Please note that scripts do not preserve data. Make sure that all data is backed up before you run any script.

Noteworthy Defect Fixes

The following defect fixes and enhancements are included in ReIM 13.0.3.2.

Defect Number	Summary
9575436	The user is able to create a credit note from submitted credit note requests. The Create Credit Note button should not be enabled.
9563143	The user is not able to create debit memo and credit note request.
9556553	EDI invoice "Vendor 0" is an invalid supplier. But when an EDI file containing records with this supplier is uploaded, the file is not rejected to the table.
9545289	The EDI Upload batch issues the following java.util.MissingResourceException: "Can't find resource for bundle java.util.PropertyResourceBundle, key error.batch.vendor_ different_than_in_order."
9538717	The Fixed Deal upload batch module fails with deadlocks, but it ends with a 0 return code.

Defect Number	Summary
9524327	When the ReIM Financial batch is run to post ReIM to EBS, the amounts in IM_AP_STAGE_HEAD and IM_AP_STAGE_DETAIL differ by 0.01. This difference causes an EBS error.
9505733	When document type = NON_MERCHANDISE INVOICE and the amount is less than zero, the INVC_TYPE_LOOKUP_CODE should be CREDIT after the Financial Posting batch is run.
9503655	A debit memo is created with zero value if the item is not present in the shipment.
