Release 13.0.5.1

Oracle Retail Invoice Matching (ReIM) Release 13.0.5.1 is a bundled hot fix release for ReIM 13.0. ReIM 13.0.5.1 includes selected defect fixes and enhancements for ReIM 13.0 code.

Oracle Customer Support investigates submitted issues assuming that all released updates have been applied. It is the customer's decision when to apply a new release; however, delays in applying updates can complicate the support process.

About Bundled Hot Fix Releases

Oracle Retail bundled hot fix releases are the most frequent releases to update Oracle Retail applications. These releases typically contain only defect fixes; they may also include enhancements that address application performance or other issues. Bundled hot fix releases are of smaller scope than less-frequent patch releases, and they are intended to be easier and faster for the customer to install than major patch updates.

Each bundled hot fix release contains a unique set of defect fixes or enhancements. Note that bundled hot fix releases are not cumulative; that is, defect fixes from a previous bundled hot fix release are not also included in a later bundled hot fix release.

Bundled hot fix releases must be applied in sequential order. Before you can apply a new bundled hot fix release, you must first apply all previous bundled hot fix releases since the last patch release. The Release Notes for each Oracle Retail release identify whether a release is a bundled hot fix release or a patch release.

Periodic patch releases include all defect fixes that have been released through bundled hot fix releases since the last patch release. Patch releases may also include new defect fixes and enhancements that have not previously been included in any bundled hot fix release.

Running Scripts

Back up data before running any script, because the scripts provided *do not* preserve data. See defect reports for details.

Check with your database administrator to determine whether your database should be analyzed after a script is run. In many cases, analysis of the database is necessary to take advantage of new or modified indexes intended to improve performance of the application.

Documentation Correction

With the ReIM 13.0.5.1 release, information about Light Directory Access Protocol (LDAP) is expanded in the *Oracle Retail Invoice Matching Operations Guide*, specifically in Chapter 5, "Integration."

Defect Fixes and Documentation

A defect fix is a modification to the base Oracle Retail code (for example, a bug fix, a performance enhancement, or a functional enhancement). Each defect fix that is included in this patch has a corresponding defect report titled *<defect-number>.PDF* (for example, 1234567.PDF).

In the same folder, the file named DEFECT MODULE XREF ReIM 13.0.5.1.XLS lists every defect number and the modules and scripts that are included in the patch. Review each defect report carefully before implementing the defect fixes. Please note that scripts do not preserve data. Make sure that all data is backed up before you run any script.

Noteworthy Defect Fixes

The following defect fixes and enhancements are included in ReIM 13.0.5.1.

Defect Number	Summary
10247680	Matched invoice quantities are not recorded on SHIPSKU when there is a cost discrepancy.
11880174	Rather than issuing an error, the EDI Invoice upload aborts when encountering an old invoice date, when due date is null and no invoices are applied.
12387092	The amount on a fixed deal debit memo outbound invoice does not balance with the posted invoice total amount.
12386294	A complex deal debit memo is posted with four decimal places in IM_AP_STAGE_HEAD and IM_AP_STAGE_DETAIL, when IM_CURRENCY_LOCALE specifies two decimal places.
12372143	A zero quantity invoice results in problems when running the ReIM Resolution Posting Batch.
12370630	Performance issue when running REIMPOSTING Batch.
11873350	When attempting to complete resolution through the Quantity Variance Resolution screen from Detail Matching, the user is returned to the main screen and the following error is issued: "Your Lock has expired. Please retry your operation."
11938426	The available quantity to match reverts to a negative amount after cost and quantity discrepancies are resolved for the same item.
12350012	For a Credit Note created through Credit Note Request, discrepancy handling does not work correctly if there are several items, were some are Resolved by Cost and some are Resolved by Quantity.
12357011	When an order with multiple items is received by multiple shipments, the invoice is in unresolved match status with a quantity discrepancy. However, the receipt corresponding to the invoice is matched. The invoice cannot be matched and posted.

Defect Number	Summary
12381229	When EDI Invoice download is run, a "memory out of" error is issued.

Installing the Bundled Hot Fix Release

1. Shut down the server and connected clients.
2. Download the .ZIP file from My Oracle Support.
3. Unzip the .ZIP file into a folder, such as REIM_HOTFIX.
4. There will be another .ZIP file called ReIMxxApplication.zip (where xx is the version number, such as 11, 12, and 13).
5. Unzip ReIMxxApplication.zip. Inside the file is reim.ear.
6. Copy the reim.ear file to the destination directory in your application server.
7. Go to the DBChanges folder inside REIM_HOTFIX to find the changed .SQL scripts and .PLS files.
8. Open a SQL*Plus session as an ReIM database user and compile all the .PLS files and execute .SQL files.
9. Restart the application server.
