Noteworthy Defect Fixes

The following defect fixes are included in AIP 13.4.1.

Defect Number	Summary
16922890	AIP produces the error message "Unable to change Working Order Group" for automated order groups on the Order Group screen.
16835007	In the SRP (Store Replenishment Planning) Implementations Parameters workbook, setting the Prioritize External Demand measure to FALSE causes the scrp batch to fail.
16770295	AIP produces a scaling error when producing a pull list for SUPPLIER_MINIMUM_SCALING.
16623115	Creating an SRP (Store Replenishment Planning) Interactive Evaluation workbook fails when building it with less than 20 days in the calendar.
16205581	In Warehouse Replenishment Planning (WRP), the Delivery Day Demand Percent (DDP) is not correct when the Day is not Available To Plan (ATP) and has Expected Receipts.
