Noteworthy Defect Fixes

The following defect fixes are included in AIP 13.4.2.

Defect Number	Summary
17670664	<p>The 13.4 AIP Install Package is missing the conversion file for Integer Indexing.</p> <p>In AIP 13.4 install package, there is no file called 13.3.0_measure_value_convert_list.txt. This file is used to run an RPAS/AIP 13.2.3.x conversion to the Integer Indexing schema. Without this file, customers cannot upgrade directly to an AIP version such as 13.4.2.</p>
17828064	<p>The script, clearArrayScript.ksh, fails making the assumption that all local domains reside inside the root of the global domain.</p>
17830412	<p>Order Group assignment changes yields incorrect output.</p> <p>Changing the Order Group to a new group with an effective date of X and on the same day, then making a change back to a different Order Group with effective date of X+5 (as an example) does not yield the correct data on export.</p>
