## 2. Kernel Environment Setup

The following steps to be followed to do the initial environment setup for FCC – FC SSI MH Integration Adapter deployment:

1. Copy the ***FC\_UBS\_V.UM\_8.0.0.0.0.0.0 Lot1/Adapter/SSI*** folder from the Kernel Vercon Software Release area to local machine (say ***D:\FC\_UBS\_V.UM\_8.0.0.0.0.0.0Lot1\SSI*** for WINDOWS or ***/home/kernel/FC\_UBS\_V.UM\_8.0.0.0.0.0.0Lot1/SSI*** for UNIX).
2. Go to ***D:\FC\_UBS\_V.UM\_8.0.0.0.0.0.0Lot1\SSI\Utilities\Java-install*** directory (for WINDOWS) or ***/home/kernel/FC\_UBS\_V.UM\_8.0.0.0.0.0.0Lot1/SSI/Utilities/Java-install*** directory (for UNIX).

Update following parameters with relevant values in ***set\_env.bat*** (for Windows platform) and ***set\_env.sh*** (for UNIX platform).

a) APP\_SERVER\_NAME

This parameter specifies the name of the J2EE compliant application server.

- ✓ For WebSphere Application Server, this parameter should be set as APP\_SERVER\_NAME=WAS
- ✓ For Oracle 10g AS Application Server, this parameter should be set as APP\_SERVER\_NAME=OC4J

b) APP\_SERVER\_HOME

This parameter specifies the installation directory of the application server.

- ✓ For WebSphere Application Server, enter the path of the installation directory. e.g.:  
APP\_SERVER\_HOME=D:\Program Files\IBM\WebSphere\AppServer
- ✓ For Oracle 10g AS Application Server, enter the path of the installation directory. e.g.:  
APP\_SERVER\_HOME=D:\Oracle10gAS

c) KERNEL\_INSTALL\_DIR

This parameter specifies the directory where KERNEL Software will be installed.

e.g.

- ✓ For WINDOWS:

KERNEL\_INSTALL\_DIR=D:\Kernel8.0

- ✓ For UNIX:

KERNEL\_INSTALL\_DIR=/home/kernel/Kernel8.0

d) IS\_ENTERPRISE\_QUEUE\_WebSphereMQ

This parameter specifies the JMS Provider used in the application. The two JMS providers supported are:

1. OracleAS JMS

2. WebSphere MQ

- ✓ If the JMS Provider is IBM WebSphere MQ, specify  
IS\_ENTERPRISE\_QUEUE\_WebSphereMQ=true
- ✓ If the JMS Provider is Oracle 10g Application Server JMS, specify  
IS\_ENTERPRISE\_QUEUE\_WebSphereMQ=false

e) IBM\_WEBSPHERE\_MQ\_INSTALL\_DIR

This parameter specifies the IBM WebSphere MQ installation directory.

Provide the path of the WebSphere MQ Installation directory, if the JMS provider used is IBM WebSphereMQ, i.e. if

IS\_ENTERPRISE\_QUEUE\_WebSphereMQ=true

- ✓ IBM\_WEBSPHERE\_MQ\_INSTALL\_DIR=D:\Program Files\IBM\WebSphere MQ

### 3. Setting up the environment.

#### a) For WINDOWS

- ✓ Open a DOS command prompt and change directory to,

*D:\FC\_UBS\_V.UM\_8.0.0.0.0.0Lot1\SSI\Utilities\Java-install*

- ✓ On the command prompt type set\_env.bat and press enter.
- ✓ Change directory to,

*D:\FC\_UBS\_V.UM\_8.0.0.0.0.0Lot1\SSI\Utilities\Java-install\%APP\_SERVER\_NAME%*

- ✓ Execute the build file,
  - For WebSphere Application Server, type “**ws\_ant**” on the command prompt and press enter.
  - For Oracle 10g Application Server, type “**ant**” on the command prompt and press enter.

#### b) For UNIX

- ✓ Open a UNIX shell prompt and change directory to,

*/home/kernel/FC\_UBS\_V.UM\_8.0.0.0.0.0Lot1\SSI\Utilities\Java-install*

- ✓ On the command prompt type **set\_env.sh** and press enter.
- ✓ Change directory to,

*/home/kernel/FC\_UBS\_V.UM\_8.0.0.0.0.0.0Lot1/SSI/Utilities/Java-install*

*/\$APP\_SERVER\_NAME*

- ✓ Execute the build file,
    - For WebSphere Application Server, type “**ws\_ant**” on the shell prompt and press enter.
    - For Oracle 10g Application Server, type “**ant**” on the shell prompt and press enter.
4. After step 3, <KERNEL\_INSTALL\_DIR> folder structure as shown in the attached excel sheet will get created under. Please verify the same.



5. Gather the required jar files [Please refer the [Software Requirements](#) in the Appendix].
