Accepted Document Types (8.31.4)

Materials Control now includes a configuration to restrict the accepted document types for attachments in:

- Purchase Orders
- Requisitioning (for Purchase Managers)
- Receiving
- Invoicing

To configure the list of document types:

1. Click **Maintenance**, click **Configuration**, and then click **PATH**.
2. Configure the comma-separated list in **DOCUMENTSTORAGEFILETYPES**.

Poland Fiscal Inventory Export Interface Updates (8.31.4)

The Poland Fiscal Inventory Export interface:

- Allows you to exclude internal transfers when configuring a fiscal export.
- Shows the Cost Center configured for the Automation Service job in the **Magazyn** field.
- Return to Supplier documents report using the tag `<tns:WZ>` instead of `<tns:PZ>`.
