Oracle Retail Integration Bus (RIB) Release 13.1.4.1 is a bundled hot fix release for RIB 13.1. RIB 13.1.4.1 includes selected defect fixes for RIB 13.1 code.

Oracle Customer Support investigates submitted issues assuming that all released updates have been applied. It is the customer's decision when to apply a new release; however, delays in applying updates can complicate the support process.

About Bundled Hot Fix Releases

Oracle Retail bundled hot fix releases are the most frequent releases to update Oracle Retail applications. These releases typically contain only defect fixes; they may also include enhancements that address application performance or other issues. Bundled hot fix releases are of smaller scope than less-frequent patch releases, and they are intended to be easier and faster for the customer to install than major patch updates.

Bundled hot fix releases must be applied in sequential order. Before you can apply a new bundled hot fix release, you must first apply all previous bundled hot fix releases since the last patch release. The Release Notes for each Oracle Retail release identify whether a release is a bundled hot fix release or a patch release.

Periodic patch releases include all defect fixes that have been released through bundled hot fix releases since the last patch release. Patch releases may also include new defect fixes and enhancements that have not previously been included in any bundled hot fix release.

Supplemental Support Documentation

Defect 9706804

For the RIB defect 9706804, a separate document has been created to support RIB payload customization. It includes a workaround to prevent TAFR errors when attempting to unmarshal the payload during the customization of ExtOf* elements in a base RIB message.

The document has been published to My Oracle Support as "RIB Payload Customization Workaround," ID 1313337.1.

Defect Fixes and Documentation

A defect fix is a modification to the base Oracle Retail code (for example, a bug fix, a performance enhancement, or a functional enhancement). Each defect fix that is included in this release has a corresponding defect report titled *<defect-number>.PDF* (for example, 1234567.PDF).

Defect Number	Summary
9706804	Customizing ExtOf* elements in a base RIB message results in an error in TAFRs when attempting to unmarshal the payload.
11692238	RIB Hospital retry adapters are not started/stopped by the adapter controller script (rib-adapter-controller.sh), even after deploying the appropriate patch.
12311055	When a store is created in RMS, the store open date does not flow down to SIM. STORE_OPEN_DATE is not mapped in the RIB TAFR, StoresToStoresPhys, for stores message.
