Overview

Oracle Retail Financial Integration Release 13.2.6 represented the initial release of the direct integration solution between Oracle Retail Merchandising Suite and enterprise financial systems.

The Oracle Retail Financial Integration is supported by Oracle for customers who have purchased the Oracle Retail Integration Bus product. As with most packaged integration, the base package provides the most common integration content to satisfy end-to-end scenarios, but customers often make some integration and mapping changes to meet their specific needs. This release includes technical and design documentation to assist customer-specific deployments.

About Patch Releases

Oracle Retail patch releases are periodic releases that can include the following:

- New defect fixes
- Product enhancements
- Technology upgrades
- Performance fixes

Documentation for patch releases includes new and updated guides (for example, Operations Guides, User Guides, and so on) that apply to the patch release level.
