Oracle Retail Financial Integration represents the direct integration solution between Oracle Retail Merchandising Suite and enterprise financial systems.

The Oracle Retail Financial Integration is supported by Oracle for customers who have purchased the Oracle Retail Integration Bus product. As with most packaged integration, the base package provides the most common integration content to satisfy end-to-end scenarios, but customers often make some integration and mapping changes to meet their specific needs. This release includes technical and design documentation to assist customer-specific deployments.
