Overview

This release of Oracle Retail Integration Bus (RIB) includes changes in architecture, technology stack, and deployment. Major highlights of this release are as follows:

- Enhanced Retail Business Objects (RBO) with new data types and concepts
- Added RIB Runtime Monitoring
- Significant number of new RBOs
- Updated technical stack
- Enhancements in supporting tools

Functional Enhancements

The following functional enhancement is included in this release.

Integration RBO Changes

A significant number of RBOs were updated in this release.

Technical Enhancements

This section addresses the technical enhancements included in Oracle Retail Integration Bus Release 15.0.

RIB Runtime Monitoring Framework

The RIB runtime monitoring framework was added in this release.

- An asynchronous in-memory data collection framework is added
- Services that make the monitoring data accessible are added
- RIB runtime data visualized through RIC

JMS Console in rib-home/tools-home

JMS Console can now be deployed from tools-home.

RIB Deployment on JRF Domain

RIB applications now need JRF domain for deployment.

Support for DB Credential Store

The credential wallet is enhanced to utilize DB credential store.

JMS Console Enhancement

JMS Console is now enhanced with many features like search, internationalization, etc.

RIC Standalone Deployment

You can now deploy the RIC as a standalone application.
