Oracle Retail Financial Integration (RFI) Release 16.0.2 is a patch release for ORFI 16.0.

The release synchronizes with the release of the Retail Business Objects (RBOs) for RIB. There were no changes made to the existing old RFI interface code.

Overview

Oracle Retail Financial Integration provides a direct integration solution between Oracle Retail Merchandising Suite and enterprise financial systems.

The Oracle Retail Financial Integration is supported by Oracle for customers who have purchased the Oracle Retail Integration Bus product. As with most packaged integration, the base package provides the most common integration content to satisfy end-to-end scenarios, but customers often make some integration and mapping changes to meet their specific needs. This release includes technical and design documentation to assist customer-specific deployments.

About Patch Releases

This version of the Oracle Retail Financial Integration adds integration between Oracle Retail Merchandising System and Oracle Financials Cloud (CFIN). This is in additional to the integration previously provided to the Oracle E-Business Suite Financials and Oracle PeopleSoft. Integration best practices have been applied to this integration so that it can be easily implemented and supported by our retail customers.
