# 2 Oracle Financial Services Price Creation and Discovery Application

Oracle Financial Services Price Creation and Discovery application is intended to be used as a tool to aid a banker price an asset product or liability product or a bundle across all enterprise product, for a customer while taking into account the customer and product attributes, depth of the customer that is customer's relationship with the bank and the overall profitability at an account or customer level.

The application addresses the pricing needs of both retail as well as the institutional customer through three methodologies namely Carded, Negotiated, and User Input pricing. It enables the banker to take into account the Transfer Pricing rate and the capital charge components associated with the deal along with a projection of expenses, other revenue, and all existing relationships (made available through the OFS Funds Transfer Pricing, Basel, OFS Instituinal Performance Analytics, and OFS Retail Performance Analytics products) to generate the rate.

The rate thus generated is saved and available for further analysis and tweaking through What-If analysis.

### 2.1 New Features

This maintenance release of OFS PCD does not have any new features. Enhanced User Interfaces developed for pricing of Asset Products developed during the release have not been made Generally Available to customers.

### 2.2 Bugs Fixed in this Release

This maintenance release of PFS PCD does not have any fixed bugs.

### 2.3 Known Issues and Limitations in this Release

The limitations and known issues in this release are as follows:

- This release of OFS PCD pack AIX installer is verified only on AIX 7.
- PCD 80740 Patch installer needs to be handled with Oracle 19.5 Database Client version on Solaris X86 due to Oracle 19.3 Database Client is not compatible on Solaris X86.
- RM Summary screen is not opening in the the client (SOLARIS SPARK 10 & X86 10), that is, a blank screen is coming as draggable.js file is getting created as draggable.j
- PCD\_BULK\_PRICE\_RUN task was hardcoded with dev infodom name because of which the task was failing and flat files were not getting generated.
- In case of invalid product code with respect to product type in the backend bulk pricing table, instead of failing the pricing, the deal is getting created successfully after the batch execution.
- Bulk Pricing script is not getting called when the batch bulkpricing was executed.
