1 Features and Updates

The following sections contain a list of updates for all modules of Suite8 and the XML Interface.

Cashiering

• You can now split amounts for postings in foreign currency when original posting was made in foreign currency.

Central Reservation System (CRS)

 You can now use Bed Management in Suite8 Central CRS environment (Partner, Mirror). You can start the room rack in the master from menu Quick Keys -> Room Rack, or with the shortcut Ctrl-L.

The new room rack design from bed management will be used for all hotels, even if there is one property without active bed management license.

The room rack starts in the same window like Reservation and can be simply switched to another hotel by click on the hotel name on the top of the window.

Miscellaneous

General

• You can now define **color schemes** for Suite 8 under Miscellaneous > User Settings > Appearance > Color schemes with the ability to make the schema public or private (depending on the User right > Configuration > Create/Modify public colors. The default can be set at any time with Ctrl +Shift + F12 und then restart Suite8. The color schemes are also valid for Availability (CTRL+D).

TAC Reservation Assistant

- A new license for TAC Reservation Assistant (L102883) is available now. To install TAC only this license is needed and it includes:
 - Profile lookup
 - XML Interface 2 way
 - Basic XML interface

Profiles

You can now use the guest anonymization feature to anonymize guest information. The anonymization of a guest completely removes all guest information which might make it possible to identify the individual guest. Checks are performed to make sure that no profile with current or future activities is anonymized, for example: reservations, financial accounts, CCM bookings or activities. The anonymization will also not take place if the last activity has passed less than the defined number of days

in global settings. The functionality is controlled via a global setting and additional configuration.

Reservation

- You can now define a display order for the Package Report Groups under Setup >
 Configuration > Reservations > Rate Management > Package Report Groups.
- Country specific requirement for Sweden: You can now use enhanced credit invoice handling with the following options:
 - Activate the global setting **Enable Enhanced Credit Invoice** under Country Specifics > Country Specifics3 > Swedish Settings with the ability to define **Only on the day of the check-out** and the selection of the **Allowed Payment Methods**. If an invoice is checked-out and needs to be 'voided', go to **Options > Credit Invoice**. Depending on the allowed payment methods a contra entry and an invoice will be created with the question if the revenue should be booked to a new billing window. If there is a mixture of allowed and not allowed payment methods, the invoice cannot be 'voided'.
- The following is only needed when you have Hotel Mobile installed: As you have in Hotel Mobile 4 housekeeping statuses, you can now define in Suite8 also the maximum of 4 housekeeping statuses to be consistent. Activate the setting Limit Housekeeping Status under Setup > Configuration > Global Settings > Generic > Hotel Mobile 5. If this option is activated a maximum of 4 housekeeping statuses are allowed. If more exist you have to reduce them in Setup > Configuration > Reservations > Room Management > Housekeeping after you have checked that the statuses that should be removed are not linked to a room.

Bed Management

• The ability to move beds on Room Rack and in Reservations is available now.

Room Rack:

Select the target bed using right mouse menu and then left click on **Select bed foraction** (As an indicator, the bed line gets a yellow frame). Select the bed reservation with right click on the day the bed move should be performed, and left click on

Move to selected room/bed.

Moving a bed to another bed with a different bed type may need certain adjustments. Such moved reservations are indicated with a yellow house symbol in the reservation line of the room rack. See also **Options > Legend**.

Reservation:

In reservation profile tab multi guest grid: Change the display to show **Room**. Double click on a certain day for the related guest bed. You will be asked to change for this day and all days after that day or just for the selected day. It is also possible to mark a range and then select **Options > +Room** to assign the room/bed for the marked days.

Perform bed move:

Select **Reservation > Room move** from the main menu bar. Current room or bed moves are displayed. Select the appropriate reservation and click the button **Move** to perform the bed move.

- Availability (CTRL + D): You can now define columns in different colors by right click > Settings. You can define and select different color schemes and define certain schemes as public to provide the schema to other users. A new user right to restrict the creation/modifying of public colors is available under Setup > Configuration > User > User Definition > Rights > Configuration > Create/Modify public colors.
- On detailed availability, each column can have its own background and text color, or
 you can choose predefined ones from global settings. You can define colors in a
 custom color scheme, in room type setting and for hotel segments. All three can be
 turned on/off on availability screen right click Menu > Settings.

If multiple colors are defined, colors are applied in this order:

- 1. custom color scheme
- 2. room type color
- 3. segment color

The colors are displayed in the upper part and also in the lower part (Control Panel).

Note: Named screen settings are not changed, no matter what you do, unless you click **Save** and save with the same or different name. If however the default or none is selected then all changes are saved for the user.

Spa and Leisure

The following features are available with this release:

- Install Shield enhancements (Config Options)
- Suite8 XML Interface exchange of profile data
- Guest search using wild cards
- webConnect: ability to add a picture to offers to be displayed online

For further information refer to the *Oracle Hospitality Suite8 Spa and Leisure Installation Guide*.

- You can now test the XML-Interface connection during the installation or update, or later within the Config option by clicking the button TEST. As a result the license information is displayed or if the connection failed, a corresponding message pops up.
- For clearer selection and display, you can now select the **Room Type** and **Room Number** from the select box right from the name in the booking screen. It shows the information separated by a pipe:

 roomtype|roomnumber|reservationnumber|arrival-departure

XML Interface

 Voucher Management: You can now change the VoucherConsumingGuestID via XML Interface.

OTA XML Interface

- The OTA XML interface now supports the rate code availability restriction Closed to departure, allowing the hotel to close a rate code for a departure day.
- OTA XML Interface and Online Interface: in case a dependent rate code is marked as
 Online/OTA XML Interface in rate code configuration to be able to upload it to an
 external system, it is not possible anymore to choose the price rounding type
 Discount Amount. Only Percentage is allowed. A corresponding warning message is
 displayed.

Online Interface

- The Seekda mapper now supports the upload of rate code restrictions from Suite8 to Seekda.
 - The following restrictions are supported:
 - Open / Close, Close to Arrival, Close to Departure, Min / Max Length of Stay, Min Length of Stay Through.
- TRUST Voyager mapper: the element "confirmationID" in the reservation
 message is now a string value and not an integer value anymore. This was changed
 in the TRUST system and a request to make that change also in the Online Interface
 was made by TRUST. Therefore from this release onwards the confirmation ID is a
 string value.

webConnect

- It is now possible to add a default Cancel Status Code on Setup > Configuration > Suite8 Homepage > Setup > Tab 1 and cancel future bookings. On Tab 2 you can activate the option Show conference bookings to define if the page Meeting Rooms is available under My Account. Opening this tab displays future and past Conference Bookings of the guest.
- The Guest anonymization feature (see Profiles > Guest anonymization) is also available in webConnect. When the guest presses the button Forget me, an alert is displayed that all data including history will be deleted. When the guest confirms this alert Suite8 will perform the necessary checks. The guest will be informed if the data could be anonymized or not. If so, the guest will be logged out of Suite8. In addition the check Allow to save profile information is available on the according screens. If the guest selects this option the profile will be updated in Suite8 accordingly.

XML Interface	26736379	It is now possible to remove a room number from an existing reservation using the following XML element: <field name="RoomNum"></field> or <field name="RoomNum">-1</field> . This is only possible for not yet checked in reservations and only for reservations without superblock flag.
	26484294	From 8.10 version onwards, the encryption method in FidelioV8DBPasswordEncrypt.exe was changed to generate a machine based encrypted password, which is only valid in the same machine.
		The Decryption method in the XML interface was still using the methods from version 8.9.6 and hence it fails to decrypt the password generated by the Suite8 8.10 tool.
		From this version onwards passwords need to regenerated for the XML Interface if password encryption is used and will be machine based.

		If OTA XML Interface errors occur and recorded in the error log, the little red square in the lower right corner of the Suite8 main screen, indicating that there are new errors is blinking now on all workstations and not only on the workstation where the error occurred.
Online Interface	26626203	Channel Manager mapper: the rate amounts are now correct when uploading a rate detail message of a rate code with attached add to rate and percentage packages.
	26811414	GHA Profile Lookup: Primary communication methods are flagged now correctly in Suite8 when downloading a profile from GHA.
webConnect	26496347	CCM webConnect > Calendar: The end time reflects now the end time and not the possible last booking, e.g. if end time is 5:00 pm and you select 4:00 pm all packages > 1 hour will not be displayed.
Miscellaneous	26021647	Setup > Configuration > Miscellaneous > Text Templates: Apostrophes are no longer doubled when saving/editing text templates.
	26228969	If the Global Setting Status bar under Setup > Configuration > Global Settings > Generic2 is active the status bar is interactive now again.
