## **Pre-installation Requirements**

The following pre-installation steps are required for this release:

- 1. The OFS Sanctions Application Pack v8.1.2.0.0 base pack must be installed.
- 2. Download and install the following mandatory patches from My Oracle Support by searching for the patch under the Patches & Updates tab:
  - Bug 35013409- OFSAA 8.1.2.0.0 AAI ML RELEASE #3 (8.1.2.3.0)
  - Bug 35197649 OFS ECM v8.1.2.0.0 Minor Release #5 (8.1.2.5.0)

**NOTE** 

Download and install the above patch if the ECM Application is installed on the same pack.

Bug 35189486- OFS BD Application Pack v8.1.2.0.0 Minor Release #5 8.1.2.5.0

Download and install the above patch if the BD Application is installed on the same pack.

#### **New Features**

#### **Sanctions Pack**

- Introduced the Read-Only user group.
- You can perform Bulk Action against alerts added to the alert list page.

#### **Customer Screening specific**

- The Real-Time screening will point to the ECM priority table to create a case priority.
- Added Customer Status, Gender, Tax Id, and Tax Country to the Customer Details section.
- Added Multi-select option and Search using code functionality in the dropdown menu requirement for Country fields.
