Who Should Use this Guide

The Oracle Financial Services Compliance Regulatory Reporting User Guide NZSTR, Release 8.0.1 is designed for use by various users. Their roles and responsibilities, as they operate within the Oracle Financial Services Suspicious Transaction Reporting application, include the following:

- Analyst: This user can enter report details, edit report details, add comments to the report, submit the report
 details for approval, mark reports as submitted or acknowledged, and re-open closed or acknowledged
 reports.
- **Supervisor**: This user is responsible for taking action on the reports submitted by the Analyst, such as approve, reject, or close. This user can edit report details and add comments to the report and approve the report. Users mapped to the role of Supervisor can perform all the tasks performed by an Analyst.
- System Administrator: This user is responsible for managing the static data used in the application, creating
 application users, mapping users to user groups, and configuring the various parameters used in the
 application.

CHAPTER 1 About Compliance Regulatory Reporting

This chapter provides an overview of the Oracle Financial Services Suspicious Transaction Reporting application. This chapter discusses the following topics:

Introduction of Compliance Regulatory Reporting

As a part of regulations and compliances, a Financial Services Organization must perform appropriate analysis and report any suspicious activities that may lead to fraud and money laundering to the regulatory authorities. These regulatory bodies are responsible for safeguarding financial institutions and consumers from abuse, providing transparency in the country's financial system, enhancing that country's security, and deterring and detecting criminal activity in the financial system.

Financial institutions are required to provide data regarding suspicious activities to their geographic region's regulatory authority. This data is delivered to the regulatory bodies through regulatory reports. These reports, depending on the regulatory geographic region, can be delivered in a paper format or in an electronic format.

About Oracle Financial Services Compliance Regulatory Reporting Application

The Oracle Financial Services Compliance Regulatory Reporting (OFSCRR) application supports the management, delivery, and resolution of regulatory reports across multiple geographic regions and across multiple financial lines of business. The OFSCRR application supports the generation of Suspicious Transaction Reports (STR) for various countries such as The United States of America Suspicious Activity Reports (US SAR), Nigeria (NG STR), Pakistan (PK STR), Malaysia (MY STR), Singapore (SG STR), and New Zealand (NZSTR). Since there are several differences in requirements for paper-based formats versus electronic formats, between different geographic regions, and the data elements that are required on these reports, the approach to satisfy the end goal is to provide a Compliance Regulatory Reporting framework that is configured to support paper-based and electronic formats for different geographic regions and to generate and file different types of reports.

The Oracle Financial Services Suspicious Transaction Reporting application is integrated with Oracle Financial Services Enterprise Case Management (OFSECM) to allow users to generate reports automatically populated with information relevant to an investigation for any report filed.

Users mapped to appropriate roles can update the report information and submit the report details for approval to the Supervisor. The Supervisor can approve, reject, or, close the report.

- 5. Click **Login**. The OFSECM page is displayed.




Figure 2. OFSAAI Page

- 7. Click **New Zealand STR from Compliance Regulatory Reporting** tab in the OFSECM Home page. The RR List page opens.




Figure 3. RR List page

The Compliance Regulatory Reporting link is enabled only for users who have access to the OFSCRR Application.

Overview

The following figure explains the workflow of regulatory reports for users mapped to the role of Analyst.




Figure 4. Compliance Regulatory Reporting Workflow for Analyst

The following figure explains the workflow of regulatory reports for users mapped to the role of Supervisor.




Figure 5. Compliance Regulatory Reporting Workflow for Supervisor

Overview Chapter 3-Managing OFSRR

A report is created in the OFSCRR application as a result of taking an action to generate an NZSTR from within OFSECM. When a report is created in the OFSCRR application, the report details are auto-populated with information from the alert or case which triggered the action to generate the STR. Users mapped to the role of Analyst can update the report information as needed and submit the report details for approval to the Supervisor. Supervisors can also edit and approve report details directly if needed.

The Supervisor can approve, reject, or, close the report once an Analyst has requested approval.

If the report is approved by the Supervisor, the OFSCRR application generates an e-file in XML format after all the necessary validations. The e-file is then submitted by the OFSCRR client with the regulatory authorities. Submission to the regulator occurs outside of OFSCRR. The report can then be marked as *Submitted* in the OFSCRR application. The status of the Report changes to *Submitted*. For more information on marking reports as Submitted refer to section, *Marking Reports as Submitted*, on page 88.

After the report is submitted, an acknowledgment is received from the regulatory authorities. The report can then be marked as *Acknowledged* in the OFSCRR application. For more information on marking reports as Acknowledged refer to section, *Marking Reports as Acknowledged*, on page 90. The status of the report changes to *Acknowledged*. You can enter the Financial Intelligence Unit (FIU) Reference number into the OFSCRR application while marking a submitted report as acknowledged. The FIU Reference number is the acknowledgment number received from Financial Intelligence Unit once the report is submitted to the FIU.

If the Supervisor rejects the report after submitting for approval, then the analyst must re-work on the report and resubmit the report for approval. This process continues until the report is approved or closed. For more information on rejecting reports, refer to section, *Rejecting Reports*, on page 84.

If the Supervisor determines that a report should not be filed they can close it. If the report is closed, the report details cannot be edited and the report is in View mode. For more information on closing reports, refer to section, *Closing Reports*, on page 85.

The Supervisor can re-open a closed/acknowledged report. Analyst must then re-work on the re-opened report and submit the report for approval. This process continues until the report is approved or closed. For more information on re-opening reports, refer to section, *Re-opening Reports*, on page 86.

For more information on user roles, refer to Table 2 on page 4.

The report has a life cycle which begins with the open status and ends when it is closed/acknowledged. The report is in View mode (read only) in the following statuses:

- Closed
- Approved
- Submitted
- Acknowledged

Note: You cannot edit report details when the report is in View mode. All action buttons are hidden in View mode.

To view report details, click the report name in the RR List page.

If the report is already opened by another user, the following message is displayed: This report is currently locked by another user. You will not be able to edit/take action on the report. Do you wish to open report details in read only mode?

Searching Regulatory Reports

The Compliance Regulatory Reporting List page allows you to search the report list and details.

To search regulatory reports using search components, follow these steps:

1. Hover over the Compliance Regulatory Reporting menu and click **New Zealand STR**. The RR List page is displayed.




Figure 6. RR List Page

The moment Generate NZ STR action is taken from OFSECM, each report is assigned a filling time of 3 days. A due date is set based on the filling time. You can use this field to search for reports based on their due dates. While taking reopen action, the application will set a due-date of 3 business days. This field is configurable from the backend.

	Note: Transaction Account ID is the account number of the transaction party involved in the suspicious activity.

	Every report is associated with a jurisdiction. When an STR is created from an alert or case, the STR inherits the jurisdiction that was associated to that alert or case.
	Each user has access to a set of jurisdictions. Each STR is associated with a single jurisdiction. A user has access to any report where the user's jurisdictions intersect with the STR's jurisdiction.
FIU Reference Number	Enter the FIU reference number to display reports with the selected FIU reference number
	Note: FIU reference number is the acknowledgment number received from Financial Intelligence Unit. This information is updated in the OFSCRR application while marking the report as acknowledged and is mandatory while re-submitting a corrected/supplemental report.

4. Click **Go**. The relevant search list is displayed.

Note: If you click Reset, all search fields are set to default values (blank).

Creating Regulatory Reports in OFSCRR Application

OFSCRR supports creation of reports from OFSECM. For more information on how a report is generated from OFSECM, refer to *Creating a New Regulatory Report from OFSECM*, on page 19.

This section explains the steps involved in creation of regulatory report from OFSECM.

Creating a New Regulatory Report from OFSECM

When a user with access to Compliance Regulatory Reporting selects **Recommend NZ STR** on an Alert or Case from OFSECM, the data is passed to OFSCRR through the web service and a report is opened in the OFSCRR application.

To create regulatory reports from OFSECM, follow these steps:

- 1. Log in to the OFSECM application. and click **FCCM**.
- 2. Select Alerts from Monitoring.




Figure 7. Monitoring Tab

- 3. Click **Advanced Search**. Select **FR** (Fraud), **ML** (Money laundering), **IML** (Institutional Money Laundering) in the scenario class drop-down. Options for selecting a scenario class will depend on your current installation and user access to scenarios.
- 4. Select **AC** (Account), **CU** (Customer), and **HH** (Household) in the Focus drop-down. Options for selecting a Focus type will depend on your current installation and user access to scenarios. Select any additional desired filters, including modifying the Created From and To dates as needed.




Figure 8. Alerts Advanced Search

- 5. Click Go.
- 6. Select the required alerts from the Alert Search and List page and click **Reg Reporting** in the Action bar.




Figure 9. Alert Search and List Page

7. Select **Generate NZ STR** from the Choose Action drop-down list in the Monitoring Actions Window and enter the comments.




Figure 10. Monitoring Actions Window

- 8. Click **Save**. The following confirmation message is displayed: Would you like to save these actions?
- 9. Click **OK.** A success message is displayed along with the alert ID. Click **OK**.
- 10. Navigate to the RR list page. The latest alert on which **Generate NZ STR** action was taken is displayed in the RR List page.

Sending On-Line Acknowledgement to OFSECM from Compliance Regulatory Reporting

RR sends a positive acknowledgment to OFSECM when all the mandatory information verification is completed successfully. The following information is sent as a part of the positive acknowledgment:

- Alert/Case ID (Alert/Case ID)
- Acknowledgment Code 0 (Meaning successful)
- Report ID (System Generated)
- Report Status

In case of any errors, the OFSCRR application sends a negative acknowledgment to OFSECM. The error may be due to the following reasons:

- User ID failure
- Unsuccessful mandatory information verification
- System/Application Error

The negative acknowledgment sent to OFSECM contains the following details:

- Alert/Case ID
- Acknowledgment Code
 - 1 stands for Invalid User ID
 - 2 stands for Mandatory Information Missing
 - 3 stands for Format Failure
 - 4 stands for System/Application Error
- Error Description

Note: If an alert or case fails to successfully complete the generate NZ STR action, then the failure is recorded in the alert or case audit history.

Submitting Regulatory Reports

This process involves the following steps:

- Entering Report Details
- Submitting the Report Details for Approval/Requesting for Approval

Entering Report Details

The RR Details page allows users mapped to the role of Analyst or Supervisor to enter or update report information.

Click on the report name in the RR list page to navigate to the RR Details page.

The RR Details page displays the following:

- Report Context
- Reporting Entity Tab
- Transactions Tab
- Narrative Tab
- Audit Tab

Report Context

The Report Context container in the Compliance Regulatory Reporting (RR) Details page displays information about the report and is non-editable. It contains minimize and maximize buttons that allow you to expand and collapse the details in the Report Context. By default, the report context container is minimized.

You must enter the report details in the tabs present in the RR Details page.

The tabs in the RR Details page are explained in detail in the following sections.

Managing Reporting Entity Information

The Reporting Entity Tab page is the default page for the RR Details.




Figure 12. Reporting Entity - Edit Mode

This tab consists of data classified into the following four sections:

- Reporting Entity Information
- Reporting Entity Location
- Reporting Entity Branch
- Reporting Person

Reporting Entity Information

The Reporting Entity information section provides details about the reporting institution filing the STR. The Reporting Entity is the financial institution filing the STR.

The possible values for the Reporting Entity Identifier drop-down are determined by your institution and fetched from the static data tables. If there is only one value defined for your institution, that value is selected as the default value for the Reporting Entity Identifier. If there is more than one Reporting Entity Identifier defined for your institution; it is possible for the administrator to configure a default value for pre-selection, should there be an identifier more commonly used within your institution for filing STRs. If there is no default configured, then the blank option will be selected and it will be necessary for you to choose a value.

The following table explains the fields in the Reporting Entity Information section:

Reporting Entity Identifier	Reporting Entity Identifier is a unique number assigned by the Financial Intelligence Unit (FIU) to the reporting entity.
	Note: This data is fetched from the static data tables.
Reporting Entity Reference Number	Reporting Entity Reference number is the internal reference number of the reporting entity for the report.
	Note: This value is derived from OFSECM Alert or Case ID on which the action to generate the NZSTR was taken and is non editable.
Filing a Corrected/Amended Report	Corrected/Amended report is a term used to identify a report that was previously submitted but is being resubmitted with modifications to correct earlier provided information either with some corrections or with additional information. A corrected report must refer to the previously submitted STR by virtue of the FIU reference number of the previous STR.
	FIU reference number is the acknowledgment number received from Financial Intelligence Unit. This information is updated in the OFSCRR application while marking the report as acknowledged and is mandatory while re-submitting a corrected/amended report.
	For reports, which are in reopened status the application displays the Corrected/Amended check box selected by default. You must uncheck this check box if the report is reopened from closed status and it's not a corrected/supplemental report (not acknowledged before).

Local Currency Code	Displays the local currency code of the reporting entity.
	Note: This field is auto-populated based on the value selected for Reporting Entity Identifier and is defined by your institution. In most instances, this will be <i>NZD</i> .
FIU Reference Number	FIU Reference Number is the reference number updated while marking the report as Acknowledged.
	Note: This field is editable if the report is a Corrected/Amended Report, and is non-editable if the report is being filed for the first time or is an initial report.
	If you have marked the report as Corrected/ Amended but failed to provide the FIU Reference Number, the application displays the following message: FIU Reference Number is mandatory if Filing a Corrected/Amended Report check box is checked.
	In case, the FIU Reference number is already populated and you uncheck the Filing a Corrected/Amended Report check box this field will be non-editable and blank. You must reset to get back the value.

Reporting Entity Location

This section displays information about the location of the reporting (entity) institution filing the report. This is defined by the FIU as the location (business address) of the person making the report.

The possible values for the Reporting Entity Location drop-down list are defined by your institution and fetched from the static data tables. If in case there is only one value defined for your institution, that value is selected as the default value for Reporting Entity Location. If there is more than one Reporting Entity Location defined for your institution it is possible for the administrator to configure a default value for pre-selection, should there be a Location more commonly used within your institution for filing STRs. If there is no default configured, then the blank option will be selected and it will be necessary for you to choose a value.

All other fields in the Reporting Entity Location section will be auto-populated and non-editable based upon the selected Location.

The following table explains the fields in the Reporting Entity Location section:

Location Name	Select the location name of the reporting entity from the drop-down list.
	Note: The possible values for location name drop-down are fetched from the static data tables. In case, the table contains only one value, that value is the default value and all the other fields in this section are auto-populated as per the location name.
Address Type	Displays the address type of the reporting entity. Displays whether it is the reporting entity branch address, business address, employer address, work address, home address, and so on.
Address	Displays the complete address of the reporting entity.

Reporting Entity Branch

The Reporting Entity Branch section displays information about the branch of the entity reporting the transaction. As defined by the FIU, this may be different than the branch at which the activity being reported took place.

The possible values for the Reporting Entity Branch name drop-down list are defined by your institution and fetched from the static data tables. If in case, the table contains only one value defined for your institution, that value is the default value for Reporting Entity Branch. If there is more than one Reporting Entity Branch defined for your institution, it is possible for the administrator to configure a default value for pre-selection, should there be a Branch more commonly used within your institution for filing STRs. If there is no default configured, then the blank option will be selected and it will be necessary for you to choose a value.

Reporting Person

The Reporting Person section displays information about the individual who logs into the OFSCRR application and generates the STR XML report that is to be sent to the FIU.

This section provides details about the person whom the regulators can contact regarding the Suspicious Transaction Report. The possible values for the Reporting Person drop-down list are defined by your institution and fetched from the static data tables. By default, the current user is pre-selected. All other fields in the Reporting Person section are auto-populated and non editable based upon the selected value.

To enter details about the reporting entity, follow these steps:

- 1. Hover over the Compliance Regulatory Reporting menu and click **New Zealand STR**. The RR List page is displayed.
- 2. Click the Report Name. The RR Details page is displayed.
- 3. Click **Reporting Entity** tab. The **Reporting Entity** details are displayed.
- 4. Enter the required information.
- 5. Click **Save**. The following message is displayed: *Update Operation Successful*.
- 6. Click **OK**. The Reporting Entity details are displayed.

Note: If you click Reset, the unsaved data is reset to the last saved value in the Reporting Entity tab.

Editing Filing Institution Information

To edit details about the filing institution, follow these steps:

- Hover over the Compliance Regulatory Reporting menu and click New Zealand STR. The RR List page is displayed.
- 2. Click the Report Name. The RR Details page is displayed.
- 3. Click the **Reporting Entity** tab. The **Reporting Entity** details are displayed.
- 4. Modify the required information in the fields in the **Reporting Entity** tab.
- 5. Click Save. The following message is displayed: Update Operation Successful.
- 6. Click **OK**. The Reporting Entity details are displayed.

Note: If you click **Reset**, the unsaved data is reset to the last saved value in the Reporting Entity tab. If you have made no edits to information on this page and no modifications to the default selections in the drop-down lists on this page; the default values will be considered to be *Saved* values and will be the information included in the XML.

You cannot edit the report details when the report is in View mode. Action buttons, such as Save and Reset, are hidden in the Reporting Entity tab when the report is in View mode.

If you click **Approve/Request for Approval**, the application verifies whether all the mandatory information is entered in the Reporting Entity tab.

Submitting Regulatory Reports Chapter 3–Managing OFSRR

If any of the mandatory details are missing, the application warns you with the following error messages.

- 1. If you click **Request for Approval/Approve** button with **Reporting Entity Identifier** as blank, the following error message is displayed: Reporting Entity Identifier is missing from the Reporting Entity Tab. Please enter it.
- 2. If you click **Request for Approval/Approve** button with **Reporting Entity Branch** as blank, the following error message is displayed: Reporting Entity Branch is missing from the Reporting Entity Tab. Please enter it.
- 3. If you click **Request for Approval/Approve** button with **Reporting Person** as blank, the following error message is displayed. Reporting Person is missing from the Reporting Entity Tab. Please enter it.

Managing Transactions

The Transaction tab in the RR Details page displays all involved transactions and their details as received from OFSECM or added directly to the STR that are specific to the current report. The application allows you to add, update, or delete only one transaction at a time.

The Transactions tab displays the following sections:

- **Transaction Details** Transaction Details captures specific information related to the transaction such as unique transaction identifiers, date of transaction, and amount.
- Sending Funds Information (From) The Sending Funds Information section supports information related to the origination of the transaction, to include type of funds (such as cash, bank draft) as well as information on involvement of foreign currency.
- Transaction Party Sending This is the sender of funds. This can be an account or person who may or may not be a client of the filing institution. As the application supports only bi-party transactions there can be only one sending party reported.
 - Conductor A Conductor is any third party who is not directly the source of the funds but who is acting on behalf of the sending party. A Conductor will only be associated with the sending side of the transaction for the purpose of filing an STR.
- Receiving Funds Information (To) The Receiving Funds Information section supports information related to the beneficiary of the transaction, to include type of funds (such as cash, bank draft) as well as information on involvement of foreign currency.
 - Transaction Party Receiving This is the recipient of the funds. As with Transaction Party Sending this can be an account or person who may or may not be a client of the filing institution. As the application supports only bi-party transactions there can be only one receiving party reported.
- Goods and Services This section is optional depending on the nature of the transaction being reported.
 This section is used to report goods or services associated with the report. This is most often relevant for Suspicious Property Reports (SPRs), but in certain instances, goods and services should be reported in a STR or other report. As an example, the sale or purchase of securities such as stocks and bonds should be reported using this section.




Figure 14. Transactions Tab

Adding Transactions

By default, the application displays only the Transactions grid when you first navigate to the Transactions tab. To view the transaction details, either select the check box at the beginning of a transaction row or click anywhere in the row. The selected record gets highlighted and the details of that particular transaction display below the transaction grid.

Note: The Transactions grid displays only four transactions per page. You can use the paging controls to move to additional transactions pages as needed.

The Transactions grid displays the following columns:

- Record
- Transaction number
- Transaction date
- Transaction method
- Transaction conduction type
- Transaction amount

Note: The Record value is a system generated number to help distinguish the unique transaction to the user in validation messages. It is not a field that will be available for adding or editing a transaction record.

For more information on the columns in the Transactions grid, refer to Table 9 on page 33.

To add transactions to the report, follow these steps:

- 1. Hover over the Compliance Regulatory Reporting menu and click **New Zealand STR**. The RR List page is displayed.
- 2. Click the Report Name. The RR Details page is displayed.
- 3. Navigate to the Transactions tab.
- 4. Click **Add** in the Transactions grid. The Add Transaction window is displayed.

5. Enter the required information in the Add Transaction window.

The following table provides details about the fields in the Add Transaction window.

Transaction Number	Enter the transaction number. Transaction number is a unique transaction number associated with a particular transaction. This is a mandatory field and the data is auto-populated from OFSECM or can be user editable. Internal Reference Number	Enter the internal reference number. Transaction Conduction Type Other	If the Transaction conduction type is anything other than the options provided in the Transaction Conduction Type drop-down list, you must select Other and provide a description of the transaction type in this field. Transaction Location Lookup	The Transaction Location Lookup allows you to search for the business name of the branch or location where this specific transaction occurred by using internal branch and location identifiers. To find an internal branch to report as location, enter a branch code and click You may also enter branch information directly into the Transaction Location text field. Enter a branch location code and click on lookup or The application searches for the static data and confirms if the code is correct and populates the entered code's branch name in the Location field. If the entered code is invalid or cannot be found, the application will return a message that the code does not exist.
Transaction Location	Enter the branch or location where this specific transaction took place. This should be the full, official name of the branch with no abbreviations. This data is auto-populated from OFSECM or can be user editable. If you elect to use the Transaction Branch Lookup, upon successful validation of the entered code, this field will be populated from the static data.
Transaction Description	Enter a brief description or the purpose of the transaction. You are limited to 4000 characters or less for the description.

- 6. Click **Save**. The following message is displayed: Add operation successful.
- 7. Click **OK**. The Add Transaction window resets and you can capture a new transaction.

Deleting Transactions

To delete a transaction, follow these steps:

- 1. Navigate to the **Transactions** tab of the report. The list of transactions associated with the record is displayed in the Transactions grid.
- 2. Select the check box of the transaction record you want to delete.
- 3. Click Remove. The following message is displayed: Are you sure you mant to delete this record.
- 4. Click **OK**. The following message is displayed: Delete operation successful.
- 5. Click **OK**. The application refreshes and displays the Transactions grid.

Note: The Validate button in the Transactions grid checks for any missing or incomplete transaction information. The Validate button on the grid will validate all of the information related to the transaction details as well as the child records of the transaction (Sending/Receiving etc). If any part of the transaction or its children are missing any information, you will be directed to select that transaction (identified by the record number in the grid) and perform additional validations for each section to find the error.

Transaction Details

To view the details of transactions, click anywhere on a transaction row. The details of the transaction will appear below the grid along with all associated transaction fund and party information. You can edit information about the transaction in the Transaction Details section.

For more information on the fields in the Transaction Details section, refer to Table 9 on page 33.

Sending Funds Information (From)

The application supports only bi-party transactions. Bi-party transactions are composed of a source and destination. The source and destination can be either a person or account.

The Sending Funds Information (From) section reports the origin of the funds/transaction. This is the sender of funds or the party who is sending the funds. In addition, this section describes the type of funds used (for example, cash, bank draft, and so on) as well as information on use of foreign currency.

Since the application support only bi- party transactions, a reported transaction can have only one sending party information.

The Sending Party Information (From) contains two sub-sections, namely:

- Transaction Party Sending
- Conductor

The following table explains the fields in the Sending Funds Information (From) section:

From Funds Code Comment	If the From Funds Code is anything other than the options provided in the From Funds Code drop-down list, you must select Other and provide a description of the fund in this field. This field is mandatory if From Funds Code is other.

From Foreign Currency Code	Select the type of foreign currency involved in the transaction from the drop-down list, if applicable.

Transaction Party Sending

The Transaction Party Sending section allows you to enter information about the party responsible for originating the transaction.

- If a *person/individual* is the sender of the funds, add the person details in the Transaction Party Sending section. Use the classification of **person** when there is no specific account information available.
- If an account is the sender of the funds, add the account details in the Transaction Party Sending section. Use
 the classification of account when the primary identification for the party includes account specific
 information, such as an account identifier.

The classification of the party as account or person determines what information must be reported when filing the report.

Parties will be further classified as a client of the filing institution (**person my client** or **account my client**) or an external party (**person** or **account**). For parties that are considered to be clients of the filing institution there is a greater expectation that information is available and thus more fields will be considered mandatory for filing.

In addition, a transaction can also have a *conductor* apart from the source and the destination. A conductor is a third-party who is not the source of the funds, but is acting on behalf of the sending party. A conductor will only be associated with the sending side of the transaction and will inherit the Transaction Party Sending classification with respect to being considered *my client* or not.

Adding Person Information

The application allows you to add a new Transaction Party - Sending if there is no other party present. If a transaction already has a transaction party sending present, the application disables the add button, and thus stops you from adding another transaction party sending.

The person/individual who is the sender of the funds can either be a client of the reporting entity or not. If the sender (person) is a client of the reporting entity, then the party is classified as **person my client.** If the sender (person) is not a client of the reporting entity, then the party is classified as **person.**

To add person information, follow these steps:

- 1. Navigate to the **Transactions** tab of the report. The list of transactions associated with the record displays in the Transactions grid.
- 2. Select the check box of the transaction record to view the transaction details.
- 3. Click **Add Person** in the Transaction Party Sending grid. The Transaction Party Information Person page is displayed.
- 4. Select the Transaction Party Classification.

Note: Select **person my client** if the sender of the funds is a client of the reporting entity. Select **person** if the sender is not a client of the reporting entity.

- 5. Enter the required information in the Transaction Party Information Person page.
- 6. Click **Save**. The following message is displayed: *Update Operation Successful*.
- 7. Click **OK**. The person details are saved.

The Transaction Party Information – Person page comprises the following sections:

- Transaction Party Classification
- Party Details

- Phone
- Address
- Email
- Identification
- Employer Details

The Save button in the Transaction Party Information – Person page saves any details entered in this page.

The **Validate** button in the Transaction Party Information – Person page provides details about any missing information in the Transaction Party Information – Person page. When clicked, it will provide information about missing mandatory information that is required for filing with a party type of person or person my client. You can validate until there are no longer messages informing you of missing information.

If you click **Reset**, the unsaved data is reset to the last saved value in the Transaction Party Information – Person page.

The **Back** button in the Transaction Party Information – Person page allows you to navigate back to the Transactions tab.

Transaction Party Classification

The person/individual who is the sender of the funds can either be or not be a client of the reporting entity. If the sender (person) is a client of the reporting entity, then the party is classified as **Person My Client**. If the sender (person) is not a client of the reporting entity, then the party is classified as **Person**.

Select **Person My Client** if the sender of the funds is a client of the reporting entity. Select **person** if the sender is not a client of the reporting entity. This selection will allow the application to properly validate that the information entered for the report meets mandatory reporting requirements which vary based upon classification as my client versus not my client.

If the transaction party Classification is **Person my client**, the fields First Name, Last Name, and Country of Primary Residence are mandatory in the Party Details section. If the transaction party Classification is **Person**, only the fields First Name and Last Name are mandatory in the Party Details section.




Figure 16. Transaction Party Sending Person




Figure 17. Transaction Party Sending - Person My Client

Note: You will not be allowed to enter employer information before entering and saving Person Details.

Adding Account Information

If an account is the sender of the funds, add the account details in the Transaction Party Sending section.

The account which is the sender of the funds can either be or not be a client of the reporting entity. If the account involved is a client of the reporting entity, then the party is classified as **Account my client (account internal)**. If the account is not a client of the reporting entity, then the party is classified as **Account (account external)**.

If the primary account holder of the account sending the funds is an individual, the party is classified as **Individual**, and if the primary account holder of the account involved in sending the funds is a legal entity such as a corporation or another financial institution, the party is classified as **Entity**.

The classification as Entity or Individual is important as it allows the application to properly validate the information entered in the report. The FIU has different requirements for mandatory information when the party on the report is an individual versus a legal entity.




Figure 18. Account Page




Figure 19. Account My Client Page

The **Save** button in the Transaction Party Information – Account page saves any details entered in this page.

The **Validate** button in the Transaction Party Information – Account page provides details about any missing information in the Transaction Party Information – Account page. When clicked, it will provide information about missing mandatory information that is required for filing with a party type of account or account my client. You can validate as often as it takes until there are no longer messages informing you of missing information.

If you click **Reset**, the unsaved data is reset to the last saved value in the Transaction Party Information – Person page.

The **Back** button in the Transaction Party Information – Account page allows you to navigate to the Transactions tab.

Transaction Party Classification

The account sending the funds can either be a client of the reporting entity or not. If the account sending the funds is a client of the reporting entity, then the party is classified as **Account my client (account internal)**. In these instances, the Reporting Entity will have additional information regarding the account, and hence more fields are marked mandatory in Account Details section. If the primary account holder of the account sending the funds is an individual, then the Entity Details are hidden in the Transaction Party Information - Account page. Entity information is only applicable if the account being reported is an account associated with a legal entity such as a business or other organization.

Mandatory requirements are enforced only if any part of Entity Details is entered. Phone, Address and Director details for an Entity are mandatory if held. Mandatory requirements for Address, Phone and Director details are only enforced if any part of address, phone or director information is entered.

To add entity information, follow these steps:

The Signatory grid will list all the signatories of an account in a grid.

This section provides the signatory details of the account. This section lists all the signatories of an account.

An account signatory is a trusted person who has signatory rights in business or corporate offshore bank account. An offshore bank account signatory is entitled to execute wire transfers, sign cheques, and make other payments from the offshore bank account.

Signatory will defined as Person my client if the Account is classified as Account my Client. For external accounts, Signatory will be Person type.

Signatory is mandatory for Account My Client. The Phone, Address, Email, Identification and Employer Details for a Signatory are mandatory if held regardless of account type. Mandatory requirements for each information type will only be enforced if some part of that information is entered. For Accounts my client, at least one signatory must be present. However, it is not mandatory that any one of the signatories must be primary.

For Accounts, signatory is not mandatory.

To add signatory details, follow these steps:

- 1. Navigate to the **Transactions** tab of the report. The list of transactions associated with the record is displayed in the Transactions grid.
- 2. Select the check box of the transaction record to view the transaction details.
- 3. Click **Details** in the Transaction Party Sending grid. The Transaction Party Information Account page is displayed.
- Click Add in the Signatory grid. The Signatory Details window is displayed.




Figure 20. Signatory Details Window




Figure 21. Signatory Grid Displaying Signatory Details

The **Validate** button in the Signatory Details section provides details about any missing information in the Transaction Party Information – Person page. When clicked, it will provide information about missing mandatory information that is required for filing with a party type of person or person my client. You can validate until there are no longer messages informing you of missing information.

You cannot edit the details in the Signatory grid. You can edit the Signatory details only in the Signatory details section by selecting a signatory from the grid.

Mandatory requirements for completion of Signatory address, phone, identification, email, and employer information is only enforced if any part address, phone, identification, email, and employer information is entered.

The phone grid in the Signatory details section allows you to add signatory phone details. You will not be allowed to enter signatory phone information before entering and saving signatory Details. For more information on the steps to add, edit, or modify phone details, refer to section *Adding Person Phone Details*, on page 42.

Signatory Address Details

The Address grid in the Signatory details section allows you to add signatory address details. You will not be allowed to enter signatory address information before entering and saving signatory Details. For more information on the steps to add, edit, or modify address details, refer to section *Adding Person Address Details*, on page 43.

Signatory Email Details

The Email grid in the Signatory details section allows you to add signatory email details. You will not be allowed to enter signatory email information before entering and saving signatory Details. For more information on the steps to add, edit, or modify email details, refer to section *Adding Person Email Details*, on page 45.

Signatory Identification Details

The Identification grid in the Signatory details section allows you to add signatory identification details. You will not be allowed to enter signatory identification information before entering and saving signatory Details. For more information on the steps to add, edit, or modify identification details, refer to section *Adding Person Identification Details*, on page 46.

Signatory Employer Details

The Employer details grid in the Signatory details section allows you to add signatory employer details. You will not be allowed to enter signatory employer information before entering and saving signatory Details. For more information on the steps to add, edit, or modify employer details, refer to section *Adding Employer Details*, on page 47.

Adding Existing Party

Often the transactions which are part of the suspicious behavior for which the report is being filed are related and may have common parties. For example, there may be five transactions included in a single report. Each transaction must be reported individually within the report XML. However, each transaction may involve the same two parties. Once you have added and edited information about a party, such as their address and phone, it is much easier to copy that information to the next transaction rather than having to reenter that information.

The application allows you to copy the details of an existing party of the report to another transaction within the same report. In other words, if you want to add a transaction party to a transaction, where the party already exists as a Transaction Party on another or same transaction of the report, you can use the Add Existing Party button to copy the details.

To add existing party, follow these steps:

- 1. Navigate to the **Transactions** tab of the report. The list of transactions associated with the record is displayed in the Transactions grid.
- 2. Select the check box of the transaction record to view the transaction details.
- 3. Click **Add Existing party** in the Transaction Party Sending grid. The Existing Transaction Party window is displayed and lists the parties currently associated with the current report.

Note: The Existing Transaction Party window displays only distinct existing transaction parties.




Figure 22. Existing Transaction Party Window

4. Select the check box of the transaction party you want to add.

Note: You can add only one existing party.

- 5. Click Add Party. The following message is displayed: Update Operation Successful.
- 6. Click **OK**.

Click **Close** in the Existing Transaction Party window. The Transaction page refreshes to reflect the newly added party.

Adding Conductor Details

The Conductor section provides details about the conductor of the transaction. A Conductor is a person who has conducted the transaction from the sender's side.

You can add only one conductor for transaction party sending. The Add button in the Conductor section is enabled only when the transaction sending party has no existing conductors.

The Details button in the conductor section provides details of the conductor.

The Conductor must be of the same person classification as the Transaction party sending. While adding conductor details, the application derives the conductor type classification from the sending party type. If the Transaction party sending classification is Person_my_client or Account_my_client then the Conductor type will be Person_my_client. If the Transaction party sending is classified as Account/ Person the Conductor will be Person.

The default person classification for conductors is same as that of Transaction party sending. (Internal if Transaction Party sending is Internal and External if Transaction Party sending is external).

If the conductor is added when sending party information is not present, then the application will define the conductor type with default value, that is, External (person). Once the Transaction Party Sending gets added the Conductor Party will be updated by the application to make it in sync with Transaction Party Sending.

Conductor information is mandatory if held. Mandatory requirements for completion of information will only be enforced if any part of conductor information is reported. A conductor will automatically be defined as the same type (my client/not my client) as the Sending Party.

To add Conductor details, follow these steps:

- 1. Navigate to the Transactions tab of the report. The list of transactions associated with the record is displayed in the Transactions grid.
- 2. Select the check box of the transaction record to view the transaction details.
- 3. Click Add in Conductor grid. The Transaction Party Information -Conductor page is displayed.




Figure 23. Transaction Party Information -Conductor Page

- 4. Enter the required information in the Transaction Party Information Conductor page.
- 5. Click **Save**. The following message is displayed: *Update Operation Successful*.

The Save button in the Transaction Party Information – Conductor page saves any details entered in this page.

The Validate button in the Transaction Party Information – Conductor page provides details about any missing information in the Transaction Party Information – Conductor page. When clicked, it will provide information about missing mandatory information that is required for filing the report. You can validate as often as it takes until there are no longer messages informing you of missing information.

If you click **Reset**, the unsaved data is reset to the last saved value in the Transaction Party Information – Conductor page and click **Back** to navigate to the Transactions tab.

Conductor Address Details

The Address grid in the Transaction Party Information – Conductor page allows you to add conductor address details. You will not be allowed to enter conductor address information before entering and saving conductor Details. For more information on the steps to add, edit, or modify address details, refer to section *Adding Person Address Details*, on page 43.

Conductor Email Details

The Email grid in the Transaction Party Information – Conductor page allows you to add conductor email details. You will not be allowed to enter conductor email information before entering and saving conductor Details. For more information on the steps to add, edit, or modify email details, refer to section *Adding Person Email Details*, on page 45.

Conductor Identification Details

The Identification grid in the Transaction Party Information – Conductor page allows you to add conductor identification details. You will not be allowed to enter conductor identification information before entering and saving conductor Details. For more information on the steps to add, edit, or modify identification details, refer to section *Adding Person Identification Details*, on page 46.

Conductor Employer Details

The Employer details grid in the Transaction Party Information – Conductor page allows you to add conductor employer details. You will not be allowed to enter conductor employer information before entering and saving conductor Details. For more information on the steps to add, edit, or modify employer details, refer to section *Adding Employer Details*, on page 47.

Receiving Funds Information (To)

The Receiving Funds Information (To) section reports the destination of the funds/transaction. This is the receiver of funds or the party who is receiving the funds.

Since the application support only bi-party transactions, any transaction can have only one Receiving Party (To) information.

The Receiving Funds Information (To) section contains the Transaction Party – Receiving section.

The Sending Funds Information (From) and Receiving Funds Information (To) sections have the same functionality. The only difference between these two sections is that the Receiving Funds Information (To) section will not have a subsection for Conductor information in the application. If there is a conductor on the receiving side of a transaction, the conductor details must be updated in the Reason for Suspicion field in the Narrative tab.

For more information on the field descriptions in Receiving Funds Information (To) section, refer to section *Sending Funds Information (From)*, on page 36.

For more information on Transaction Party – Receiving and for information on adding person, account, or existing party in Transaction Party – Receiving section, refer to section *Transaction Party Sending*, on page 38.

Managing Goods and Services

This section is optional depending on the nature of the transaction being reported. This section is used to report goods or services associated with the report. This is most often relevant for Suspicious Property Reports (SPRs), but in certain instances, goods and services should be reported in a STR or other report. As an example, the sale or purchase of securities such as stocks and bonds should be reported using this section.

Click the **Details** button in the Goods and services grid to view the details of the record in the Goods and Services pop-up.

Adding Goods and Services

To add Goods and services, follow these steps:

- 1. Navigate to the **Transactions** tab of the report. The list of transactions associated with the record is displayed in the Transactions grid.
- 2. Select the check box of the transaction record to view the transaction details.
- 3. Click **Add** in the Goods and Services grid. The Goods and Services window is displayed.




Figure 24. Goods and Services Window

Managing Narrative

The Narrative tab enables the investigator to enter detailed, free-form information about the suspicious activity being reported as well as actions which may have been taken by the institution in response to the activity. It also provides a means for the investigator to categorize the suspicious activity using Reporting Indicators as defined by the FIU.

This tab allows you to enter the following details:

Reason for Suspicion: This field is used to report the grounds for suspicion for submitting the report. This
information is initially populated from the comments provided in the Narrative tab of OFSECM, and is
editable. This field can also be completely blank for you to enter the details. This mainly depends on the
configuration applied during OFSCRR installation.

Note:

The Reason for Suspicion text box in narrative tab allows entering a maximum of 4000 characters. As you begin entering the comments, the word count displayed below the reason for suspicion text box keeps decreasing. If you try to enter more than 4000 characters in this field, the following error message is displayed: *Number of characters exceeded*.

- If you click request for approval/approve button and if the reason for suspicion missing in the Narrative tab, the application displays the following message: Reason for Suspicion in the Narratives tab is mandatory. Please enter it.
- Action Taken: This section provides information related to any actions taken by the reporting institution regarding the event mentioned in the report. This field allows an entry of maximum 4000. As with the Reason for Suspicion section, there is a counter provided to help you keep track of the numbers of characters used.
- Reporting Indicators: The application categorizes different reporting indicators into sections. You must select the applicable indicators from this list. There are different indicators in the list like Suspicion Identified By, Suspected Offending, and so on. You can select more than one of the check boxes in this section. As defined by the FIU the different Reporting Indicator categories are:
 - Suspicion Identified By: Select values in this section that reflect how the suspicion was identified.
 - **Entity or Entities Appear on OFAC or Other List:** Select values in this section if any one reported entity appears on OFAC or Other lists or involves PEPs.
 - **Note:** OFAC stands for Office of Foreign Asset Control. OFAC is a department of the U.S. Treasury that enforces economic and trade sanctions against countries and groups of individuals involved in terrorism, narcotics and other disreputable activities.
 - **Suspected Typology:** Select values in this section if the suspicious activity is believed to involve money laundering or terrorist financing type activities.
 - Suspected Offending: Select values in this section where applicable, to define the type of legal offense suspected of taking place.
 - Sub Agent or Master Agent May Submit Additional Reporting: Select the value in this category if a sub-agent or master agent may submit an additional report on the same transaction or suspicious occurrence as is being reported in the current STR.
 - Sector Supervisor: Select a value to indicate your Reporting Entity's sector supervisor (DIA: Department of Internal Affairs; FMA: Financial Markets Authority; RMNZ: Reserve Bank of New Zealand).
 - Additional Information: Select values that indicate what type of additional information is being reported in the Reason for Suspicion narrative.

Updating Narrative

To update the Narrative tab, follow these steps:

- 1. Hover over THE Compliance Regulatory Reporting menu and click **New Zealand STR**. The RR List page is displayed.
- 2. Click the Report name in the RR list page. The RR Details is displayed.
- 3. Click the Narrative tab. The Narrative details are displayed.
- 4. Enter the required information in the Narrative tab.
- 5. Click Save. The following message is displayed: Update Operation Successful.
- 6. Click **OK**. The narrative details are saved.

Note: Click **Reset** to clear the changes made in the Narrative tab. The page refreshes to display the last saved data.

You cannot edit the report details when the report is in View mode. Action buttons, such as Save and Reset, are hidden in the Narrative tab when the report is in View mode.




Figure 27. Audit Tab

Submitting the Report Details for Approval/Requesting for Approval

After updating the report details, they must be validated. The RR Details page allows users mapped to the role of Analyst to submit a report for approval. When the Analyst submits the report for approval the application will validate that the mandatory fields within the report have been populated. The Supervisor can review the report details and can either Approve, Close, or Reject the report.

An Analyst can initiate Request for Approval action, only when the report is in Open, Re-open, and Rejected status. To submit a report for approval, follow these steps:

- 1. Hover over the Compliance Regulatory Reporting menu and click **New Zealand STR**. The RR List page is displayed.
- 2. Click the Report Name. The RR Details page is displayed.

If you try to Approve or Request for Approval a report with no transaction information entered for the report, the application displays the following message: You are trying to Approve/ Request for Approval without any transaction information. Report should have at least one transaction.

To approve a report, follow these steps:




Figure 29. Approve Action Pop-up Window

Rejecting Reports

The RR Details page allows users mapped to the role of Supervisor to reject reports from filing. A supervisor may choose to reject a report for incomplete or inaccurate information, or additional investigation may be required of the analyst. A user can reject report when the report is in Approved or Request for Approval status. If a report is rejected, then you must re-work on the report and again submit the report for approval. This process continues until the report is approved or closed.

To reject a report, follow these steps:

- Hover over the Compliance Regulatory Reporting menu and click New Zealand STR. The RR List page is displayed.
- 2. Click the Report Name. The RR Details page is displayed.
- 3. Click **Reject**. The Reject Action pop-up window is displayed.




Figure 30. Reject Action Pop-up Window

Closing Reports

If Supervisor determines that an STR report should not be filed they can close it.

A Supervisor can close a report if for any reason, it is determined that the STR no longer needs to be filed. This may be because of late arriving information to the investigation or other subsequent events that eliminate the need for reporting the activity.

A Supervisor can initiate close action when the report is in Open, Request for approval, Approved, Rejected, and Re-open status.

Once the report is closed, you cannot edit the report details and the report is in View mode.

To close a report, follow these steps:




Figure 31. Close Action Pop-up Window




Figure 33. Re-open Reports Window

When you reopen an acknowledged report, the submission notes entered while submitting the report gets deleted.

Marking Reports as Submitted

Once the report is approved, it must be filed with the Regulatory authorities.

The OFSCRR application does not support the process of uploading and filing of approved reports to the regulatory authorities. This is a process that will occur outside of the application. However, for tracking and reporting purposes, the application allows you to mark the reports that are filed with the regulatory authorities as Submitted once the STR XML has been uploaded to the FIU, or whenever is defined as appropriate per your institution's business practices. In addition, the application also allows you to update the acknowledgment details received from the regulatory authorities after the reports have been submitted to the Regulatory authorities. When the report is submitted, the due date gets deleted.

Users mapped to the role of Analyst/Supervisor can mark the reports filed with the regulatory authorities as submitted. An Analyst/Supervisor can mark the report as submitted only when the report is in *Approved* status.

If you select records from RR List page which are not in Approved status and click on Submitted button, the application displays the following message: Some reports are not in Approved status. Submitted action can only be taken on Approved reports. Please deselect those reports and try again.

The RR Details page/RR List page allows Supervisor/Analyst to submit approved reports.

To mark a report as submitted from the RR Details page, follow these steps:




Figure 34. Mark as Submitted Pop-up Window




Figure 36. Mark as Acknowledged Pop-up Window




Figure 37. Acknowledged Window

If the user ID sent from RR does not exist in OFSECM, then the default ECM user is marked against the RR action.

Exporting Report Details to Excel

The RR List page allows you to export the report list into an Excel template.

To export the report details into an Excel template, follow these steps:

- Hover over the Compliance Regulatory Reporting menu and click New Zealand STR. The RR List page is displayed.
- 2. Click **Export to Excel**. The Export Properties dialog box is displayed.

All the reports in the RR List page are exported into an Excel template. You cannot export individual reports into Excel.




Figure 38. Export Properties Dialog Box

- 3. Set Document Type as **Excel** and select Form Data/Grid Data as **Grid** Data.
- 4. Click **Export** in the Export Properties dialog box.

When processing is complete, the data is displayed in an IE window with a dialog box.




Figure 39. File Download Box (Export)

- 5. Click **Save** from the dialog box. The Save As dialog box is displayed.
- 6. Select a directory location where you want to save the file.
- 7. Enter a new name in the File Name field or the application automatically generates a name for the file to accept.
- 8. Click Save.

The application saves your file to the specified location.

Note: Open the file in Microsoft Excel to edit as needed.

Viewing E-file

The RR List page allows users mapped to the role of Analyst and Supervisor to view the generated e-file. The application generates an e-file once the report is approved by the Supervisor.

To view e-file, follow these steps:

- 1. Hover over the Compliance Regulatory Reporting menu and click New Zealand STR. The RR List page is displayed.
- 2. Click the icon in the E-file column of the RR List page. The File Download box is displayed.

Adding Comments to Report

The Regulatory Report Details page allows users mapped to the role of Analyst and Supervisor to add comments to a report. You can add comments to a report when the report is in any status.

To add comments to a report, follow these steps:

- 1. Hover over the Compliance Regulatory Reporting menu and click New Zealand STR. The RR List page is displayed.
- 2. Click the Report name to view the report details.
- 3. Click **Add Comments**. The Action pop-up window is displayed.

4. Enter the comments in the Action pop-up window.

The comments box in the Action pop-up window allows entering a maximum of 255 characters. As you begin entering the comments, the word count displayed below the comments box keeps decreasing. If you try to enter more than 255 characters in the Comments box, the following error message is displayed: *Number of characters exceeded*.

If you click **Save**, without entering the comments in the Action pop-up window, the following error message is displayed: *Mandatory fields are not entered*.

- 5. Click **Save**. The following message is displayed: *Add Operation Successful*.
- 6. Click **OK**. The Action pop-up window closes and displays the RR Details page.

The Comments grid in the Audit tab displays the comments added to the report.
