This release of OFS CRR is cumulative of enhancements and bug fixes since the 8.1.2.0.0 release. It is compatible with the 8.1.2.0.0 release of Oracle Financial Services Enterprise Case Management (OFS ECM).

New Features

The following is the list of new features included in this release:

- USSAR New search filters- Filing Type, Assigned To, Status (added Accepted, Acknowledgment Accepted with Warnings, and Acknowledgment Rejected statuses) to search reports.
- USSAR Report statuses are updated based on the Acknowledgment/Message XML received from FinCEN upon uploading Acknowledgment
- USSAR Views option to search reports
- USSAR Reassigning reports to another user
- USSAR Set Due Date for Reports
- USSAR New search filters in the E-File Search E-File name and E-File Status

34190301	USSAR lookback period- The Approved tab parameter is missing the lookback period in days in the appln_parameters table.
34188429	When an E-File is generated, the duplicate values are displayed.
34188328	The upload Acknowledgement button disappears after the Upload Acknowledgement action is taken.
34188316	The Approved By search filter is not working in the Approved tab.
34188177	In Subject Tab, the Address Unknown checkbox is not working, and validation fails.
34185415	When you select a few reports to generate an E-File in the Approve Tab, it displays all reports in the list instead of only those reports.
34185384	E-File Generated From Date validation is failing after taking Acknowledgment action.
34183740	View details data are displayed instead of View name in the Views drop-down on the Search and List page.
34093083	The due date indicator color remains green for the expired due date. It must be red for expired due dates.
34093068	"Oracle. All rights reserved" is displayed in the reports list on the Search and List page. It must be displayed at the bottom right of the page.
34093051	When the user takes Assigned To action on the Search and List page, the validation of Created Date from and Created Date To fails.
34093043	Not able to reassign a report to another user.
34052136	When a user takes Reassign action (Assigned To) for multiple users, it must search with 'or' condition, but it searches with 'or' condition in current behavior.
34047762	In the Type of Filing drop-down in the Search and List page, only Initial report & Correct/Amend prior report types are

	displayed. The Continuing Activity Report & Joint Report type is missing.
34024469	Validation of Financial Institution Where Activity Occurred Tab is not working.
34024319	On the Create New Report window, when a user selects assign value and clicks Save. The incorrect validation message is displayed "SQL Exception Occurred".
34001350	Branch details are not added when a user tries to clear and save new branch details in the Fin Inst Where Activity Occurred tab.
34001172	The upload Acknowledgement button is disabled when the Mode of Submission is 'M', which is not according to the SDTM rule.
