Oracle Financial Services (OFS) Compliance Regulatory Reporting (CRR) Pack is a separately licensed product.

Description

Release ID 37344204 – OFS CRR 8.1.2.0.0 MINOR RELEASE #9 (8.1.2.9.0).

This release of OFS CRR is a cumulation of enhancements and bug fixes since the 8.1.2.8.0 release. It is compatible with the 8.1.2.9.0 release of Oracle Financial Services Enterprise Case Management (OFS ECM).

Prerequisites

Before applying OFS CRR v8.1.2.9.0, it is required to install OFS CRR v8.1.2.0.0. For detailed instructions on installing this OFSCRR Release, see [OFSCRR Application Pack Installation Guide 8.1.2.0.0](#).

You must follow the additional set of prerequisites accordingly using MOS:

- If the environment has BD 8.1.2.8.x and CRR 8.1.2.8.x version installed, for the upgrade from any CRR 8.1.2.8.x version to CRR 8.1.2.9.0, the patch CRR 8.1.2.8.1 (37073503) and CRR patch 8.1.2.8.2 (37079344) are mandatory to be installed, in the same order of mention, before applying CRR 8.1.2.9.0.
- If the environment is having BD 8.1.2.x. and CRR 8.1.2.x version installed, for the upgrade from any CRR 8.1.2.x version (except CRR 8.1.2.8.x) to CRR 8.1.2.9.0, the patch CRR 8.1.2.0.2 (37529329) and patch CRR 8.1.2.0.3 (37529337) are mandatory to be installed, in the same order of mention, before applying CRR 8.1.2.9.0.
- If the environment has CRR 8.1.2.8.x version installed without BD application present, for the upgrade from any CRR 8.1.2.8.x version to CRR 8.1.2.9.0, the patch CRR 8.1.2.8.1 (37073503) and CRR patch 8.1.2.8.2 (37079344) are mandatory to be installed, in the same order of mention, before applying CRR 8.1.2.9.0.
- If the environment is having CRR 8.1.2.x version installed without BD application present, for the upgrade from any CRR 8.1.2.x version (except CRR 8.1.2.8.x) to CRR 8.1.2.9.0 the patch CRR 8.1.2.0.4 (37635174), patch CRR 8.1.2.0.5 (37637396), CRR 8.1.2.0.2 (37529329) and patch CRR 8.1.2.0.3 (37529337) are mandatory to be installed, in the same order of mention, before applying CRR 8.1.2.9.0.
