## 1.1 Who Should Use This Guide

The *Oracle Financial Services Compliance Regulatory Reporting User Guide US SAR* is designed for use by various users. Their roles and responsibilities, as they operate within the *Oracle Financial Services Compliance Regulatory Reporting* application, include the following:

- **Analyst:** This user can view, create, and edit report details. An Analyst can request reports for approval, close reports, add comments to the report, and view the final PDF.
- **Supervisor:** This user can view, create, and edit report details. The Supervisor is responsible for taking action on the reports submitted by the Analyst, such as approve, reject, re-approve, or close reports. This user can also add comments to the report and view the final PDF.
- **Super User:** This user can create, update, approve, reject, re-approve, and close reports. The Super User can also generate e-file and file the reports with the regulatory bodies. This user can also perform all the tasks performed by an Analyst.
- **Auditor:** This user can add comments, generate a draft PDF, and view the final PDF.
- **RR Admin:** This user handles various configurations required to support the reporting workflow. For more information on administration activities, see [Administration Guide](#).

US SAR stands for the United States Suspicious Activity Report. As a part of regulations and compliances, a Financial Services Organization has to perform appropriate analysis and report any suspicious activities that may lead to fraud and money laundering to the regulatory authorities. These regulatory bodies are responsible for safeguarding financial institutions and consumers from abuse, providing transparency in the country's financial system, enhancing that country's security, and deterring and detecting criminal activity in the financial system.

Financial institutions are required to provide data regarding suspicious activities to their geographic region's regulatory authority that is Financial Crimes Enforcement Network (FinCEN) in the US. This data is delivered to the FinCEN through regulatory reports. These reports, depending on the regulatory geographic region, can be delivered in a paper format or in an electronic format.

### 2.2 About CRR Application

The *Oracle Financial Services Compliance Regulatory Reporting (OFS CRR)* application supports the management, delivery, and resolution of regulatory reports across multiple geographic regions and across multiple financial lines of business. As there are several differences in requirements for paper-based formats versus electronic formats between different geographic regions, and the data elements that are required on these reports. The approach to satisfy the end goal is to provide a Compliance Regulatory Reporting framework that is configured to support paper-based and electronic formats for different geographic regions and to generate and file different types of reports.

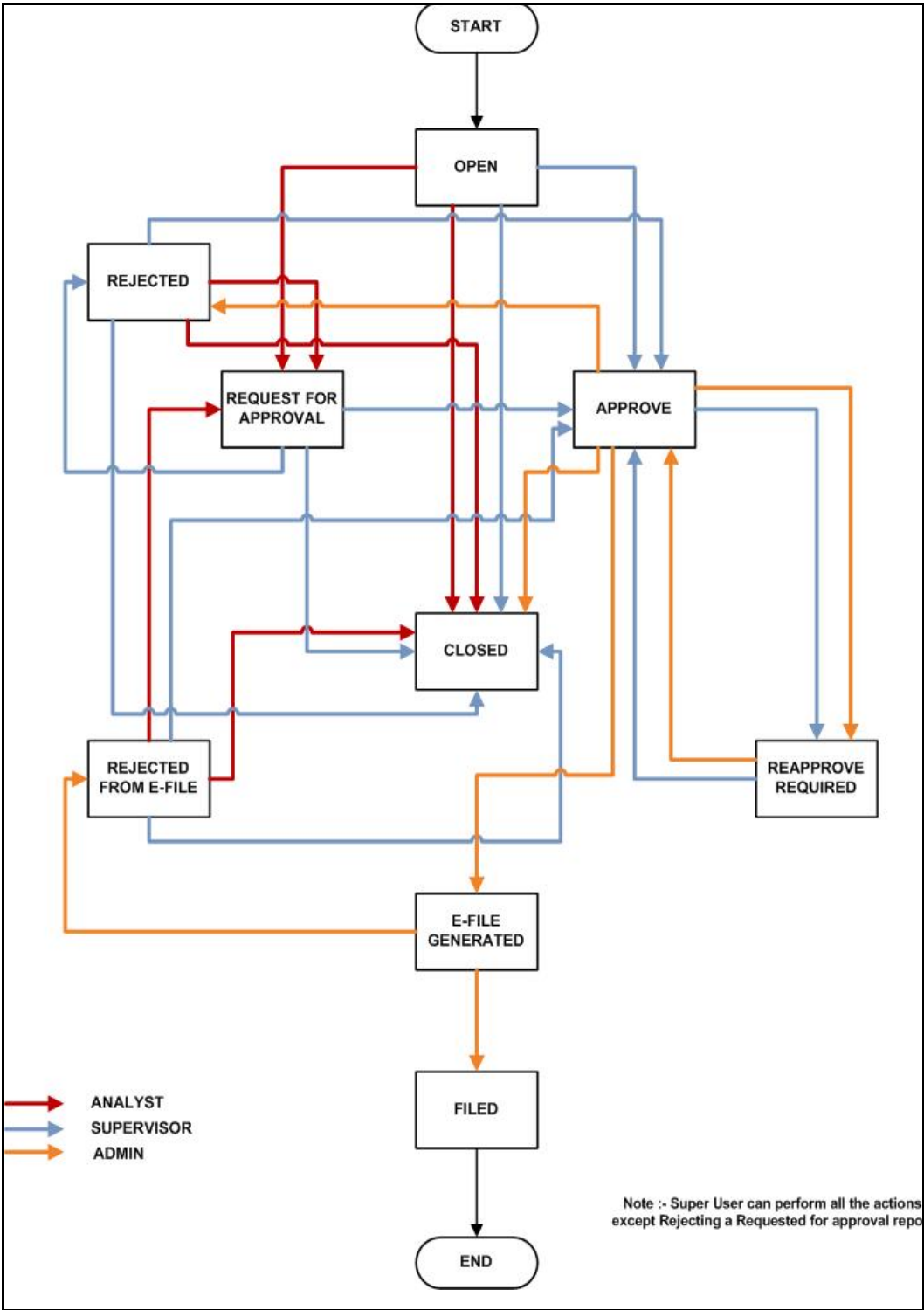
The *Oracle Financial Services Compliance Regulatory Reporting* application is integrated with the *Oracle Financial Services Enterprise Case Management* to allow you to generate reports automatically populated with information relevant to an investigation for any report filed.

The OFS CRR application helps in generating e-file in a .xml format according to specifications described in FinCEN Suspicious Activity Report (FinCEN SAR) Electronic Filing Requirements. After successfully e-filing, you can download the acknowledgment (XML) file from the BSA E-Filing System and upload the acknowledgment into the OFS CRR application, thereby completing the SAR process.

### 2.3 Workflow

The life cycle of the Compliance Regulatory Reports is described in the following workflow diagram.

Figure 1: Regulatory Reporting Workflow



A report is created in the OFS CRR application either from OFS ECM or within the application. When a report is created in the application, the report details are entered and then submitted for approval. An authorized user validates the report details and either approves, rejects, or closes the report.

If the report is approved, an e-file is generated for the report. The generated e-file is submitted with FinCEN's BSA E-Filing System. The e-file is validated and an acknowledgment (XML file) is generated. The acknowledgment file is then uploaded into the OFS CRR application, thereby completing the SAR process. The status of the report changes to *Filed*. The *Filed* status is the final status given to a SAR that has been submitted to and processed by FinCEN.

If the report is rejected, then you must rework the report and submit the report for approval or you can close the report. If you close the report after being rejected, then the status of the report changes to closed. But if you choose to rework the report, then the status of the report changes to request for approval, which must again be validated and approved by authorized users. This process continues until the report is approved or closed.

If there are any changes done to an approved report, the status of the report changes to Re-approve Required, which must be validated by authorized users.

If you determine that a SAR report should not be filed, they can close it. The Closed status removes it from the work queue and helps to distinguish it from those in a *Filed* status. If the report is closed, the report details cannot be edited, and the report is in View mode.

Every report generated in the OFS CRR application can have various statuses.

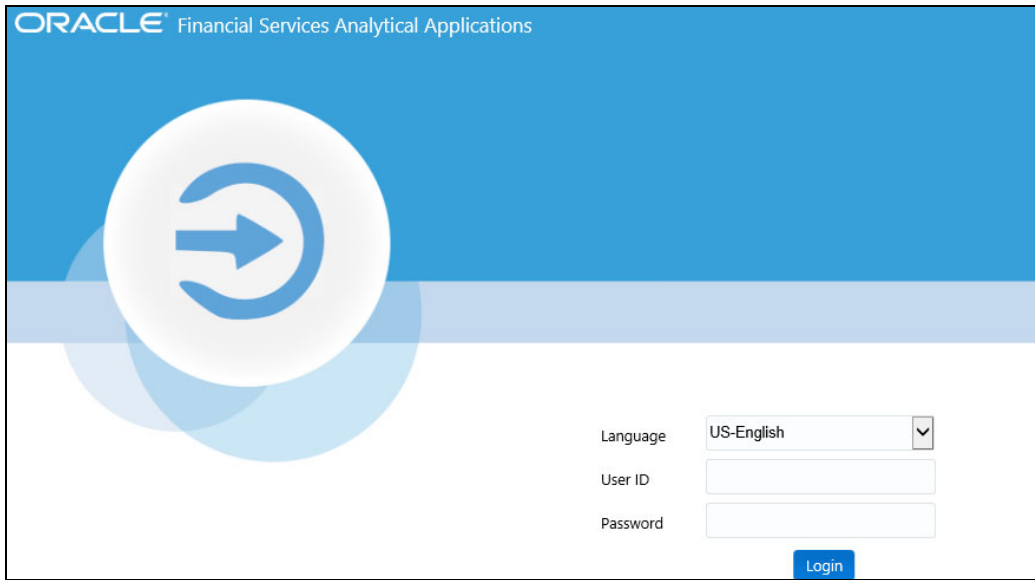

5. Enter your **User ID** and **Password**.
6. Click **Login**. The OFSAA Application page is displayed.
7. Click **Financial Services Regulatory Reporting**.
8. Go to the *Navigation List*. Click **Compliance Regulatory Reporting** in LHS. The US SAR primary menu is displayed in the LHS.
9. Click **US SAR**. The **Regulatory Reporting** Landing page is displayed with the Search and List page as a default page.
10. To access other menus, hover over Regulatory Reports and US SAR primary menu.
11. The US SAR menu displays the following sub-menus:
  - Search and List
  - File Regulatory Reports
  - Create New Regulatory Report

*Regulatory Reports SAR* is the primary menu. Regulatory Reports, File Regulatory Reports, and Create a New Regulatory Report are the secondary menus.

In addition, Super User can access the User Attributes menu through the Administration menu. This menu allows this user to map and maintain the security attributes for each user role.

## 4 Creating Reports

When a report is created in the OFS CRR US SAR application through the OFS ECM application, the report details are auto-populated with information from the Case, which triggered the action to generate the report. The newly created report is available in the OFS CRR US SAR application and it is assigned to a specific user with a due date to take appropriate action. These parameters are configurable. Users who have the same security attributes as the Case posted from OFS ECM will be able to view the report in the OFS CRR US SAR application.

This chapter provides step-by-step instructions to create new reports in the OFS CRR US SAR application.

### 4.1 Creating SAR from OFSECM

When a user with appropriate access permission performs the *Close and Generate SAR* action on a case from the OFS ECM application, the data is passed to the OFS CRR application through the web service, and a new SAR is created in OFS CRR.

### 4.2 Creating a New Report from OFSCRR Application

Analyst, Supervisor, and Super User users can create new regulatory reports.

To create a new regulatory report, follow these steps:

1. Go to the **Regulatory Reporting** menu, hover over **Regulatory Reports – SAR** and click **Create New Regulatory Report**. The Create New Regulatory Report page displays.

## 5.1 All Views

Views search helps you quickly filter the reports based on pre-defined search queries. You can save your search criteria as Views. For more information on pre-defining the search as views, see [Saving Views](#).

To search reports using Views option, follow these steps:

1. On the **Search and List** page, click **All Views** to view the available options.
2. Select the options from the drop-down list. The required list of reports are displayed.

You can create your pre-defined views. For more information, see [Saving Views](#).

**NOTE** You can view only those options in the drop-down that you have created in [Saving Views](#) section.

## 5.2 Saving Views

Use Save as View option to save your search criteria as a View. The saved views are available in the Views drop-down list. For more information, see [Views](#).

For example, if you regularly search for reports approved by Supervisor and reports approved on or before December 2021, you can pre-define a search as *SupDecember* under Views. When you log in to the application next time, rather than re-entering search criteria, you select the required pre-defined view as *SupDecember* from the Views search option and filter the reports.

To save your search criteria as a view, follow these steps:

1. Open the **Search and List** page.
2. Enter the required search criteria in the search fields. For more information on the search criteria, see [Table 5](#).
3. Click **Save as View**. The **Save as View** window is displayed.

4. Enter the View Name and View Details. The field marked with \* an asterisk is mandatory.

**NOTE** The View Details field allows a maximum of 255 characters.

5. Click **Save** to add a new pre-defined view.
6. Click **OK**. The view is saved and displayed in the **Views** drop-down list.

**NOTE** The saved view is available only to the user who has created it, not to other users.

The Search bar allows you to search and view the report details.

### 5.3.2 List Header

The header contains the title *Regulatory Reports* and displays the total number of reports. The header also provides pagination with forward and backward arrows for advancing page by page or for advancing to the first or last page. This is applicable only when the number of reports is more than 20.

### 5.3.3 Action Buttons

**NOTE** If the report version is 1.1, you cannot take any actions.

The system provides the action button that appears above the Regulatory Report List section:

#### 5.3.3.1 Data Exporting

The List of Regulatory Reports allows you to export the report details into an Excel and .CSV files.

To export the report details, follow these steps:

1. Go to the **Regulatory Reports List** page.
2. Click  **Data Export**. The Export options Excel and .CSV are displayed.

**NOTE** All the reports in the Regulatory Reports List are exported into an Excel or .CSV files. You cannot export individual reports .

3. Select Excel or .CSV. The all reports are exported according to your selection and downloaded in your local system.

**NOTE** Open the file in Microsoft Excel or .CSV to edit as needed.

#### 5.3.3.2 Setting Due Date for Reports

Set Due Date action allows you to set a due date or modify an existing due date of a SAR. The CRR application allows you to set the due date for SAR. The due date is set based on the date the SAR creation request is sent from the OFS ECM to OFS CRR. This is the period during which the SAR must be filed with FinCEN. The Due date is configurable and by default, it is set to 30 days from the date the SAR creation request is sent from the OFS ECM to OFS CRR. It includes only business days, excluding holidays and weekends. For more information, see [Setting Due Date for Reports](#).

#### 5.3.3.3 Reassigning Reports

This section describes how to reassign a report or reports to a different user. If a report's initial analysis reveals an issue that must be reviewed by another user, then you can reassign such reports to the most appropriate users. For more information, see [Reassigning Reports](#).

### 5.3.3.4 Closing Reports

This section allows you to close one or more reports from the Search and List page results. You can close report in the *Requested for Approval*, *Approved*, *Rejected*, *Rejected from E-File*, *Open*, and *Reopen* statuses.

To close reports, follow these steps:

1. On Search and List page, select the required one or more reports.
2. Click **Close**. A confirmation message is displayed. The status the of the report changes to *Closed*.

### 5.3.3.5 Reopening Reports

This section allows you to reopen one or more reports which are in Closed statues on the Search and List page results.

To reopen reports, follow these steps:

1. On Search and List page, select the required one or more reports in the Closed status.
2. Click **Reopen Report**. A confirmation message is displayed.

#### NOTE

You can perform bulk actions on the Report Search and List page. These actions are limited to Reopen, Reassign, Set Due Date, and Close.

## 5.3.4 Column Headings

Column headings provide labels that tell you what kind of information displays in the columns. Most column headings in the List matrix can be sorted. Right-click on the column heading to sort the display.

The following sorting options display:

- Ascending
- Descending
- Clear Sort
- Field Chooser

Select the relevant sorting option. The application refreshes the list and re-sorts the list based on the selection you have made.

## 5.3.5 List Matrix

The List matrix displays the summary of all reports.

### 5.3.5.1 Viewing the Draft Report

The *Regulatory Report Details* page allows Analyst, Supervisor, and Super User users to view the draft report. You can view the draft PDF in any status.

To view the draft report, follow these steps:

1. Go to the **Regulatory Reports List** page.
2. Click the Report Number. The Report Details page is displayed.

---

**NOTE**

If the report version is 1.1, you cannot open a report. An error message is displayed. However, you can download the report PDF using the Download link from the Report List.

3. Click the **Draft Report** icon. The File is downloaded to your local system.

**NOTE**

You can also view the report details in PDF by clicking the PDF icon in the Draft Report column in the Regulatory Reports List.

4. Click **Open** to view the report details in a PDF. Click **Save** to save the PDF in your local system. Click **Cancel** to close the File Download box.

## 6 Managing Report Details

To declare any report to be suspicious and report it to the FinCEN, you must view and assess the selected report and its details. The *Regulatory Report Details* page allows you to view, enter, or update report information. Users who can view and updated report details are mentioned in [Table 5](#).

You must enter the report details in the tabs present in the Regulatory Report Details.

All the fields in the Regulatory Report Details tabs have some numbers preceding the field labels. These numbers correspond to the numbers of fields as they appear in FinCEN's SAR PDF that is used for discrete filing.

### 6.1 Components of Regulatory Report Details

This section provides the complete details of the components of the Regulatory Report Details page. Click the report name in the *Regulatory Reports* to view the Report Details.

**NOTE** If the report version is 1.1, you cannot open a Report Details page. An error message is displayed.

#### 6.1.1 Action Buttons

The action buttons are displayed based on your role and the current status of the report. For more information on the user roles, see [Table 5](#).

The following are the action buttons in the Regulatory Report Details:

- **Add Comments:** This button displays in the Regulatory Report Details in all the report statuses. It allows you to add comments to the report. For more information about adding comments, see [Adding Comments to Report](#).
- **Draft Report:** This button displays in all the report statuses. It allows you to view the report details in a PDF. For more information about the draft report, see [Viewing the Draft Report](#).

- **Request For Approval:** This button displays in the Regulatory Report Details when the report is in *Open*, *Rejected*, or *Rejected from e-file* status. It allows you to submit a report for approval. For more information about requesting for approval, see [Requesting for Approval](#).
- **Approve:** This button displays in the Regulatory Report Details when the report is in *Request for Approval* status for the Supervisor user and in *Open*, *Rejected*, *Rejected from e-file*, *Request for Approval* status for Super User. It allows you to approve reports. For more information about approving reports, see [Approving Reports](#).
- **Re-approve:** This button displays in the Regulatory Report Details when the report is in *Approved* or *Re-approve Required* status for the Supervisor and Super User. It allows you to re-approve reports. For more information about re-approving reports, see [Re-Approving Reports](#).
- **Reject:** This button displays in the Regulatory Report Details when the report is in *Request for Approval*, *Approved*, and *E-file generated* status for the Supervisor and Super User. It allows you to reject reports. For more information about rejecting reports, see [Rejecting Reports](#).
- **Close:** This button displays in the Regulatory Report Details when the report is in *Request for Approval* status for the Supervisor user and in *Open*, *Approved*, *Rejected*, *Rejected from e-file*, *Request for Approval* status for the Super User. For more information about rejecting reports, see [Closing Reports](#).
- **Set Due Date:** Set Due Date action allows you to set a due date or modify an existing due date of a SAR. The due date is set based on the date the SAR creation request is sent from the OFS ECM to OFS CRR. This is the period during which the SAR must be filed with FinCEN. The Due date is configurable, and by default, it is set to 30 days from the date of SAR creation. It includes only business days excluding, holidays and weekends. This action button is also available on the Report List page so that you can take action on multiple reports.

## 6.1.2 Report Context

The Report Context displays information about the report, and only the Report Name can be modified; rest of the fields are non editable. It contains minimize and maximize buttons that allow you to expand and collapse the details in the Report Context.

The BSA ID (Bank Secrecy Act Identifier) is generated when the acknowledgment file (XML file) is uploaded into the OFS CRR application. After the XML file is uploaded into the OFS CRR application, the BSA ID field in the Report Context is auto-updated.

To modify the Report Name, follow these steps:

1. On the **Search and List** page, click the **Report Number** link, the Report Details page is displayed. Click  The expanded Report Details page is displayed.
2. Click **Edit**. The Report Name field is enabled.
3. Modify the required changes and click **Save**. These changes will be captured in the Audit history.

The Regulatory Report Details displays the following tabs:

- Fin Inst Where Activity Occurred
- Suspicious Activity Information
- Subject Information
- Documents
- Narrative
- XSD Validation Details
- Audit

**NOTE**

You cannot edit the report details when the report is in View mode. Action buttons, such as Add, Edit, Delete, and Validate, are hidden when the report is in View mode.

### 6.1.3.1 Adding Comments to Report

The Regulatory Report Details allows users mapped to the role of Analyst, Supervisor, and Super User users to add comments to a report. You can add comments to a report when the report is in any status.

To add comments to a report, follow these steps:

1. Go to the Reports Details page.
2. Click **Add Comments**. The *Action Type: Add Comments* pop-up window displays.
3. Enter the comments in the **Comments** box.

**NOTE**

The comments box in the Action Type: Add Comments pop-up window allows you to enter a maximum of 255 characters. As you begin entering the comments, the word count displayed below the comments box keeps decreasing. If you try to enter more than 255 characters in the Comments box, the following message displays: Number of characters exceeded.

If you click **Save**, without entering the comments in the *Action Type: Add Comments* pop-up window, the following message displays: *Mandatory fields are not entered.*

4. Click **Save**. A confirmation message is displayed.
5. Click **OK**. The *Action Type: Add Comments* window closes and displays the Regulatory Report Details.

**NOTE**

The Regulatory Report Comments grid in the Audit tab displays the comments added to the report.

## 6.2 Filing Institution Information

The Filing Institution Information tab is the default tab on the Regulatory Report Details page.

This tab displays the following sections:

- Reporting Information
- Managing Filing Institution Information

This tab has a single **Validate** button that checks the information present in both the Reporting Information section and the Filing Institution Information section.

**NOTE**

If you click on Request for Approval and if there is an error in the details of the Filing Institution Information tab, then the application displays the following message: *Please Validate Filing Institution Information.*

## 6.2.1 Reporting Information

This section displays information on the type of report filing.

The following are the possible types of filing:

- **Initial Report:** These reports are submitted to the FinCEN for the first time.
- **Correct/Amend Prior Report:** These reports were previously submitted but are being resubmitted with modifications to correct earlier provided information. A corrected SAR must refer to the previously submitted SAR by virtue of the BSA ID of the previous SAR.
- **Continuing Activity Report:** A continuing report is filed on suspicious activity that continues after an initial SAR is filed with FinCEN.
- **Joint Report:** It is a suspicious activity report that is being filed by the current institution jointly in cooperation with another financial institution.
- **Filing Institution Note to FinCEN:** This field displays the notes that you want to mention to FinCEN.

**Validations:**

If you have selected the report as *Joint Report* and have not selected *Initial Report* or *Correct/Amend Prior Report* or *Continuing Activity Report*, then the application displays the following message: *Select at least one of the Initial Report, Correct/Amend Prior Report, or Continuing Activity Report.*

## 6.2.2 Managing Filing Institution Information

This section provides details about the filing institution which is reporting the suspicious activity. There can be only one filing institution reporting the suspicious activity.

To enter or modify filing institution information, follow these steps:

1. Go to the **Filing Institution Information** section.

## 6.3 Financial Institution Where Activity Occurred

The Financial Institution Where Activity Occurred tab captures the data of the financial institution where the suspicious activity has occurred and also the associated branches of the financial institution that are involved in the suspicious activity.

To access the Financial Institution Where Activity Occurred tab, select the **Fin Inst Where Activity Occurred** tab. The page refreshes and displays the Financial Institution Where Activity Occurred grid.

This page allows you to add a new financial institution and edit or delete the existing financial institution where the activity occurred and branch details.

### NOTE

The Internal Control/File Number field displays in the Financial Institution Where Activity Occurred tab only in View mode. Editing or entering a value for this field must be done from the Financial Institution Information tab.

### 6.3.1 Managing Financial Institution Where Activity Occurred Details

Use this section to add a new financial institution where the activity occurred and related branch details.

You can add financial institution where the activity occurred in the following ways:

**NOTE** This depends on whether your organization has configured Automatic or Manual mode.

- **Automatic Mode:** When you want to add a new *Financial Institution Where the Activity Occurred* you have to enter only the *Loss Incurred During the Suspicious Activity, Legal Name of the Financial Institution*, or select *Role*. Based on your selection, the system retrieves all the information pertaining to financial institution where the activity occurred.
- **Manual Mode:** When you want to add a new *Financial Institution Where the Activity Occurred* you must manually enter all the required fields. When you enter the *TIN* or *Financial Institution Code* field, if the related information is not in the system, the application displays a message- *Please enter the Financial Institution information*. You must enter the details of the new Financial Institution.

When you enter the *TIN* or *Financial Institution Code* field, if the related information is already present in the system, it displays information in all the fields.

These modes are configured by your Administrator according to the organization's requirement. For more information on the configuration, see [Administration Guide](#).

You can also edit and remove existing financial institution where the activity occurred and related branch details.

To add a new financial institution where the activity occurred and modify or remove existing details, follow these steps:

**Manual Mode**

This mode is applicable only if your organization has opted for Manual mode.

1. On the **Fin Inst Where Activity Occurred** tab, click **Add**. The *Financial Institution Where Activity Occurred* window displays.

### 6.3.1.1 Managing Branch Details

After adding Financial Institution Details, you can add the branch details too.

This tab displays the *Validate* button and *Validate* tab button. The Validate button checks the information on the current section, whereas the Validate tab button validates information for all the sections on this tab.

If you click on request for approval and if there is an error in the details of the Suspicious Activity tab, then the application displays the following message: Validate Suspicious Activity.

2. Within each category, there are related options to select specific behavior that indicates why it was felt the suspicious activity. Review these options within each category and select one or more that best describes the activity being reported.
3. Each of these classifications in the *Activity Classification* LHS menu contains subtypes. You can check all the options applicable to the suspicious activity.
4. If you do not find the relevant option in the required section, then select **Other** from the activity classification list and enter the description of the activity classification.
5. Click **Save**. All the details in the *Activity Classification* pane are saved.
6. Click the **Validate** button in the Activity Classification section to validate the information present in the Activity Classification section and check for any missing mandatory information

## 6.5.1 Overview

A subject is a person who is involved in a suspicious activity. The *Subject Information* section provides the details of the subject for the selected report. This section contains details of the subject's Address, Phone, Form of Identification, Alternate Name, Email address, Website (URL) Address, Account Information, and Relationship With Financial Institution.

Table 20 explains the columns in the Subject Information grid.

### 6.5.2 Managing Subject Information

In the Subject Information section, you can add a new subject and modify or remove existing Subject Information.

A maximum of 999 records can be added to one report or suspicious activity

To add a new Subject Information, and modify or remove an existing Subject Information, follow these steps:

1. Click the **Subject Information** tab. The Subject Information page is displayed.
2. Click **Add**. The Subject Details window expands below the section. where you can enter the required subject information.

**NOTE**

For some fields where information may not be known there is an option to select the *Unknown* check box. A value must be provided for those fields where the unknown check box is not selected unless the *Is All Critical Information* check box is selected, in which case these fields will be considered unknown.

5. Click **OK**. The subject information is saved.

You can now view sections such as Address, Phone, Form of Identification, Alternate Name, Email address, Website (URL) Address, Account Information, and Relationship With Financial Institution where you can enter the required subject details.

6. Click the **Validate** button in the Subject Information section to validate the information present in the Subject Information section and checks for any missing mandatory information

To edit the subject information, follow these steps:

1. Select the record you want to edit in the Subject Information section. The page expands below the section displaying all Subject Information.
2. Modify the necessary information.
3. Click **Save**. The following message displays: *Update Operation Successful*.
4. Click **OK**. The subject information is saved.

To delete the subject information, follow these steps:

1. Select the record you want to delete in the Subject Information section.
2. Click **Delete**. The following message displays: *Are you sure you want to delete this record?*
3. Click **OK**. The following message displays: *Delete Operation Successful*.
4. Click **OK**. The Subject information is deleted.

**Validations:**

1. If *Is critical information unknown?* is unchecked and you have not entered information for at least one critical field or have not checked all of the subject info associated with Unknown check boxes, the following message displays: *Sub# Subject Record- "Is critical information unknown" is not checked and some mandatory fields are missing. Please make sure you enter values for mandatory Subject details i.e. (Last Name/ Entity Name, First Name, TIN, DOB, address, and Identification Information or mark fields as Unknown.*
2. If you are adding or editing the subject details and select the *Is critical information unknown?* check box after entering information in one or more critical fields, the following message displays: *All critical information of the subject i.e. Last Name/ Entity Name, First Name, TIN, DOB, Address details and Identification Information will be cleared if the critical information unknown field is checked. Click OK to continue and clear values from the mandatory fields or Cancel to modify your selection.*
3. If you select the *Critical Information Unknown* check box, you will not be able to add subject address and identification details and the following message displays: *You are not allowed to add address and identification info when 'Is critical information unknown?' field is true.*
4. In the *Subject Information* tab, if you click on the **Validate** button and if there are no records present in the Address, Alternate Name, Phone, Email, Website, and Accounts grid, then the application displays the following message: *There is no Record present to Validate the information.*

5. In the *Subject Information* tab, if you click on the **Validate** button and if there is a blank record present in the Address, Alternate Name, Phone, Email, Website, and Accounts grid, then the application displays the following message: *There is Blank Record present to Validate the information. Please enter the information in the record and then Validate.*

### 6.5.3 Address

The address section provides the location details of the subject involved in the suspicious activity. This option allows you to add new Address details of the subject. You can add new address details only after new Subject Details are added to the selected report. You can also modify and remove the existing Subject Address.

To add a new Subject Address, and modify or remove an existing Subject Address, follow these steps.

1. On the **Subject Information** tab.
2. Select the record to which you want to add the subject Address details. The page expands below the section and it displays the following details: Address, Phone, Form of Identification, Alternate Name, Email address, Website (URL) Address, Account Information, and Relationship With Financial Institution where you can enter the required subject details.
3. On the **Address** section, click **Add**. The Address window displays.

**NOTE** You must either provide a value for each field or select the Unknown check box if you are not aware of any part of the address.

5. Click **Save**. The following message displays: *Update Operation Successful.*
6. Click **OK**. The Subject Address details are saved.
7. Click the **Validate** button in the Address section to validate the information present in the Address section and check for any missing mandatory information.

#### Validations:

The OFS CRR application performs the following validations while entering subject address details:

- You are not allowed to add Address and Identification Information when *Is critical information unknown?* the field is true.

- You must not enter more than 100 characters in the Address field.
- You must not enter more than 50 characters in the city field.
- For the US, the postal code must contain only numbers, either 5 or 9 in length.
- For the US, the postal code should not end with 0000 and 9999.

To edit the subject address, follow these steps:

1. On the **Address** section, click **Edit**. The Address window displays.
2. Modify the required information.
3. Click **Save**. The following message displays: *Update Operation Successful*.
4. Click **OK**. The subject address details are saved.

To delete the subject address details, follow these steps:

## 6.5.4 Phone

The Phone section provides the telephone details of the subject involved in the suspicious activity. This option allows you to add new Phone details of the subject. You can add new Phone details only after new Subject Details are added to the selected report. You can also modify and remove the existing Phone Numbers.

To add new subject phone details and modify or remove existing phone details, follow these steps:

1. Go to the **Phone** section.
2. Click **Add**. The Phone window displays.

  - You must not enter more than 16 characters in the phone number field.
  - You must not enter more than 6 characters in the extension field.

To edit the subject phone details, follow these steps:

2. Click **Edit** in the Phone grid. The Phone pop-up window displays.
3. Modify the required information.
4. Click **Save**. The following message displays: *Update Operation Successful*.

## 6.5.5 Form of Identification

Form of identification provides the unique identifier associated with the subject involved in the suspicious activity such as Driver's license, Passport, and so on. This option allows you to add new identification details of the subject. You can also modify and remove the existing identification details.

#### NOTE

Select the **Unknown** check box if you do not want to enter any information for Forms of Identification.

To add the subject identification details, follow these steps:

1. Go to the **Form of Identification** section.
2. Click **Add**. The Form of Identification window displays.

2. If you try to add new identification details when you have already selected the Unknown check box, the application displays the following message: *You have indicated that no identification details are available. You must unselect that option before adding identification information.*
3. The application performs the following validations while entering subject identification details:
  - You are not allowed to add Address and Identification Information when *Is critical information unknown?* the field is true.
  - It is mandatory to enter the Identification type for Identification details.
  - It is mandatory to enter a brief description of Identification if the Identification type is *Other*.
  - You should not enter a description of Identification when the Identification type is *not Other*.
  - You should not enter more than 24 characters in the *Identification number* field.
  - You should not enter more than 50 characters in the *Other* field.
  - The Country is mandatory for all the identification details entered.

To edit the subject identification details, follow these steps:

1. Select the record you want to edit in the Form of Identification section.
2. Click **Edit**. The Form of Identification window displays.
3. Modify the required information.
4. Click **Save**. The following message displays: *Update Operation Successful*.
5. Click **OK**. The subject identification details are saved.

To delete the subject identification details, follow these steps.

1. Select the record you want to delete in the Form of Identification section.
2. Click **Delete** in the Form of Identification grid. The following message displays: *Are you sure you want to delete this record.*

## 6.5.6 Alternate Name

Alternate Name is another name of the subject. The Alternate Name section provides the alternate names associated with the subject involved in the suspicious activity. This option allows you to add new alternate name details of the subject. You can also modify and remove the existing alternate name detail.

To add a new alternate name of the subject and modify or remove an existing alternate name, follow these steps.

1. Go to the **Alternate Name** section.
2. Click **Add**. The Alternate name window displays.
3. Enter the required information in the Alternate Name window.
4. Click **Save**. The following message displays: *Update Operation Successful*.
5. Click **OK**. The alternate name details are saved.
6. Click the **Validate** button in the Alternate Name section to validate the information present in the Alternate Name section and check for any missing mandatory information.

### Validations:

The application performs the following validations while entering subject alternate name details:

- You should not enter more than 150 characters for an alternate name.
- You should not use prohibited words such as AKA, computer-generated, customer, DBA, Non-customer, none, not applicable, other, same, same as above, see above, see narrative, signature card, T/A, unknown, various, and so on.

To edit the subject alternate name details, follow these steps:

1. Select the record you want to edit in the Alternate Name section.
2. Click **Edit** in the Alternate Name grid. The Alternate Name pop-up window displays.
3. Modify the required information.
4. Click **Save**. The following message displays: *Update Operation Successful*.
5. Click **OK**. The alternate name details are saved.

To delete the subject alternate name details, follow these steps.

1. Select the record you want to delete in the Alternate Name section.
2. Click **Delete** in the Alternate Name grid. The following message displays: *Are you sure you want to delete this record.*

## 6.5.7 Email Address

The Email Address section provides details of the email address associated the subject involved in the suspicious activity. This option allows you to add new email address details of the subject. You can also modify and remove the existing email address.

To add new email details and modify or remove existing email addresses, follow these steps.

1. Go to the Email Address section.
2. Click **Add** in the Email Address section. The Email Address window displays.
3. Enter the required information in the Email Address pop-up window.
4. Click **Save**. The following message displays: *Update Operation Successful*.
5. Click **OK**. The email details are saved.
6. Click the **Validate** button in the Email Address section to validate the information present in the Email Address section and check for any missing mandatory information.

### Validations:

1. If you enter an invalid Email address, the application displays the following message: *Invalid Email Id.*
2. The application performs the following validations while entering subject email details:
  - You should not enter more than 50 characters in the Email ID field.
  - One or more Email ID(s) is in invalid format. Email addresses must contain only one "@" sign and a period in the text following the "@" sign.

To edit the subject email address, follow these steps:

1. Select the record to which you want to modify the subject's Email Address details.
2. Click **Edit** in the Email Address section. The Email Address window displays.
3. Modify the required information.
4. Click **Save**. The following message displays: *Update Operation Successful*.
5. Click **OK**. The subject's email details are saved.

To delete the subject email details, follow these steps.

1. Select the record you want to delete in the Email Address section.

## 6.5.8 Website (URL) Address

Website (URL) Address section provides the details of the website (URL) associated with the subject involved in the suspicious activity. This option allows you to add new website details of the subject. You can also modify and remove the existing website details.

To add new subject website details and modify or remove the existing website (URL) address, follow these steps.

1. Go to the **Website (URL) Address** section.
2. Click **Add** in the Website (URL) Address section. The Website (URL) Address window displays.
3. Enter the required information in the URL address window.
4. Click **Save**. The following message displays: *Update Operation Successful*.
5. Click **OK**. The Website (URL) Address details are saved.
6. Click the **Validate** button in the Website (URL) Address section to validate the information present in the Website (URL) Address section and check for any missing mandatory information.

### Validations:

1. If you enter an invalid URL address, the application displays the following message: *Invalid URL*.
2. The application performs the following validations while entering subject website details:
  - You should not enter more than 517 characters in the URL field.
  - The URL addresses must contain a dot (.) and must not include the "@" character.

2. Click **Add**. The *Account Add* window displays.

2. Click **Edit**. The Account Add pop-up window displays.
3. Modify the required information.
4. Click **Save**. The following message displays: *Update Operation Successful.*
5. Click **OK**. The subject account details are saved.

To delete the subject account details, follow these steps:

1. Select the account you want to delete in the Account Information section.
2. Click **Delete**. The following message displays: *Are you sure you want to delete this record.*
3. Click **OK**. The following message displays: *Delete Operation Successful.*
4. Click **OK**. The subject account detail is deleted.

### 6.5.9.1 Updating TIN in Account Information Automatically

This section explains how TIN is automatically updated for the selected filing Institution in the following scenarios.

- On the Filing Institution Information tab, when you select the Filing Institution Name, the TIN value associated with the selected Filing Institution name is auto populated and shown in the Account Information section of the Subject Information tab - TIN field. You can modify this TIN number here.
- If you have not added a Filing Institution, the TIN field will be empty in the Account Information section of Subject Information tab. However, you can add the TIN number manually here.
- When you modify the Filing Institution for the report that has already accounts details and click **Save**. The TINs for all the accounts associated with the report will be overwritten with the new Filing Institution TIN value.

If there are no accounts present in the report or if you select the *No Account Involved* field check box, then there will be no updates on the TIN field if you add or edit Filing Institution.

### 6.5.10 Relationship with Financial Institution

The relationship with Financial Institution section provides the details of the relation of the subject with the Financial Institutions mentioned in the report. This option allows you to add new relation of the subject with the Financial Institutions. You can also modify and remove the existing relation of the subject with the Financial Institutions.

To add a new subject relationship with a financial institution and modify or remove existing subject relationship with a financial institution, follow these steps:

1. Go to the **Relationship with Financial Institution** section.
2. Click **Add**. The Relationship with Financial Institution window displays.

## 6.6 Documents

When filing the report with regulatory authorities, you can also send additional documents. This additional information aids in taking the correct decision about the report. When you attach a document to a report, the status of that report does not change. However, the attachment is added to the report's history.

Analyst, Supervisor, and Super User can attach, modify, or delete documents in all statuses except when the report is in View-Only mode.

The Documents tab lists all the documents that are attached to the report. It also allows you to add additional documents. You can upload files of any format with a size of less than 1 MB.

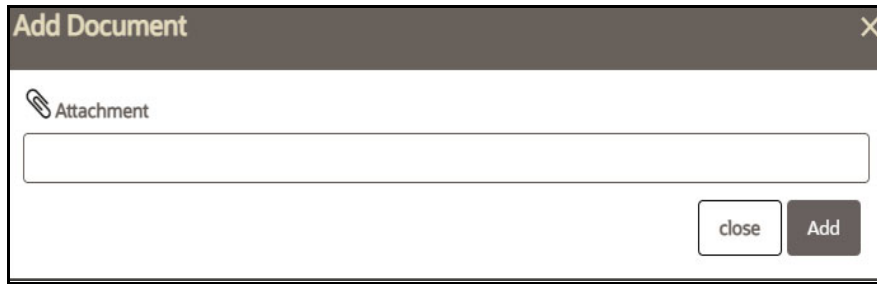
You can upload files of any format in the Documents tab. You can choose to include the attached document in the report.

However, only one file of .csv format can be included in the report. You cannot include files of any other format other than .csv in the report.

To add the documents, follow these steps:

1. On the **Documents** tab, click **Add**. The Attach Document window displays.

2. Click **Attachment Icon** to add one or more documents. Select the document that must be attached from the local system.
3. Click **Add**. The following message displays: *Add Operation Successful*.
4. Click **Close** to view the newly added document in the List of Documents section.
5. To view documents, click **View Document**. A File Download box displays.
6. Click **Open** in the File Download Box to view the document attached. Click **Save** to save a copy of the attached document in your local system or click **Cancel** to close the File Download Box.

To delete the attached documents, follow these steps:

1. Select the document you want to delete.
2. Click **Delete**. The following message displays: *Are you sure you want to delete this record*.
3. Click **OK**. The following message displays: *Delete Operation Successful*.
4. If you click **Cancel**, the document is not deleted.
5. Click **OK**. The List of Documents grid displays.

### 6.6.1 Including Documents in the Report

You can include the document attached in the Documents tab in the report. Only one file of .csv format can be included in the report. You cannot include files of any other format.

To include the attached document, follow these steps:

1. On the **Documents** tab, the documents attached display in the List of Documents section.
2. Select the check box of the document you want to include in the report.
3. Click **Include in Report**.
4. Click **Save** in the List of Documents grid. The following message displays: *Update Operation Successful*.
5. Click **OK**. The List of Documents grid displays.

#### Validations:

If you try to include files of any other format (other than .csv format), the following message displays: *Only a document with csv extension can be included in the report*.

If you try to include more than one .csv file in the report, the following message displays: *Only one document can be made primary for a report.*

**NOTE**

You cannot edit the report details when the report is in View mode. Action buttons, such as Add, Delete, and Save, are hidden in the Documents tab when the report is in View mode.

## 6.7 Narrative

The narrative section of the report is critical to understanding the nature and circumstances of the suspicious activity. The narrative may determine whether the described activity and its possible criminal nature are clearly understood. You must provide a clear, complete, and concise description of the activity, including what was unusual or irregular that caused suspicion.

To update the Narrative section, follow these steps:

1. Click the **Narrative** tab. The Narrative pane displays.

2. Enter the information in the Narrative pane.

**NOTE**

You can enter a maximum of 20000 characters in the narrative pane.

3. Click **Save**. The following message displays: *Update Operation Successful. Carriage returns (if any) will be removed when submitting to FinCEN.*

**NOTE**

The line breaks in the Narrative tab is removed while submitting the e-file to FinCEN.

4. Click **OK**. The narrative details are saved.

- To clear the changes made in the Narrative tab, click **Reset**. The page refreshes to display the last saved data.

**NOTE**

You cannot edit the report details when the report is in View mode. Action buttons, such as *Save* and *Reset* are hidden in the Narrative tab when the report is in View mode.

## 6.8 XSD Validation Details

The XSD Validation Details tab allows to validate report formats/details against the XSD (XML Schema Definition) files. If there are any errors related to XSD, those errors will be listed in the XSD Validation Details tab. This feature helps avoid E-Files being rejected from the FinCEN E-File System due to errors during submission.

This allows Analysts to validate each detail before they request SAR approval, and helps Super Users or Supervisor users validate errors and approve the report. If there are any errors related to XSD, it will not allow them to approve the report until the errors are rectified.

To view errors in SAR details, follow these steps:

- Go to the **Reports Details** page.
- Click the **XSD Validation Details** tab. The XSD Validation Details page is displayed with the list of errors present in the SAR.

## 6.9 Audit

Use the Audit tab to view the audit history of a report. It provides details of actions performed on the report and comments provided by the users in the various statuses. This tab contains the Regulatory Report Actions section and the Regulatory Report Comments section.

## 7 Acting on Reports

This chapter explains various actions that can be performed on the reports.

Topics:

- Requesting for Approval
- Approving/Rejecting/Closing Reports
- Setting Due Date for Reports
- Reassigning Reports
- Generating Correct/Amend Report
- Filing Regulatory Reports

### 7.1 Requesting for Approval

After updating the report details, they must be validated. The Regulatory Report Details page allows you to submit a report for approval. You can assess the report details and can either Approve, Close, or Reject the report. For more information on user roles, see [Table 5](#).

You can initiate Request for Approval action only when the report is in *Open/Rejected/Rejected from e-file* status.

For example, an Analyst user updates the report details and submits the report for approval. The Supervisor user verifies the report and either Approves, Closes or Rejects the report.

To submit a report for approval, follow these steps:

1. On the **Regulatory Report Details** page, click **Request for Approval**. The Request for Approval Action window is displayed.

#### NOTE

If there is mandatory information that is missing or information that is in some way invalid for the report submission, you will receive warnings to correct the information before requesting the approval. If there are no errors detected, the *Request for Approval Action* window displays.

If the report size is more than 60 MB, the following message is displayed: *The report contents exceeded the efile size limit. Please reduce report contents before proceeding further.*

2. Enter the comments in the Action window. You can enter a maximum of 120 characters.
3. Click **Save**. The following message displays: *Update Operation Successful*.
4. Click **Clear** to clear the data in the Action window and click **Close** to close the Action window. The report audit details display.

#### NOTE

The Regulatory Report Action section in the Audit tab displays the comments added in the Request for Approval Action window.

5. If you click **Save** without entering the comments in the *Request for Approval Action* pop-up window, the following message displays: *Mandatory fields are not entered*.

#### NOTE

Super User and Supervisor users can edit a report in the Request for Approval status before approving it.

## 7.2 Approving/Rejecting/Closing Reports

The *Regulatory Report Details* page allows you to approve, reject, or close the regulatory reports.

You can approve, reject, or close the report only when all the mandatory fields in the Report Details tabs are complete.

If the report is approved, an e-file is generated for the report. The generated e-file is submitted with FinCEN's BSA E-Filing System.

If the report is rejected, then you must rework the report and submit the report for approval, or you can close the report. If you close the report after being rejected, then the status of the report changes to Closed. But if you choose to rework the report, then the status of the report changes to Request for Approval, which must again be validated and approved by authorized users. This process continues until the report is approved or closed.

If you close the report, the report details cannot be edited, and the report is in View mode. For more information on user roles, see [Table 5](#).

### 7.2.1 Approving Reports

To approve a report, follow these steps:

1. On the **Regulatory Report Details** page, click **Approve**. The Approve action window displays.

#### NOTE

If there is mandatory information that is missing or information that is in some way invalid for the report submission, you will receive warnings to correct the information before requesting approval. If there are no errors detected, the Approve Action window displays.

If the report size is more than 60 MB, the following message is displayed: *The report contents exceeded the efile size limit. Please reduce report contents before proceeding further.*

2. Enter the comments in the Action window.

#### NOTE

The comments box in the Action pop-up window allows entering a maximum of 120 characters. As you begin entering the comments, the word count displayed below the comments box keeps decreasing. If you try to enter more than 120 characters in the Comments box, the following message displays: *Number of characters exceeded.*

3. Click **Save**. The following message displays: *Update Operation Successful*.

#### NOTE

If you click **Save** without entering the comments in the Approve Action pop-up window, the following message displays: *Mandatory fields are not entered*. If the report is approved, the status of the report changes to *Approved*.

4. Click **OK**. The report audit details display. The Regulatory Report Action grid in the Audit tab displays the comments added in the Approve Action pop-up window.

5. Click **Clear** to clear the data in the Action pop-up window and click **Close** to close the Action pop-up window.

### 7.2.1.1 Re-Approving Reports

The Regulatory Report Details page allows you to re-approve reports. You can re-approve reports when the report is in *Re-Approve Required* status. This action must be performed if the report has been edited in any way. Taking the action of Re-Approve will re-run the report validations and ensure that the editing did not introduce any report validation errors.

If an approved report is edited in any way, the status of the report changes to *Re-approve Required*. When a report in *Re-approve Required* status is re-approved, the status of the report changes to *Approved*.

To re-approve a report, follow these steps:

1. On the **Regulatory Report Details** page, click **Re-approve**. The *Re-approve Action* window displays.
2. Enter the comments in the *Action* pop-up window. You can enter a maximum of 120 characters.
3. Click **Save**. The following message displays: *Update Operation Successful*.
4. Click **Clear** to clear the data in the Action pop-up window and click **Close** to close the Action pop-up window.
5. Click **OK**. The report audit details display.

The Regulatory Report Action grid in the Audit tab displays the comments added in the Re-approve Action pop-up window.

6. If you click **Save** without entering the comments in the Re-approve Action pop-up window, the following message displays: *Mandatory fields are not entered*.

### 7.2.2 Rejecting Reports

The Regulatory Report Details page allows you to reject reports from filing. You can reject the report when the report is in *Approved* or *Request for Approval* status. If a report is rejected, then the requester must rework the report and re-submit the report for approval. This process continues until the report is approved or closed.

If a report is rejected, the status of the report changes to *Rejected*.

To reject a report, follow these steps:

1. On the **Regulatory Report Details** page, click **Reject**. The Reject Action window displays.
2. Enter the comments in the Action pop-up window. You can enter a maximum of 120 characters.
3. Click **Save**. The following message displays: *Update Operation Successful*.

---

**NOTE**

If you click **Save** without entering the comments in the Reject Action pop-up window, the following message displays: *Mandatory fields are not entered*. If the report is rejected, the status of the report changes to *Rejected*.

4. Click **Clear** to clear the data in the Action pop-up window and click **Close** to close the Action pop-up window.
5. Click **OK**. The report audit details display.
6. The Regulatory Report Action grid in the Audit tab displays the comments added in the Reject Action pop-up window.

### 7.2.2.1 Updating Rejected Reports

If a report is rejected, then you can either close the report or can rework the report and again submit the report for approval. This rework process continues until the report is either approved or closed.

### 7.2.3 Closing Reports

If you determine that a SAR report should not be filed, then you can close it. The Closed status removes it from the work queue and helps to distinguish it from those in the Filed status.

The Regulatory Report Details page allows you to close reports without filing. You can close reports when the report is in Approved, Request for approval, or Rejected status.

After the report is closed, you cannot edit the report details, and the report is in View mode.

If a report is closed, the status of the report changes to *Closed*.

To close a report, follow these steps:

1. On the **Regulatory Report Details** page, click **Close**. The Close Action window displays.
2. Enter the comments in the Action pop-up window. You can enter a maximum of 120 characters.
3. Click **Save**. The following message displays: *Update Operation Successful*.
4. Click **Clear** to clear the data in the Action pop-up window and click **Close** to close the Action pop-up window.
5. Click **OK**. The report audit details display.
6. The Regulatory Report Action grid in the Audit tab displays the comments added in the Close Action pop-up window.
7. If you click **Save** without entering the comments in the Close Action pop-up window, the following message displays: *Mandatory fields are not entered*.

### 7.2.4 Generating Correct/Amend Report

When a SAR filing is completed, the status of report is *Filed* then a *Generate C/A Report* button is displayed on the Report Details page and Report List section in E-File Status tab.

---

**NOTE** *Generate C/A Report* button is enabled only in SDTM mode.

To generate correct/amend report, follow these steps:

1. On the Search and List page, select the report number with Filed status. The Reports Details page is displayed.
2. On the **Regulatory Report Details** page, click **Generate C/A Report** button. A new report is generated with Open status.

---

**NOTE** You can take *Generate C/A Report* action only one time on the parent report.

## 7.3 Setting Due Date for Reports

Set Due Date action allows you to set a due date or modify an existing due date of a SAR.

The due date is set based on the date the SAR creation request is sent from the OFS ECM to OFS CRR. This is the period during which the SAR must be filed with FinCEN. The Due date is configurable, and by default, it is set to 30 days from the date of SAR creation. It includes only business days excluding, holidays and weekends. This action button is also available on the Report List page so that you can take action on multiple reports.

**Table 28** explains the statuses in which the Analyst, Supervisor, and Superuser users can perform the Set Due Date action.

To set a due date of a SAR, follow these steps:

1. Go to the **Report List** or **Report Details** page of a report. On the Report List page, you can select multiple reports and set the due date. On the Report Details page, you can set the due date for the selected report.
2. Click **Set Due Date**. The Set Due Date Action window is displayed.

## 7.4 Reassigning Reports

This section describes how to reassign a report or reports to a different user. If a report's initial analysis reveals an issue that another user must review, you can reassign such reports to the most appropriate users.

**NOTE** By taking this action, the status of the report doesn't change.  
You cannot reassign when one or more reports are in different statuses. You must select reports of the same status to reassign.

To reassign a report or reports to another user, follow these steps:

1. On the **Regulatory Report Details** page, select one or more reports and click **Reassign**. The Reassign window is displayed.

**NOTE** If you select a report or reports with Closed status and try to reassign, an error message is displayed.

2. Select a user from the drop-down list.
3. Enter the comments in the Comments box. You can enter a maximum of 255 characters.
4. Click **Save**. A confirmation message is displayed. The user assigned to these reports is displayed in the Assigned To column on the Report List page.

## 7.5 Filing Regulatory Reports

After the report is approved, you must file the regulatory reports with the regulatory bodies.

The OFS CRR application helps in generating an E-File for an approved report. The e-file generated is in a .xml format that is according to the specifications described in FinCEN Suspicious Activity Report (FinCEN SAR) Electronic Filing Requirements. After successfully e-filing, you can download the acknowledgment (XML) file from the BSA E-Filing System and upload the acknowledgment into OFS CRR, thereby completing the SAR process. The status of the report changes to *Filed*.

Filed status is the final status given to a SAR that has been submitted to and processed by FinCEN.

Only users mapped to the role of *Super User* can generate an E-File.

### 8.1 Overview

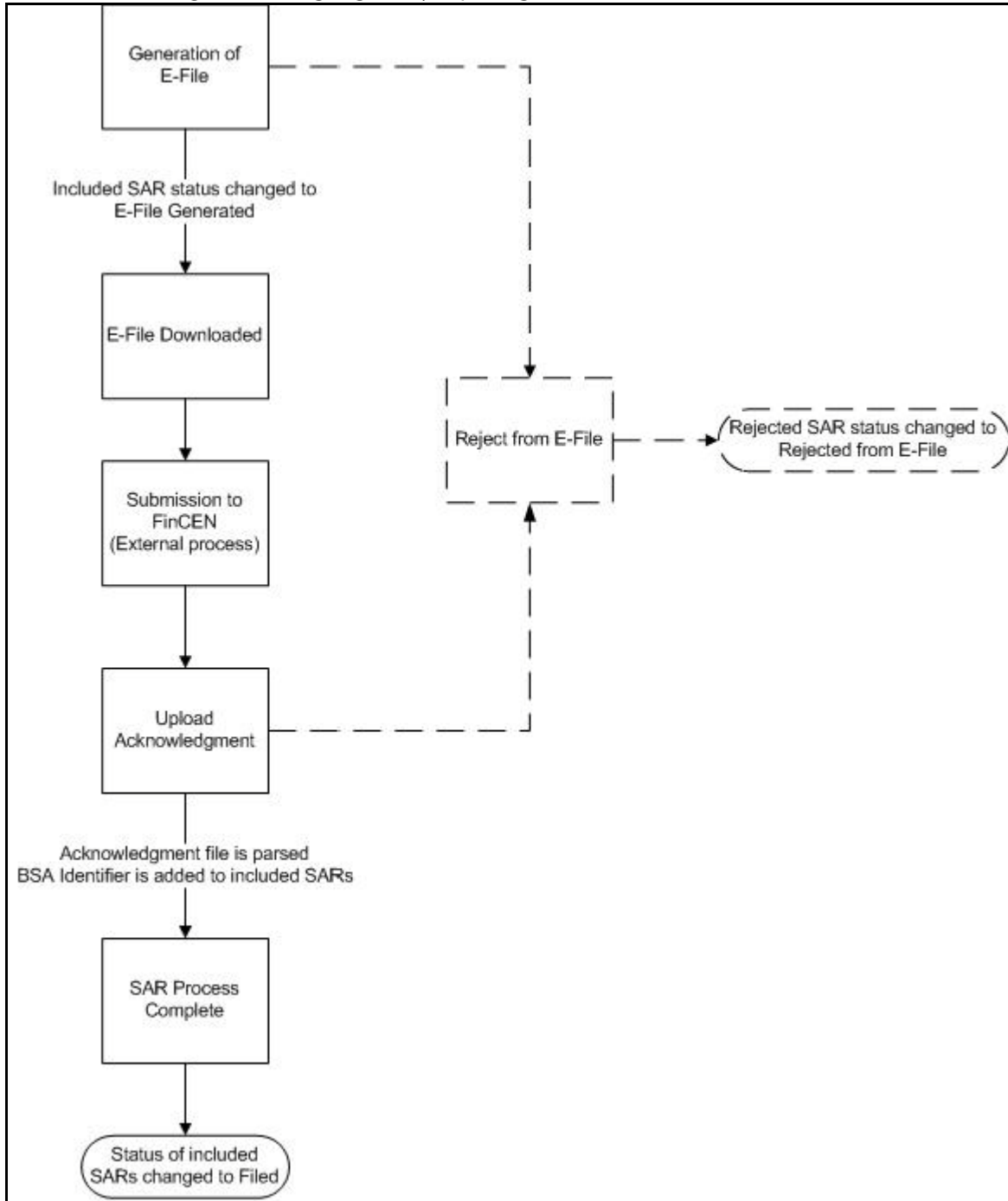
When a report is created in the application, the report details are entered and then submitted for approval. After the report is submitted for approval, you can validate the report details and either approve, reject, or close the report.

If you approve the report then the report is available for E-File generation. The generated E-File is submitted to FinCEN's BSA E-Filing System. The E-File is validated by FinCEN and an acknowledgment (XML file) is generated. Then the acknowledgment file can be uploaded into the OFS CRR application. The application will associate the FinCEN returned BSA Identifier to each SAR within the E-File. Now, you can mark that the SAR process is completed.

#### 8.1.1 Workflow for Filing the Regulatory Report

## 8.2.1 Searching Approved Reports

The Approved Reports tab enables you to search for and display reports that are in an Approved status and are ready for e-filing. It is from this tab that you can generate the E-File.

Super Users can reject or close approved reports from this tab.

To search for approved reports, follow these steps:

1. Go to the **Regulatory Reporting** menu, hover over **Regulatory Reports – SAR** and click **File Regulatory Reports**. The *File Regulatory Report* page displays.
2. Click the **Approved Reports** tab. The Approved Report List page displays all the reports in *Approved* status.

3. To further filter the list of Approved reports, enter criteria in one or more filters.

4. Click **Search**. The relevant search list displays.

## 8.2.2 Generating E-File

After the status of a regulatory report changes to *Approved*, you can generate the E-File for those report(s) and upload the resultant *.xml* file into FinCEN' BSA E-Filing System.

When an E-File is generated, an attachment zip file is created for the E-File with a *.csv* file in it. This *.zip* file is only available if attachments were associated with any SAR within the E-File.

To generate an E-File, follow these steps:

1. Go to the **Approved Report List** section, select the required report(s) for which you want to generate an E-File.

**NOTE** If the size of E-File is more than 60 MB, the following message is displayed:  
*"The efile is exceeding the size limit. To automatically split the efile, click on OK or else reduce the number of report selection before proceeding to generate an efile."*

2. Click **Generate E-File**. The following message displays: *E-File Generated Successfully*. The status of the regulatory report changes to *E-File Generated*.

#### NOTE

- For manual E-File generation, the E-File naming convention will be: <E-file number>.xml. For example: 1123.xml.
- For SDTM, the E-File naming convention will be: <SARXST.<DATETIMESTAMP>.<SDTM\_UID>[.xml|.zip]>. For example: SARXST.20220826161243.sdtmprtgobnk.xml.
- The reports on which **Generate E-File** action is taken are moved from the *Approved Reports* list to the *E-File* list.
- If you try to generate E-File for the same report(s) which is already locked by another user, the following message displays: *One or more reports selected by you are locked by another user for generating E File or it has already been generated. Click OK to refresh the list*
- If you try to E-File or reject a report which is already locked by another user, the application displays the following message: <Report nm1>-<user>, <Report nm2>-<user>..... *One or more r Report(s) selected by you are locked by another user and not available for action.*
- If you try to E-File a report which is already generated or rejected, the application displays the following message: <Report nm1>, <Report nm2>..... *Report(s) selected by you has already been actioned to either include in an E-File or rejected from the E-File. So you cannot perform this action.*

## 8.2.3 Rejecting Approved Reports

Use this section to reject one or more reports that are in Approved status in an E-File. After the report is rejected from an E-File, it is removed from the E-File Reports list and the status of the report changes to Rejected from E-File. The rejected report is available in the Regulatory Reports List. Users can rework the report and request approval. This workflow continues till the report is closed or the report is filed at the FinCEN E-File system.

To reject approved reports, follow these steps:

1. Go to the **Approved Report List** section.
2. Select the required report or reports and click **Reject**. A confirmation message is displayed.

#### NOTE

If you try to reject a report which is already locked by another user, the application displays the following message: <Report nm1>-<user>, <Report nm2>-<user>..... *One or more r Report(s) selected by you are locked by another user and not available for action.*

## 8.2.4 Closing Approved Reports

If you determine that a SAR should not be filed, then you can close it. The Closed status removes it from the work queue and helps to distinguish it from those in the Approved status.

The Approved Report section allows you to close reports without filing. You can close reports when the reports are in Approved status. After the report is closed, you cannot edit the report details and the report is in View mode. If a report is closed, the status of the report changes to *Closed* and you cannot take any action on this report.

To close approved reports, follow these steps:

1. Go to the **Approved Report List** section.
2. Select the required report or reports and click **Close**. A confirmation message is displayed.

## 8.3 E-Filed Status

The E-Filed Status tab provides the list of E-Files so that you can take different actions on the selected E-File such as Downloading the E- File, Submitting the E-File at FinCEN, Saving E-File acknowledgments from FinCEN, and so on.

### 8.3.2.1 Viewing E-File Details

From the E-File list results page, you can view the generated E-File details. Each E-File provides of the list of Reports included in the E-File. This details displays the Report Number, Report Name, Due Date and so on. The E-Files are arranged in ascending order of SAR document number.

To view the generated E-File file details, follow these steps:

1. Go to the **E-Filed Status** tab.
2. Click **E-file Number** link on the E-File Number column. This E-File displays the number of SARs included in the selected E-File under the Report List section below the E-File List.

#### 8.3.2.1.1 Generating Correct/Amend Report

When a SAR filing is completed, the status of report is *Filed* then a *Generate C/A Report* button is displayed in the Report List section of E-File Status tab. This allows you to take action on multiple reports.

#### NOTE

*Generate C/A Report* button is enabled only in SDTM mode.

To generate correct/amend report, follow these steps:

1. Go to the **E-Filed Status** tab.
2. Click **E-file Number** link on the E-File Number column. This E-File displays the number of SARs included in the selected E-File under the Report List section below the E-File List.

**NOTE** You can take *Generate C/A Report* action only one time on the parent report.

3. Select the required reports, and click **Generate C/A Report** button. A confirmation message is displayed.

- NOTE**
- If some of the selected reports in which Correct/ Amend action is already taken, a message dialog is displayed - Generate C/A Report action cannot be taken for reports which already have C/A report generated. Would you like to proceed with the rest of the reports? Click OK to continue.
  - If all the selected reports in which Correct/ Amend action is already taken, an error message is displayed.

### 8.3.2.2 Downloading E- File and Attachment

After you generate an E-File, the OFS CRR application generates a *.xml* file with its content formatted according to Financial Crimes Enforcement Network (FinCEN) specifications for electronic filing. You must save this *.xml* file and submit it to FinCEN's BSA E-Filing System. You can also download an E-File attachment, which contains *.csv* document that are included in the SAR.

To download the generated E-File and attachment, follow these steps:

1. On the **E-Filed Status** tab, click **Download link** in the E-File column. A File Download window displays. Click **Save** to copy *.xml* file to your system.
2. To download the E-File attachments, click **Download** link in the Attachments column for the corresponding E-File. A file download window prompts to **Open** or **Save** the attachments zip file. The attachments zip file contains the *.csv* file included for a report from the Regulatory Reports Details page. The naming convention of this zip file is - *Attachment.<E-File Number>.xml.zip*. For example, Attachment.5244.xml.zip.

### 8.3.2.3 Downloading Message File

When you upload an E-File to the FinCEN's BSA E-Filing System, it will validate xml and revert with a message file. If an E-File is accepted or accepted with warning then FinCEN will send you a valid acknowledgment after few days.

If FinCEN has rejected or accepted the E-File, the status of the message is displayed in the *Message Status* column. The date the message is uploaded to the CRR application via Message batch is displayed in the *Message Date* column. The message file is displayed in the *Message File* column with a Download link. You can download the file to verify the message file for further action.

**NOTE** This is applicable only if you have enabled SDTM mode.

To download the Message File, follow these steps:

1. On the **E-Filed Status** tab, click **Download** link in the Message File column. A File Download window displays. Click **Save** to copy the file to your system.

### 8.3.2.4 Submitting the E-File at FinCEN

There are two ways to submit an E-File at FinCEN - Automatic (SDTM) mode and Manual mode.

#### Automatic (SDTM) Mode

If you select submission mode as S and enable SDTM as Y then E-Files are transferred automatically to the designated directory. If you select submission mode as S and enable SDTM as N then you have to run the E-File batch to transfer E-Files to the designated directory.

The FinCEN's E-Filing system retrieves these transferred E-Files from the designated directory and uploads them to its system.

For more information, see *Configuring Secure Direct Transfer Mode (SDTM)* section in [Administration Guide](#).

#### Manual Mode

If you select submission mode as M then you have to manually submit the E-Files in the FinCEN's E-Filing system and you have to download a confirmation message XMLs from the same system.

To submit the E-File at BSA E-Filing System manually, follow these steps:

1. Login to the **BSA E-Filing System** website (<http://bsaefiling.fincen.treas.gov>.)
2. From the left-hand side menu pane click **New Reports**, then select **File Batch FinCEN SAR**. The **Open an Existing Form** window displays.

### 8.3.2.5 Saving E-File Acknowledgments from FinCEN

When the BSA E-Filing System Track Status page shows that the submitted file is acknowledged, then you can retrieve an acknowledgment file from the BSA E-Filing System Secure Messaging center. This file is in a XML format. You must save this acknowledgment file and upload it into the OFS CRR application.

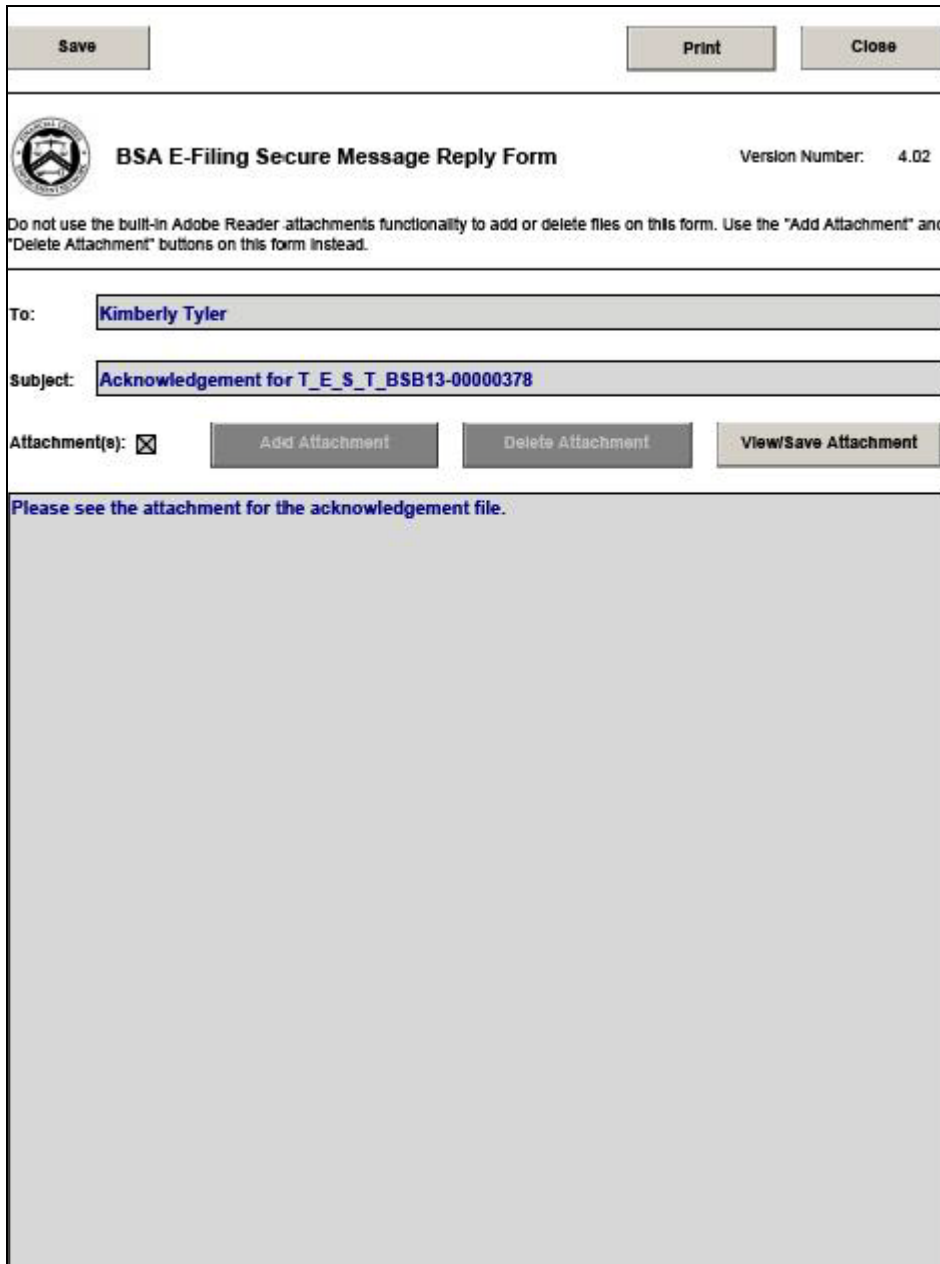
An acknowledgment file is not generated when an e-filing is rejected.

To save the acknowledgment file from BSA E-Filing System, follow these steps:

- Login to the **BSA E-Filing System**.

2. From **Secure Messaging**, select **View Inbox** to display a list of acknowledgments.

### 8.3.3 Uploading E-File Acknowledgment

There are two ways to upload an acknowledgment - Automatic (SDTM) mode and Manual mode.

#### Automatic (SDTM) Mode

An Acknowledgement batch must be executed to parse an acknowledgement received from the FinCEN E-Filing system upon submitting an E-File. The FinCEN's E-Filing system transfers acknowledgements to the configured Acknowledgment directory. Once the batch is successful, all the acknowledgements are parsed against the respective E-Files and acknowledgement XMLs are transferred to the Archive directory. These acknowledgements are populated in the Acknowledgment tab of OFS CRR US SAR application UI.

**NOTE** If you have enabled SDTM mode, you can not upload acknowledgement manually.

#### Manual Mode

After downloading the acknowledgments from BSA E-Filing System, you can update the status of regulatory reports in the OFS CRR application. After you upload the acknowledgment (XML) file into the application, the file is then parsed to retrieve the BSA Identifier that is assigned by FinCEN to each report. This BSA Identifier is then added to the report record.

To upload the acknowledgment, follow these steps:

1. Go to the **E-Filed Status** tab.
2. From the **E-File List** results, select the record for which you want to upload the acknowledgment.
3. Click **Upload Acknowledgment**. A SAR Acknowledgment window display

### 8.3.4 Rejecting Reports from an E-File

You can reject reports from an E-File at any point in time before completing the SAR process. After a SAR report is rejected from an E-File, it is removed from the reports list and the status of the rejected report changes to *Rejected from E-File*.

For reports that are not rejected, a new E-File is regenerated. If the acknowledgment file is already uploaded, you can complete the SAR process of the regenerated E-File by clicking **Complete SAR Process**.

You can correct/amend a rejected report and submit it for Super User's approval. After the corrected report is approved, you can follow the workflow of filing a regulatory report all over again. Subsequently, while uploading the acknowledgment (XML) file received from FinCEN into the OFS CRR application, a new BSA Identifier overwrites the previously associated BSA Identifier of the rejected reports.

In the SDTM mode, when rejected Message XML is uploaded via batch while parsing the Message.xml if the value for attribute "Level" is as FATAL or WARN, the associated reports in the corresponding E-File will be automatically rejected. This will be captured in the Audit history for each report being rejected. It will also have associated rejected Message XML, which can be downloaded from the Attachment column in the Audit tab.

With the reports left after the automatic rejection of reports, a new E-File will be regenerated and will be transferred to the configured location as per the transfer settings done for SDTM mode.

With the reports, left after the automatic rejection of reports, a new E-File will be regenerated and will be transferred to the configured location as per the transfer settings done for SDTM mode..

After an E-File is uploaded and accepted by FinCEN, you cannot reject SARs from the E-File until the acknowledgment file is uploaded and parsed. If you reject a report after submission but before processing the acknowledgment files there will be a mismatch in the files referenced in the acknowledgment file and the current E-File. If a report is rejected prior to uploading the acknowledgment into the application, then you have to re-submit the E-File at FinCEN's BSA E-Filing System to get the latest acknowledgment file.

To reject the reports from an E-File, follow these steps:

10. Go to the **E-Filed Status** tab.
11. From E-File List results, select an E-File record that you want to reject.
12. Click  to view the E-File details.
13. From the **Report** list page, select the required reports and click **Reject**. An E-File Rejected window displays.
14. Enter comments in the comments field and click **Save**. The following message displays: *Reports Successfully removed from E-File.*

#### NOTE

The comments box in the E-File rejected window allows entering a maximum of 120 characters. As you begin entering the comments, the word count displayed below the comments box keeps decreasing. If you try to enter more than 120 characters in the Comments box, the following message displays: *Number of characters exceeded.*

15. Click **OK**. The rejected E-File is removed from the E-File List results.

## 8.3.5 Completing the SAR Process

After the status of the regulatory reports reflects the acknowledgment action and the BSA Tracking Identifier, you can complete the suspicious activity reporting process by clicking the **Complete SAR Process**. The status of all regulatory reports included in the E-File then changes to *Filed*. After a report is moved to the *Filed* status it cannot be edited.

To complete the SAR process, follow these steps:

1. Go to the **E-Filed Status** tab.
2. Search for the report using the E-File Search bar or from the E-File List results.

3. Select the E-File for which you want to complete the SAR process.
  4. Click the **SAR Process Complete**. A SAR Process Complete dialog is displayed. Enter the required comments and click **Save**. This comment is displayed in E-File list Completion Comment column. The following message displays: *Update Operation Successful*.
- When you try to take **Complete SAR Process** action before performing the Upload Acknowledgment action the following warning message displays: *You must first upload an acknowledgment file before taking this action*.
  - When you try to take **Upload Acknowledgment** action on a file for which the SAR process is already completed, the following warning message displays: *The SAR process is complete for this file. No further action is permitted*.

### 8.3.6 Continuing Activity Report

A continuing report is filed on suspicious activity that continues after an initial SAR is filed with FinCEN. The FCCM ECM and CRR solutions can be configured to assist with this process.

In the ECM system, when you close and file a SAR on an AML case, a new Continuing Activity (AML\_CA) case is created, and an Initial Report is created in the CRR system.

In the CRR system, when an initial SAR is filed with FinCEN an Acknowledgement generated by the FinCEN E-File System. For more information on the Acknowledgement, see [Acknowledgement](#) section. If using SDTM integration with FinCEN, this Acknowledgement is automatically processed. If not using SDTM, you can complete the suspicious activity report process by performing the Complete SAR Process action. For more information on SDTM, see [Configuring Secure Direct Transfer Mode \(SDTM\)](#) section in [USSAR Administration Guide](#).

Once the Acknowledgment is processed, information about the SAR filing will be available in the Previous Report Summary tab of the CAR case in the ECM system.

The Continuing Activity (CAR) case allows investigators to review activities that occurred after filing the SAR on the previous case. This case must be investigated and concluded within your firm's review period, typically 90-120 days. After this period, if the individual involved in the case continues to be engaged in reportable behavior, a continuing SAR must be filed.

When you file a SAR for the CAR case, the relevant information of the previously filed report will be provided to the Continuing Activity filing and pre-populated in the relevant fields.

The workflow continues in both CRR and ECM systems till the case is closed in the ECM system.

When Continuing Activity Report SAR is generated, the following field details are auto-populated in the CRR application.

- Filing Institution Information tab
  - Type of Filing Section: The Continuing Activity Report box is auto checked.
  - Filing Institution Information section: Prior Report Doc Number is auto populated.
- Suspicious Activity Information tab: field 30. Activity Date from and To and field 31. Cumulative Amount details are auto populated.

### 8.3.7 Adding Comments to E-File

You can add comments to a record at any time using the Comment button. Adding comments to an E-File does not have any impact on the reports included in the E-File. If you select to add a Comment to an E-File with an existing report you can either append it to the previous comment or replace it completely.

To add comments to an E-File, follow these steps:

1. Go to the **E-Filed Status** tab.
2. From **E-File List** results, select an E-File record for which you want to add a comment.
3. Click **Add Comments**. An E-File Comments window displays.
4. Enter comments in the comments field and click **Save**. The following message displays: *Update Operation Successful*.
5. **Note:** The comments box in the E-filing Comments window allows entering a maximum of 250 characters. As you begin entering the comments, the word count displayed below the comments box keeps decreasing. If you try to enter more than 250 characters in the Comments box, the following message displays: *Number of characters exceeded*.
6. Click **OK**. The E-File Comments window displays.
7. Click **Close**. The E-File List results page displays.

### 8.3.8 Export to Excel

In the E-File List, you can export the report details into an Excel or CSV format.

To export the report details into an Excel or CSV format, follow these steps:

1. Go to the **E-File List** page.
2. Click  **Export to Excel** . Select either Excel or .CSV option. The complete list of E-Files is exported in the Excel or .CSV format based on your selection and saved in your local directory.

**NOTE** You cannot export individual reports into Excel or CSV format.

## 8.4 Acknowledgement

An Acknowledgement is a receipt generated by the FinCEN E-File System when you submit an E-File. After submitting an E-File, the FinCEN E-File System sends an acknowledgement. The acknowledgement file contains a BSA Identifier and corresponding acknowledgement errors associated with each SAR element received via automatic or manual submission.

This feature helps filter acknowledgement receipts processed by the FinCEN E-File System for further verifications in the Acknowledgement tab of the OFS CRR US SAR application.

To search and view the acknowledgement receipts, follow these steps:

1. On the **File Reports** page, click the **Acknowledgements** tab. The **Acknowledgement Receipts Search and List** page is displayed.

- Click **Go**. The relevant search list is displayed with Acknowledgement Name, Efile Name, Filing Date, Status, BSA Tracking ID.
- To view acknowledgment and report detail, select the required record number and click on the row from the list. The **Acknowledgment Errors** pane is displayed. This pane details the Report ID, Level (Fatal, warning, and so on), Context (issues related to address, phone, and son), Code (FinCEN code), Description (reason for rejection).
