## 1.1 Who Should Use this Guide

The Enterprise Case Management User Guide, is designed for the following users:

- **Case Analyst**: This user works on the cases within the application frequently. This user's specific role (that is, Case Analyst) determines what this user can see and do within the application.
- **Case Supervisor**: This user works on cases within the application on a daily basis and is typically a higher level Analyst.
- **Case Viewer**: This user has specific viewing rights to the cases. This user's specific role (that is, Case Viewer) determines what this user can see within the application. For complete details on the user roles and privileges, see the <u>User Roles and Privileges</u> section.

# 2 About Enterprise Case Management

The purpose of Enterprise Case Management (ECM) is to help your firm to investigate and resolve cases.

Topics:

- Introduction
- Enterprise Case Management UI
- User Roles and Privileges

## 2.1 Introduction

Enterprise Case Management (ECM) supports the investigation and resolution of cases. Once created, a case is taken through various statuses as part of the investigation and reaches closure through resolution actions.

Enterprise Case Management supports modifying the case details and the associated business data. Investigation workflows can vary based upon the type of case being investigated. Case investigation and resolution are supported by various actions, which may be specific to the case type. Access to types of cases as well as certain actions can be controlled based on a user's role and access permissions. Cases can be manually created within ECM.

Enterprise Case Management supports product default case types that drive the Investigation workflow. Case types are configurable values and can be defined by your firm to meet your business needs. For more information on configuring case type, see the *Managing Case Designer* chapter in Administration and Configuration Guide.

### 2.1.1 Key Features

The following are the key features of the ECM application:

- Create cases manually for investigating business entities involved in the potentially suspicious
   event
- Add events manually to a case or create them and have them place in the correlation pool
- Perform in-depth analysis of each case by using Case Summary details
- Operational tabs: assist to capture various information to investigate a case for resolution
- Business tabs: help in categorizing large amounts of supporting data into smaller tabs of data, organized by data type (for example, account information, customer information) to aid in the analysis of a case
- View and analyze correlation details source correlation, linked events, and business data correlation
- View how the case score breaks down into individual scoring components
- Act on the case based on the analysis

- Filter cases based on the Case or Event IDs, search criteria and create and manage Personal Search Views
- Record the complete audit history of the case
- Export case information in Excel and CSV formats

## 2.2 Enterprise Case Management UI

The Enterprise Case Management User Interface (UI) is used to understand case details for the investigation and based on the user privileges you can perform various tasks.

- <u>Case Creation</u>
- <u>Case Search</u>
- <u>Case Investigation</u>
- <u>Action on Case</u>
- <u>Case Audit History</u>

### 2.2.1 Case Creation

The cases are listed on the ECM UI based on the case type and user privilege.

Cases are also created manually by privileged users by entering new case information. Cases are created based on the case type. The case types are displayed based on the logged-in user. See <u>Creating</u> <u>Cases</u> for more information.

NOTE

Manual case creation for KYC is not supported.

### 2.2.2 Case Search

The Case Search enables to filter cases to view and investigate the Case List section. The Views search option represents pre-populated search queries and Case ID search criteria is mutually exclusive with all other filter criteria. Various other search criteria assist in filtering required cases for the investigation. See <u>Searching Cases</u> for more information.

### 2.2.3 Case Investigation

The comprehensive case investigation is carried out for the selected case resolution using the Case Summary page. This page provides details of the selected case to have complete insight of the case for the analysis.

The Case Summary page has the Case Context section, which provides a snapshot of the selected case. It also has Case tabs, which provides the comprehensive details of the selected case in form of Operational tabs (mandatory tabs) and Business tabs (optional tabs, available based on the case type). See <u>Investigating Cases</u> for more information.

### 2.2.4 Action on Case

After investigating the case, you can take appropriate action on the selected case or cases for the resolution. You can assign a case to other user and add evidence to the case. Using Take Action button, you can set due date, email a case, and take resolution action on the case. See Acting on Cases for more information.

## 2.2.5 Case Audit History

The Audit History displays complete historic details of the case. This allows to view and analyze actions previously performed on the current case by the system or user and the date and time of the case action, status. This helps to save time to analyze a case details and determine the next course of action on the case resolution. See <u>Using Audit History</u>, for more information.

## 2.3 User Roles and Privileges

Enterprise Case Management system offers three different types of user roles for investigating the cases. These are Out of box roles used in the default workflows.



Cookies must be enabled. If you have problems troubleshooting your display, contact your System Administrator.

# 3.3.3 Enabling Temporary Internet Files

Temporary Internet files are pages that you view on the Internet and store in a folder for quick viewing later. You must adjust this setting to always check for new versions of a stored page.

# 3.3.4 Enabling File Downloads

File downloads must be available.

# 3.3.5 Setting Printing Options

Printing background colors and images must be enabled.

**TIP** For best display results, use the default font settings in your browser.

# 3.3.6 Enabling Pop-up Blocker

Some users may experience difficulty running the Oracle Financial Services ECM application when the Pop-up Blocker is enabled. It is recommended to add the URL of the application to the *Allowed Sites* in the Pop-up Blocker Settings.

# 3.4 Setting Preferences

The Preferences section enables you to set your OFSAA Home Page.

To access this section, follow these steps:

1. Click **Preferences** from the drop-down list in the top right corner, where the user name displays.

**2.** In the Property Value drop-down list, select the application which you want to set as the Home Page.

# 4.1 About Case Search and Case List

Case Search enables you to filter cases that you want to view and analyze on the Case List section. You can filter the Case List based on following case search criteria.

- Enterprise Case Management filters cases based on the following conditions:
  - The Case/Event IDs, Views, and search criteria.
  - Your access control permissions.
- The Views search option represents pre-populated search queries.
- The Case ID Search Criteria are mutually exclusive with all other filter criteria.
- The Case List displays the list of cases as per the search criteria specified in the Case Search section.
- Various actions can be taken on the filtered cases.
- Export cases in Excel or CSV format.
- Highlighted overdue cases in Red color in Due Date column

- Cases nearing the due date is highlighted in Blue color in Due Date column.
- Displays colored Case priority that helps you to easily differentiate the cases with high and low priority.

To access the Case Search and List page, navigate to the Enterprise Case Investigation page and click Search Cases. The Case Search and List page displays. , For more information, see the <u>Getting</u> <u>Started</u> section.

# 4.3 Searching Cases

This section describes different ways to search cases and steps to filter cases based on the search criteria.

NOTE

You can use only one search criteria at a time.

You can filter cases using the following ways:

- Using Views
- Using Case ID or Event ID
- Using Search Criteria

# 4.3.1 Using Views

The following are the salient features of Views search:

- Views represent pre-populated search queries.
- Views allow a single-click option for returning a filtered case list based upon the view's preset search criteria.
- Search fields display based on the type of Views you select.
- You can create and manage personal saved views.

To search for cases using the **Views** search, follow these steps:

- 1. Navigate to the Case Search and List page.
- 2. Select a view type from the **Views** drop-down list.

### 4.3.1.1 Creating a Search View

The Save View option allows you to create and manage personal search criteria for your future uses. You can also make Search View as a default search criterion. The newly created search views are listed in the Views Search drop-down list and User Preference page. These search views are available only to the user who creates it.

To create search views, follow these steps:

- 1. Navigate to the **Case Search and List** page.
- 2. Enter your search criteria in the Advanced Search fields and click Save As View.

- **3.** Enter a View Name for the personal search view.
- **4.** Optional: Select **Set as Default Search** to make this Search View as default search criteria for all your future uses.
- **5.** A confirmation message displays and a newly created save view displays in the Views dropdown list. This save view is also displayed in the User Preference page. For more information, see <u>Setting User Preferences</u>.

# 4.3.2 Using Case ID or Event ID

Using the Case ID or Event ID enables you to search cases by simply entering the case or event IDs. When searching by Case ID or Event ID, consider the following :

- Enables you to search cases by simply entering the case or event IDs.
- It is mutually exclusive with all other search criteria.
- If you attempt to search by a combination of case or event ID and other search criteria, the search results display only based on the Case or event ID and ignore other criteria.
- It exactly matches the values you have entered. You can search for one or more cases or event IDs.

To search for cases using Case or Event IDs, follow these steps:

- 1. Navigate to the **Case Search and List** page.
- 2. Click Advanced Search. The Advanced Search pop-up appears.
- 3. Enter one or more unique case or event identification numbers in the Case ID or Event ID field.

**NOTE** To search for multiple IDs, separate the Case ID or Event ID with commas.

**4.** Click **Search** or press **Enter** key on the keyboard. The Case List page displays information about the cases with the Case ID or Event ID that exactly matches the values you have entered.

**NOTE** Search by Case ID or Event ID ignores all other search criteria.

# 4.3.3 Using Search Criteria

The following are the salient features of other Search Criteria:

- The Case List is dynamically populated based on the different set of input criteria.
- Blank value is equivalent to select all.

- Only the data that match your specified criteria and cases, which you are authorized to view are displayed as search results.
- 1. To search cases using **Advanced Search** criteria, click **Advanced Search**. The additional search fields are displayed.

Scenario	Scenarios are displayed in the list based on the event type you select in the Event Type search field. If you don't select any event type then all available scenarios are displayed.
Assignee	This filters the Case List by a user or user pool to whom a case is assigned. The multi-select drop-down list contains only users or the user pool whose jurisdictions you are authorized to view.
Standard Comments	This filters the Case List by the standard comments associated with the case.

Narrative/Comments	This filters the Case List by narrative or comments associated with the case. When searching on Narrative/Comments from advanced search, a percent sign ('%') is automatically appended to the beginning and end of the values entered. This is necessary since Narratives are stored as rich text to allow for formatting.
Created By	This filters the Case List by a user or user pool, who created the case.
Regulatory Report Status	This field allows you to filter the cases based on Regulatory Report Status of case. For example, Approved for Filing, Closed-No Action, and so on.
Case Score	This filters the Case List by the score of the case.
Description	This filters the Case List by the description of the case that matches the search criteria. This supports wild-card search. The percent sign (%) is used for this.

# **NOTE** When you filter using multiple search fields, the results are filtered after matching all the search criteria specified. The Risk Score field is available only for KYC cases.

- 2. Click Search. The Case List section displays the list of cases that meet the search criteria.
- **3.** The Case List section enables you to view details about the cases and take various actions depending on the user privileges.

**NOTE** By default, the search list is sorted by Due Date, Priority, and then Case ID.

# 4.4.1 About Case List

The Case List is the case search result area which displays a list of cases based on your search criteria.

Navigate to the Case Summary page by clicking a Case ID link. Based on your role, you can take various actions on one or more cases, such as assigning cases to the user or user pool, or adding evidence to one or more cases.

The Case list is sorted in ascending and descending order in the column header. Columns that depict the case information are hidden or shown using field chooser.

You can also export cases in Excel or CSV formats.

# 4.4.2 **Preview Case**

This section displays the list of cases based on the cases title. To preview the case, follow these steps:

- 1. Navigate to the Case Search and List page
- 2. Select the Case ID.
- 3. Click **Preview Case** . Case ID preview displays.

The following table provides the Preview Case details.

- 2. Click Search. The Case List pane displays.
- **3.** The following table provides the case details based on the search criteria.

Jurisdiction	Displays the jurisdiction to which the case belongs to.
Business Domain	Displays the business domain to which the case belongs to.
Linked Events	Displays the event which is linked to the case.
Linked Case	Displays the other case which is linked to the case.
Created By	Displays the name of an individual or user pool who has created the case.

Age	Displays the age of the case. The case age is the number of calendar days between case creation and the current date.
Score	Displays the score of the case.

- **4.** Click the required **Case ID**. The Case Summary page displays to perform in-depth analyses of individual case.
- **5.** If the selected case is locked, that is, another user has currently accessed the same case, a message displays, informing you that the case is locked by another user. Click OK to view the case details page in view-only mode. You cannot take action on the case. For more information, see Investigating Cases.

# 4.4.4 Acting on Cases

You can take various actions on cases that are listed in the Case List section.

**NOTE** Actions are visible as per your access permissions.



# 5.1 About Investigating Cases

The comprehensive case investigation is carried out using the Case Summary page for the selected case resolution. This page provides complete details of the selected case and you can take appropriate action on the case. The limited Case details are also available in the List page for your analysis.

# 5.1.1 About Case Summary

The Case Summary page provides information about the case in the following ways:

- **Case Context**: The Case Context section provides a snapshot of the selected case. You can also modify a few information based on your analysis.
- **Case Tabs**: The comprehensive details of the selected case are available in the tabs. The following types tabs are available for the selected case:
- **Case Operational Data tabs**: These tabs are available for all types of cases. For example, Evidence, Audit History, and Narratives. The data in each tab displays based on the access privilege provided to the user. Users view, analyze, update information pertaining to cases, and provide inputs using these tabs. This information enables you to take appropriate action on the cases. For more information, see the <u>Using Operational Data Tabs</u>.
- **Case Business Data tabs**: These tabs are available based on the case type selection. Business tabs help users categorize large amounts of supporting data into smaller tabs of data, organized by data type (for example, account information, customer information) to aid analyzing of a case. The data in each tab displays based on the access privilege provided to the user. For more information, see the <u>Using Business Data Tabs</u>
- Action Buttons: Some actions can be taken directly on the selected case from the Case Summary. For example, you can assign a case, add evidence, and email a case. Action buttons are available based on the case type and access privilege. More information on how to use these buttons can be found in their respective sections.

**NOTE** When you open a case and navigate to the Case Summary page, the selected case is locked by you and other users are allowed *view-only* access to the case. If other users attempt to access the same case, they receive a message informing that the case is locked by another user and granted only view rights (they can take no action on the case).

# 5.2 Accessing Case Summary Page

This section explains how to access the Case Summary page.

To access the Case Summary page, follow these steps:

- 1. Navigate to the **Enterprise Case Investigation** page, see the <u>Getting Started</u> for more information.
- 2. Select Search Case. The Search and List page displays.
- **3.** Search cases based on your requirement. For more information, see the <u>Searching Cases</u> section.
- 4. Click the required Case ID link. The Case Summary page displays.

NOTE	If the selected case is locked, that is, another user has currently accessed the same case, a message displays, informing you that the case is locked by another user. Click OK to view the Case Details page in view-only mode or click Cancel to return to the Case List. You cannot take action on the case.

# 5.3 Using Case Context

This section describes how to view complete case details and take appropriate action on the case.

# 5.3.1 About Case Context

The Case Context section provides a brief description of the case and the context for determining what actions have to be taken to dispose of the case. The Case Context displays on the top of every tab. Once you have entered the workflow for a single case (by a selection of the case from the Case List), the Case Context remains visible to you as you navigate the various tabs relevant to the particular case. You can also click the selection of second expand the Case Context. By default,

the Case Context displays in the contracted mode. Case ID, Title, Status, and Priority details are visible on the header in a contracted mode with an expand sign visible on it.

# 5.3.2 Viewing Case Context

To view the Case Context, follow these steps:

- **1.** Navigate to the Case Summary page.
- **2.** Go to the Case Context section. The basic case details are displayed with Case ID, Title, Status, and Priority.
- **3.** Click Case ID. The Case Context section is expanded to view and modify the selected Case ID.

The Case Context fields are configurable, for more information, see the *Adding and Configuring Derived Attribute* section in <u>Administration and Configuration Guide</u>.

The following table provides a list of the fields that display in the Case Context section.

Field	Description
Title	Displays the name of the case. You can modify the title of the case if your role permits.
Case ID	Displays the unique Identifier of the case.
Class	Displays the class of case. For example, AML, Fraud.
Туре	Displays the type of case. For example, AML_Surv.
Status	Displays the current state of the case relative to its analysis and closure.
Priority	Displays the priority assigned to the case. For example, High, medium, or low. You can modify the priority of the case if your role permits.
Jurisdiction	Displays the geographical Jurisdiction associated with the case.
Business Domain	Displays the business domains associated with the case.
Created	Displays the date on which the case is created.

Risk Score	Displays the risk score as provided by the system or the override score (applicable only for KYC cases).

Owner	Displays the name of an individual user or the user group who owns the case.
Owner Organization	Displays the organization that owns the cases.
Due	Displays the date by which action should be taken on the case.
Closed Date	Displays the date when the closing action was taken on the case.
Assignee	Displays the user or group to whom the case is assigned.
Age	Displays the age of the case. The case age is the number of calendar days between case creation and current date.
Score	Displays the score of the case.
Regulatory Report Status	Displays the regulatory report status of the case. For example, Approved for Filing, Closed- No Action, and so on.
Description	Displays the description of the case that gives a high-level insight on the subject matter of the case.
Event Last Added	Displays the date in which the last event was added to the case. The field can be blank until correlation extends the case or an event has been manually added to the case.

# 5.3.3 Editing Case Context Details

The Edit button is enabled for the case details modification based on the user permission.

To edit the Case Context details, follow these steps:

- 1. Navigate to the Case Context section.
- 2. Click Case ID. The Case Context section is expanded to view and modify the selected Case ID.
- 3. Click Edit. The following fields are enabled to modify the case details.
  - Title
  - Priority
  - Description

Below three are specific to KYC Case types

- **Risk Score:** Users can edit the risk score provided by the system during the investigation. The overridden risk score is given preference over the system risk score.
- **Risk Score Expiration Date:** User can provide a risk score expiration date which indicates that the overridden risk score for this customer is applicable as on this date.

Note: How to use the risk score expiration date is to be configured during deployment as per your requirements.

• **Next Periodic Re-review Date:** User can provide a periodic review date manually which is given priority over the system derived next periodic review date.

For more information on the fields, see <u>Table 12</u>.

- 4. Modify the necessary changes and click Save. A confirmation message displays.
- 5. Click **OK**. The Case Context section is refreshed to display the updated detail.

The following tasks are performed using operational data tabs:

- Assist to capture various information to investigate a case for resolution
- Record narrative analysis of a case
- Link or unlink existing involved parties and link new involved parties to the case
- Provide comments and attach relevant documents
- View other cases that are related to the current case being investigated
- Link, unlink or add more links in the related cases
- Draw a graph with one or more business entities as the starting point for the network creation
- View complete audit history of the case to take further action

# 5.4.2 Using Narrative

This section discusses Narrative and its usage in investigating a case.

The following sections are covered in this section:

- About Narrative
- Creating/Editing a Narrative
- <u>Viewing Narrative History</u>

### 5.4.2.1 About Narrative

If your role permits, the Narrative allows you to capture any narrative surrounding the analysis of a case that has helped you to dispose a case. The narrative exists as a single data element on a case, which allows you to add and to maintain that narrative. The case narrative is used for SAR filing. Narrative supports Rich Text Formatting (RTF).

The following tasks are performed using the Narrative:

• View Relevant Events and Involved Party List.

**NOTE** Only those events which are marked as Relevant are shown in the Relevant Events List.

- Record textual analyses of a selected case
- Modify the existing narrative for the case
- View the audit history of the narrative to know the last updated date, timing, and user who updated it

### 5.4.2.2 Creating / Editing a Narrative

If your role permits, the Narrative allows you to capture any narrative surrounding the analysis of a case that has helped you to dispose a case.

**NOTE** By default, the entry box is blank if the previous narrative is not added.

To create a narrative, follow these steps:

- 1. Navigate to the Case List page. Select a case for which you want to create a narrative. The Case Summary page displays for the selected case.
- **2.** Click the **Narrative** button at the top right side of the screen. **Add Narrative Comment** pop-up window displays.

Narrative History page in the Narrative button allows you to view the date and time on which the narrative is created or edited, the user who created or edited, and the complete narrative analysis of the selected case.

To view the audit history of a narrative, follow these steps:

1. Click Narrative button. Add Narrative Comment pop-up window displays.



2. Enable the History Toggle button. The Narrative History window displays with the following information for your analysis.

An Involved Party is an entity (for example, account, customer, or correspondent bank) that is associated with a case investigation in some capacity. Parties are primarily involved in a case investigation as a witness, suspect, victim, or other. Existing parties are linked from various Business entity tabs using the Designate as Involved Party option.

- View and analyze the list and detailed information of parties that are linked to the current case
- Add existing parties to the case or create new involved parties
- Modify and remove parties linked to the case

### 5.4.3.2 Viewing Linked Involved Party

This section displays the list of the linked involved parties and provides complete information of involved parties that are currently linked to this case. This section identifies the nature of the relationship the party has with the case. Parties are considered to be involved with a case either as a suspect, victim, or witness. If the relationship cannot be categorized as one of these types, then it can be categorized as other.

The following sections are covered in this topic:

- <u>Viewing Involved Party Details</u>
- <u>Viewing Involved Party History</u>

#### 5.4.3.2.1 Viewing Involved Party Details

This section helps you to view the complete information about the selected involved party.

To view linked involved party details, follow these steps:

- 1. Navigate to the Case Summary page.
- 2. Click **Involved Party** tab. By default, involved parties that are linked to the selected case are displayed in a list. You can view Involved Party details relationship type, party name, party ID, issuing authority, and so on.
- **3.** To view individual Involved Party details, select an Involved Party in the list and click **Details** link. The Involved Party Details window displays with complete information of the selected Involved Party.

### 5.4.3.2.2 Viewing Involved Party History

This section guides you to view the complete audit history of the selected involved party so that you can analyze how, when, and by whom the party is linked to the case.

To view the history of the involved party, follow these steps:

- 1. Navigate to the **Involved Party** tab.
- **2.** Select a linked involved party from the list and click the **History** link. The History window displays.
- **3.** The History window has the following sections:
  - Audit History: lists any changes that are made to the involved party's profile, such as, name
    or address change. Records that are modified display as Inactive and original values. The
    modified and current version of the record display as Active.
  - History of the Involved Parties Linkage to this Case: lists any changes that are made to the involved party's relationship to the case. Records that are modified displays as Inactive and original values. The modified and current version of the record display as Active.
  - Other Cases the Involved Party is Linked to: lists all other cases to which the involved party is linked to.

### 5.4.3.3 Adding Involved Party

This section provides instructions on how to add existing or new involved party or parties to the selected case.

You can add a new business entity in the following ways:

- Adding a New Involved Party Manually
- Adding a New Involved Party from Existing Entities

### 5.4.3.3.1 Adding a New Involved Party Manually

To add a new involved party manually, follow these steps:



- 2. Select an involved party. Click Edit. The Edit Involved Party Detail window displays.
- 3. Modify the necessary information in the required fields.
- 4. Click **Save**. A confirmation message displays. Click **Cancel**. The window closes and navigates you to the refreshed list of Involved Party. Also, corresponding audit entries are recorded on the case.

### 5.4.3.5 Removing Involved Party

To remove existing involved parties, follow these steps:

- View and analyze comments and attachments previously added to the case.
- View and analyze comments and attachments associated with the case that has been added through specific case actions
- Add new comments or attachments to the case under investigation.
- Evidence has three sections:
  - **Comments**: This section allows you to view the comments added to the case either through the Evidence or added as a part of any actions taken on the case during investigation. The Comments section includes the creation date and time of the comment action, the user who took the action, case status at the time of the comment, and comments added.
  - **Attachment**: The Attachment section allows you to view the attachments added to the case either through the Evidence or added as a part of any actions taken on the case during investigation. It includes the creation date and time of the case action associated with the attachment of the file to the case, the user who took the action, case status at the time of the action or resulting from the action, any comments associated with the attachment name, and the Attachment count.

You can also post attachments and comments from an external application to a case in Oracle's Enterprise Case Management application. For more information, see the <u>OFS ECM</u> <u>Attachment/Comment Service Guide.</u>

NOTEThe attachments send along with Send Email and SendRFI actions can be seen in Email and Request For<br/>Information section.

 Email and Request For Information: The Email and Request For Information section allows you to view the details of Send Email and Send RFI actions. For more information, see <u>Viewing Email Details</u> and <u>Viewing the RFI Details</u> sections.

### 5.4.4.2 Viewing Comments or Attachment

This section allows you to view comments and attachments previously added to the case.

To view comments and attachment to a case, follow these steps:

- Navigate to the Case Summary page. Click **Evidence** button.
- Go to Comments or Attachment section. Click 🗈 to expand to view the existing Comments or Attachment for the selected Case ID.

The Add Evidence button is available on the top of all tabs. For more information on adding comments and attachment to the case, see the Adding Evidence.

### 5.4.4.4 Removing Attachment

If your role permits, you can remove attachments to the case under investigation.

To remove an attachment, follow these steps:

- 1. Navigate to the Case Summary page. Click **Evidence**.
- **2.** Go to Attachment section. Select the Attachment name.
- 3. Click **Remove**. The Attachment window displays.
- **4.** Enter the comments for removing the selected attachment in the Comments box.

**NOTE** If the window has more than one attachment, select the required attachment and enter the comments in the Comments box.

5. Click **Save**. The attachment is removed from the Attachment List for the selected case.

# 5.4.8.1 About Correlation Tab

A Correlation is defined as a group of events, which are associated with one another based upon matching a set of criteria as defined by a correlation rule.

This correlation is referred to as the source correlation of the case and events, which are members of that correlation become events linked to the case. The Correlations tab provides information regarding the source correlation and the business associations of the events linked to the current case. You can view the source correlation that resulted in the automatic creation of the case, if applicable. In addition, the Correlation tab provides a complete listing of the business entities correlated with the events linked to the case, regardless of whether or not those entities become part of a correlation.

# 5.4.8.2 Viewing Correlation Details

This section provides you details of correlation rule, the date on which it is created, the date on which it is updated, and score details.

To view score details breakdown, click the **Score** link. The breakdown of the correlation score displays. For example, Event Score, Entity Score, correlation Score, and Adjustment Score.

#### 5.4.8.3 Viewing Correlation

The Correlation section displays the correlation that is the source and target of this case creation.

The Correlation section displays only when the case was created due to promotion of events. If the case is manually created, this section is collapsed and does not possess any correlation information. A message displays, indicating that no source correlation is associated with this case.

Correlation provides information about events that are correlated based on the correlation rule that is set by the client. For more information, see the Administration and Configuration Guide.

To view source and target correlation details, follow these steps:

- **1.** Navigate to the Case Summary page.
- 2. Click the **Correlation** tab. Go to the Correlation section. The following correlation details are displayed.



- Transactions can generate a network on its own, using the search criteria provided by the user via Filters.
- This tab provides the flexibility to draw a graph with one or more business entities as the starting point for the network creation.
- Using Filters feature, the ad-hoc networking, network can be generated from all entities that are part of the case.

**NOTE** In the Network Analysis tab, all entity searches are run on the business data of the application, and not the case data.

#### 5.4.10.2 Filtering Network Analysis



- **2.** Go to the LHS section and filter the Network Graph based on your requirements. The Network Graph displays.

- View Node Details: This opens a window that displays the current information associated with the selected node. You can interact with the main application window that displays the graph while this window is open. At any given time, only one window can be open for a particular node. If you select to view node details of a node for which a Node Details window is already open, an error message displays.

#### 5.4.11.1 About Relationship Tab

The Relationship tab allows you to view the list of cases and events which are linked to the case being viewed. This tab has two sections- Related Cases and Related Events.

The following tasks are performed using the Relationship tab:

- View the list of cases and events related to the current case through relationships to entities involved in other cases and events or by virtue of another case and events being linked to the current case.
- Link related cases or events, which are not yet linked to the current case.

- Unlink related cases or events, which are already linked to the current case.
- Search cases or events record for adding an additional case or event links to the current case.

**NOTE** Linking and Unlinking activities of cases and events depend on the user roles.

#### 5.4.11.2 Managing Related Cases

If your role permits, you can link or unlink to the selected case and also add more cases to link to the selected case.

The following topics are covered in this section:

- About Related Cases
- Using Links

#### 5.4.11.2.1 About Related Cases

The Related Cases sections allow you to view cases that are related to the current case through common business entities and cases, which are manually linked to the current case by a user.

The following example explains the logic used to identify common business entities. For Case A, all cases that have the same business entity ID(s) as that of Case A are considered as related cases. For example, if two cases possess the same customer IDs, account IDs, or other business entity IDs applicable in Enterprise Case Management then they are considered as related.

- The Related Cases section visually distinguishes cases that are manually linked to the current case from those that are related to the current case through common business entities.
- The **Case ID** link in Related Case section allows you to view the following details of the related case: Event Details tab, Evidence (including comments, attachments, Email, and RFI), Narrative, and Audit History.
- The User Linked column in the Related Cases section displays *Yes* when you manually link a case to the current case by performing the Link action and displays *No* when the system links the case (as part of correlation promotion to a case).
- The Linked column in Related Cases section displays, relationship type. For example, Linked, Merged or Closed Duplicate. If the case is related as a result of being linked and displays *No* when the case is considered related to the current case by a business association but has not been linked to the current case.

**NOTE** Related cases are not displayed if they are created after the closure of the selected case.

#### 5.4.11.2.2 Using Links

This section describes how to link the case to one another, merge case to one another, and close cases as duplicate for the related cases. You can perform any of the case link actions by selecting multiple cases and choosing the appropriate Case Link action, that is, Link, Merge, and Close as Duplicate.

Case Supervisor and Case Analyst can link a case.

This section covers the following topics:

- Linking/Merging Case
- Unlinking Case
- Adding Cases
- <u>Viewing Relationship Reason</u>

#### 5.4.11.2.3 Linking/Merging Case

This section allows you to link and merge cases to the current case. You can link cases to one another, merge case to one another, and close cases as duplicate for the related cases. All the information, including events, business entities, narrative, comments, and attachments of child case are copied to the parent case.

The audit history of the parent case will record which cases were merged into it.

To link and merge cases to current case, follow these steps:

- 1. Navigate to the Relationship tab. Go to the Related Cases section.
- 2. Select Case ID or IDs.
- 3. Click Link/Merge. The Link Cases window displays.
- 4. Enter the following information in the respective fields.

- 5. Click **Save**. A confirmation message displays. The selected cases will be linked and merged with the current cases. Click OK to save the changes.
- 6. Click **OK**. The window closes and navigates you to the refreshed list of Related Cases, and the updated records are displayed. Also, corresponding audit entries are recorded on the case.
  - **a.** If you select Link action, No information is transferred to the selected case. The action is recorded in the Audit History as a Link Case for the current case and the selected related cases, with the case ID attached to the Comments section of the Audit tab for the parent case.

This action does not affect the status of the cases. If you select Merge action, the selected related cases are merged to the current case, and the information is transferred. The system records the action as Merged Case Linked (Case Linked and Merged) for the current case and Merged Case for the merged cases. The status of the merged case changes to Closed-Merged, if the present status is not Closed, else the status remains as Closed. This action does not change the status of the current case.

**b.** You can see merged attachments and comments in the **Evidence** and **Audit History** of the parent case. You can view the comments on the **Evidence** or through **Audit History**. Once you confirm Close-Duplicate action, the system records the action as Duplicate Case Linked for the current case and Closed Duplicate for the selected cases in the Audit history. This action does not have any change the status of the current case, but changes the status of the selected cases to Closed-Duplicate.

NOTE

For merged cases, accounts related to the customer will not be filtered based on the Account Role configuration done in the Manage Common Parameters section. Only the accounts and customers on the child case are added to the parent. No additional accounts are added.

#### 5.4.11.3 Unlinking Case

This section allows you to unlink related cases that are linked to the current case.

You can unlink only those cases which are already linked by the user.

To unlink cases to the current case, follow these steps:

- 1. Navigate to the Relationship tab. Go to the Related Cases section.
- 2. Select only those cases which are already linked by the user with Link status *Linked*.
- 3. Click Unlink Cases. The Unlink Cases window displays.
- 4. Enter comments to unlink the selected Case ID or IDs. A confirmation message displays.
- 5. Click **OK**. The selected cases are unlinked. The updated Related Cases section displays.

**NOTE** If the case was only considered related based upon the link action, the Related Cases section refreshes and the unlinked case no longer appears.

# 5.4.11.4 Adding Cases

If your role permits (not only role, the security attribute mapping also matters) you can search for any case record by Case ID for the purpose of adding additional case links to the current case.

To add cases, follow these steps:

- 1. Navigate to the Relationship tab. Go to the Related Cases section.
- 2. Click Add Cases. The Add Cases window displays.
- **3.** Enter the Case IDs, Domain, Title, Type, Created From/To, or Jurisdiction in the Case Search fields.
- **4.** Use a comma to separate Case IDs.
- 5. Click **Search**. The required case details are displayed.
- 6. Select the required case IDs and Click Link/Merge.
- 7. For more information on linking cases, see the <u>Linking/Merging Case</u>.

#### 5.4.11.5 Viewing Relationship Reason

You can view the reason of the relationship associated with the case. This shows the details of common entities between the parent and the selected case.

To view the relationship reason, follow these steps:

- 1. Navigate to the Relationship tab. Go to the Related Cases section.
- 2. Select the Case ID using the corresponding check-box.
- **3.** Click **Reason**. The **Reason for Relationship** window displays. This window shows the ID, Name, and Type of Entity.

#### 5.4.11.6 Managing Related Events

If your role permits, you can link or unlink events to the selected case and also add more events to link to the selected case.

The following topics are covered in this section:

#### 5.4.11.7 About Related Events

The Related Events section displays all those events that are related through common business entities and events which are manually linked to the current case by the user. The following example explains the logic used to identify common business entities.

For Case A, all events which are focused on the same business entity ID as that of Case A are considered as related events. For example, if an event and a case are focused on the same customer ID or

account ID or any other business entity ID applicable in the Enterprise Case Management, then they are considered as related.

In the Related Events section, the user Linked column visually distinguishes events that have been manually linked to the current case from those that are related to the current case through common business entities. The User Linked column displays *Yes* when the linking of the events to the case was performed by a user taking a link action, It displays *No* when the action to link the events is performed by the system (as part of events promotion and correlation promotion to a case). In the Related Events section, the Linked column has a value Yes if the event is related by virtue of being linked, *No* when the event is considered related but not linked. In the Related Events section, the Last Status column provides the last closing or status changing action for events which were previously dispositioned and then migrated.

Related events are not displayed if they are created after the closure of the selected case.

#### 5.4.11.8 Filtering Events

This option allows you to filter events related to the current case. By default, all the events are displayed in the Related Events section.

You can filter events based on the following search criteria:

- Association

- Focus

You can select all the filters and apply them using the **Apply** button to filter the related events.

To filter Related Events, select *All Events, Events in Case,* or *Uncorrelated Events* from Association drop-down list. Based on the selection, the Related Event list displays.

#### 5.4.11.10 Linking Events

This section allows you to link related (but not yet linked) events to the current case.

To link events to the current case, follow these steps:

1. Navigate to the Relationship tab. Go to the Related Events section.

- **2.** Select Event ID or IDs.
- **3.** Click **Link Events**. The Link Events window displays. Enter the following information in the respective fields.

Field	Description
Selected Cases	Displays the selected event or events.
Transfer event Information	Select the transfer event information from the multi-select list (Employee, Account, and so on).
Comments	Enter comments for selecting these records.

- 4. Click **Save**. A confirmation message displays.
- **5.** Click **OK** to save the changes. The selected events will be linked with the current cases. The refreshed list of Related Events and updated records display, and corresponding audit entries are recorded on the case.
- **6.** If you select Link action, no information is transferred to the selected case. The system records the action as Link Event for the current case and the selected related events in the audit history with the case ID appended in the comments section in the Audit tab. This action does not affect the status of the cases.

NOTE

Transfer Case Information parameter displays blank values as no information is transferred to the selected case.

Transfer Events Information displays only when you select the Events to be linked. All selected events are linked to the case and data of all the selected data types associated with the event is transferred to the case. You can view the event information in the respective Enterprise Case Management tabs.

When the transfer event information is in synchronous mode, the system processes data transfer while you wait and is unavailable for additional actions until the transfer is completed. The system displays messages for Successful and Unsuccessful data transfer. When the data transfer is successful, a confirmation message displays.

When the data transfer is unsuccessful, an error message displays indicating that the selected events and cases were linked, but an error occurred during the requested transfer of event information to the case.

The case may reflect incomplete business information. Once the data transfer is complete, whether successful or unsuccessful, you are able to continue working.

When the transfer event information is in asynchronous mode, the system processes the data transfer in the background, allowing you to continue to work.

- If you do not make a selection of at least one data type of information to be transferred, the system defaults to transferring all possible event data during the link (that is, not making a selection is equivalent to selecting all).
- The data transferred to the case is the data available as of the date of link action.
- The event information that is already associated with the case as a result of the previous promotion or link actions will not be transferred again during the current link action.


#### 5.4.11.11 Unlinking Events

This section allows you to unlink related events that are linked to the current case.

You can unlink only those events which are already linked by the user.

To unlink events to the current case, follow these steps:

- 1. Navigate to the Relationship tab. Go to the Related Events section.
- 2. Select only those events which are already linked by the user.
- 3. Click Unlink Events. The Unlink Events window displays.
- 4. Enter comments to unlink the selected Events ID or IDs. A confirmation message displays.
- 5. Click OK. The selected events are unlinked and the updated Related Events section displays.



During Unlink action when one or more events are unlinked from the case, the event information which is transferred during link action is not be removed by the system. If required you can manually remove the event information from the appropriate tabs through the Remove action.

#### 5.4.11.12 Adding Events

If your role permits you can search for event record by Event ID for the purpose of adding additional event links to the current case.

To add events, follow these steps:

- 1. Navigate to the Relationship tab. Go to the Related Events section.
- 2. Click Add Events. The Add Events window displays.
- **3.** Enter the Event IDs, Jurisdiction, Focus Name, Domain, Focus, Created From/To, or Scenario in the Event Search fields.
- 4. Use a comma to separate Event IDs
- 5. Click Search. The required event details are displayed.
- 6. Select the required event IDs and Click Link Event.
- 7. For more information on linking cases, see the <u>Linking Events</u>.

# 5.4.11.13 Viewing Event Details

To view the Event Details, follow these steps:

Navigate to the **Relationship** tab. Go to the **Related Events** section and click the **Event ID**. A new window displays with details. The window details of Events will be the same as when you click Event ID on the Search Event page. For more information, see <u>Search Events</u>.

# 5.5 Using Audit History

The Audit History displays complete historic details of the case. This helps to save time to analyze case details and determine the next course of action on the case resolution. Based on the user roles, you can access the different parts (RFI actions, SAR actions, and so on) of the Audit History. If the type of the case is changed, the Audit History shows the case type change details. # 5.5.1 About Audit History

The following tasks are performed using the Audit History:

- View and analyze of all changes which are performed on the case
- Filter audit history of the case by using search criteria such as **view-only** actions, entity changes, **Attachments** Included, **Status** changing action, and **linking** actions
- View and analyze actions previously performed on the current case by the system or user
- View and analyze the date and time of the case action, status, and so on
- View and analyze the attachment pertaining to the case
- View and analyze the RFI details. This includes the User name, Date and Time, Action (RFI Sent), Assignee/Owner, Resulting Status (such as Pending RFI Response), Comments, and Attachment
- Export audit information in Excel or CSV format

# 5.5.1.1 Viewing the Case Type Updates

If the type of the case is changed, the Audit History shows the case type change details with status.

#### 5.5.1.2 Filtering and Viewing Audit History Details

This section explains how to filter audit view details based on your filter criteria selection.

#### 5.6.1.1 About Business Data Tabs

- Case investigations are typically associated with some type of business entity, such as an Account, Customer, Household or Correspondent Bank.
- Business tabs help the users in categorizing large amounts of supporting data into smaller tabs of data, organized by data type (for example, account information, customer information) to aid in the analysis of a case.
- The Business tabs display conditionally based on the case type.
- The Business tabs are divided into two section
- **Entity List**: this section lists the business entities that are associated with the current case.
- **Entity Details**: furnishes complete information of the selected entity.
- Business entities can be associated with a case in one of three ways.
- They can be manually added to the case using the Add feature available on most business tabs.
- They can be associated with a case based on their association with one or more events that are linked to the current case at some point after the case's creation.

By default, the business entities section displays five records.

#### 5.6.1.9.1 About Trusted Pair

Designating Trusted Pairs reduces the number of false positive events by identifying transactions between parties which are viewed as having a trusted relationship. After analyzing events, you can determine two parties are trusted when the activity between the two parties is an acceptable business practice and poses lower risk to the institution.

These transactions can be optionally excluded from detection for many Money Laundering (ML) class scenarios through the use of a threshold parameter. If the relationship between a pair of parties is marked Trusted for a designated period of time and is excluded from the process of behavior detection, the alert will not be created and the workload of an analyst can be greatly reduced.

When investigating a case, ECM users can define a trust for two parties on a transaction and then define the direction of the transaction and the duration of the trust. Upon submission it is sent to an administrator for review and approval.

Administrators review the trusted pairs periodically to approve, reject or extend the trusts. Once a trust is approved, the pair is transmitted to the Behavior Detection application and future alerts for that pair are not created.

### 5.6.1.9.2 Designating a Trusted Pair

You designate a Trusted Pair on the Event Details page.

**NOTE** Select a single record to view the Trusted Pairs History.

- 6. Designate Trust grid: Select the Direction from the drop-down list (Send/Receive/Both).
  - Send → Party 1 sending money to Party 2

### 5.6.1.10 Event Suppression

### 5.6.1.10.1 About Event Suppression

Event Suppression allows an individual to define a focal entity/scenario combination and request that future events for the same be auto-closed. While investigating a Case, users can identify a Scenario-Focal Entity pair when setting a Risk Event Decision. Once a suppression rule has been designated and approved by a Supervisor, future events which meet the criteria are suppressed by the system for the specified period of time.

Administrators review the suppression requests periodically to approve, reject or extend the trusts. Once a suppression request is approved, the information is transmitted to the Behavior Detection application.

### 5.6.1.10.2 Designating Suppression

This section describes how to designate a suppression rule. Suppression is performed on an Event as a Risk Event Decision.

To designate an event suppression, follow these steps:

- 1. Navigate to the **Events Details** tab.
- 2. Select the one or more required Event IDs.
- 3. Click **Set Event Decision**. The Set Event Decision window displays.
- 4. Select **Suppress Future Events** from the **Select Decision** drop-down list.

**NOTE** The Suppress Future Events option in the Select Decision dropdown list will only display for users with a Designate Suppression Rule permission. Contact your administrator to enable this permission.

- Select 3, 6, 9 or 12 months from the **Duration** from the drop-down list. Administrator can configure additional Durations to display in this list. For more information, see the <u>Oracle Financial Services Enterprise Case Management Administration and Configuration Guide</u>.
- **6.** Select the Expiration Date. If both the duration and the expiration are selected, the expiration overrides the duration.
- **7.** Select the Standard Comment from the drop-down list. By default, the following standard comments are provided for AML and FRAUD Case types.

- a. Based on Account Type
- **b.** Based on Customer Type
- **c.** Will be evaluated for Suppression
- d. Will be evaluated for Auto-close

You can select multiple events and set one or more standard comments along with risk event decisions. Administrator can create different Standard Comments per case type. For more information, see the <u>Oracle Financial Services Enterprise Case Management Administration and Configuration Guide</u>.

- **8.** Enter comments in the Comment box for the selected option.
- 9. Click Save.

The updates are recorded and displayed in the Decision column of Event List section. The suppression request is sent for approval. These suppression requests will be available on the Suppression Administration page once the current case is closed. All suppression requests must be reviewed and approved. For more information on how that is done see, <u>Taking Action on</u> <u>Suppression Requests</u>.

NOTE	<ul> <li>The Suppression History below the Cancel/Save button displays whether the Focal Entity/Scenario pair has had suppression rules before.</li> </ul>
	• When multiple events are selected, the Suppression History for all events is displayed in a single grid.

## 5.6.1.11 Network Visualization

Network Visualization is used to communicate information clearly and efficiently via graphics. Effective visualization helps you analyze cases and events. It makes complex data more accessible, understandable, and usable. The Network Visualization section provides insight into the relationship between various entities through graphics.

The Network Visualization link page is accessible for cases that are created using the Enterprise Case Management Framework platform link analysis capabilities such as Networks of Accounts, Entities, Customers, and Hidden Relationships scenarios. The Link Analysis algorithm produces a network of all the related entities that are linked by the information they share.

Nodes are entities, such as a Customer or Account, and each node can join to none, one or many other nodes via a link. The Network Visualization Link page allows you to visualize the nodes involved in a network and the links between those nodes.

There can be more than one link between two nodes. For example, if two bank accounts have multiple transactions between them, then each transaction forms one link.

The graphical representation is supplemented with information regarding each node and link.

The Network Graph displays all nodes in that network even if the node represents an entity that you do not have access to view. In that case, you are restricted from viewing additional details about the node (accessible via the Node Menu).



- **3.** Select the Event ID from **Network Structure** section and click **Network Visualization** link. The Network Visualization page displays.

### 5.6.1.12.1 Using Network Graph Components

A typical network graph shows nodes and links. Nodes are entities such as a customer or account and each node can join to none, one or many other nodes via a link.

Each type of node is associated with a specific icon on the graph. The following table describes the icon displayed on the graph for each type of node

When two nodes are connected by more than one link, the graph displays the link as a complex activity.

The arrowhead on a link represents the directionality of that link.

The direction of arrows are as follows, depending on the nature of links between nodes:

- One direction ( ---->)
- Bi-directional (<---->)
- Non-directional (-----)

#### 5.6.1.12.2 Repositioning Nodes

The Network Graph page allows you to move nodes around the screen, using drag and drop, to reposition them.

To reposition nodes, follow these steps.

- **1.** Navigate to the Network Graph page.
- **2.** Select a node to reposition and click it, pressing your mouse button until your cursor is where you want the node to be positioned, then release.

NOTE	The graph only uses a specific portion of the browser window
	to display the graph. Dragging a node beyond a certain point
	towards the right side of the browser hides the portion of the
	graph dragged beyond that point. However, you can use the
	Zoom Out feature on the Graph Toolbar to view the hidden
	portion again.

### 5.6.1.12.3 Collapsing and Expanding Nodes

This option allows you to hide all outgoing links and nodes to which these outgoing links are connecting from the node being collapsed. The collapsed node remains on the graph and the node icon changes to indicate the collapsed state. To collapse nodes, follow these steps.

- 1. Navigate to the Network Graph page.
- 2. Select a node to collapse and right-click. An option menu displays.
- 3. Select the **Collapse** option from the menu. The outgoing links are hidden on the page.

NOTE If any child node has at least one incoming link from any other node, the child node and its child network are not collapsed. But the link from collapsed node to the child node is hidden and icon of collapsed node changes to indicate the collapsed state.
 On the Node Menu of a collapsed node, the Collapse option changes to Expand. If the user collapses a node but there is no impact on the graph (meaning, nothing was hidden), the Node Menu remains unchanged. There is no restriction on how many nodes can be collapsed on a graph.

**4.** To expand the node, select **Expand** from the menu. The outgoing links are restored on the page.

NOTE

The Collapse option does not appear for outer nodes. Outer nodes are nodes that do not have any outgoing links.

### 5.6.1.12.4 Viewing Node Details

This section allows you to view the current information associated with the selected node. This is the same information that displays on the Business Entity tab for this entity.

To view nodes' details, follow these steps.

- 1. Navigate to the Network Graph page.
- 2. Select a node and right-click. An option menu displays.
- **3.** Select the **View Node Details** option from the menu. The Node Details window displays with current information associated with the selected node.

**NOTE** Stated above can interact with the main application window (that displays the graph) while this window is open. But only one window can be opened for a particular node. If you select to view node details of a node for which a Node Details window is already open, an error message displays.

### 5.6.1.12.5 Using Graph Toolbar

The Graph Toolbar allows you to perform general operations associated with the graph. It displays on the top of the Network Graph page. You can select different toolbar options such as Node Label, Link Label, and so on.

To use the graph toolbar, follow these steps:

- 1. Navigate to the Network Graph page.
- 2. You can perform the following actions using the Graph Toolbar:
  - Viewing Node Label: Select the Node Label checkbox to view a label for each node on the graph. The Node Label displays in the following format *NodeType: NodeID*.

Node Type represents - the type of entity.

Node ID represents- the identifier of the entity represented by this node.

- Viewing Link Label: Select the Link Label checkbox to view a label for each link on the graph. The middle of each link is labeled with the sum of the amount of all transactional links between the nodes. That is, if there is a transaction between nodes (such as a transfer of funds from one account to another), the total amount of all transactions, across all transactions types, between these nodes displays. When links between nodes are non-transactional links, the Link Label does not display.
- Viewing Link Tooltip: Select the Link Tooltip checkbox to view additional information about the link by mouse over on the graph. A link tooltip displays the following information:

<From Node>: The identifier of the entity represented by the first node.


Link Direction Arrow: The direction of the relationship between nodes.

One way ----> or <----- : Displays when one node has a transactional link. For example, the *From Node* has sent funds to the *To Node*.


Bi-directional <---->: Displays when both nodes have a transactional link. For example, the *From Node* has both sent and received funds from the *To Node*.

Non-directional -----: Displays when the nodes have shared attribute s, but no transactional link. For example, nodes share a common address.

- <To Node>: The identifier of the entity represented by the second node.
- Shared Attributes: Information or attributes, two nodes have in common, such as a common address, phone number, or tax ID.



- **3.** Viewing Node Tooltip: Select the Node Tooltip checkbox to view additional information (in the form of a tooltip) about the node by mouse over on the graph. A node tooltip displays the following information:
  - Node Type: The type of entity
  - Node ID: The identifier of the entity represented by this node
  - **Total Amount**: Sum of the transaction amount of all links involving this node within the network
  - Incoming Amount: Sum of the transaction amount of all links going into this node within the network
  - Outgoing Amount: Sum of the transaction amount of all links going out of this node within the network



- Zooming In: To view the objects closely on the Graph Tool page, click the Zoom In. You can also use your mouse wheel to zoom out.
- Zooming Out: To view the objects from far on the Graph Tool page, click the Zoom Out. You can also use your mouse wheel to zoom in.
- Using Highlight: To highlight nodes or links, follow these steps:
- Click **Highlight**. The Highlight dialog box displays. This box allows a user to locate nodes and links on the network graph.
  - i. To locate a node or link, select **Node** or **Link** options using the radio buttons.
  - **ii.** Enter the node or link business unique identification number in the Value Contains field or select from drop-down list.
  - **iii.** To select more than one node, hold down the **Shift key**, and click **Nodes** inside the selection box. The text box includes a wildcard search feature. The textbox applies the wildcard search automatically, you need not add any wildcard characters before or after the text entered in this textbox. Blank space before or after the text entered in the textbox is considered part of the search criteria.
  - iv. Click **Apply**. Nodes that match the search criteria are visually distinguished on the graph by placing a blue border around them. Links that match the search criteria are visually distinguished on the graph by making the link line thicker.
  - v. To clear highlights on the Graph Tool page, click **Clear Highlight.** All visual distinctions made on the graph as a result of using the Highlight feature are cleared.
- Viewing Legend: To view various graphical components of the Network Graph page, click Legend. The Legend dialog box displays which provides a dynamic indicator of nodes and links that are visible in the graph.

# 5.6.1.13 Viewing Link Details

The Link Details allows you to view additional information related to the selected link.

To view link details, follow these steps.

- 1. Navigate to the Network Structure section of the **Event Details** tab.
- 2. Select the Event ID. Click **Details link** under Network Structure. The Link Details page displays. It provides details of the nodes at either end of the link and the link(s) involved in the relationship.

The following table describes the Link details.

Headings	Description
Participating Nodes	Displays nodes on both ends of the link.
Source ID	Displays the node at one end of the relationship.
Direction	Displays the type of relationship existing between two nodes. This can reflect a relationship based on transactional activity such as a Wire or it can reflect a link based on a known relationship such as a Common Address.
Link	Displays the individual link.
Weight	Displays the value of the activity involved in a transaction. For example, when a transaction forms a link between two accounts, the link amount is the transaction amount.

The following tasks are performed using the Account tab:

- View and analyze the list of accounts that are associated with the case from the date of case creation or which are added to the case during the course of the investigation
- Associate new accounts with the case
- Disassociate or modify existing accounts
- View and analyze complete details of each account
- Designate as an involved party
- Retrieve the latest account details in the Current Information window
- Add, modify, and remove account restriction, contact information, and watch list members associated with the account
- View and analyze investment advisor, risk information, anticipatory profile, and peer groups associated with the account

- 1. From the homepage, Click **Enterprise Case Investigation**.
- 2. Click Search Cases.

### 5.6.3.11.1 Quantifind Batch Processing

The Quantifind batch process submits customer entities to an ECM processing layer where they are then submitted in batch to Quantifind. ECM users do have the ability to request Quantifind risk cards in an ad-hoc manner through the ECM UI but the Quantifind batch process allows for bulk processing of customers which are extracted from the events created by the Behavior Detection Framework. This can provide great efficiency as cards are automatically available to the ECM users.

To run the Quantifind batch process, follow these steps:

- 1. Login to the application with Supervisor credentials.
- 2. Search the Case.
- 3. Click the Customer Tab to view the list of customer details.

The risk parameters with the line color displays as a reference. To view the complete risk parameters with the actual values click on the scores which you are interested in from the Customer Risk Score History. The respective data corresponding to the selection in the Customer Risk Score History is highlighted in this section. The selection is a standing line, you can mouse over the line to view the risk parameters, risk score along with actual values.

In the Case Summary page, when you select a CS or CS Escalated case type, an additional search section related to CS, Optional Case Attributes displays.

The Real Time Screening tab has the following sections:

- **Alert Summary**: details the alerts associated with the selected escalated customer screening case from the L1 Customer Screening system.
- **Event List**: details the list of Real Time Customer Screening Events associated with the selected case.
- Watchlist and Candidate Details: provides complete information about watchlists and candidates associated with the selected Real Time Customer Screening event.

The following tasks are performed using the Real Time Screening tab:

- View and analyze the list of Real Time Customer Screening event details associated with the case
- View and analyze the individual Real Time Customer Screening events details such as matches list, customer and watchlist details
- Determine whether the selected Real Time Customer Screening event is true or false

**NOTE** If Oracle's Customer Screening application is implemented in your instance, any action taken on an escalated case is sent to the Customer Screening application as feedback.

## 5.6.18.2.1 About Real Time Screening Event List

• Based on the analysis, you can determine whether the event is true or false.

### 5.6.18.2.2 Deciding Event as True or False

To decide whether the Event is True positive or False positive, follow these steps:

- 1. Navigate to the Real Time Screening tab.
- 2. Select the required Event ID. Perform the complete analysis of the selected Event. For more information, see the <u>Managing Real Time Screening Event Details</u>.
- **3.** Select the whether the event is True positive or True positive from the drop-down list. A confirmation message displays.

This section displays the details of the escalated alerts from the L1 Customer Screening system. This provides details of the Alert ID, Alert Type, Screening Type, Primary Name, Jurisdiction, Business Domain, Due Date, Assignee, Match score, Risk Score, and so on.

**NOTE** The Alert Summary section is only displayed for Escalated Customer Screening case types.

- Disassociate or modify existing transactions

- Transaction Chart is used to view and analyze the transaction data of a customer for a various date range.

To add new transactions to the case, follow these steps:

- Navigate to the Case Summary page.
- Click **Transaction** tab. The Transaction page displays.
- Click **Add**. The Add New Transaction window displays.

- **3.** Select any one transaction from the list and click the **Details** link. The select transaction window displays with complete information.

#### 5.6.19.3.3 Modifying and Removing Transactions

To modify or remove the existing transactions, follow these steps:



### 5.6.19.3.4 About Transaction Chart

This section displays a graphical representation of all the transactions for all the customers involved in the selected case within the defined time period. This helps investigators identify patterns of expected customer activity.




All users can view the transactions using the following steps:

- 1. Navigate to the Transactions diagram by clicking the Transactions tab from the Case Summary page.
- 2. You can filter which transactions display in the chart.
  - Select the types of Transactions you want to view in the graph. All Transaction Types are selected by default.
  - Select the Customer you want to view the Transactions for, from the drop-down list. The graph will display transactions from all accounts of the customer.
  - Select the Accounts you want to view Transactions for, from the drop-down list. All Accounts are selected by default.
  - Select the date range for these transactions using the Date To and Date From calendar options. The default search date range is 3 months from the current date and it can be configured. The OOB manual search date range is 12 months and it also can be configured. For more details see <u>Administration Guide</u>.
    - Scroll or zoom out to view a longer date range. You can also resize the window in the overview bar. The chart will display at the scale selected.
    - Scroll or zoom in to view a shorter date range. You can also resize the window in the overview bar. The chart will display at the scale selected.
    - Click and drag to move to other sections of the graph.
    - The overview bar provides the trend of the transactions over the defined time period.
       Resizing the window in this bar displays the Transactions chart in the time range

selected.

Hover over the transaction to view transaction details such as,

- Transaction Date: Specifies the date on which the transaction occurred.
- **Transaction Category:** Specifies the transaction category whether it is Debit Value, Credit Value, Debit Volume or Credit Volume
- **Total Volume or Total Value:** Specifies the transaction volume or value depending on the Transaction Category.
- **Evented:** Specifies whether the transaction is an evented transaction or not.

- View currently updated information.

#### 5.6.20.2 Adding an Entity

During the course of an investigation of a case, you can add an entity or entities to a case to reflect the relationship of the entities with the case.

You can add a new business entity in the following ways:

- Adding a New Entity Manually
- Adding an Existing Entity


#### 5.6.20.2.1 Adding a New Entity Manually

To add a new entity manually, follow these steps:

- 1. Navigate to the Case Summary page and go to the applicable business tab.
- 2. Go to the business entity list section and click **Add**. The Add entity window displays.
- 3. Note: By default, the Search Existing Entities radio button option is selected.
- 4. Select Add Entity Manually radio button option. The Add entity window displays.
- **5.** This is a sample Add entity window. This window and respective fields change based on the entity you select. For example, Customer, Account, and Employee.

**9.** The window closes and navigates you to the refreshed list of business entities section, and the newly added records display. Also, corresponding audit entries are recorded on the case.

#### 5.6.20.2.2 Adding an Existing Entity

To add a new entity to a case, you can search for entities from the existing entities and then add them to the current case. This section includes the following topics:

#### 5.6.20.2.3 Adding a New Entity from Existing Case Entities

These existing entities are part of other cases. You can search these entities and add them to the current case.

To add a new entity from existing case entities, follow these steps:

- 1. Navigate to the Case Summary page and go to the applicable business data tab or operational data tab.
- **2.** Go to the business entity list section and click **Add**. The Add entity window displays. By default, the **Search Case Entities** radio button is selected.

**3.** Enter the required search criteria. See the <u>Search Criteria for Adding Existing Entities</u> to know about the search conditions that are applicable while search existing entities.

**NOTE ID** and **Name** fields are mutually exclusive. The Name field supports wildcard and case-insensitive search.

- 4. Click Search. The relevant search list displays.
- **5.** Go to the Lists section, select the required entity and click **Add to Case**. A confirmation message displays.

**NOTE** The system saves the new data and associates it to the current case. The window is not closed and allows you to add more entities until you click the **Cancel** button.

**6.** The window closes and navigates you to the refreshed list of business entities section, and the newly added data displays. Also, corresponding audit entries are recorded on the case.

#### 5.6.20.2.4 Adding a New Entity from Existing Business Entities

These existing business entities are not part of other cases. You can search these entities and add them to the current case.

To add a new entity from the existing business entities, follow these steps:

- **2.** Go to the business entity list section and click **Add**. The Add entity window displays. By default, the **Search Case Entities** radio button is selected.
- **3.** Select the **Search Current Business Entities** radio button option from the Search Existing Entities.
- **4.** Enter the required search criteria. See the <u>Search Criteria for Adding Existing Entities</u> to know about the search conditions that are applicable while search existing entities.

NOTE

**E ID** and **Name** fields are mutually exclusive. The Name field supports wildcard and case-insensitive search.

- 5. Click **Search**. The relevant search list displays.
- 6. Go to the Lists section, select the required entity and click **Add to Case**. A confirmation message displays.

NOTE

The system saves the new data and associates it to the current case. The window is not closed and allows you to add more entities until you click the **Cancel** button.

**7.** The window closes and navigates you to the refreshed list of business entities section, and the newly added data displays. Also, corresponding audit entries are recorded on the case.

#### 5.6.20.3 Modifying an Entity

This section explains how to modify information pertaining to an existing entity in the current case.

To modify an entity, follow these steps:

- 1. Navigate to the Case Summary page and go to the applicable business tab.
- 2. Go the entity section and select the required entity and click **Edit**. The Edit window displays.
- 3. Modify the necessary information in the required fields.
- **4.** Click **Save**. A confirmation message displays. The window closes and navigates you to the refreshed list of business entities section, and the modified data displays. Also, corresponding audit entries are recorded on the case.

#### 5.6.20.4 Removing an Entity

To remove an entity, follow these steps:

- 1. Navigate to the Case Summary page and go to the applicable business tab.
- 2. Go the entity section and select the required entity and click **Remove**. A confirmation message displays.

NOTE	If the entity is also an IP on the case, they will not be removed from the IP tab and a message displays indicating that the
	entity being removed is also marked as an involved party on this case. If the entity should no longer be an involved party, they also need to be removed from the Involved Party tab.

3. Click **OK**. The window closes and navigates you to the refreshed list of business entities section.

#### 5.6.20.5 Designating as Involved Party

The Involved Party Detail details about an entity that is associated with a case investigation in some capacity. Entities are primarily involved in a case investigation as a witness, suspect, victim, or other.

Entity List section allows you to designate business entity as an involved party for being a witness, suspect, victim, or other. You can designate - Account, Customer, Employee, Corresponded Bank, and External Entity as an involved party. You can also designate a selected entity as the involved party from Involved Party tab. For more information, see the <u>Using Involved Party Tab</u>.

To designate an entity as an involved party, follow these steps:

- 1. Navigate to the Case Summary page and go to the applicable business tab.
- 2. Go to the entity list section and select the required entity and click **Designating as Involved Party**. The Designating as Involved Party window displays.
- 3. You cannot designate an entity as Involved Party if it is already designated.
- 4. Enter the following information in the respective fields.

The Current Information window allows you to view the latest information pertaining to the selected entity in a nutshell. This gives you an option to review the case quickly and take appropriate action. This option is available for Account, Customer, Employee, Corresponded Bank, Household, External Entity, and Trade Finance tabs.

To view current information of an entity, follow these steps:

- Navigate to the Case Summary page and go to the applicable business tab.
- Select the required entity and click **View Current Information**. The Entity details window displays with complete information on the selected entity.

- 2. Select an entity from the List. The selected entity details are displayed with different sections.
- **3.** Go to the respective sections and click **Add**. An Add window displays.
- 4. Enter the information in the respective fields.
- 5. Click **Save**. A confirmation message displays.
- **6.** The new information is saved and associates it to the current entity. You can continue to add more information to the current entity.
- **7.** Click **Cancel**. The window closes and navigates to the refreshed list of business entities section, and the newly added information displays. Corresponding audit entries are recorded on the case.

#### 5.6.21.3 Modifying Business Record

This section explains how to modify an existing information of an entity.

To modify existing business information, follow these steps:

- 1. Navigate to the Case Summary page and go to the applicable business tab.
- 2. Select an entity from the List. The selected entity details are displayed in various sections.
- **3.** Go to the respective sections and select the required record to modify.
- 4. Click Edit. An Edit window displays.
- 5. Modify the information in the respective fields.
- 6. Click Save. A confirmation message displays.
- **7.** The modified information is saved. The window closes and navigates to the refreshed list of business entities section. The modified information displays the edited record. Corresponding audit entries are recorded in the case.

#### 5.6.21.4 Removing Business Record

This section explains how to remove information from an entity. The removed information and any supplemental information associated with that business entity are removed from all supplemental section. For example, removing an Account from a case removes that account's account balance information, account summary information, and so forth.

To remove existing business information, follow these steps:

- 1. Navigate to the Case Summary page and go to the applicable business tab.
- 2. Select an entity from the List. The selected entity details are displayed with various sections.
- 3. Go to the respective section and select the required information to remove it.

- 4. Click **Remove**. A confirmation message displays.
- 5. Click **OK** to continue and save changes.
- **6.** At any point in time, if you do not want to perform the selected action, click **Cancel** on the popup or on the pre-save confirmation message and to abort the action.
- **7.** The selected record(s) are deleted from the entity. The list of business entities section refreshes. Corresponding audit entries are recorded for the case.
- **8.** Adding, editing, and removing information from a case does not affect that record as it exists in other cases.
- **9.** It is also possible to add, edit, and remove information in supplemental section that displays additional information. This information is specific to a business entity selected in the primary section list on the business tab. This supplemental information displays upon the selection of an entity in the primary section list and then navigating to the respective section.

## 6.1 About Case Action

During the analysis of a case, you can take various actions, such as setting the due date to a case, assigning a case to the user, and adding evidence to a case to document the analysis and resolution of the case.

- Actions are performed individually and along with other actions. Multiple actions are taken simultaneously. For example, you can simultaneously assign a case, add comments to the case, add attachment to the case, and e-mail the case details.
- Actions are displayed based on the case type, case status, and user role.
- Some actions represent definitive progress in analysis and therefore can update the status of the case.
- The actions available when a user selects more than one case shall be determined by the intersection of actions available for each of the cases.
- Recommend actions enable you to propose the closing of a case, but requires authorized users to look at that case before it can actually be closed. This is applicable if you have configured Four-eyes approval.

# 6.2 Using Take Action Window

The Take Action window allows taking various actions on case or cases. For example, Set Due Dates, Email, and Resolution of the case. Assign, Add Evidence are available in the Take Action pop-up window.

NOTE

To perform non-status changing actions on a closed case, a status changing action must be selected.

To take action on multiple cases, use the Case List page.

## 6.2.1 Accessing Take Action Window

The Actions in the Take Actions window are displayed based on the case type, case status, and the user role for the selected case.

- 1. Navigate to the Case List page. Select one or more cases using checkboxes.
- 2. Click **Take Action** button Take Action. The Take Actions window displays.

## 6.2.2 Setting Due Date and Time

This section explains how to set a due date or clear existing due date set time (in hours & minutes) on cases.

- 1. Set due date action sets a deadline to complete the action.
- **2.** Clear due date action clears the existing due date.
- 3. Due Date actions are performed individually or with other actions.
- **4.** If the action is configured with default due dates, then that default date is applied to the case when those actions are taken.
- 5. To set a due date or clear due date and set time (in hours and minutes), follow these steps:
- 6. Navigate to Take Action window.

Or,

- 1. Navigate to the Case List page. Click the **Case ID** link. The Case Summary page displays.
- Click Take Action link. The Take Action Window displays. To set the due date, select Set Due Date checkbox. The Calendar field displays. Select the due date. Enter the timings in (hours and minute/s) and click Done.

NOTE	Manually entered due date overrides the default due date
	configuration.

3. Or, to clear the existing due date, select **Clear Due Date** checkbox.

**NOTE** Clear due date action overrides the default due date configuration.

4. Enter comments. For more information, see the <u>Adding Evidence</u> section.

*Optional:* assign user or group of users or set case owner, see the <u>Taking Resolution Action</u>, for more information.

Entering comments is mandatory. If you do not enter comments, a warning message displays, indicating that some mandatory values are missing. Attaching documents is optional.

**5.** Click **Save**. The application records the action, updates the case information, and navigates you to the refreshed Case List page or Case Summary page based on from where you took the action.

## 6.2.3 Taking Resolution Action

This section explains how to take resolution action on the selected case or cases. Supervisor approval provides a dual control or approval process that requires an authorized user (for example, a Supervisor) to approve actions of other users, prior to those actions taking full effect on the case (for example, closing the case). This process also enables users of specified roles to acknowledge approved or rejected changes proposed and to annotate an acknowledgment with comments.

Recommending a Case for resolution - if you are an Analyst user and perform the resolution action on a non-closed case, the case moves to the Recommend Closure status, where you need to assign to a supervisor for approval. The supervisor can approve or reject the recommendation. If approved, the case is closed and if rejected, the case is pushed back to the old status without closing. If you are a Supervisor user and perform the resolution action on a non-closed case, the case is directly closed without requiring additional approval.

NOTE	<ul> <li>When a Resolution action is performed and the case is moved to the Closed status, the existing due date of the case is cleared by the system.</li> </ul>
	<ul> <li>When a Resolution action is performed and the case is moved to the Closed status, the associated suppression requests workflow will be initiated and will be available in the Suppression Administration page.</li> </ul>

To take resolution action, follow these steps:

- 1. Navigate to Take Action window.
- **2.** Go to the Resolution section.
- 3. Select No SAR Filed- Closed or Close and generate SAR.
- 4. Enter comments. For more information, see the <u>Adding Evidence</u> section.

**NOTE** Entering comments is mandatory. If you do not enter comments, a warning message displays, indicating that some mandatory values are missing. Attaching documents is optional.

- 5. *Optional:* assign user or group of users or set case owner, for more information see the <u>Taking</u> <u>Resolution Action</u>.
- 6. Optional: set due date for the case, for more information, see the Setting Due Date.
- 7. Click **Save**. The application records the action, updates the case information, and navigates you to the refreshed Case List page or Case Summary page based on from where you took the action.
- **8.** For more information on the Compliance Regulatory Reporting (CRR) documents, see the CRR Documentation Library.

### 6.2.4 Changing Case Type

There are times in the investigation when it may be necessary to change the case type of a case. For example, correlation may initially determine that the case was an AML case but upon investigation, it may be decided it is actually related to fraud and should follow a different workflow. Workflows are decided by the case's case type so when the case type is changed, the user will also need to decide which status the case should be in once placed into the new case type. Note that the possible owners and assignees for the new case type cannot be determined until the case has been saved. Therefore,

until the case is saved, the owner and assignee drop-down list will show those individuals for the prior case type. Once the case is saved, the user can then change the owner and assignee. For example, if you have changed the case type from AML to Fraud, the owners and assignees will be for AML case type. After saving the case, the Fraud users will be available for the Fraud case type. When the case type is changed, the Audit History is also updated. For more information, see <u>Audit History</u>.

For the Change Case Type action to display on the UI, the administrator must first set specific configurations. For more information on configuration, see the *Configuring Change Case Type Action in PMF* section in <u>Administration and Configuration Guide</u>.

To change the case type, follow these steps:

- 1. Navigate to the **Take Action** window.
- **2.** Go to the **Resolution** section.
- **3.** Select Change Case Type.
- **4.** Select the new Case Type and new Case Status. The Case Status is the status you want the case to be in when saved.
- 5. Click Save.

### 6.2.5 Assigning Cases

You can assign one or more cases using the Take Action window. For more information, see the <u>Assigning Case</u>.

### 6.2.6 Adding Evidence

Using Take Action window you can add comments and attach required documents. For more information, see the <u>Adding Evidence</u>.

## 6.3 Assigning Case

You can assign cases from the Case List page, the Case Summary, or by using Take Action. This section describes how to assign cases or reassign ownership to different users or user groups.

- If a case's initial analysis reveals an issue that should be reviewed by another user, reassign such cases to the most appropriate user or group of users.
- It is also possible to retain ownership of a case while assigning it to another user to handle part of the investigation.
- The list of a user or group of users available based on user role and case type.
- Auto Assignment option enables to automatically assign an owner or case assignee for a case through pre-defined rules.
- **Case Owner**: this user has defaulted to a user or user group on the creation and the user can modify the same during the case investigation. The ownership means the user is responsible for the case investigation.

• **Case Assignee**: this user is responsible for the investigation and resolution of cases. For example, User A is the owner of the case-1 and User B is the assignee of the case, then any action that has been taken on the case will have and assignee as the user taking the action and audited.

## 6.3.1 Assign Case

To set case assignee or case owner, follow these steps:

1. Select one or more cases using check boxes.

3. Select Auto Assignment, Set Case Assignee, or Set Case Owner by marking the check box.

- NOTEAuto Assignment option is mutually exclusive to the Set Case<br/>Assignee and Set Case Owner option. The Set Case<br/>Assignee and Set Case Owner drop-downs will display the list<br/>of users who can take all types of actions (status-changing and<br/>non-status-changing actions) on the case in the resulting case<br/>status.Auto Assignment option enables you to automatically assign<br/>an owner for a case through pre-defined rules. The pre-<br/>defined rules can be configured. For more information, see the<br/>Administration Guide.
- **4.** Select a user or group of users to whom the case is to be assigned as Owner from the dropdown list. Or, select the a user or group of users to whom the case is to be assigned as Case Assignee from the drop-down list.

**NOTE** The list of a user or group of users available in the Set Case Assignee and Set Case Owner drop-down list is based on access privileges to the case type or cases on which the action is being taken and the eligibility to own a case.

5. Enter comments. For more information, see the <u>Adding Evidence</u> section.

**NOTE** Entering comments is mandatory. If you do not enter comments, a warning message displays, indicating that some mandatory values are missing. Attaching documents is optional.

- 6. Optional: set the due date, for more information, see the Setting Due Date.
- 7. Optional: attach any related documents, for more information, see the Adding Evidence.
- 8. Click **Save**. The application records the action, updates the case information, and navigates you to the refreshed Case List page or Case Summary page based on from where you took the action.


Set Case Assignee action does not change the ownership of the case, whereas, the Set Case Owner action changes the ownership of the case.

- If you select cases in the Case List page in Closed status and try to perform assignment actions, an error message displays. To save this action, select at least one status-changing action.
- In the Case Summary page, if the case is in Closed status and try to perform assignment actions, an error message displays. To save this action, select at least one status-changing action.

### 6.3.2 Assign Case to Self

To set yourself as the case assignee, follow these steps:

1. Select one or more cases using check boxes.



# 6.4 Emailing Cases

This section explains how to email case attachments or details in the form of a HyperText Markup Language (HTML) files to multiple recipients.

Following two options are available:

- **Send Email:** to send emails with no mechanism to receive a response back from the recipient.
- **Send RFI:** to send emails and have the recipient respond to a questionnaire included in the email.

If you want to send a questionnaire along with the email, then use the Send RFI option.

### 6.4.1 Send Email

To email a case, follow these steps:

- 1. In the Case Summary page, click **Send Email/RFI**.
- 2. Select Send Email. The Email related fields are displayed.
- **3.** Enter the following information in the fields:

- 6. The details of the Email can be viewed by clicking on **Email Sent** link in the **Evidence**. For more information, see the <u>Using Audit History</u>.

### 6.4.2 Send RFI

This option allows system users to request information from others while working on a case, with an ability to track response from the respondent. It also allows for notification and reminders.

Sometimes, Case Management users may require information about the case from any user in the organization (based on system access) and receive the responses within the specified time. You can send the questionnaire template to user for the response.

To email a case, follow these steps:

- 1. In the Case Summary page, click **Send Email/RFI**.
- 2. Select Send RFI. The RFI related fields display.
- **3.** Enter the following information in the fields:

Include Case Details	Select this check-box if you want to send the case details along with the email. The case context will be present in the email content.
Email Content	Enter additional information regarding the case that you want to email.

- 4. Click **Send**. The recipient of the email receives the mail with questionnaire details.
- 5. When the RFI email is sent, the status of the case displays as Pending RFI Response .
- 6. An **RFI Sent** action is also displayed in the **Audit History**. The details of the RFI can be viewed by click on the RFI Email link on the Audit History. For more information, see the Audit History.
- 7. When an RFI email is sent, the recipient (or recipients, if the CC field was used) will receive a token-based Questionnaire link, and the link's validity can be configured. If it exceeds the configured time limit (default value = 60 minutes), the RFI expires and an error page is displayed if the user attempts to access the link. If the user clicks the Questionnaire URL within the time limit, they will receive another email with the captcha. The RFI expiry is applicable only to token-based approach.

The token/non-token based approach for Questionnaire expiry can be configured. For more information, see *Configuring Token/Non-Token Based RFI* in <u>OFS ECM Administration and</u> <u>Configuration Guide 8.1.2.2.0</u>.

**NOTE** To return the Case to the Investigation status, the Case User must click the Cancel RFI button in the Email or RFI grid in the Evidence tab.

8. Recipients must enter their captcha to open the questionnaire, fill and submit it. If the CC field was used, recipients can submit more than one response to a questionnaire. Otherwise only one response can be submitted to a questionnaire. A confirmation message will display when the form is submitted.

# 6.5 Adding Evidence

This section guides you on how to add comments and attachments to the case or cases.

- Evidence is added to a case from the Take Action window, Case List page, and Case Summary page.
- Evidence is comments and attachments, they provide more insight into the case investigation.

- Add comments or attachments to the selected cases, exclusive of any other actions or as a part of any other action.
- Adding comments and attachments to the case does not change the status of the case. The comment action is reflected in the audit of a case.
- Attachments are removed from the case. This does not change the status of the case
- If any other non-status changing actions are taken along with evidence actions, then the evidence actions are audited with higher-order actions. In case, any status changing action is taken along with non-status changing actions in addition to evidence action then the evidence actions are audited with status changing action.

To add comments and attachment to multiple cases, follow these steps:

1. Navigate to the Case List page. Select one or more cases using checkboxes.

**NOTE** If you select cases with Closed status and try to add evidence, an error message displays.

2. Click Add Evidence Add Evidence . The Add Evidence pop-up Window displays.

- **3.** Select the Evidence Type Comments or Attachment. By default, Comments option is selected as Evidence Type.
- **4.** Select standard comments from the Standard Comments multi-select option. Or, enter your own comments in the text box and click Save.

**NOTE** The standard comments are based on the current case type. You can select as many comments from the Standard Comments selection box as appropriate.

**5.** Or, to attach documents, select **Attachment** in Evidence Type. The Attachment details are displayed.

- **6.** Click **Attach**. Select documents from the source. You can attach multiple documents at a time. The size of attachment and percentage of attachment progress displays.
- 7. Enter comments in the Attach Comments box.
- **8.** Click **Save.** The system records the action, updates the case information, and displays the added comments and attachments in the Comments and Attachment section of the Evidence.

**NOTE** If evidence actions are performed through the **Take Action** window, the following validations are applied.

- If you select cases in the Case List page in Closed status and try to perform evidence actions, an error message displays. To save this action, select at least one status-changing action.
- In the Case Summary page, if the case is in Closed status and try to perform evidence actions, an error message displays. To save this action, select at least one status-changing action.

# 8.1 About Case Creation

- Cases are created for investigating business entities involved in potentially suspicious events.
- If there is a need for investigation on an entity for which there are no open cases, then you can create case manually and proceed with the investigation. This section explains how to create a new case.
- Only privileged users can create a case.
- Cases are created by users by entering new case information manually.
- Case types are displayed based on the logged-in user.
- Cases are created based on the case type. For example, AML Surveillance and Fraud Account.
- Fields are displayed based on the case type selected.
- Case type attributes (fields) are configured in the Case Designer by the Administrator. For more information, see the Administration and Configuration Guide.

NOTE

Since the manual adding of events and watchlist features is not available for these case types, manual case creation using the CS Case Type is not supported.

# 8.2 Accessing Create Case Page

This section explains how to access Create Case page.

To access Create Case page, follow these steps:

- 1. Navigate to the Enterprise Case Investigation page, see the <u>Getting Started</u> for more information.
- 2. Select the Create Case. The Create Case page displays.

# 8.3 Creating a New Case

If there is a need for investigation on an entity for which there are no open cases, then you can create case manually and proceed with the investigation. This section explains how to create a new case.

To create a new case, follow these steps:

- **1.** Navigate to the Create Case page.
- **2.** Select the case type from the Type drop-down list. Based on the Case Type selected, the Create New Case page displays with the relevant fields.




Figure 29: Create New Case screen

The Research feature allows you to view detailed information on business entities and the cases and events related to them.

## 9.1 Key Features

## 9.2 Accessing Research Page

To access the Research tool, navigate to the Enterprise Case Investigation menu and select Research. Only users mapped to the Supervisor user role can access this page. For more information, see the <u>Getting Started</u> section.

## 9.3 Searching for an Entity

- The Entity Search and List page allows you to search for an entity and view the results..
- To search for an entity, follow these steps:
- 1. Navigate to the Entity Search and List page.
- The following search criteria are available to find the entity you are looking for:

**NOTE** All search fields are mutually exclusive unless otherwise noted.

- **4.** In the **Overview** tab, you can view details of the entity. These details vary based on the Entity Type (Account, Customer, or External Entities).
- **5.** In the **Relationships** tab the events and cases related to the entity are displayed. The Case ID is hyperlinked to view the details of a related case.

## 9.4 Creating an Event

It is also possible to create an event for the entity being viewed. This places the event into the correlation layer of Enterprise Case Management for inclusion in a future case. To create an event, from the entities details page select the Create Event link and a modal window will allow you to define the event. For more information, see <u>Creating Events</u>.

# **10** Event Search

The Event Search feature helps Investigators to search the Events within the ECM application to see the details and relationship of that event to the case. The **Search Event** page captures your selection criteria related to a type of event and then searches to find the specified event.

This chapter describes how to use the Event workflow to search and inquire about a specific focus type and its related information.

### 10.1 Key Features

To access the Search Event page, navigate to the **Enterprise Case Investigation** menu, and select **Search Events**. Users mapped to Supervisor and Analyst user roles can access this page. For more information, see the <u>Getting Started</u> section.

# 10.3 Searching for an Event

The **Event Search and List** page allows you to search Events. This page captures your selection criteria related to a type of event and then searches to find the specified event.

By default, the **Search Events** window displays all the events of the ECM system. You can also view the migrated events along with other events of the ECM system. Migrated events are alerts from the old system (for example BD) that are moved to the ECM system. To view migrated events, you must configure the **Include Historical Migrated Alerts** parameter. For more information, see the *Configure Include Historical Migrated Alerts Parameter* section in <u>Oracle Financial Services Enterprise Case</u> <u>Manage-ment Administration & Configuration Guide</u>.

When you configure the **Include Historical Migrated Alerts** parameter, **the Include Historical Migrated Alerts** checkbox displays on the Search Event window and all the Relationship tab Uls. Select **Include Historical Migrated Alerts** if you want to view migrated events along with other events of the ECM system.

An alert's details, including audit history, narrative, and evidence, can be viewed through ECM. This allows upgrading the customers without logging into AM. All historical alert information can be viewed in ECM.







This appendix explains the common features of OFS ECM application. It describes the concept and provides step-by-step instructions for navigating through the application.

## 14.1 Common Screen Elements

The following section describes the common screen elements in the ECM UI:

- <u>Masthead</u>
- <u>Buttons</u>
- Field Types
- <u>Column Sort Options</u>
- Links
- Business and Operational Data Tabs
- Pagination

Common screen elements consistently perform the same type of function in the same way when they display in the UI.

- Section header: serve as labels and never change
- Buttons: enable you to get help or complete a task
- Tool tips: offer an explanation for a specific item
- **Fields**: operate as variables that allow you to type entries (text boxes) and make selections (drop-down lists).

### 14.1.1 Masthead

The masthead displays at the top of the page and contains the following components:

- Hamburger menu enables you to select the option that you want to work on ECM UI (search or create a case)
- Session Information with session user name and language.

### 14.1.2 Buttons

Buttons on the ECM UI enable you to perform tasks such as executing and canceling actions, or commands. Click a button to complete the desired task. The following are two kinds of the button:

- Task Button
- <u>Action Buttons</u>

#### 14.1.2.1 Task Button

Task buttons display throughout ECM and include the following:

- **Save:** records actions and navigates you to the appropriate page and displays the updated case information accordingly.
- **Reset:** displays on those actionable sections of the UI which display some pre-populated data. It discards the data entered by you and resets the contents to their original state.
- **Cancel:** displays on all the actionable sections of the UI and cancels the action you intend to take and closes the action window.
- **Add:** displays in the some Business tabs, Financials tab, and in the Evidence. It provides you with a window to add a new piece of information.
- **Edit:** displays in the some Business tabs, Financials, Narrative, and Evidences. It provides you with a window to edit the existing piece of information you have chosen to edit.
- **Remove:** displays in the some Business tabs. It also displays in the Financials tab. It helps you delete information that you think is not relevant.
- **History:** displays in the Financials, Narrative, and Involved Party tabs. It provides you with a detailed account of previous activities on the selected record.
- **Details** button displays the complete details of the selected entity record in a window.
- **Search** button displays in all the Case Search bars **Case List** button displays in the Priority Case List on the landing page. It helps you navigate to the Search & List page.
- **Designate as Involved Party** button displays in some Business tabs. It allows to designate a business entity as involved party in a window.
- **View Current Information** button displays in some Business tabs. It allows to view the current information of the business entity in a separate window.
- **Print**: allows you to print the summary page that you are on.
- **Export**: displays in Case List and Case Summary pages. It enables you to export case details in Excel and CSV format.

#### 14.1.2.2 Action Buttons

The Action buttons display in the Search and List page and/or in the Case Summary page. Each of these buttons provides you with an action window for taking actions in the category these buttons are representative of. These include buttons for each action category:

- **Assign** For more information, see the section Taking Resolution Action.
- **Add Evidence** For more information, see the section Adding Evidence.
- Take Action For more information, see the section Reopening Cases.

### 14.1.2.3 Help Button

A Help button is in the form of a question mark, displays to the extreme right of the bread crumbs. Click **Help** while working in the ECM to get the following:

- More detailed information about the page
- Explanations of the screen elements
- How to perform instructions on a task that you want to perform

### 14.1.2.4 Radio Button

A round button used to select one of a group of mutually exclusive options.

### 14.1.3 Save Preference Button

This button is available on the right corner of the Case List page. Click **Save Preference**, once you complete the required preference setting in the page.

### 14.1.4 Clear Preference Button

This button is available on the right corner of the Case List page. Click **Clear Preference**, clear the preference setting in the page.

#### 14.1.4.1 Calendar Button

A **Calendar** button displays when you have the option of selecting a date. For example, you can specify a date range to search for closed cases. If you click the **Calendar** icon, a calendar of the current month displays and highlights the current date.

To use the Calendar window to select dates, follow these steps:

- Select a date. The application automatically enters the selected date in the date field.
- Click the arrows at the top of the Calendar window to view other months or years.
- Click the **Close** link to close the calendar without selecting a date.

### 14.1.4.2 Expand/Collapse

You can view the complete information in a section, matrix, and field by using various expand or collapse options.

This section covers the following topics:

- Section Expand Icon
- <u>Section Collapse Icon</u>
- <u>Column Expand</u>
- <u>Column Collapse</u>

#### 14.1.4.2.1 Section Expand Icon

If you want to expand a section on a page, you can click the button displayed at the top left corner of the section. This expands the section and all sub-sections and fields in the section are visible.

#### 14.1.4.2.2 Section Collapse Icon

If you want to collapse a section, which is already expanded, you can click the  $\checkmark$  button displayed at the top left corner of the section. This collapses the section and all sub-sections and fields in the section are hidden.

#### 14.1.4.2.3 Column Expand

When you cannot view the complete information displayed in the columns of a section, then keep the cursor on the column line and simply drag towards the right side till you view the complete information.

NOTE	In case of extensive length of comments that cannot fit within the Comments text box:
	<ul> <li>Mouse over the Comment section to view the full comment</li> </ul>
	<ul> <li>Double click on the Comment section to expand and scroll through the comment details.</li> </ul>

#### 14.1.4.2.4 Column Collapse

When values displayed in the columns of a section are expanded and you want to reduce the size of a column, then keep the cursor on the column line and simply drag towards the left side till you arrange the size of a column according to your requirement.

### 14.1.5 Field Types

The following sections describe field types.

- Text Area
- <u>Text Box</u>
- Wildcard Text Box
- <u>Context-Sensitive Text Box</u>
- Drop-down List
- Selection Box
- <u>Checkbox</u>
- <u>Check All/Uncheck All Checkbox</u>

### 14.1.5.1 Text Area

A multi-line rectangular box in which you can type text, such as case comments. If the box already contains text, you can select the default text or delete it and type new text. You may type as many characters in this box as desired.

#### 14.1.5.2 Text Box

A single-line rectangular box in which you can type text. If the box already contains text, you can select the default text or delete it and type new text. Some text boxes limit the number of characters that you can use. If so, the text box shows the maximum number of characters you can enter.

### 14.1.5.3 Wildcard Text Box

The ECM permits the use of wildcards in specific text boxes. If you do not know the information to type into the text box field, you can type a wildcard character for the missing part of the information. The ECM recognizes the percent sign (%) and underscore (\_) as wildcard characters. You can use the wildcard character at the beginning, end, and anywhere within a string.

The more specific you are when using the wildcard character, the fewer extraneous matches ECM returns. For example, if you specify a last name of Sm%, ECM may return 100 matches, but if you specify a last name of Sm%, the ECM may return only 17 matches.

### 14.1.5.4 Context-Sensitive Text Box

The ECM permits the use of context-sensitive input in specific text boxes. If you want to perform a search on multiple values, you can enter a string of comma-separated values in the case ID field. The ECM recognizes the values as individual values.

### 14.1.5.5 Drop-down List

A list of items from which you can select one item. Selecting the blank (empty) option applies no filter to your selection.

### 14.1.5.6 Selection Box

A list from which you can choose multiple items by selecting them.

### 14.1.5.7 Check box

A square box that displays beside an item or option. Select the check box once to place a check mark in the box. Select the check box again to clear it.

### 14.1.5.8 Check All/Uncheck All Check box

You can select all the records or deselect all preselected records using the check box provided at the header of the check box column of all section.

A check on the header check box selects all records in the section. An uncheck on the header check box deselects all the selected records in the matrix.

## 14.1.6 Column Sort Options

Column headings provide labels that tell you what kind of information displays in the columns. Most of the column headings in the list sections are sortable.

ECM supports right-click options on columns within the List header that allows you to specify the sorting options such as Sort Ascending, Sort Descending, and Column.

The Columns option allows you to choose the fields that you want to display in the List section thereby allowing you view additional columns that are not displayed by default. You can also change the width of the column by modifying the width or you can select the Auto Fit option. Click **Save Preference** on Column saves the selected settings for the current session and for future logins.

## 14.1.7 Reordering Columns

You can reorder the columns by selecting the column header and repositioning them manually.

## 14.1.8 ToolTips

A window ToolTip displays when you position the mouse cursor over an abbreviated field, usually indicated by an ellipsis, or a column label in the ECM UI. A Tooltip displays and provides the definition or other pertinent information for the abbreviated field or column label.

## 14.2 Navigation

The following sections describe the navigation features that you can use to navigate within ECM.

The following sections are covered in this topic:

- Hamburger Menu
- Links
- Search Bars
- Page Context Controls
- Business and Operational Data Tabs
- Pagination

Navigation features enable you to move easily between pages in the UI to view, analyze, or research cases while working in ECM.

## 14.2.1 Hamburger Menu

This menu allows you to navigate in the application. This is available on the top of the Home page . Click this icon to select - Create Case or Search Case option.

### 14.2.2 Links

Links display as hypertext on the page when clicked, takes you to other pages within the ECM UI or expand in the same page.

### 14.2.3 Search Bars

The search bar allows you to specify values with which to filter your data. Search bars for a specific page are described in the chapter where that page's use is explained.

## 14.2.4 Page Context Controls

Page context controls (also called bread crumbs) show your location in ECM. It allows you to navigate back to the previous page.

## 14.2.5 Business and Operational Data Tabs

Business and Operational Data tabs help the case investigator in categorizing large amounts of supporting data into smaller tabs of data, organized by data type (for example, account information, customer information, and so forth) to aid in the analysis of a case.

#### 14.2.5.1 Business Data tab

Depending on the type of case that you are eligible to view, you may have access to these business tabs. Business data tab pages display detailed information about a business entity. Depending on the type of business entity being displayed (for example, Account, Customer), the content of the tab is different and specific to that type of entity.

#### 14.2.5.2 Operational Data tab

These tabs are available for all users (for example, Audit, Narrative, Correlation). Operational data tabs display detailed information about the selected case.

### 14.2.6 Pagination

Pagination refers to the mechanism on the page that enables you to move through multiple pages of information (cases, business data and so forth).

You can move forward and backward through the pages one at a time by clicking the back arrow to the left of the Page text box (unless you are on page #1) or the forward arrow to the right of the total number of pages (unless you are on the last page).

To navigate to different pages of the search results in the List page, you can use the **Page** option. Enter a number in the text box and press Enter in the keyboard to navigate to the respective page.

## 14.3 Exporting Cases

For all roles, ECM enables you to export data in Excel and CSV formats where you can then review and edit the data as necessary. The Excel function exports all records available on the list.

This Export functionality is available as follows within the Enterprise Case Management UI:

- **Case List** page: displays in the Case List section
- Relationship tab: displays in the Related Cases, Related Events sections
- **Audit History**: displays in the Audit History List section.

## 14.3.1 Exporting

To export a case list or case details, follow these steps:

- Navigate to any one of the above-mentioned sections. Click the **Export** icon.
- Select Excel or CSV from the drop-down list.
- The selected file is downloaded in your system.
- Open the file and view the details.

**NOTE** The number of records to be exported in the Case List Grid can be configured. For more information see, <u>Exporting Cases</u> in Admin Guide.

When you click on Entity ID in **Search List** section, the details of associated Entity Names and corresponding Entity IDs will display in **Related External Entity** window. Multiple Entity Names can be present for an Entity ID or Multiple Entity IDs can be present for an Entity Name'. For example, External Entity ID "123456" can display multiple Entity Names, such as "GE Industrial Services", "GE Industrial Svr", "GE Ind. Svrs" in **Related External Entity** window. Similarly, External Entity Name "GE Industrial Services" can display the Entity IDs, such as "11", "22", "33" in **Related External Entity** window. An Entity ID/Name can have multiple Addresses which will be displayed in the Address pop-up. The following table describes the search criteria applicable while adding a new business entity using the Search Existing Entities option for the Transaction tab.



The following attributes are considered for establishing a link between the nodes:

- Wire Transactions: The activity link is established:
- Between Beneficiary and Originator
- Between Secondary Beneficiary and Originator
- Between Secondary Originator and Beneficiary
- Between Secondary Originator and Secondary Beneficiary
  - Between Sending Institution and Receiving Institution

For **Account** starting nodes the link is established using Account to Account wire transactions, and Account to External Entity wire transactions.

For **External Entity** primary nodes the link is established using External Entity to Account wire transaction, and External Entity to External Entity wire transactions.

For **Correspondent Bank** primary nodes the link is established between Sending and Receiving Institution.

- Journal Transactions: The nature of the relationship is established:
  - Between Account and Offset Account

For **Account** primary nodes the link is established between Account and Offset Account (where focal account is the offset account and vice versa).

- Monetary Instrument Transactions: The nature of the relationship is established:
  - Between Beneficiary and Remitter
  - Between Secondary Beneficiary and Remitter
  - Between Issuing Institution and Depositing Institution

For **Account** primary nodes the link is established using Account to Account MI transactions, and Account to External Entity Monetary Instrument transactions.

For **External Entity** primary nodes the link is established using External Entity to Account Monetary Instrument transactions, and External Entity to External Entity Monetary Instrument transactions.

For **Correspondent Bank** primary nodes the link is established between Issuing and Depositing Institution.

- **Insurance Transactions:** The nature of the relationship is established:
  - Between Insurance Policy Identifier and the Counter Party Derived Entity Identifier
  - Between Insurance Policy Identifier and the Counter Party Identifier
- Transaction Date>=
  - The Transaction Date >= is used to build a network based on shared activity. Whenever this date is selected, the system checks for the transaction between Transaction Date >= and Transaction Date <= for establishing the link for Wire, Journal, MI and Insurance Transaction.</li>
  - The Transaction Date >= is defaulted to 3 months prior to the current date.
  - The Transaction Date >= cannot be greater than or equal to Transaction. An error message displays. You must enter a date in Transaction Date >= date field which is less than or equal to the Transaction Date <= field.</li>
  - The Transaction Date>= cannot be a future date and when the user enters or select a future date. An error message displays.
- Transaction Date<=
  - The Transaction Date <= is used to build a network based on shared activity. Whenever this
    date is selected, the system checks for the transaction between Transaction Date >= and

Transaction Date <= for establishing the link for Wire, Journal, MI and Insurance Transaction.

- The Transaction Date <= is defaulted to the current date.
- The Transaction Date <= cannot be less than Transaction Date >=. When the user enters or selects an incorrect date, an error message displays.
- The Transaction Date <= cannot be a future date. When the user enters or select a future date, an error message displays.
- Maximum Degrees of Separation: The value you provide determines how many cycles out from the starting entity a repetition of queries will go, that is, how many levels of entities need to be identified. This number must be within your institution's limits (the default is 1-10). You cannot enter 0, decimals, or negative numbers. If you do not enter a number, the value displays the default of 3.
- Transaction Activity Options: Transaction Activity Options filter the network based on the transaction activity. The following Transaction Activity Options display:
  - **Transaction Amount >=** filters out transactions with amounts greater than or equal to the specified amount.
  - Transaction Amount <= filters out transactions with amounts less than or equal to the specified amount.









## 16.3.1 Transaction Filtering Real Time Cases (TF\_RT)


