2 OFS CAP Application Pack Release 8.0.8.3.0

This Maintenance Level (ML) Release of OFS CAP Application Pack includes all enhancements and bug fixes since the OFS CAP Application Pack 8.0.8.3.0 release.

2.1 Pre-Installation Requirements

The pre-installation requirements are as follows:

- The minimum patch set level must be OFS CAP Application Pack version 8.0.8.2.0.

NOTE This ML does not contain the fixes provided as part of CAP one-off patch 8.0.8.0.2 (32210736). In case those fixes are required, please install the patch explicitly over 8.0.8.0.0 before upgrading to 808x version.

- Apply the AAI patches 35113863, and 35134099.

NOTE If the AAI patch 35113863 is already installed in the setup for CAP version 8.0.7.3.0, and the setup was later upgraded to version 8.0.8.2.0, then reinstall the AAI patch 35113863 on the setup before upgrading to version 8.0.8.3.0.

- Ensure that you take a backup of the AAI_APP_B and AAI_APP_PACK_B tables before running the update.
- Run the following updates in the config schema:
 - UPDATE AAI_APP_B SET V_VERSION='8.0.8.2.0' WHERE V_APP_ID IN ('OFS_OREC', 'OFS_ECA', 'OFS_BASEL_IRB', 'OFS_BASEL_BASIC', 'OFS_BASELA');
 - UPDATE AAI_APP_PACK_B SET V_VERSION='8.0.8.2.0' WHERE V_APP_PACK_ID IN ('OFS_CAP_ADQ_PACK');
- If the runs are already executed in the setup, then run the following steps:
 - In config schema, take back up of tables PR2_RULE_QUERY, PR2_RUN_EXECUTION_FILTER and PR2_RUN_EXECUTION_B.
 - Truncate the tables in following order: PR2_RULE_QUERY, PR2_RUN_EXECUTION_FILTER, PR2_RUN_EXECUTION_B.

NOTE To upgrade Java 7 in an existing OFSAA 8.0.8.x.x instance to Java 8, see Appendix P in the Oracle Financial Services Analytical Applications Infrastructure Installation and Configuration Guide.

2.2 Installing OFS CAP 8.0.8.3.0 ML Release

Perform the following instructions to Download, Extract, Install, and Configure this ML Release.

To install this release, follow these steps:

1. Log in to [My Oracle Support](#), and search for patch ID **35105287** under the **Patches and Updates** tab.
2. Download the **OFSCAP 8.0.8.0.0 ML RELEASE #3 (8.0.8.3.0)** archive file and copy it to your OFSAA Server in Binary mode.

NOTE The archive files are different for every Operating System like Solaris, and RHEL, or Oracle Linux.

3. Shut down all the OFSAAI Services.

4. Login to the OFSAA Server as a non-root user and navigate to the **\$FIC_HOME** folder.
5. Assign WRITE permission to the files or folders such as commonscripts, EXEWebService, ficapp, ficweb, and ficdb in the \$FIC_HOME folder by executing the command:

```
chmod -R 775 *
```

6. If you have Unzip utility, skip to the next step. Download an Unzip utility (OS-specific) and copy it in the Binary mode to the directory that is included in your PATH variable, typically the **\$HOME** path or directory in which you have copied the OFSCAP 8.0.8.3.0 Application Pack.
 - Uncompress the unzip installer file using the following command:

```
uncompress <unzip utility filename>
```

NOTE If you notice an error message “uncompress: not found [No such file or directory]” when the package is not installed, contact your UNIX Administrator.

- Execute the following command to provide EXECUTE permission to the Application Pack file:
- ```
chmod 751 p35105287_80000_<OperatingSystem>.zip
```
7. Extract the contents of the 8.0.8.3.0 ML archive file using either of the following commands:

```
unzip_<os> -a <name of the file to be unzipped>
```

Or

```
unzip -a <name of the file to be unzipped>
```

8. Update the UPLOAD\_MODEL, MODEL\_TYPE, DATAMODEL, and DM\_DIRECTORY parameters in the `params.conf` file present in the `OFS_CAP_ADQ_PACK/OFS_CAP_ADQ/conf/` directory as detailed in the file.

**NOTE** Set the upload model value to 0, since there is no DM change for this Maintenance Level release.



9. Navigate to the path where the ML installer archive is extracted, and grant EXECUTE permission to the installer file using the following command:

```
chmod 755 OFSAAIUpdate.sh
```

10. Execute the following software upgrade command:

```
./OFSAAIUpdate.sh
```

11. Verify that the ML release is applied successfully by checking the `./logs` and `./OFS_CAP_ADQ/logs` folder. You can ignore the ORA-00001 entry in the log file.
12. In case of any error in the log file, contact [My Oracle Support](#).

## 2.2.1 Post Installation Steps

After a successful installation, perform these steps:

1. Clear the Application Cache. Navigate to the following path depending on the configured Web Application Server and delete the files:
  - **Tomcat**

```
<Tomcat installation directory>/work/Catalina/localhost/<Application name>/org/apache/jsp
```
  - **WebLogic**

```
<Weblogic installation location>/domains/<Domain name>/servers/<Server name>/tmp/_WL_user/<Application name>/<auto generated folder>/jsp_servlet
```
  - **WebSphere**

```
<Websphere installation directory>/AppServer/profiles/<Profile name>/temp/<Node name>/server1/<Application name>/<.war file name>
```
2. Restore the backup of PR2\_RULE\_QUERY, PR2\_RUN\_EXECUTION\_FILTER and PR2\_RUN\_EXECUTION\_B, tables, for the runs that are already executed for the audit.
3. Back up and delete the existing EAR/WAR file available in the folder **\$FIC\_HOME/ficweb**.
4. Generate the application EAR or WAR file and redeploy the application onto your configured Web Application Server.
