This release of OFS Crime and Compliance Studio includes the enhancements, bug fixes, and security vulnerabilities (8.0.8.3.1, 8.0.8.3.2) since the 8.0.8.3.x release.

New Features in this Release

The following new features are incorporated in this release. For detailed information on how to use these features, see the <u>Oracle Financial Services Crime and Compliance Studio User Guide</u> 8.0.8.3.0.

1. Incremental training for ML-Boosted Name Matching

Previously the ML-Boosted Name Matching algorithm used a pre-trained model. In this version of FCC Studio, incremental training improves the model over time, taking into account user feedback based on decisions made within the updated Manual Decision UI.

Tags which are entered by the user in the **Manual Decision UI** are used along with automatically generated similarity edges to incrementally train the ML-Boosted Name Matching scoring model (**Bundled notebooks for ML-boosted namematching model training**).

2. New pgql Java Interpreters: In order to ensure compatibility with PGX High Availability configurations, there is a new PgxInterpreter available that ensures that all PGX capable interpreters use the same PGX client and share a common environment. The PgxInterpreter is an interpreter that will delegate to other PGX interpreters, ensuring Data Studio creates only one of these interpreters per session. This will ensure that all PGX interpreters will share connection properties (such as cookies and source IP address) on a session basis.

The PGX-Java has the following interpreters:

- Pgql interpreter
- Pgx-Algorithm interpreter
- Pgx-Java interpreter

Note: You need the Oracle connection configuration in the pgx-java interpreter.

- 3. Other Improvements:
 - Added zeppelin interpreter output limit to all interpreters except markdown.
 - **NameMatching** Incremental Training with **MMG**.
 - Included Pgx-Java custom getQuantifindRiskReport method.
 - Update the PGX data limits in runtime.
 - Updated bases images from the container registry
 - Non-SSO user creation and role mappings through configuration dummy-users.json.
 - Added alias to default redaction fields for customers.
 - Added additional two attributes, "Event type" and "Data Origin" to node, Event, in the Global Graph.
 - Included xgboost and imbalanced learn as default python packages.

- Updated datastudio and pgx versions.
- PGX configuration: Ignore & log invalid loaded graph data and invalid changeSets.
- Enabling dynamic forms in Studio for Python interpreter.
- The studio works with Elastic Search, which has https enabled, and authentication enabled.
- While PGX configuration, you can provide Data memory limit for users/sessions/all pgx limits.
- Using Hive temp-table in connector job.
- Added Cash Transaction between Customer and Account in Global Graph.
- Updated FCGM Template.
