OFS Compliance Studio is an advanced analytics application that supercharges anti-financial crime programs for better customer due diligence, transaction monitoring, and investigations by leveraging the latest innovations in artificial intelligence, open-source technologies, and data management. It combines Oracle's Parallel Graph Analytics (PGX), Machine Learning for AML, Entity Resolution, Model Management and Governance, notebook-based code development and enables Contextual Investigations in one platform with complete and robust model management and governance functionality.

### 2.2 New Features in this Release

• Graph

The Graph Analytics Engine within Compliance Studio now supports two methods for operation:

- **In-memory**: It collects all the data from the nodes and edge tables and it will be transformed into a graph in the Oracle Graph Analytics Engine(PGX).
- **Offloaded**: It creates only metadata of the executed PGQL query instead of loading the entire graph into the PGX server. Using the off-loaded graph has the advantage of significantly reducing the hardware needed for PGX.
- Scenario Conversion Utility

The additional scenarios are supported in this release. For more information, see Using Scenario Conversion Utility section in the OFS Compliance Studio User Guide.

- API Configuration
  - Support for registering third-party APIs.
  - Ability to map and integrate with Model Pipelines.

- Health UI
  - Introduced status messages related to Graphs and PGX server.
  - Service Status: Provides information on the services that are running.
  - Environment: Provides information on the System and Application properties.
  - Log Trace: Provides the logs which will help during analysis and debugging.
- **Object Migration** menu has been introduced.

Object Migration is the process of migrating or moving objects between environments.

You may want to migrate objects for several reasons such as managing global deployments on multiple environments or creating multiple environments so that you can separate the development, testing, and production processes.

• Model Training menu has been introduced.

The Model Training page allows you to add and manage the Model Technique, Model Library, and Model Objectives.

• UI/UX Enhancements

Modified UI/UX elements include the Compliance Studio application's menu, button, widget, and theme.

- New ER pipeline (CSA\_8124) has been introduced.
- OPenSearch has been supported and ElasticSearch is deprecated in this release.
- Updated the supported versions for Java, OpenSearch and Logstash.

The following new features have been added to Automated Scenario Calibration.

- Automated Scenario Calibration
  - Pre-pod Analysis: ASC now supports tuning and initial threshold determination for new scenarios without historical event data.
  - Re-run/update run: Scenarios can be re-executed for just select run dates if it failed for any reason in the first run.
