The application comes with pre-built reports and dashboards using OBIEE tool which enables financial institutions to monitor and track risk. It works as starter kit which can be utilized by users to further develop their own analytics.

  - Modellable and Non-Modellable risk factor identification as per FRTB IMA approach
- Model Validation
  - Back Testing
  - P&L Attribution as per FRTB IMA approach
