These applications are built on a common technology infrastructure, which works off a Singular Data Model that has unified structures for non-redundant acquisition, hosting and processing of data, and renders rich information output that can be analyzed across a conformed set of perspectives. Sophisticated processing engines underlying the suite facilitate modular deployment and are controlled by comprehensive, user-configurable metadata.

The OFSAA Applications are in use at a number of financial institutions across the globe.

Oracle Financial Services Analytical Applications delivers a comprehensive, integrated suite of Financial Services Analytical Applications for both banking and insurance domains.

# 2.1 About the Oracle Financial Services Data Foundation Application Pack

The Oracle Financial Services Data Foundation (OFSDF) Application Pack is an Analytical Data Warehouse platform for the financial services industry. OFSDF Application Pack combines an industry Data Model for financial services along with a set of management and infrastructure tools that allows financial services institutions to develop, deploy, and operate analytical solutions spanning key functional areas in financial services, including:

- Enterprise Risk Management
- Enterprise Performance Management
- Customer Insight
- Financial Crime and Compliance Management

OFSDF is a comprehensive Data Management Platform that helps institutions to manage the Analytical Data Life Cycle from sourcing to reporting and Business Intelligence (BI) using a unified, consistent platform and toolset.

### 2.2 Components of the OFSDF Application Pack

The OFSDF Application Pack consists of the following components, which are described in additional detail in the following sections:

#### Financial Services Analytical Warehouse Data Model

This is a Physical Data Model that supports Data Sourcing and Reporting related to key analytical use cases in the Financial Services industry. The Warehouse Model is a Physical Data Model, unlike the OFSDF LDM, meaning that it is readily deployable, and consists of database object definitions, and additional supporting scripts.

It is organized into two distinct sets of tables based on purpose: The Staging Model, which facilitates data sourcing from the bank's internal operational systems such as Lending systems,

Trading Systems, Collateral Management systems, and Master Data Management Systems. The Reporting Model, which facilitates the storage of outputs from analytical tools, applications, and engines in a manner that is conducive to Business Intelligence Reporting. The Warehouse Model is typically deployed into production through a set of management tools known as the Oracle Financial Services Analytical Application Infrastructure (OFSAAI). OFSAAI is a separate product and is a prerequisite for OFSDF.

#### Supporting Scripts

As part of the OFSDF Package, additional scripts are provided for basic operations such as internal data movement between the Staging and Reporting Tables.

### 3.3 Applying this One-off Patch Release

To install this release, follow these steps:

#### NOTE

This release patch is applicable only for the RDBMS mode of installation.

When OFSDF Release v8.0.8.1.0 is installed on an environment where other OFSAA Applications are at a lower Release version, the <code>.js</code> and <code>.jar</code> files in the <code>viewModels</code> and <code>views</code> folders of the <code>fsapps</code> folder may get overwritten. As a result, some UI Screens in those Applications may not load. This issue is resolved in this Patch ID **33607362**.

- Log in to the My Oracle Support (MOS) and search for the Patch ID 33607362 under the Patches & Updates Tab.
- 2. Download the 33607362\_GENERIC.zip archive file and copy it to your OFSAA Server in the Binary Mode.
- **3.** Before applying this One-off Patch Release, take a backup of the following files present in the mentioned paths:
  - For IRC (Interest Rate Change):
    - \$FIC\_HOME/ficweb/webroot/fsapps/common\_oj/viewModels/ircDetails.

    - \$FIC\_HOME/ficweb/webroot/fsapps/common\_oj/views/ircDetails.html
    - \$FIC HOME/ficweb/webroot/WEB-INF/lib/commonapps rates-ws.jar
  - For CFE (Cash Flow Edits):
    - \$FIC HOME/ficweb/webroot/fsapps/common oj/views/CFE.html
    - \$FIC HOME/ficweb/webroot/fsapps/common oj/viewModels/CFE.js
- 4. Shut down all the OFSAAI Services.

**5.** Extract the contents of the patch archive file by using the following command:

```
unzip -a <name of the file to be unzipped>
For example: unzip -a 33607362 GENERIC.zip
```

#### NOTE

The "-a" option is mandatory to unzip the patch archive file. If you notice the error message "unzip: not found [No such file or directory]" when the package is not installed, contact your UNIX Administrator to resolve this issue. **6.** Grant the RWX (755) permissions for the OFS BFND folder by executing the following command:

chmod -R 755 OFS BFND

- **7.** Navigate to the <>/OFS BFND/conf directory.
- 8. Update the UPLOAD MODEL parameter value to 0 in the params.conf file to skip the model upload.
- **9.** Navigate to the <>/OFS BFND/bin directory.
- **10.** Execute the following command:
  - ./install.sh
- **11.** Verify the patch installation logs in the <>/OFS BFND/logs directory. If there are any errors, contact My Oracle Support (MOS).
- 12. Generate the application EAR or WAR file, and redeploy the application in the configured Web Application Server.

**13.** After the successful deployment, restart all the OFSAAI Services.
