These applications are built on a common technology infrastructure, which works off a singular Data Model that has unified structures for non-redundant acquisition, hosting, and processing of data, and renders rich information output that can be analyzed across a conformed set of perspectives. Sophisticated processing engines underlying the suite facilitates modular deployment and are controlled by comprehensive, user-configurable metadata.

The OFSAA applications are in use at several financial institutions across the globe.

Oracle Financial Services Analytical Applications delivers a comprehensive, integrated suite of financial services analytical applications for both banking and insurance domains.

# 2.1 About the Oracle Financial Services Data Foundation Application Pack

The Oracle Financial Services Data Foundation (OFSDF) Application Pack is an analytical data warehouse platform for the financial services industry. OFSDF Application Pack combines an industry Data Model for financial services along with a set of management and infrastructure tools that allows financial services institutions to develop, deploy, and operate analytical solutions spanning key functional areas in financial services, including:

- Enterprise Risk Management
- Enterprise Performance Management
- Customer Insight
- Financial Crime and Compliance Management

OFSDF is a comprehensive Data Management platform that helps institutions to manage the analytical data life cycle from Sourcing to Reporting and Business Intelligence (BI) using a unified, consistent platform and toolset.

### 2.2 Components of the OFSDF Application Pack

The OFSDF Application Pack consists of the following components, which are described in additional detail in the following sections:

### • Financial Services Analytical Warehouse Data Model

This is a physical Data Model that supports data sourcing and reporting related to key analytical use cases in the Financial Services industry. The Warehouse Model is a physical Data Model, unlike the OFSDF LDM, meaning that it is readily deployable, and consists of database object definitions, and additional supporting scripts.

It is organized into two distinct sets of tables based on purpose: The Staging Model, which facilitates data sourcing from the bank's internal operational systems such as Lending systems, Trading Systems, Collateral Management systems, and Master Data Management Systems.

The Reporting Model, which facilitates the storage of outputs from analytical tools, applications, and engines in a manner that is conducive to Business Intelligence Reporting. The Warehouse Model is typically deployed into production through a set of Management Tools known as the Oracle Financial Services Analytical Application Infrastructure (OFSAAI). OFSAAI is a separate product and is a prerequisite for OFSDF.

### Supporting Scripts

As part of the OFSDF Package, additional scripts are provided for basic operations such as internal data movement between the Staging and Reporting tables.

## 3.2 Prerequisites

The following prerequisite software must be installed for this release:

- Oracle Financial Services Data Foundation (OFSDF) Application Pack v8.1.2.5.0 Maintenance Level Release Patch ID 36176090 plus other prerequisite OFSDF Patches (download from My Oracle Support (MOS)) must be installed and configured on your machine. For more information, see the Preparing for Installation Section in the Oracle Financial Services Data Foundation Application Pack Installation and Configuration Guide Release 8.1.2.5.0.
- Oracle Financial Services Data Foundation (OFSDF) v8.1.2.5.0 POI slice for integration Patch ID 36266570.

# 3.3 Installing this One-off Patch Release

To install this release, follow these steps:

#### **NOTE**

The OFSDF Application Pack Release 8.1.2.5.1 patch is applicable only for the RDBMS mode of installation.

- Log in to My Oracle Support (MOS) and navigate to the Patches & Updates tab.
- 2. Search for the OFSDF Application Pack patch ID 36261347.
- **3.** Download the 36261347\_GENERIC.zip archive file and copy it to your OFSAA Server in the Binary mode.
- 4. Shut down all the OFSAAI Services.

**5.** Create a new directory for the patch 36261347\_GENERIC.zip archive file using the following command:

mkdir 36261347

- **6.** Copy the 36261347 GENERIC.zip archive file into the 36261347 directory.
- **7.** Extract the contents of the patch archive file using the following command:

```
unzip -a <name of the file to be unzipped>
For example, unzip -a 36261347 GENERIC.zip
```

### **NOTE**

The "-a" option is mandatory to unzip the patch archive file. Before installing the package, if you notice the error message "unzip: not found [No such file or directory]", contact your UNIX Administrator to resolve the issue.

**8.** Navigate to the path <>/OFS FSDF/bin.

```
Unzip the mediaPack.tar.gz file.
tar -xvf mediaPack.tar.gz
```

- **9.** Navigate to the path <>/OFS\_FSDF/bin/ExternalEngine\_Artifacts.
- **10.** In the ExternalEngine\_Artifacts folder files, replace the placeholders (For example, ##INFODOM##). Then execute the following Metadata Scripts in the Config Schema:
  - DM\_T2T\_FCT\_IFRS\_PLACED\_COLLATERAL.sql
  - DM T2T FCT LLFP CRE FACILITY SUMMARY.sql
  - DM T2T FCT LRM MITIGANTS SUMMARY.sql

- DM T2T FCT LRM PLACED COLLATERAL.sql
- DM T2T FCT COHORT LOAN LOSS DETAILS.sql
- DM T2T FCT IFRS CREDIT LINE DETAILS.sql
- DM T2T FCT IFRS MITIGANTS SUMMARY.sql
- DM T2T FCT IFRS ACCOUNT SUMMARY.sql
- DM T2T FCT LLFP ACCOUNT SUMMARY.sql
- **11.** For creating a PMF Run for the External Engine T2Ts, in the PMF Script file, replace the placeholders (For example, ##INFODOM##). Then execute the following Script in the Config Schema:
  - pmf\_EXTERNAL\_ENGINE\_LOAD\_RUN.sql
- 12. The External Engine related PMF Process (Process Name is Financial Services Data Foundation External Engine Run and Process ID is EXTERNAL\_ENGINE\_RUN) is available for usage in the Process Modeling Framework Module of the OFSDF Application UI. In the Process Modeller Page, execute the External Engine PMF Process (Process Name is Financial Services Data Foundation External Engine Run and Process ID is EXTERNAL\_ENGINE\_RUN) and verify the result (data populated) in the following Fact Tables:
  - FCT\_IFRS\_CREDIT\_LINE\_DETAILS
  - FCT IFRS MITIGANTS SUMMARY
  - FCT IFRS PLACED COLLATERAL
  - FCT LLFP CRE FACILITY SUMMARY
  - FCT COHORT LOAN LOSS DETAILS
  - FCT LRM MITIGANTS SUMMARY
  - FCT LRM PLACED COLLATERAL
  - FCT\_IFRS\_ACCOUNT\_SUMMARY
  - FCT LLFP ACCOUNT SUMMARY
- **13.** Generate the application EAR or WAR file and redeploy the application in the configured Web Application Server.
