These applications are built on a common technology infrastructure, which works off a singular data model that has unified structures for non-redundant acquisition, hosting, and processing of data, and renders rich information output that can be analyzed across a conformed set of perspectives. Sophisticated processing engines underlying the suite facilitates modular deployment and are controlled by comprehensive, user-configurable metadata.

The OFSAA Applications are in use at several financial institutions across the globe.

Oracle Financial Services Analytical Applications delivers a comprehensive, integrated suite of financial services analytical applications for both banking and insurance domains.

# 2.1 About the Oracle Insurance Data Foundation Application Pack

The Oracle Insurance Data Foundation (OIDF) Application Pack is an analytical data warehouse platform for the financial services industry. OIDF combines an industry data model for financial services along with a set of management and infrastructure tools that allows financial services institutions to develop, deploy, and operate analytical solutions spanning key functional areas in financial services, including:

- Enterprise Risk Management
- Enterprise Performance Management
- Customer Insight
- Financial Crime and Compliance Management

OIDF is a comprehensive data management platform that helps institutions to manage the analytical data life cycle from sourcing to reporting and business intelligence (BI) using a unified, consistent platform and toolset.

## 2.2 Components of the OIDF Application Pack

OIDF consists of the following components, which are described in additional detail in the following sections:

## • Financial Services Analytical Warehouse Data Model

This is a Physical Data Model that supports data sourcing and reporting related to Key Analytical Use Cases in the Financial Services Industry. The Warehouse Model is a Physical Data Model, meaning that it is readily deployable, and consists of database object definitions, and additional supporting scripts.

It is organized into two distinct sets of tables based on purpose: The Staging Model, which facilitates data sourcing from the bank's internal operational systems such as Lending Systems, Trading Systems, Collateral Management Systems, and Master Data Management Systems.

The Reporting Model, which facilitates the storage of outputs from analytical tools, applications, and engines in a manner that is conducive to Business Intelligence Reporting. The Warehouse Model is typically

deployed into production via a set of Management Tools known as the Oracle Financial Services Analytical Application Infrastructure (OFSAAI). OFSAAI is a separate product and is a prerequisite for OIDF.

## • Supporting Scripts

As part of the OIDF Package, there are many scripts provided for basic operations such as internal data movement between the Staging and Reporting Areas.

## 3.1 New Features

- Oracle Insurance Data Foundation (OIDF) Application Pack v8.1.2.7.0 Maintenance Level Release Patch ID
  37003069 plus other prerequisite OIDF Patches (download from My Oracle Support (MOS)) must be
  installed and configured on your machine. For more information, see the *Preparing for Installation* Section

  8.1.2.0.0.
- Install and Configure Oracle Financial Services Analytical Applications Infrastructure (OFSAAI) Release
   8.1.2.5.0 (Patch ID: 36420089) and other prerequisite OFSAAI Patches (see Section 4 Pre-installation of OFSAAI Installation and Configuration Guide) on your machine.

## 3.3 Installing this One-off Patch Release

To install this release, follow these steps:

Note

The OIDF Application Pack Release 8.1.2.7.1 patch is applicable only for the RDBMS mode of installation.

- 1. Log in to My Oracle Support (MOS) and navigate to the Patches & Updates tab.
- **2.** Search for the OIDF Application Pack patch ID **37479297**.

- **3.** Download the 37479297\_GENERIC.zip archive file and copy it to your OFSAA Server in the Binary mode.
- **4.** Shut down all the OFSAAI Services.

**5.** Create a new directory for the patch 37479297\_GENERIC.zip archive file using the following command:

mkdir 37479297

- **6.** Copy the 37479297\_GENERIC.zip archive file into the 37479297 directory.
- **7.** Extract the contents of the patch archive file using the following command:

```
unzip -a <name of the file to be unzipped>
For example, unzip -a 37479297 GENERIC.zip
```

## NOTE

The "-a" option is mandatory to unzip the patch archive file. Before installing the package, if you notice the error message "unzip: not found [No such file or directory]", contact your UNIX Administrator to resolve the issue.

**8.** Assign the RWX or 775 permissions to the 37479297 directory using the following command:

chmod -R 775 37479297

- **9.** Navigate to the <>/appsLibConfig/conf directory.
- **10.** In the params.conf file, update the UPLOAD\_MODEL parameter value to 0 and MODEL\_TYPE parameter value to 1.
- **11.** Navigate to the <>/OFS OIDF/bin directory.
- **12.** Execute the following setup command:

```
./setup.sh
```

- **13.** Verify the patch installation logs in the <>/OFS\_OIDF/logs directory. If there are any errors, contact My Oracle Support (MOS).
- **14.** Generate the application EAR or WAR file and redeploy the application in the configured Web Application Server.

**15.** Restart all the OFSAAI Services after successful deployment.
