Oracle Financial Services Regulatory Reporting for US Federal Reserve (OFS REG REP USFED) enables the customers to enables the banks to comply with BCBS 239 regulations. It integrates risk data reporting systems and enhances the accuracy of reporting in banks. OFS Risk Regulatory Solution (RRS) helps in achieving the objectives by enabling preset steps based on the generalization of a set of solutions. This is made possible by:

- Providing a centralized data storage for risk data through relevant subject areas of Financial Services Data Foundation (FSDF).
- Interfacing with a Regulatory Reporting tool Lombard AgileREPORTER to build necessary template reports to meet the regulatory expectations.
- Managing accuracy of risk reporting through Data Governance Studio (DGS).

OFS REG REP US FED Pack Release 8.0.7.4.0

This Maintenance Level (ML) Release of OFS REG REP US FED – Lombard Risk Integration Pack is cumulative and includes all enhancements and bug fixes done since the OFS REG REP US FED – Lombard Integration Pack v8.0.7.4.0 release. For more information, refer the Oracle Financial Services Regulatory Reporting for US Federal Reserve – Lombard Risk Integration Pack User Guide – Release 8.0.7.0.0 on <u>OHC</u>.

Pre-installation Requirements

The prerequisite software that must be installed for customers who are on OFS REG REP US FED 8.0.7.3.0 version are:

- Oracle Financial Services Analytical Applications Infrastructure (OFSAAI) 8.0.7.1.0 (patch 29002529) plus other prerequisite OFSAAI patches (see Section 1.1 Pre-Installation Requirements of <u>OFS AAI Installation Guide</u>) should be installed and configured in your Machine (<u>OHC</u> Documentation Library).
- Oracle Financial Services Data Foundation (OFSDF) 8.0.7.1.0 (patch 29327317) plus other prerequisite OFSDF patches (see Section 3.1 Installer and Installation Prerequisites of <u>OFSDF</u> <u>Installation Guide</u>) should be installed and configured in your Machine (<u>OHC</u> Documentation Library).
- Oracle Financial Services Regulatory Reporting for US Federal Reserve Lombard Risk Integration Pack Guide 8.0.7.0.0 (patch **28877382**).
- AgileREPORTER version **19.1.0-b100**
- AgileREPORTER Templates version **AR_FED_Package_v1_17_0_9**
- Ensure that you have executed .profile before you trigger the installation.
- Ensure that the FICServer is up and running before you trigger the installation. For information on restarting the services, see *Oracle Financial Services Analytical Applications Infrastructure Release* 8.0.2.0.0 Installation Guide (OHC Documentation Library) for more information.

How to Apply This Maintenance Level Release?

To apply this maintenance release, follow the steps in <u>Installing OFS REG REP US FED 8.0.7.4.0 ML</u> and <u>Post-installation Steps</u> sequentially.

Installing OFS REG REP US FED 8.0.7.4.0 ML

Perform the following instructions to download, extract and install this ML patch:

- Search for patch 29394451 under the Patches & Updates tab and download the OFS_REG_REP_USFED_8.0.7.4.0_GENERIC.zip archive file from https://support.oracle.com/
- 2. Copy the archive file to your OFSAA server in **Binary** mode.
- 3. Shut down all the OFSAA Services. For more information, refer to the *Start/Stop Infrastructure Services* section in <u>Oracle Financial Services Advanced Analytical Applications Infrastructure Pack</u> <u>Installation Guide – Release 8.0.2.0.0</u>.

NOTE: Ensure that the **FICSERVER** is up and running.

- 4. Execute chmod -R 750 \$FIC HOME
- 5. If you have an Unzip utility, skip to the next step.

Download the Unzip utility (OS specific) unzip_<os>. Z from the location <u>https://updates.oracle.com/unzips/unzips.html</u> and copy it in **Binary** mode to the directory that is included in your PATH variable, typically **\$HOME** path or directory in which you have copied the 8.0.7.4.0 ML patch.

• Uncompress the unzip installer file using the command:

```
uncompress unzip <os>.Z
```

NOTE: If you notice an error message "uncompress: not found [No such file or directory]", contact your UNIX administrator.

- 6. Execute chmod 751 OFS_REG_REP_USFED_8.0.7.4.0_GENERIC.zip
- 7. Execute unzip -a <name of the file to be unzipped> For example: unzip -a OFS_REG_REP_USFED_8.0.7.4.0_GENERIC.zip
- 8. Configure UPLOAD_MODEL parameter in the param.conf file present under the OFS_REG_REP_USFED/conf directory to determine if Model Upload is required or not:
 0 = If you have already performed Model Upload and want to skip Model Upload process 1 = If you want to perform Model Upload
- 9. Navigate to OFS REG REP USFED/bin directory and execute ./install.sh
- 10. The installation progress can be viewed by periodically refreshing the log file under the **OFS REG REP USFED/logs** directory.
- 11. After installation is completed, verify the log file for any Errors or Warnings. Contact My Oracle Support in case of any issues.

NOTE: This patch installation has taken approximately 10 minutes to complete in Oracle Labs.

Post-installation Steps

Perform the following instructions after successful installation of the 8.0.7.4.0 ML patch:

• Apply the OFS AAI **33663417** mandatory patch.

ATTENTIONOn the 10th of December 2021, Oracle released Security Alert
CVE-2021-44228 in response to the disclosure of a new
vulnerability affecting Apache Log4J before version 2.15. The
application of the **33663417** Mandatory Patch fixes the issue.For details, see the My Oracle Support Doc ID 2827801.1.Ensure that you reapply the **33663417** Mandatory Patch

Ensure that you reapply the **33663417** Mandatory Patch whenever you install or upgrade the application or apply an incremental patch.

- Refer to the log file in the **/OFS_REG_REP_USFED**/logs directory to ensure that there are no errors reported.
- Generate the application EAR / WAR file and redeploy the application on the configured Web Application Server. For more information on generating and deploying EAR / WAR file, refer to the Post Installation Configuration section in <u>Oracle Financial Services Advanced Analytical</u> <u>Applications Infrastructure Pack Installation Guide – Release 8.0.2.0.0</u>.
- Restart all the OFSAA services. For more information, see the Start/Stop Infrastructure Services section in <u>Oracle Financial Services Advanced Analytical Applications Infrastructure Pack</u>
 <u>Installation Guide Release 8.0.2.0.0</u>.
- Execute the following script in the ATOMIC SCHEMA followed by Commit command: <u>FSI_M_CELL_DETAILS_9C_031_041_TEXT.sql</u>
- Execute **##INFODOM##_SYNC_ADJUSTMENT_CELLS** batch for adjustment entries.
- Execute Resave batches to reflect the changes.
- Perform the additional configurations if required as mentioned under the Additional Configurations section in <u>OFS AAAI Release 8.0.2.0.0 Installation Guide</u>.
- The Recommendations on existing Customized Run/Process with respect to Run Level changes are mentioned in the following document:

Post US FED Run Execution

Perform the following instructions after US FED Run Execution:

- 1. For prior date reporting, please see the <u>Prior Date Reporting</u> document.
- Execute <<INFODOM>>_REG_RUNEXE_RESAVE batch to populate RUNEXESUMM table. Lombard AgileREPORTER would display additional filters of Run Execution ID and Run Status during report retrieval based on RUNEXESUMM table.
 - a. Run Execution ID is Run Execution Identifier concatenated with Run Description.
 - b. Run Status shows the status of US FED Run Execution.
 - c. Define the entities as SOLO or CONSOLIDATED in Lombard AgileREPORTER before retrieving returns.
- 3. Execute all the REFRESH batches to refresh the Derived Entities.

Deploying Config Package

This section describes the steps to deploy the config package after saving the derived entities:

- To deploy the product configuration on Lombard AgileREPORTER using the package
 OFSAA_REG_REP_USFED_80740.zip bundled inside the Config_Package folder of
 installer:
 - a. Navigate to <LombardAgileREPORTER>/bin under the installed location
 - b. Add a new configuration with the following command:

```
./config.sh -a <Config_Package Full Path>
```

For example:

```
./config.sh -a
/scratch/kit/80740/OFS_REG_REP_USFED/Config_Package/
OFSAA_REG_REP_USFED_80740.zip
```

c. Update the Alias with the following command:

```
./config.sh -ea OFSAA_REG_REP_USFED_80740 -iv 8.0.7.4.0 -
alias "OFSAA FED DATA SOURCE" -aif
<LombardAgileREPORTER>/bin/aliasinfo.properties
```
