It provides integrating risk data reporting systems and enhances the accuracy of reporting in banks. OFS Risk Regulatory Reporting (REG REP) Solution helps in achieving the objectives by enabling preset steps based on the generalization of a set of solutions. This is made possible by:

- Providing a centralized data storage for risk data through relevant subject areas of Financial Services Data Foundation (FSDF).
- Interfacing with a third party reporting tool such as Lombard Risk Reporter Portal to build necessary template reports to meet the regulatory expectations.

Data Governance Studio (DGS).

## 2 Hardware and Software Requirements and Specifications

This section describes the various Operating System, Database, Web Server, and Web Application Server version and other variant details on which this release of the OFS Regulatory Reporting for US Federal Reserve – Lombard Risk Integration Pack (OFS REG REP US FED) application has qualified.

### 3 Preparing for Installation

This Maintenance Level (ML) Release of OFS REG REP US FED – Lombard Risk Integration Pack is cumulative and includes all enhancements and bug fixes done since the OFS REG REP US FED – Lombard Integration Pack v8.0.7.4.0 / v8.0.7.4.1 release. For more information, refer the Oracle Financial Services Regulatory Reporting for US Federal Reserve – Lombard Risk Integration Pack User Guide – Release 8.0.7.0.0 on OHC.

### 3.1 Obtaining the Software

This release of OFS REG REP US FED 8.0.7.5.0 can be downloaded from the Oracle Support Site (<a href="https://support.oracle.com">https://support.oracle.com</a>). Log in and search for **29964961** under Patches and Updates.

You need to have a valid Oracle account in order to download the software.

# 3.2 Pre-installation Requirements (to upgrade from OFS REG REP US FED 8.0.7.4.0)

The prerequisite software that must be installed for customers who are on OFS REG REP US FED 8.0.7.4.0 version are:

- Oracle Financial Services Analytical Applications Infrastructure (OFSAAI) 8.0.7.0.0 (patch 28226275) plus other prerequisite OFSAAI patches (see Section 1.1 Pre-Installation Requirements of OFS AAI Installation Guide) should be installed and configured in your Machine (OHC Documentation Library).
- Oracle Financial Services Data Foundation (OFSDF) 8.0.7.1.0 (patch 29327317) plus other
  prerequisite OFSDF patches (see Section 3.1 Installer and Installation Prerequisites of
  OFSDF Installation Guide) should be installed and configured in your Machine (OHC
  Documentation Library).
- Oracle Financial Services Regulatory Reporting for US Federal Reserve Lombard Risk Integration Pack 8.0.7.0.0 (patch **28877382**).
- Oracle Financial Services Regulatory Reporting for US Federal Reserve Lombard Risk Integration Pack 8.0.7.4.0 (patch 29394451).

## 3.3 Pre-installation Requirements (to upgrade from OFS REG REP US FED 8.0.7.4.1)


The prerequisite software that must be installed for customers who are on OFS REG REP US FED 8.0.7.4.1 version are:

- Oracle Financial Services Analytical Applications Infrastructure (OFSAAI) 8.0.7.0.0 (patch 28226275) plus other prerequisite OFSAAI patches (see Section 1.1 Pre-Installation Requirements of OFS AAI Installation Guide) should be installed and configured in your Machine (OHC Documentation Library).
- Oracle Financial Services Data Foundation (OFSDF) 8.0.7.1.0 (patch 29327317) plus other
  prerequisite OFSDF patches (see Section 3.1 Installer and Installation Prerequisites of
  OFSDF Installation Guide) should be installed and configured in your Machine (OHC
  Documentation Library).

### 3.4 Installing OFS REG REP US FED 8.0.7.5.0 ML

Perform the following instructions to download, extract and install this ML patch:

- 1. Search for patch 29964961 under the Patches & Updates tab and download the OFS\_REG\_REP\_USFED\_8.0.7.5.0\_GENERIC.zip archive file from <a href="https://support.oracle.com/">https://support.oracle.com/</a>
- 2. Copy the archive file to your OFSAA server in **Binary** mode.
- 3. Shut down all the OFSAA Services. For more information, refer to the Start/Stop Infrastructure Services section in <u>Oracle Financial Services Advanced Analytical Applications Infrastructure Pack Installation Guide Release 8.0.2.0.0</u>.



- 4. Execute chmod -R 750 \$FIC\_HOME
- **5.** If you have an Unzip utility, skip to the next step.

Download the Unzip utility (OS specific) unzip\_<os>.z from the location <a href="https://updates.oracle.com/unzips/unzips.html">https://updates.oracle.com/unzips/unzips.html</a> and copy it in Binary mode to the directory that is included in your PATH variable, typically \$HOME path or directory in which you have copied the 8.0.7.5.0 ML patch.

Uncompress the unzip installer file using the command: uncompress unzip\_<os>.Z

#### NOTE

If you notice an error message "uncompress: not found [No such file or directory]", contact your UNIX administrator.

- 6. Execute chmod 751 OFS REG REP USFED\_8.0.7.5.0\_GENERIC.zip
- 7. Execute unzip -a <name of the file to be unzipped> For example: unzip -a OFS REG REP USFED 8.0.7.5.0 GENERIC.zip
- 8. Configure UPLOAD\_MODEL parameter in the param.conf file present under the OFS\_REG\_REP\_USFED/conf directory to determine if Model Upload is required or not:
  - 0 = If you have already performed Model Upload and want to skip Model Upload process
     1 = If you want to perform Model Upload
- 9. Navigate to OFS REG REP USFED/bin directory and execute ./install.sh
- **10.** The installation progress can be viewed by periodically refreshing the log file under the OFS REG REP USFED/logs directory.
- 11. After installation is completed, verify the log file for any Errors or Warnings. Contact My Oracle Support in case of any issues.

#### **NOTE**

This patch installation has taken approximately 10 minutes to complete in Oracle Labs.

### 3.5 Post-installation Steps

Perform the following instructions after successful installation of the 8.0.7.5.0 ML patch:

Apply the OFS AAI 33663417 mandatory patch.

#### **ATTENTION**

On the 10th of December 2021, Oracle released Security Alert CVE-2021-44228 in response to the disclosure of a new vulnerability affecting Apache Log4J before version 2.15. The application of the **33663417** Mandatory Patch fixes the issue.

For details, see the My Oracle Support Doc ID 2827801.1.

Ensure that you reapply the **33663417** Mandatory Patch whenever you install or upgrade the application or apply an incremental patch.

- Refer to the log file in the /OFS\_REG\_REP\_USFED/logs directory to ensure that there are no
  errors reported.
- Generate the application EAR / WAR file and redeploy the application on the configured Web Application Server. For more information on generating and deploying EAR / WAR file, refer to the Post Installation Configuration section in <u>Oracle Financial Services Advanced Analytical</u> Applications Infrastructure Pack Installation Guide – Release 8.0.2.0.0.

- Restart all the OFSAA services. For more information, see the Start/Stop Infrastructure Services section in <u>Oracle Financial Services Advanced Analytical Applications Infrastructure Pack</u> Installation Guide – Release 8.0.2.0.0.
- Execute ##INFODOM##\_SYNC\_ADJUSTMENT\_CELLS batch for adjustment entries.
- Execute Resave batches to reflect the changes.
- Perform the additional configurations if required as mentioned under the Additional Configurations section in <u>OFS AAAI Release 8.0.2.0.0 Installation Guide</u>.

The Oracle Financial Services Regulatory Reporting for US Federal Reserve – Lombard Risk Integration Pack (OFS REG REP US FED) is now ready for use. If you encounter any problems during set up, contact OFSAA Support at Oracle Support.

#### 3.6 Post US FED Run Execution

Perform the following instructions after US FED Run Execution:

- 1. For prior date reporting, please see the Prior Date Reporting document.
- 2. Execute << INFODOM>> REG RUNEXE RESAVE batch to populate RUNEXESUMM table.

Lombard AgileREPORTER would display additional filters of Run Execution ID and Run Status during report retrieval based on RUNEXESUMM table.

- a. Run Execution ID is Run Execution Identifier concatenated with Run Description.
- **b.** Run Status shows the status of US FED Run Execution.
- **c.** Define the entities as SOLO or CONSOLIDATED in Lombard AgileREPORTER before retrieving returns.
- 3. Execute all the REFRESH batches to refresh the Derived Entities.

# 3.7 Deploying Config Package (to upgrade from OFS REG REP US FED 8.0.7.4.0)

This section describes the order to deploy the config package after saving the derived entities:

- To deploy the product configuration on AgileREPORTER using the package OFSAA\_REG\_REP\_USFED\_80750.zip bundled inside Config\_Package\_80740\_Upgrade directory of installer:
  - a. Navigate to <LombardAgileREPORTER>/bin directory under the installed location
  - **b.** Add a new configuration with the following command:

```
./config.sh -a <Config_Package Full Path>
For example:
./config.sh -a /scratch/kit/80750/OFS_REG_REP_USFED/
```

Config\_Package\_80740\_Upgrade/OFSAA\_REG\_REP\_USFED\_80750.zip

2. Update the Alias with the following command:

```
./config.sh -ea OFSAA_REG_REP_USFED_80750 -iv 8.0.7.5.0 -alias "OFSAA FED DATA SOURCE" -aif <LombardAgileREPORTER>/bin/aliasinfo.properties
```

  - a. Navigate to <LombardAgileREPORTER>/bin directory under the installed location
  - **b.** Add a new configuration with the following command:
    - ./config.sh -a <Config\_Package Full Path>
      For example:

      /config.sh -a /scratch/kit/80750/OFS PEG\_PED\_USEED/
    - ./config.sh -a /scratch/kit/80750/OFS\_REG\_REP\_USFED/
      Config\_Package\_80741\_Upgrade/OFSAA\_REG\_REP\_USFED\_80750.zip
- 2. Update the Alias with the following command:
  - ./config.sh -ea OFSAA\_REG\_REP\_USFED\_80750 -iv 8.0.7.5.0 -alias "OFSAA FED DATA SOURCE" -aif <LombardAgileREPORTER>/bin/aliasinfo.properties
