2 Oracle Financial Services Regulatory Reporting for US Federal Reserve – Lombard Risk Integration Pack

In terms of regulatory reporting, financial institutions feel increasingly boxed in. - Oracle Financial Services Data Foundation (OFSDF) 8.0.9.1.0 (patch 30942190) plus other prerequisite OFSDF patches (see Section 3.1 Installer and Installation Prerequisites of <u>OFSDF Installation Guide</u> should be installed and configured in your Machine (OHC Documentation Library).

The <u>Data Model Changes</u> (Columns and Tables) must be added on top of the FSDF 8.0.9.1.0 data model and sliced model upload must be performed.
