- Providing a centralized data storage for risk data through relevant subject areas of Financial Services Data Foundation (FSDF).
- Interfacing with a third-party reporting tool such as Lombard Risk Reporter Portal to build necessary template reports to meet the regulatory expectations.

Data accuracy of risk reporting is ensured by:

• Data Governance Studio (DGS).

2 Hardware and Software Requirements and Specifications

This section describes the various Operating System, Database, Web Server, and Web Application Server version and other variant details on which this release of the OFS Regulatory Reporting for US Federal Reserve – Lombard Risk Integration Pack (OFS REG REP US FED) application has qualified.

Refer to the Technology Matrix for Hardware and Software requirements for this release.

3 Preparing for Installation

This Maintenance Level Release of OFS REG REP US FED – Lombard Risk Integration Pack is cumulative and includes all enhancements and bug fixes done since the OFS REG REP US FED – Lombard Integration Pack v8.0.9.0.0 release. For more information, refer the Oracle Financial Services Regulatory Reporting for US Federal Reserve – Lombard Risk Integration Pack User Guide Release 8.0.9.0.0 on <u>OHC</u>.

3.1 Obtaining the Software

This release of OFS REG REP US FED 8.0.9.3.0 can be downloaded from <u>My Oracle Support</u> website. Log in and search for **31119572** under Patches and Updates and download the OFS_REG_REP_USFED_8.0.9.3.0_GENERIC.zip archive file.

You need to have a valid Oracle account in order to download the software.

3.2 Prerequisites for Installation

This installer has Fresh install capabilities and following are the minimum prerequisites to install the OFS REG REP US FED application:

- Oracle Financial Services Analytical Applications Infrastructure (OFSAAI) 8.0.9.0.0 (patch 30330054) plus other prerequisite OFSAAI patches (see Section 1.1 Pre-Installation Requirements of OFS AAI Installation Guide) should be installed and configured in your Machine (OHC Documentation Library).
- Oracle Financial Services Data Foundation (OFSDF) 8.0.9.1.0 (patch 30942190) plus other prerequisite OFSDF patches (see Section 3.1 Installer and Installation Prerequisites of OFSDF Installation Guide) should be installed and configured in your Machine (OHC Documentation Library).
- Oracle Financial Services Regulatory Reporting for US Federal Reserve Lombard Risk Integration Pack 8.0.9.0.0 (patch **30557951**) or higher.
- AgileREPORTER version 19.4.2-b163
- AgileREPORTER Templates version AgileREPORTER for FED v1.21.0-b28
- Ensure that you have executed .profile before you trigger the installation.
- Ensure that the FICServer is up and running before you trigger the installation. For information on restarting the services, Refer *Oracle Financial Services Analytical Applications Infrastructure Release 8.0.2.0.0 Installation Guide* (<u>OHC</u> Documentation Library) for more information.

3.3 Installing OFS REG REP US FED 8.0.9.3.0 ML

Perform the following instructions to download, extract and install this ML patch:

- 1. Copy the downloaded archive file to your OFSAA server in **Binary** mode.
- Shut down all the OFSAA Services. For more information, refer to the Start/Stop Infrastructure Services section in <u>Oracle Financial Services Advanced Analytical Applications Infrastructure</u> <u>Pack Installation Guide – Release 8.0.2.0.0</u>.



Ensure that the **FICSERVER** is up and running.

- 3. Execute chmod -R 750 \$FIC_HOME
- 4. If you have an Unzip utility, skip to the next step.

```
Download the Unzip utility (OS specific) unzip_<os>.z from the location
<u>https://updates.oracle.com/unzips/unzips.html</u> and copy it in Binary mode to the directory that is
included in your PATH variable, typically $HOME path or directory in which you have copied the
8.0.9.3.0 ML patch.
```

Uncompress the unzip installer file using the command:

```
uncompress unzip_<os>.Z
```

NOTE If you notice an error message "uncompress: not found [No such file or directory]", contact your UNIX administrator.

- 5. Execute chmod 751 OFS_REG_REP_USFED_8.0.9.3.0_GENERIC.zip
- 6. Execute unzip -a <name of the file to be unzipped>

For example: unzip -a OFS_REG_REP_USFED_8.0.9.3.0_GENERIC.zip

7. Configure UPLOAD_MODEL parameter in the param.conf file present under the OFS REG REP USFED/conf directory to determine if Model Upload is required or not:

0 = If you have already performed Model Upload and want to skip Model Upload process1 = If you want to perform Model Upload

- 8. Navigate to OFS_REG_REP_USFED/bin directory and execute ./install.sh
- **9.** The installation progress can be viewed by periodically refreshing the log file under the OFS_REG_REP_USFED/logs directory.
- **10.** After installation is completed, verify the log file for any Errors or Warnings. Contact <u>My Oracle</u> <u>Support</u> in case of any issues.

NOTE This patch installation has taken approximately 10 minutes to complete in Oracle Labs.

3.4 Post-installation Steps

Perform the following instructions after successful installation of the 8.0.9.3.0 ML release:

• Apply the OFS AAI 33663417 mandatory patch.

ATTENTION On the 10th of December 2021, Oracle released Security Alert CVE-2021-44228 in response to the disclosure of a new vulnerability affecting Apache Log4J before version 2.15. The application of the **33663417** Mandatory Patch fixes the issue.

For details, see the My Oracle Support Doc ID <u>2827801.1</u>.

Ensure that you reapply the **33663417** Mandatory Patch whenever you install or upgrade the application or apply an incremental patch.

- Refer to the log file in the /OFS_REG_REP_USFED/logs directory to ensure that there are no errors reported.
- Generate the application EAR / WAR file and redeploy the application on the configured Web Application Server. For more information on generating and deploying EAR / WAR file, refer to the Post Installation Configuration section in <u>Oracle Financial Services Advanced Analytical</u> <u>Applications Infrastructure Pack Installation Guide – Release 8.0.2.0.0</u>.
- Restart all the OFSAA services. For more information, see the Start/Stop Infrastructure Services section in <u>Oracle Financial Services Advanced Analytical Applications Infrastructure Pack</u>
 Installation Guide Release 8.0.2.0.0.
- Execute Resave batches to reflect the changes.
- Perform Source Model generation for US FED Processing Source. For more information, see the Generating Source Models section in <u>Oracle Financial Services Advanced Analytical Applications</u> <u>Infrastructure Pack Installation Guide – Release 8.0.2.0.0</u>

The Oracle Financial Services Regulatory Reporting for US Federal Reserve – Lombard Risk Integration Pack (OFS REG REP US FED) is now ready for use. If you encounter any problems during set up, contact OFSAA Support at <u>Oracle Support</u>.

3.5 Post US FED Run Execution

Perform the following instructions after US FED Run Execution:

- 1. For prior date reporting, please see the Prior Date Reporting document.
- 2. Execute <<INFODOM>>_REG_RUNEXE_RESAVE batch to populate RUNEXESUMM table.

Lombard AgileREPORTER would display additional filters of Run Execution ID and Run Status during report retrieval based on RUNEXESUMM table.

- a. Run Execution ID is Run Execution Identifier concatenated with Run Description.
- **b.** Run Status shows the status of US FED Run Execution.
- **c.** Define the entities as SOLO or CONSOLIDATED in Lombard AgileREPORTER before retrieving returns.
- 3. Execute all the REFRESH batches to refresh the Derived Entities.

3.6 Deploying Config Package

This section describes the order to deploy the config package after saving the derived entities:

- 1. To deploy the product configuration on AgileREPORTER using the package OFSAA_REG_REP_USFED_80930.zip bundled inside Config_Package directory of installer:
 - a. Navigate to <LombardAgileREPORTER>/bin directory under the installed location

b. Add a new configuration with the following command:

./config.sh -a <Config_Package Full Path>

For example:

./config.sh -a /scratch/kit/80930/OFS_REG_REP_USFED/ Config_Package/OFSAA_REG_REP_USFED_80930.zip

2. Update the Alias with the following command:

```
./config.sh -ea OFSAA_REG_REP_USFED_80930 -iv 8.0.9.3.0 -alias "OFSAA
FED DATA SOURCE" -aif /scratch/agile/bin/aliasinfo.properties
```
