It provides integrating risk data reporting systems and enhances the accuracy of reporting in banks. OFS Risk Regulatory Reporting (REG REP) Solution helps in achieving the objectives by enabling preset steps based on the generalization of a set of solutions. This is made possible by:

- Providing Centralized Data Storage for Risk Data through relevant subject areas of the Financial Services Data Foundation (FSDF).
- Interfacing with a third-party reporting tool such as Vermeg Reporter Portal to build necessary template reports to meet the regulatory expectations.

Data accuracy of Risk Reporting is ensured by:

• Data Governance Studio (DGS).

This document is meant for Oracle Financial Services Regulatory Reporting for US Federal Reserve – Integration Pack System Administrator. It provides step-by-step instructions necessary for installing the OFS REG REP USFED Application components.

This document provides a stepwise instruction to install Oracle Financial Services Regulatory Reporting for US Federal Reserve – Integration Pack (OFS REG REP USFED).

1.3 Prerequisites for the Audience

The document assumes you have experience in installing Enterprise components. Basic knowledge about the Oracle Financial Services Data Foundation Application Pack components, Oracle Financial Services Regulatory Reporting for US Federal Reserve – Integration Pack Components Architecture,

Deployment of OFSAA Configuration Package on Vermeg AgileREPORTER Platform, OFSAA Architecture, UNIX Commands, Database Concepts, and Web Server or Web Application Server is recommended.

3 Preparing for Installation

This chapter provides the necessary information to review before installing the OFS REG REP USFED Application v8.1.1.1.0.

3.1 Obtaining the Software

This release of OFS REG REP US FED v8.1.1.1.0 can be downloaded from the <u>My Oracle Support</u> website. Log in and search for **33080763** under the Patches and Updates Tab and download the OFS_REG_REP_USFED_8.1.1.1.0_GENERIC.zip archive file.

You must have a valid Oracle account to download the software.

3.2 Prerequisites for a New Installation

The following are the prerequisites to install the OFS REG REP USFED Application:

- Install and Configure Oracle Financial Services Regulatory Reporting For US Federal Reserve Integration Pack (OFS REG REP USFED) v8.1.1.1.0 (33080763) and other prerequisite OFSAAI Patches (see Section 3.2 Prerequisites-installation of OFS REG REP USFED Installation Guide) on your machine.
- Install and Configure Oracle Financial Services Data Foundation Application Pack v8.1.1.0 One-off Patch Release #1 (8.1.1.2) (**33017858**). For the OFSDF Release v8.1.1.1.2 documents and the detailed Release Notes, see the following link: <u>OHC Documentation</u> <u>Library.</u>
- AgileREPORTER version 21.2.1
- AgileREPORTER Templates version FED_v1.26.1
- Ensure that you have executed the .profile file before you trigger the installation.

3.3 Installing OFS REG REP USFED 8.1.1.1.0 Release

Perform the following instructions to copy, extract, and install this release:

- 1. Copy the downloaded archive file to your OFSAA server in **Binary** Mode.
- 2. Shut down all the OFSAA Services except FICSERVER. For more information, see the *Stop the Infrastructure Services* Section in <u>OFS Advanced</u> <u>Analytical Applications Infrastructure Pack Installation and Configuration Guide.</u>]



- 3. Execute chmod -R 750 \$FIC HOME
- **4.** If you have an Unzip utility, skip to the next step.

Download the Unzip utility (OS-specific) unzip_<os>. z from the location https://updates.oracle.com/unzips/unzips.html and copy it in **Binary** Mode to the directory that is included in your PATH variable, typically **\$HOME** Path or Directory in which you have copied the 8.1.1.1.0 patch.

Uncompress the unzip installer file using the command:

uncompress unzip_<os>.Z

NOTE	If you notice an error message "uncompress: not found [No such file or directory]", contact your UNIX Administrator.	
	It is recommended you extract the contents (unzip) of every installer in a separate folder. Do not use one single folder to unzip contents of different releases or patches as some files could be overwritten.

5. Execute chmod 751 <name of the patch zip file>

For example: chmod 751 OFS_REG_REP_USFED_8.1.1.1.0_GENERIC.zip

6. Execute unzip -a <name of the file to be unzipped>

For example: unzip -a OFS_REG_REP_USFED_8.1.1.1.0_GENERIC.zip

- 7. Execute chmod -R 755 OFS_REG_REP_USFED
- 8. Execute chmod -R 755 appsLibConfig
- **9.** Configure the UPLOAD_MODEL parameter in the params.conf file present under the appsLibConfig/conf/params.conf directory to determine if Model Upload is required or not using the following parameter values:

0 = If you have already performed Model Upload and want to skip the Model Upload Process **1** = If you want to perform Model Upload

- 10. Navigate to the OFS_REG_REP_USFED/bin directory and execute ./install.sh
- **11.** The installation progress can be viewed by periodically refreshing the log file in the OFS_REG_REP_USFED/logs directory.

 After installation is completed, verify the log file for any Errors or Warnings. Contact <u>My Oracle Support</u> in case of any issues.

NOTE This patch installation has taken approximately 10 minutes to complete in Oracle Labs.

3.4 **Post-installation Steps**

The post-installation steps required for this release are as follows:

1. Apply the OFS AAI **33663417** mandatory patch.

ATTENTION	On the 10th of December 2021, Oracle released Security Alert CVE-2021-44228 in response to the disclosure of a new vulnerability affecting Apache Log4J before version 2.15. The application of the 33663417 Mandatory Patch fixes the issue.
	For details, see the My Oracle Support Doc ID <u>2827801.1</u> .
	Ensure that you reapply the 33663417 Mandatory Patch whenever you install or upgrade the application or apply an incremental patch.

- 2. See the log file in the /OFS_REG_REP_USFED/logs directory to ensure that there are no errors reported. Contact <u>My Oracle Support</u> in case of any issues.
- **3.** Execute the <u>USFED_81110_Atomic_PostScripts.sql</u> in the Atomic Schema.
- **4.** Execute the <u>USFED_81110_Config_PostScripts.sql</u> in the Config Schema after replacing the following placeholders:

##COMMON## - Replace with SEGMENT Code of OFS REG REP USFED Application

##INFODOM## - Replace with INFODOM Code of OFS REG REP USFED Application

- Generate the application EAR or WAR file and redeploy the application on the configured Web Application Server.

- 6. Restart all the OFSAA Services. For more information, see the *Start the Infrastructure Services* Section in the <u>OFS Advanced</u> <u>Analytical Applications Infrastructure Pack Installation and Configuration Guide</u>.
- Perform the Source Model generation for US FED Processing Source.
 For more information, see the *Generating Source Models* Section in the <u>OFS Advanced</u> Analytical Applications Infrastructure Pack User Guide – Release 8.1.1.0.0.

3.5 **Post US FED Run Execution**

After the US FED Run Execution, follow these steps:

- 1. For Prior Date Reporting, see the Prior Date Reporting Document.
- 2. Execute the <<INFODOM>>_REG_RUNEXE_RESAVE batch to populate the RUNEXESUMM Table if you are not using the FFIEC-002 or FFIEC-002S Reports.

If you are using the FFIEC-002 or FFIEC-002S Reports, then execute the <Installer Path>/OFS_REG_REP_USFED/Post_Scripts/RUNEXESUMM_VW.sql file in Atomic Schema.

Lombard AgileREPORTER would display additional filters of Run Execution ID and Run Status during report retrieval based on the RUNEXESUMM Table:

- a. Run Execution ID is the Run Execution Identifier concatenated with Run Description.
- b. Run Status shows the status of US FED Run Execution.
- c. Define the entities as SOLO or CONSOLIDATED in Lombard AgileREPORTER before retrieving returns.
 For more information on Derived Entity Resave, see the MOS.

4 Deploying Config Package

This section describes the steps to deploy the config package after saving the derived entities:

- To deploy the product configuration on AgileREPORTER using the package
 OFSAA_REG_REP_USFED_81110.zip bundled inside the Config_Package folder of the
 installer:
 - **a.** Navigate to the <LombardAgileREPORTER>/bin directory under the installed location.
 - **b.** Add a new configuration with the following command:

./config.sh -a <Config Package Full Path>

For example:

```
./config.sh -a /scratch/kit/811/OFS_REG_REP_USFED/Config_Package/
OFSAA_REG_REP_USFED_81110.zip
```

2. Update the Alias with the following command:

```
./config.sh -ea OFSAA_REG_REP_USFED_81110 -iv 8.1.1.1.0 -alias
"OFSAA FED DATA SOURCE" -aif scratch/agile/bin/aliasinfo.properties
```
