OFS Risk Regulatory Reporting (REG REP) Solution helps in achieving the objectives by enabling preset steps based on the generalization of a set of solutions. This is made possible by:

- Providing Centralized Data Storage for Risk Data through relevant subject areas of the Financial Services Data Foundation (FSDF).
- Interfacing with a Third-Party Reporting tool such as Vermeg Reporter Portal to build necessary Template Reports to meet the regulatory expectations.

Data Governance Studio (DGS).

#### 1.2 Scope

This document provides a stepwise instruction to install Oracle Financial Services Regulatory Reporting for US Federal Reserve – Integration Pack (OFS REG REP USFED).

### 1.3 Prerequisites for the Audience

The document assumes you have experience in installing Enterprise Components. Basic knowledge about the Oracle Financial Services Data Foundation Application Pack components, Oracle Financial Services Regulatory Reporting for US Federal Reserve – Integration Pack Components Architecture,

Deployment of OFSAA Configuration Package on Vermeg AgileREPORTER Platform, OFSAA Architecture, UNIX Commands, Database Concepts, and Web Server or Web Application Server is recommended.

This chapter provides the necessary information to review before installing the OFS REG REP USFED Application v8.1.2.1.0.

## 3.1 Obtaining the Software

This release of OFS REG REP US FED v8.1.2.1.0 can be downloaded from the My Oracle Support website. Log in and search for **35114938** under the **Patches and Updates** Tab and download the OFS\_REG\_REP\_USFED\_8.1.2.1.0\_GENERIC.zip archive file.

You must have a valid Oracle account to download the software.

## 3.2 Prerequisites for a New Installation

The following are the prerequisites to install the OFS REG REP USFED Application:

- Install and Configure Oracle Financial Services Analytical Applications Infrastructure (OFSAAI) v8.1.2.0.0 (patch 32791983) and other prerequisite OFSAAI Patches (see Section 4 Pre-installation of OFS AAI Installation and Configuration Guide) on your machine.
- Install and Configure Oracle Financial Services Data Foundation (OFSDF) Application Pack Release v8.1.2.0.0 (patch **32820351**) and other prerequisite OFSDF Patches (see *Section 4.1 Pre-installation Checklist* of the OFSDF Installation and Configuration Guide) on your machine.
- Install and Configure Oracle Financial Services Regulatory Reporting For US Federal Reserve Integration Pack (OFS REG REP USFED) v8.1.2.0.0 (patch 34006800) and other prerequisite OFSAAI patches (see Section 3.2 Prerequisites-installation of OFS REG REP USFED Installation Guide) on your machine.

- Install and Configure Oracle Financial Services Data Foundation (OFSDF) Application Pack Release v8.1.2.1.0 (patch **33716139)** and other prerequisite OFSDF Patches (see *Section 4.1 Pre-installation Checklist* of the OFSDF Installation and Configuration Guide) on your machine.
- AgileREPORTER version 21.3.0
- AgileREPORTER Templates version FED v1.28.1
- Ensure that you have executed the .profile file before you trigger the installation.

## 3.3 Installing OFS REG REP USFED 8.1.2.1.0 Release

Perform the following instructions to copy, extract, and install this release:

- 1. Copy the downloaded archive file to your OFSAA server in **Binary** Mode.
- 2. Shut down all the OFSAA Services.
  For more information, see the *Stop the Infrastructure Services* Section in OFS Advanced Analytical Applications Infrastructure Pack Installation and Configuration Guide.
- 3. Execute chmod -R 750 \$FIC HOME
- **4.** If you have an Unzip utility, skip to the next step.

Download the Unzip utility (OS-specific) unzip\_<os>.z from the location <a href="https://updates.oracle.com/unzips/unzips.html">https://updates.oracle.com/unzips/unzips.html</a> and copy it in **Binary** mode to the directory that is included in your PATH variable, typically **\$HOME** Path or Directory in which you have copied the 8.1.1.0.0 patch.

Uncompress the unzip installer file using the command:

uncompress unzip\_<os>.Z

#### NOTE

If you notice an error message "uncompress: not found [No such file or directory]", contact your UNIX administrator.

It is recommended you extract the contents (unzip) of every installer in a separate folder. Do not use one single folder to unzip contents of different release or patches as some files could be overwritten.

- 5. Execute chmod 751 OFS REG REP USFED 8.1.2.1.0 GENERIC.zip
- 6. Execute unzip -a <name of the file to be unzipped>
  For example: unzip -a OFS REG REP USFED 8.1.2.1.0 GENERIC.zip
- 7. Navigate to the appsLibConfig/conf directory containing the params.conf file.
- 8. Create a copy of this file and rename the copy as Silent.props.
- **9.** Edit the Silent.props file and specify the parameters as per the requirements.

The following table lists all the properties that must be specified.

ENABLE_CONC URRENCY	Specify if you want to Enable Parallel Processing.	0 = No 1 = Yes	MANDATORY.
CONCURRENCY _LEVEL	Specify if you want to Enable Parallel Processing.	For example:  CONCURRENCY_LEVEL=10,  which means 10 threads  created for parallelism	MANDATORY when ENABLE_CONCURRENCY=1.

- **10.** Execute the user .profile file.
- 11. Navigate to the OFS REG REP USFED/bin directory and execute ./setup.sh SILENT
- **12.** The installation progress can be viewed by periodically refreshing the log file under the OFS\_REG\_REP\_USFED/logs directory.
- **13.** After installation is completed, verify the log file for any Errors or Warnings. Contact My Oracle Support in case of any issues.

NOTE	The installation has taken approximately 23 minutes to complete in Oracle Labs.
NOTE	Follow the above installation procedure to upgrade from REG REP USFED 8.0.x to REG REP USFED 8.1.x by specifying the properties and parameters in the Silent.props file appropriately.
NOTE	There are no specific steps applicable for the installation on ADW in OFSAA for OFS REG REP USFED. However, if you need more information on ADW, see the <i>Installation Notes Specific to ADW</i> section in the <u>FSDF 8.1.2.1.0</u> . <u>Installation and Configuration Guide</u> .

## 3.4 Post-installation Steps

The post-installation steps required for this release are as follows:

- 1. See the log file in the /OFS\_REG\_REP\_USFED/logs Directory to ensure that there are no errors reported. Contact My Oracle Support in case of any issues.
- **2.** Generate the application EAR or WAR file and redeploy the application on the configured Web Application Server.
  - For more information on generating and deploying the EAR or WAR file, see the *Post Installation Steps* Section in the <u>OFS Advanced Analytical Applications Infrastructure Pack Installation and Configuration Guide</u>.
- To configure the Tomcat for User Group Authorization, Data Mapping, and Disabling WADL for the Web Service, see the MOS DOC ID <u>2869091.1</u>
- **4.** Restart all the OFSAA services. For more information, see the *Start the Infrastructure Services* Section in the <u>OFS Advanced Analytical Applications Infrastructure Pack Installation and Configuration Guide</u>.
- Perform the Source Model generation for US FED Processing Source.
   For more information, see the *Generating Source Models* Section in the <u>OFS Advanced Analytical Applications Infrastructure Pack User Guide Release 8.1.2.1.0.
  </u>

The Oracle Financial Services Regulatory Reporting for US Federal Reserve – Integration Pack (OFS REG REP US FED) is now ready for use. If you encounter any problems during the setup, contact OFSAA Support at My Oracle Support.

### 3.5 Post US FED Run Execution

After the US FED Run execution, follow these steps:

1. For prior date reporting, see the Prior Date Reporting Document.

- **2.** Execute the <<INFODOM>>\_REG\_RUNEXE\_RESAVE batch to populate the RUNEXESUMM Table if you are not using the FFIEC-002 or FFIEC-002S Reports.
- 3. If you are using the FFIEC-002 or FFIEC-002S reports, then execute the <Installer Path>/OFS\_REG\_REP\_USFED/Post\_Scripts/RUNEXESUMM\_VW.sql file in Atomic Schema.
- **4.** Lombard AgileREPORTER would display additional filters of Run Execution ID and Run Status during report retrieval based on the RUNEXESUMM Table:
  - a. Run Execution ID is the Run Execution Identifier concatenated with Run Description.
  - **b.** Run Status shows the status of US FED Run Execution.
  - **c.** Define the entities as SOLO or CONSOLIDATED in Lombard AgileREPORTER before retrieving returns.
    - For more information on Derived Entity Resave, see the MOS.

# 4 Integration with Agile REPORTER

This section provides information on how to integrate with Agile REPORTER for Last Mile Reporting using either Product Seeded Mapping Logic (Config Package) or Dynamic Mapping Logic (Dynamic Integration Package) in the application.

### 4.1 Deploying Config Package

This section describes the steps to deploy the Config Package after saving the derived entities. This Config Package consists of the Reporting Logic seeded by the product for each line item.

- 1. To deploy the product configuration on AgileREPORTER using the package OFSAA\_REG\_REP\_USFED\_81200.zip bundled inside the Config\_Package folder of the installer:
  - **a.** Navigate to the <LombardAgileREPORTER>/bin directory under the installed location.
  - **b.** Add a new configuration with the following command:

```
./config.sh -a <Config_Package Full Path>
```

#### For example:

```
./config.sh -a /scratch/kit/812/OFS_REG_REP_USFED/Config_Package/OFSAA REG REP USFED 81200.zip
```

**2.** Update the Alias with the following command:

```
./config.sh -ea OFSAA_REG_REP_USFED_81210 -iv 8.1.2.1.0 -alias "OFSAA FED DATA SOURCE" -aif scratch/agile/bin/aliasinfo.properties
```

## 4.2 Deploying Dynamic Integration Package

This section describes the steps to deploy the Dynamic Integration Package after saving the derived entities and performing the Report Publish. This Integration Package consists of the Reporting Logic seeded by the product as a Key Value pair for each line item. The key value can be controlled through report publish and therefore, the final reporting is dynamic.

- 1. To deploy the product configuration on AgileREPORTER using the package OFSAA\_REG\_REP\_USFED\_81210.zip bundled inside the Dynamic\_Package folder of the installer:
  - **a.** Navigate to the <LombardAgileREPORTER>/bin directory under the installed location.
  - **b.** Add a new configuration with the following command:

```
./config.sh -a <Dynamic Package Full Path>
```

#### For example:

```
./config.sh -a/scratch/ofsaaapp1/kit/81200/KIT_OFS_REG_REP_USFED /OFS_REG_REP_USFED/Dynamic_Integration_Package/OFSAA_REG_REP_USFED_8 1210.zip
```

2. Update the Alias with the following command:

```
./config.sh -ea OFSAA_REG_REP_USFED_81200 -iv 8.1.2.1.0 -alias "OFSAA FED DATA SOURCE" -aif scratch/agile/bin/aliasinfo.properties
```
