Oracle Financial Services Regulatory Reporting for European Banking Authority – Lombard Risk Integration Pack (OFS_REG_REP_EBA) enables the customers to enables the banks to comply with BCBS 239 regulations. It integrates risk data reporting systems and enhances the accuracy of reporting in banks. OFS Risk Regulatory Solution (RRS) helps in achieving the objectives by enabling preset steps based on the generalization of a set of solutions. This is made possible by:

- Providing a centralized data storage for risk data through relevant subject areas of Financial Services Data Foundation (FSDF).
- Interfacing with a Regulatory Reporting tool – OFS AgileREPORTER to build necessary template reports to meet the regulatory expectations.
- Managing accuracy of risk reporting through Data Governance Studio (DGS).

The document assumes you have experience in installing Enterprise components. Basic knowledge about the Oracle Financial Services Data Foundation Application Pack components, OFSAA Architecture, UNIX commands, Database concepts and Web Server/ Web Application Server is recommended.

1 OFS REG REP EBA Pack Release 8.0.5.1.0

This Maintenance Level (ML) Release of OFS REG REP EBA – Lombard Risk Integration Pack is cumulative and includes all enhancements and bug fixes done since the OFS REG REP EBA – Lombard Integration Pack v8.0.5.0.0 release. For more information, refer the Oracle Financial Services Regulatory Reporting for European Banking Authority – Lombard Risk Integration Pack – Release 8.0.5.1.0 on [OHC](#).

1.1 Pre-installation Requirements

The prerequisite software that must be installed are:

- Oracle Financial Services Analytical Applications Infrastructure (OFSAAI) **8.0.5.1.0** (patch **27094265** plus mandatory consolidated one-off patch **27504805**)
- Oracle Financial Services Data Foundation (FSDF) **8.0.5.1.0** (patch **27197750**)
- Oracle Financial Services Regulatory Reporting for European Banking Authority – Lombard Risk Integration Pack **8.0.5.0.0** (patch **26967142**)
- AgileREPORTER version **1.15.8-b31**
- AgileREPORTER Templates version **AR_ECR_Package_v1.28.0.7**
- Ensure that you have executed **.profile** before you trigger the installation.
- Ensure that the FIC Server is up and running before you trigger the installation. For information on restarting the services, Refer *Oracle Financial Services Advanced Analytical Applications Infrastructure Pack Installation Guide – Release 8.0.5.0.0* ([OHC](#) Documentation Library) for more information.

1.2 How to Apply This Maintenance Level Release?

To apply this maintenance release, follow the steps in [Installing OFS REG REP EBA 8.0.5.1.0 ML](#) and [Post-installation Steps](#) sequentially.

1.2.1 Installing OFS REG REP EBA 8.0.5.1.0 ML

Perform the following instructions to download, extract and install this ML patch:

1. Download the **OFS_REG_REP_EBA_8.0.5.1.0_GENERIC.zip** archive file from <https://support.oracle.com/> for patch **27753798** under the *Patches & Updates* tab.
2. Copy the archive file to your OFSAA server in **Binary** mode.
3. Shut down all the OFSAA Services except the FIC Server. For more information, refer to the *Start/Stop Infrastructure Services* section in [Oracle Financial Services Advanced Analytical Applications Infrastructure Pack Installation Guide – Release 8.0.5.0.0](#).

NOTE: Ensure that the **FIC Server** is up and running.

4. Execute **chmod -R 750 \$FIC_HOME**
5. If you have an Unzip utility, skip to the next step.

- Download the Unzip utility (OS specific) `unzip_<os>.Z` from the location <https://updates.oracle.com/unzips/unzips.html> and copy it in **Binary** mode to the directory that is included in your PATH variable, typically `$HOME` path or directory in which you have copied the 8.0.5.1.0 ML.

- Uncompress the unzip installer file using the command:

```
uncompress unzip_<os>.Z
```

NOTE: If you notice an error message “**uncompress: not found [No such file or directory]**”, contact your UNIX administrator.

- Execute `chmod 751 OFS_REG_REP_EBA_8.0.5.1.0_GENERIC.zip`
- Execute `unzip -a <name of the file to be unzipped>`
For example: `unzip -a OFS_REG_REP_EBA_8.0.5.1.0_GENERIC.zip`
- Configure `UPLOAD_MODEL` parameter in the `param.conf` file present under the `OFS_REG_REP_EBA/conf` directory to determine if Model Upload is required or not:
0 = If you have already performed Model Upload and want to skip Model Upload process
1 = If you want to perform Model Upload
10. Navigate to `OFS_REG_REP_EBA/bin` directory and execute `./install.sh`
- The installation progress can be viewed by periodically refreshing the log file under the `OFS_REG_REP_EBA/logs` directory.
- After installation is completed, verify the log file for any Errors or Warnings. Contact [My Oracle Support](#) in case of any issues.

NOTE: This patch installation has taken approximately 23 minutes to complete in Oracle Labs.

1.3 Post-installation Steps

After successful installation of the 8.0.5.1.0 ML patch:

- Refer to the log file in the path `/OFS_REG_REP_EBA/logs` to ensure that there are no errors reported.
- Restart all the OFSAI Servers. Refer *Oracle Financial Services Analytical Application Infrastructure Release 8.0.5.0.0 Installation and Configuration Guide* ([OHC](#) Documentation Library) for more information.

2 Config Package Deployment

This section describes the order to deploy the config package after saving the derived entities:

1. To deploy the product configuration on Lombard AgileREPORTER using the package `OFSAA_REG_REP_EBA_80510.zip` bundled inside `Config_Package` folder of installer:
2. Navigate to `<LombardAgileREPORTER>/bin` under the installed location
3. Add a new configuration with the following command:

```
./config.sh -a <Config_Package Full Path>
```

For example:

```
./config.sh -a /scratch/kit/805/OFS_REG_REP_EBA/Config_Package/  
OFSAA_REG_REP_EBA_80510.zip
```

4. Activate the configuration with the following command:

```
./config.sh -t OFSAA_REG_REP_EBA_80500 -iv 8.0.5.0.0
```

5. Update the Alias with the following command:

```
./config.sh -ea OFSAA_REG_REP_EBA_80500 -iv 8.0.5.0.0 -alias "OFSAA EBA DATA  
SOURCE" -aif <LombardAgileREPORTER>/bin/aliasinfo.properties
```
