Oracle Financial Services Regulatory Reporting for European Banking Authority – Lombard Risk Integration Pack (OFS\_REG\_REP\_EBA) enables the customers to enables the banks to comply with BCBS 239 regulations. It integrates risk data reporting systems and enhances the accuracy of reporting in banks. OFS Risk Regulatory Solution (RRS) helps in achieving the objectives by enabling preset steps based on the generalization of a set of solutions. This is made possible by:

- Providing a centralized data storage for risk data through relevant subject areas of Financial Services Data Foundation (FSDF).
- Interfacing with a Regulatory Reporting tool OFS AgileREPORTER to build necessary template reports to meet the regulatory expectations.
- Managing accuracy of risk reporting through Data Governance Studio (DGS).

# 1 Hardware and Software Requirements and Specifications

This section describes the various Operating System, Database, Web Server, and Web Application Server version and other variant details on which this release of the OFS Regulatory Reporting for European Banking Authority – Lombard Risk Integration Pack (OFS\_REG\_REP\_EBA) application has qualified.

# 2 OFS REG REP EBA Pack Release 8.0.6.1.0

This Maintenance Level (ML) Release of OFS REG REP EBA – Lombard Risk Integration Pack is cumulative and includes all enhancements and bug fixes done since the OFS REG REP EBA – Lombard Integration Pack v8.0.6.1.0 release. For more information, refer the Oracle Financial Services Regulatory Reporting for European Banking Authority – Lombard Risk Integration Pack User Guide – Release 8.0.6.1.0 on OHC.

# 2.1 Pre-installation Requirements

The prerequisite software that must be installed are:

- Oracle Financial Services Analytical Applications Infrastructure (OFSAAI) 8.0.6.1.0 (patch 28033370) plus other prerequisite OFSAAI patches (see Section 1.1 Pre-Installation Requirements of OFS AAI Installation Guide) should be installed and configured in your Machine (OHC Documentation Library).
- Oracle Financial Services Data Foundation (OFSDF) 8.0.6.1.0 (patch 28517884) plus other prerequisite OFSDF patches (see Section 3.1 Installer and Installation Prerequisites of OFSDF Installation Guide) should be installed and configured in your Machine (OHC Documentation Library).
- Oracle Financial Services Regulatory Reporting for European Banking Authority Lombard Risk Integration Pack Guide 8.0.6.0.0 (patch 28075220)
- AgileREPORTER version **1.16.0-b75**
- AgileREPORTER (European Common Reporting (ECR)) Template version 1\_28\_0\_7 and European Central Bank (ECB) Template version 1\_3\_1\_3 are available in the AgileREPORTER.
- Ensure that you have executed .profile before you trigger the installation.
- Ensure that the FICServer is up and running before you trigger the installation. For information on restarting the services, see *Oracle Financial Services Analytical Applications Infrastructure Release 8.0.2.0.0 Installation Guide* (OHC Documentation Library) for more information.

# 2.2 How to Apply This Maintenance Level Release?

To apply this maintenance release, follow the steps in <u>Installing OFS REG REP EBA 8.0.6.1.0 ML</u> and <u>Post-installation Steps</u> sequentially.



## 2.2.1 Installing OFS REG REP EBA 8.0.6.1.0 ML

Perform the following instructions to download, extract and install this ML patch:

- 1. Download the OFS\_REG\_REP\_EBA\_8.0.6.1.0\_GENERIC.zip archive file from https://support.oracle.com/ for patch 28485445 under the *Patches & Updates* tab.
- 2. Copy the archive file to your OFSAA server in **Binary** mode.
- 3. Shut down all the OFSAA Services. For more information, refer to the *Start/Stop Infrastructure*Services section in <u>Oracle Financial Services Advanced Analytical Applications Infrastructure Pack</u>

  Installation Guide Release 8.0.2.0.0.

**NOTE:** Ensure that the **FICSERVER** is up and running.

- 4. Execute chmod -R 750 \$FIC HOME
- 5. If you have an Unzip utility, skip to the next step.

Download the Unzip utility (OS specific) unzip\_<os>. Z from the location <a href="https://updates.oracle.com/unzips/unzips.html">https://updates.oracle.com/unzips/unzips.html</a> and copy it in Binary mode to the directory that is included in your PATH variable, typically \$HOME path or directory in which you have copied the 8.0.6.1.0 ML.

Uncompress the unzip installer file using the command:

uncompress unzip\_<os>.Z

**NOTE:** If you notice an error message "uncompress: not found [No such file or directory]", contact your UNIX administrator.

- 6. Execute chmod 751 OFS REG REP EBA 8.0.6.1.0 GENERIC.zip
- 7. Execute unzip -a <name of the file to be unzipped>
  For example: unzip -a OFS REG REP EBA 8.0.6.1.0 GENERIC.zip
- 8. Configure **UPLOAD\_MODEL** parameter in the **param.conf** file present under the **OFS REG REP EBA/conf** directory to determine if Model Upload is required or not:
  - **0** = If you have already performed Model Upload and want to skip Model Upload process **1** = If you want to perform Model Upload
- 9. Navigate to OFS REG REP EBA/bin directory and execute ./install.sh
- 10. The installation progress can be viewed by periodically refreshing the log file under the OFS\_REG\_REP\_EBA/logs directory.
- 11. After installation is completed, verify the log file for any Errors or Warnings. Contact My Oracle Support in case of any issues.

**NOTE:** This patch installation has taken approximately 20 minutes to complete in Oracle Labs.



## 2.2.2 Post-installation Steps

Perform the following instructions after successful installation of the 8.0.6.1.0 ML patch:

• Apply the OFS AAI 33663417 mandatory patch.

# On the 10th of December 2021, Oracle released Security Alert CVE-2021-44228 in response to the disclosure of a new vulnerability affecting Apache Log4J before version 2.15. The application of the **33663417** Mandatory Patch fixes the issue. For details, see the My Oracle Support Doc ID <u>2827801.1</u>. Ensure that you reapply the **33663417** Mandatory Patch whenever you install or upgrade the application or apply an incremental patch.

- Refer to the log file in the /OFS\_REG\_REP\_EBA/logs directory to ensure that there are no errors reported.
- Generate the application EAR / WAR file and redeploy the application on the configured Web
  Application Server. For more information on generating and deploying EAR / WAR file, refer to
  the Post Installation Configuration section in <u>Oracle Financial Services Advanced Analytical</u>
  Applications Infrastructure Pack Installation Guide Release 8.0.2.0.0.
- Restart all the OFSAA services. For more information, see the Start/Stop Infrastructure Services section in <u>Oracle Financial Services Advanced Analytical Applications Infrastructure Pack</u>
   Installation Guide Release 8.0.2.0.0.
- Perform the additional configurations if required as mentioned under the Additional Configurations section in OFS AAAI Release 8.0.2.0.0 Installation Guide.

# 2.3 Deploying Config Package

This section describes the steps to deploy the config package after saving the derived entities:

- To deploy the product configuration on Lombard AgileREPORTER using the package OFSAA\_REG\_REP\_ECB\_80610.zip bundled inside the Config\_Package folder of installer:
  - a. Navigate to **LombardAgileREPORTER>/bin** under the installed location
  - b. Add a new configuration with the following command:
    - ./config.sh -a <Config Package 1 Full Path>



For example:

- ./config.sh -a /scratch/kit/80610/OFS\_REG\_REP\_EBA/
  Ana\_Config\_Package/OFSAA\_REG\_REP\_ECB\_80610.zip
- c. Update the Alias with the following command after the configuration command is successfully executed:
  - ./config.sh -ea OFSAA\_REG\_REP\_ECB\_80610 -iv 8.0.6.1.0 -alias "OFSAA\_EBA\_DATA\_SOURCE" -aif
  - <LombardAgileREPORTER>/bin/aliasinfo.properties
