Introduction to Oracle Financial Services Data Management Applications Pack

The Oracle Financial Services Data Management (OFSDM) is an analytical data management platform for the Financial Services industry. OFSDM combines an industry data model for Financial Services along with a set of management and infrastructure tools that allows Financial Services Institutions to develop, deploy, and operate analytical solutions spanning key functional areas in Financial Services.

OFSDM is a comprehensive data management platform that helps institutions to manage the analytical data life cycle from sourcing to reporting and business intelligence/BI using a unified, consistent platform and toolset.

Components of OFSDM

OFSDM consists of the following components, which are described in additional detail in the following sections:

1. Oracle Financial Services GL Reconciliation Framework


Reconciles the balances from the operational systems of a bank with the balances as maintained in the General Ledger (hereinafter referred to as GL) of the bank. With this application banks can also reconcile between General Ledgers maintained in the bank. The balances in the GL of a bank are the ones which are audited and duly certified by the internal and external auditors. The GL balances are considered to be the final version of truth in a bank.
